ORDERED:

1. That to meet the current expenses of the City of Boston, in the fiscal year commencing July 1, 2013 and ending June 30, 2014, the respective sums of money specified in the schedules hereinafter set out, be, and the same hereby are, appropriated for expenditure under the direction of the respective boards and officers severally specified, for the several specific purposes hereinafter designated and, except for transfers lawfully made, for such purposes only said appropriations, to the extent they are for the maintenance and operation of parking meters, and the regulation of parking and other activities incident thereto (which is hereby determined to be \$16,500,000), being made out of the income from parking meters and, to the extent they are for other purposes, being made out of the proceeds from the sale of tax title possessions and receipts from tax title redemptions in addition to the total real and personal property taxes of prior years collected from July 1, 2012 up to and including March 31, 2013, as certified by the City Auditor under Section 23 of Chapter 59 of the General Laws, and out of available funds on hand, (which is hereby determined to be \$40,000,000) as certified by the Director of Accounts under said Section 23, and the balance of said appropriations to be raised by taxation pursuant to Section 23 of Chapter 59 of the General Laws:

Dear Councilors:

I retransmit herewith an appropriation order for the Boston Public Schools for Fiscal Year 2014, in the amount of \$937.4 million, submitted pursuant to the provisions of Chapter 224 of the Acts of 1936, as amended by Chapter 190 of the Acts of 1982, as further amended by Chapter 701 of the Acts of 1986, Chapter 613 of the Acts of 1987, and Chapter 108 of the Acts of 1991. The increase in the resubmission covers the costs contained in seven collective bargaining contracts that have been negotiated since the original budget submission in April.

This budget, which represents a \$57 million increase over the current year's budget, provides the financial support for our continued efforts to close achievement gaps and provide safe and welcoming high-quality schools next year. With this support we are able to increase our allocations to schools by \$30 million and enhance the options available to our students and families.

We expect to welcome nearly 1,200 new students to BPS this fall, which will represent our highest enrollment in more than eight years. This budget allows us to offer all our students the strong choices they have come to expect from us through increased teacher and school leader support; safer, more welcoming, and innovative school facilities; and greater investments in time and partnerships that extend the school day where extra learning is needed the most.

This budget also allows us to prepare for a bright future as we implement a new school choice system that emphasizes quality choices closer to home. As we do, we must meet our commitments to adding dual-language and full inclusion schools as well as Innovation and in-district charter schools, while also continuing our ongoing work to improve quality in our Turnaround and High-Support schools.

I respectfully request your support of the FY14 appropriation for the Boston Public Schools.



Dear Councilors:

I transmit herewith for your approval an order appropriating \$40,000,000 to the Other Post Employment Benefits (OPEB) Liability Trust Fund authorized under Chapter 32B, §20, as added by Chapter 479 of the Acts of 2008.

With your approval, this proposed amount will bring the total appropriated toward the City's OPEB liability to \$215 million since FY08.

According to the City's June 30, 2011 OPEB valuation, the unfunded actuarial accrued OPEB liability stands at \$3.1 billion, double the City's current pension liability. An updated OPEB valuation is scheduled for release at the end of calendar year 2013.

The City will continue to fund its OPEB obligation within the means of its current budget and manage its long-term liability responsibly, including continuing to work with the Public Employee Committee on strategies to slow the growth of health insurance.
