

Exhibit A: City of Boston Covid-19 Construction Site BEST PRACTICES WORKSHEET

The City of Boston wants to ensure that all companies who are doing permitted construction work in the city have taken precautions to improve safety for their workers.

Below is a non-exhaustive list of CDC, OSHA, Commonwealth of Massachusetts and industry best practices and guidelines to address the project hazards due to COVID-19. All projects must develop a project-specific Safety Plan for COVID-19 that addresses the CDC, OSHA, and Commonwealth of Massachusetts guidelines and best practices. This written plan must be provided to the City and all workers on site. This Safety Plan must be in place before any work can begin on site.

Your Safety Plan should meet the applicable standards set forth in the Massachusetts Covid-19 Guidelines and Procedures for All Construction Sites. Please use this worksheet to aid your development of that Safety Plan. We are mindful that building construction & roadway construction differ. If you check “no” to any of these items, please include in your safety plan your justification for why you checked “no” including your alternative approach to ensuring safety in that area.
