#### Convene

The meeting convened and entered Administrative Session at approximately 10:08 a.m. All in attendance were identified for the record and introductions were made.

## Outstanding/Ongoing Administrative Issues: Padraic P. Lydon, General Counsel ABC Project Update, Luella Wong

Ms. Wong provided an update of work in progress as they work to wrap up the ABC project. She reported that Refunded, Retired, Deceased and Transferred members are all expected to have a zero balance. The remaining accounts with those member statuses will be zeroed with a single transaction unless they are flagged as an exception by the ABC team or the subject matter experts in the department. For example, if the account is flagged as "work n progress" or "likely a duplicate account", it will not be zeroed. The ABC work with wrap up soon and the team will transition to full focus on DQ (data quality). Some team members have already started on the DQ effort.

### Travel to Carlyle Conference

Proposed travel expenses were offered to the Board for investment analyst John Kelly to attend the Carlyle Conference for one day. The anticipated expenses was largely air-flight of approximately \$300.

## Emerging Market Debt

Discussed the search analysis presented by NEPC on the shortlist of 12 respondents to the Emerging Market Debt Search. The discussion included the manager's, risk, performance, size and strategy style. After which the Board agreed upon five managers to present as finalists at the September Board meeting. The finalists chosen were Aberdeen, GMO, Loomis Sayles, Manulife and Wellington.

### Performance

NEPC presented the 2nd quarter 2018 Investment Performance Analysis. This detailed relative and absolute performance for the Plan which returned 8.6% over the trailing one year period. This ranked in the 31st percentile of its peer universe and outperformed its allocation index by some 20 basis points.

## July 2018 Flash Report

NEPC provided the preliminary July performance report which showed the Total Plan was up +1.7% for the month and +2.0% YTD through July of 2018.

#### Outstanding/Ongoing Financial Issues: Ellen M. McCarthy, Comptroller Financial Snapshot

Ms. McCarthy reviewed the July 2018 financial snapshot with the Board noting that the monthly payroll issued timely to 14,935 payees in the amount of \$50,839,897. The payroll of 60 non-contributing retirees totaled \$318,870. There were 35 new superannuation retirees, 4 survivor beneficiaries and 5 new disability retirees. Ms. McCarthy noted that 50 members refunded for a total of \$968,668, there were 20 transfers in the amount of \$1,418,209 and there were 4 option B refunds in the amount of \$176,055. She stated that operations warrants for July 2018 were \$145,126.

## Outstanding/Ongoing Operations Issues: Christine M. Weir, Operations Officer Operations Update

Ms. Weir provided an update on the July 2018 pension payroll. There were 58 potential new cases (42 superannuations, 10 disabilities & 6 DOAs), of which 43 were processed (35 superannuations, 5 disabilities & 3 DOAs). Explanations for why the 15 cases did not make the payroll was as follows:

- 1 waited on a transfer;
- 1 waited on Paternity;
- 7 members did not return their final papers;

- 1 had incomplete documents;
- 1 member was out of the country;
- 1 needed additional info to calculate;
- 1 recoupment;
- 1 needed salary from BPS; and,
- 1 waited on dependent children information.
