DCR Operations & Maintenance Plans - NOI fee calculation

The activities are not related to construction. These are day-to-day maintenance activities conducted by DCR park staff. The most reasonable way to estimate project costs is to estimate salaries of the staff for the portions of their time that are spent with maintenance activities on the DCR beaches.

For each of the 4 NOIs, cost estimate is highlighted in the choices below from the listed City of Boston NOI filing fees.

City of Boston – NOI filing fees

- \$25 for projects that cost \$1,000 or less
- \$50 for projects that cost between \$1,000 \$50,000
- \$75 for projects that cost between \$50,000 \$100,000,
- .075% of the cost for projects that are more than \$100,000. The most we will charge you is \$1,500.

Given the required split between municipal and state filing fees, the city filing fee is calculated at \$75 for each NOI, and \$50 for the state, for a total filing fee of \$125.

PROJECT NARRATIVE

Introduction

The Department of Conservation and Recreation ("Department" or "DCR") seeks an Order of Conditions issued pursuant to the Massachusetts Wetlands Protection Act (WPA) and its implementing regulations, 310 CMR 10.00 et seq. (Regulations), for an Operations and Maintenance Plan (OMP) for Constitution Beach in East Boston as defined in the resource area maps enclosed in this NOI package.

The intent of the OMP is to allow periodic, routine maintenance activities, in compliance with the WPA and Regulations, while providing for protection of coastal resource areas, improve DCR's ability to provide proper maintenance at this location and enhance the public enjoyment of Constitution Beach. Operations and maintenance practices on coastal beaches must meet the WPA Performance Standards for Coastal Resource Areas by avoiding the adverse effects listed in 310 CMR 10.27. The planned activities within coastal wetland resource areas and their buffer zones are subject to jurisdiction under the WPA and its Regulations. Coastal wetland resources that fall within the area of work activities (shown on the Work Area map) are described below. Coastal wetland resource areas that occur outside the area of work activities are not described nor included in the NOI.

Coastal Wetland Resource Areas

This section provides a brief description of each coastal resource area covered by the WPA and its Regulations that is within the OMP project site. Each section begins with the regulatory definition of the resource area, followed by WPA performance standards, and applicability to the site. Coastal wetland resource areas at this site include Coastal Beach, Salt Marsh, and Land Subject to Storm Flowage. These resource areas are delineated on the attached coastal wetland resources maps.

A. Coastal Beach:

Coastal Beach is defined as any unconsolidated sediment subject to wave, tidal and coastal storm action which forms the gently sloping shore of a body of salt water and includes tidal flats. Coastal beaches extend from the mean low water line landward to the dune line, coastal bank line or the seaward edge of existing human-made structures, whichever is closest to the ocean (310 CMR 10.27).

WPA Performance Standards:

Any project on a coastal beach shall not have an adverse effect by increasing erosion, decreasing the volume or changing the form of any such coastal beach or an adjacent or down-drift coastal beach.

Applicability for Operations & Maintenance Activities:

On this site, the coastal beach is the area characterized by the sandy substrate, occupying the intertidal area that extends along the waterfront, and extending landward toward the property boundary and adjacent local road system. Operations and maintenance activities that are conducted on a regular basis by DCR staff on DCR coastal properties are described on pages 3-5 of this narrative. All numbered activities are potentially applicable to the coastal beach resource area at Constitution



Beach. The day-to-day maintenance activities will not alter nor adversely affect this coastal resource.

B. Land Subject to Coastal Storm Flowage:

Land Subject to Coastal Storm Flowage includes low-lying areas along the coast that are within the 100-year flood hazard zone as determined by the Federal Emergency Management Agency (FEMA).

Applicability for Operations & Maintenance Activities:

At this site, the resource area includes the beach and the northeastern part of the property landward from the beach to the roadway / property boundary. (refer to FIRM map Attachment 3). The Operations and Maintenance activities listed on pages 3 – 5 will not result in adverse impacts to storm damage prevention and flood control interests.

Operations and routine maintenance activities for DCR coastal properties are listed and described in the following pages.



DEPARTMENT OF CONSERVATION AND RECREATION CONSTITUTION BEACH, EAST BOSTON, MA OPERATIONS AND MAINTENANCE PLAN

- 1. **Equipment**: The Department utilizes a variety of equipment to maintain Constitution Beach which includes 4-wheeled front-end loaders for loading and removing debris, tractor drawn mechanical beach rakes consisting of a hydraulic operated conveyer tine and hopper collection system, 6-10 wheel heavy dump trucks disposal of debris, and 4-wheel drive utility vehicles for lifeguard service and emergency response. The Department's equipment shall be operated on the beach and buffer zone for the purpose of collecting and removing debris or providing emergency response services. The equipment shall not be stored or left unattended on the beach. Equipment is stored at an off-site Department facility.
- 2. **Contractors and vendors**: The Department shall monitor contractor and vendor activities for compliance with approved operations or maintenance activities.
- 3. Shorebird nesting activities: The Department shall monitor shorebird nesting and foraging habitat and comply with the respective State and Federal Endangered Species Acts, Guidelines and Regulations. This may include, but not be limited to, erecting symbolic fences to restrict pedestrian access to shorebird nesting areas. Vehicle use under the OMP shall meet the vehicle management guidelines stated in *Guidelines for Managing Recreational Use of Beaches to Protect Piping Plover, Terns and Their Habitats in Massachusetts*, Mass. Division of Fisheries and Wildlife, Natural Heritage and Endangered Species Program, April 21, 1993.
- 4. Debris removal: Debris, including organic material and man-made debris and trash, may be removed from the beach and other resource areas identified in this Project Narrative and buffer zones as needed. The Department will remove debris by hand whenever possible. Debris may be removed using a front-end loader and heavy dump trucks when other means are not feasible. Equipment shall be staged from the coastal beach or other solid surfaces to remove debris. Debris removal will not "alter" (as defined in 310 CMR 10.04) the coastal beach, other resource areas or buffer zones. Should debris removal operations require an alteration to the coastal beach, the Department shall file for an emergency certification. Debris removal will not occur in the intertidal zone. Collected debris shall not be stored at the project site and will be removed and disposed off-site.
- 5. **Marine life mortality and disposal**: The Department follows proper and routine disposal procedures of individual vertebrate and invertebrate marine mortalities. In the case of large-volume of individuals, or large-scale marine life such as whale carcasses, the Department will consult with the proper state and federal agencies to create an acceptable plan based on guidelines and recommendations for proper disposal. If removal and disposal operations require, the Department shall file for an emergency certification.
- 6. **Mechanical beach cleaning:** This activity is essential for public health and safety and will be accomplished in such a manner to preserve the existing form, volume and grain-size distribution of the beach to avoid an alteration to the resource area. Beaching raking is only performed in the resource work areas identified in the enclosed maps. Beach raking will not occur in the intertidal zone. The Department's tractor drawn mechanical beach rake collects trash and debris buried in the top layer of loose sand to a depth of 3". The trash and debris



collected in the beach rakes hopper is then dumped into a 6-10 wheel dump truck and disposed of off-site. Front end loaders are utilized to remove debris that is too large for hand collection. Constitution Beach is periodically cleaned in this manner, 1-2 times per week, during the months of May through September.

- 7. Lifeguard stations, Disabled Access: During the months of May through September, lifeguard chairs are placed on Constitution Beach to support lifeguard service. These stations are deployed in the spring and removed in the fall via heavy equipment. During lifeguard service season, utility vehicles distribute equipment to each lifeguard station on a daily basis. Utility vehicles may temporarily access the coastal resource area for emergency response. The Department may place on the beach during the same period ADA-compliant roll-out mats to allow specifically for disabled/wheelchair access over the beach to the water.
- 8. **Special events**: The Department shall require event proponents to submit a *State Parks Special Use Permit* for applicable events. If the activity warrants, the Department will require the Permittee to file a Request for Determination of Applicability (RDA) or a Notice of Intent (NOI) with the Conservation Commission.
- 9. **Coastal storm surges, flooding, reclamation of sand, associated clean-up:** During coastal storms and astronomical high tides, surge impacts and over wash is often observed depositing sand and other debris onto the abutting sidewalks, public way and pavilion areas. This material represents a public safety hazard and may require closure of the public way during extreme events. After coastal storms cease, the Department may remove sand and other debris via heavy equipment. Debris collected from the public way will be disposed of offsite.
- 10. **Infrastructure Repairs and Maintenance:** Existing recreational facilities and structures such as the Constitution Beach Bathhouse, Harbor Walk, pavilions and playgrounds require routine maintenance. DCR must service these assets as well as other infrastructure, such as the lighting along the boardwalk and parking area, when repairs are needed due to vandalism, or when wear and tear requires replacement of some its components. This operation shall exclude the full removal or reconstruction of any entire serviced infrastructure.
- 11. Minor activities: the following activities may be performed year-round as needed:
 - Manual removal of trash from the beach and buffer zone, including sidewalks, pavilions, bathhouses, etc.;
 - Mowing, pruning or string trimming of vegetation on the parking lot side of the beach boardwalk, not within in the resource work area;
 - Power washing and graffiti removal from sidewalks, buildings, pavilions, bathhouse, concession stand and other related hardscapes and infrastructure;




- Parking area, sidewalk and public way maintenance activities such as pot-hole repairs, application of pavement markings, street light maintenance, sign installation and maintenance, and maintenance of storm water and flood control infrastructure¹.
- Activities necessary for operations and planning that are temporary and have negligible impact e.g. sampling, survey, and monitoring.
- 12. Amendments: Any change of the work and activities described in this OMP shall require the Department to file a written request for amendment with the Conservation Commission/or the Department of Environmental Protection.
- 13. **Emergency Certification Process**: The Department will seek an emergency certification in accordance with 310 CMR 10.06 for any warranted, non-approved activities needed for the protection of public health or safety.

¹ The Department's storm water maintenance activities are outlined in the Department's National Pollutant Discharge Elimination System (NPDES) permit. A copy of our NPDES permit and Checklist for Storm Water Report are enclosed with the NOI.

Certain areas not in Special Flood Hazard Areas may be protected by flood control structures. Refer to Section 2.4 "Flood Protection Measures" of the Flood Insurance Study Report for information on flood control structures for this jurisdiction.

The projection used in the preparation of this map was Massachusetts State Plane Mainland Zone (FIPS zone 2001). The horizontal datum was NAD 83, GRS 1980 spheroid. Differences in datum, spheroid, projection or UTM zones used in the production of FIRMs for adjacent jurisdictions may result in slight positional differences in map features across jurisdiction boundaries. These differences do not affect the accuracy of this FIRM.

Flood elevations on this map are referenced to the North American Vertical Datum of 1988.
