

CERTIFICATE OF DESIGN APPROVAL

Dear Ms. Edlund

At a public hearing held at Boston City Hall on November 1, 2005 the South End Landmark District Commission reviewed your application to install a roof deck with metal railings at 531 Massachusetts Avenue. To assess the visibility of the proposed deck railings, the commission appointed a subcommittee (commissioners Moneyhun and Freeman) to visit the site on November 10 to examine a mockup of the railings, however scheduling conflicts and inclement weather resulted in the postponement of the site visit

behind the front roof edge, as shown in plans dated 10.18.05. The deck structure may start at the roof ridge, as proposed, since it will not be visible from the street. Understanding that a higher degree of visibility is typically allowed at the rear, the subcommittee determined that it would allow a five-foot set back from the rear edge. The railings shall be made of thin-gauge metal and shall have a simple, unadorned design, similar to a fire balcouy railing. that the proposed location for the front railing, at the roof ridge, would result in railings that do not meet the minimal visibility standard in the district. Shifting the railing back several feet, however, reduced visibility a great deal. The front railing was approved 20'9" The subcommittee found that the building's location on Chester Square contributes to long sight lines to the roof. The mockup showed
