HAPPY TO BE WITH YOU AGAIN THIS AFTERNOON TO BE ABLE TO DISCUSS **REALLY BIG STRATEGIC INITIATIVES** THAT ARE PART OF OUR STRATEGIC PLAN AND THE PUBLIC DIALOGUE I HAD IN MY 100-DAY TOUR, AND THAT IS AMPLIFY VOICE AND EXPAND OPPORTUNITY, TWO THINGS THAT WERE VERY ELEVATED IN TERMS OF CULTIVATING TRUST WITHIN THE B.P.S. AND OUR LARGER AND BROADER COMMUNITY. AND, SO, WE ARE GOING TO BE TALKING ABOUT OUR INITIATIVES WITHIN THE FAMILY ADVANCEMENT OFFICE AS WELL AS EXPANSION OF PARTNERSHIPS, AND THEN EXPANDING **OPPORTUNITIES TO OUR STUDENTS** AND WITHIN DECISION-MAKING EXPANDING OPPORTUNITIES FOR PARENTS AND THEIR ENGAGEMENT WITH US AND FINALLY MENTIONING ABOUT BUILD B.P.S., WHERE WE ARE ON THE CAPITAL IMPROVEMENT PLANNING AND, AGAIN, AS YOU MENTIONED, THE REVOLVING ACCOUNT. COMMUNITY AND PEBS OF THE** BOSTON COMMUNITY, THANK YOU FOR JOINING US AGAIN THIS AFTERNOON. GIVING US THE OPPORTUNITY TO PRESENT ON AMPLIFYING ALL VOICES AND EXPANDING OPPORTUNITIES TO CRITICAL ISSUES THE SUPERINTENDENT MENTIONED. WE'RE FOCUSING ON THOSE TWO TOPICS FOR TODAY, THE SIX OF EIGHT HEARINGS, WE DO WANT TO EMPHASIZE THE OVERALL \$1.26 MILLION BUDGET AND RECOGNIZING WE ARE RECEIVING AN UNPRECEDENTED COMMITMENT FROM THE CITY OF BOSTON WHICH WE ARE APPRECIATIVE OF, WE'RE MAKING CRITICAL INVESTMENTS IN OUR SCHOOLS PARTICULARLY AROUND FAMILY ENGAGEMENTS, AND OUT OF THIS DISTRICT AND CITY RESPONSE TO THE IMMEDIATE DISRUPTION OF COVID 19, WE ARE EVALUATING FY'20 AND '21 BUDGETS TO CREATE FLEXIBILITY. ONE OF THE THINGS WE HAVE SEEN OVER THE LAST FEW WEEKS WITH COVID IS THE NEED TO DIRECTLY ENGAGE WITH FAMILIES, TO HAVE MULTIPLE WAYS TO REACH OUT TO FAMILIES BOTH THROUGH OUR PARTNERS AND STAFF, AND, SO, WE DO THINK THAT THIS IS A CRITICAL ISSUE FOR US GOING FORWARD. IT'S ALSO, AS WE START TO THINK ABOUT BUILD B.P.S. AND EXPANDING **OPPORTUNITIES, WE'RE REALLY** THINKING ABOUT WHAT THAT MEANS IN A CURRENT CLIMATE, WHAT DOES IT MEAN TO ENGAGE WITH FAMILIES, WHAT ARE A COMMUNITY'S ABILITY TO ENGAGE ON CRITICAL ISSUES.

WE KNOW TIME IS NOT ON OUR SIDE BUT WE ALSO NEED TO BE THOUGHTFUL AND RESPECTFUL OF OUR COMMUNITIES. WITH THAT, I LAUNCH INTO OUR PRESENTATION. YOU WILL SEE VERY SIMILAR, WE OPEN WITH A STATEMENT FROM OUR **OPPORTUNITY ACHIEVEMENT GAP** POLICY, THE NEED TO REDOUBLE OUR EFFORTS TO CLOSE OPPORTUNITY ACHIEVEMENT GAP AND TO ENSURE AN EXCELLENT EDUCATION FOR ALL OUR STUDENTS. THAT REALLY STARTS ENGAGEMENT AS SEEN AS A STRATEGY FOR IMPROVEMENT AND WE REALLY THINK IT'S A CRITICAL PART OF OUR STRATEGY. THIS MORNING OUR HEARING WAS FOCUSED ON THE ACADEMIC SIDE OF THE HOUSE, SO WE'LL JUST NOTE THAT THE 36 MILLION IN NEW **INVESTMENTS IS PART OVERAN** \$80 MILLION INCREASE OVERALL, \$44 MILLION COMING IN COST INCREASES. THE BUDGET REALLY STARTED THIS YEAR WITH THE COMMUNITY ENGAGEMENT PROCESS ROBUSTLY WHEN THE SUPERINTENDENT CAME IN. JOINING ALL OUR SCHOOLS, VISITING EVERY SINGLE SCHOOL COMMUNITY THROUGHOUT OUR NEIGHBORHOODS AND WHAT HAS EMERGED FROM THAT IN THE COMMUNITY VOICE AND REALLY TYPIFIES WHAT THE SUPERINTENDENT PUSHED HER TEAM TO THINK ABOUT IN TERMS OF AMPLIFYING ALL VOICES IS WE HAVE EMERGED WITH THE STRATEGIC PLAN THAT **REPRESENTS THE COMMUNITY'S** VISION FOR SCHOOLS THAT IS INFORMING OUR OPERATIONAL PLAN AND WE THINK IS FIRMLY REFLECTED IN THIS YEAR'S BUDGET AND IN OUR FUTURE BUDGET WE'RE PLANNING FOR **BEGINNING NOW.** CHAIRMAN BOK, OUR HEARINGS HAS BEEN ALIGNED TO OUR STRATEGIC PLAN, PARTICULARLY THE SIX COMMITMENTS ON THE STRATEGIC PLAN.

TODAY, IN THIS HEARING, WE'RE ABLE TO FOCUS ON COMMITMENT THREE AND ONE PART OF COMMITMENT 4. A LOT OF COMMITMENT 4 WE HAD ALREADY TALKED ABOUT IN SCHOOLS HEARINGS, WE'LL FOCUS ON BUILD **B.P.S. AND ACTIVATE PARTNERSHIPS** WILL BE COMMITMENT 6, WE'LL COME BACK AND TALK ABOUT THE PARTNERSHIP ELEMENTS OF IT. BUT TODAY WE'RE TALKING ABOUT ENGAGEMENT, WE'RE TALKING ABOUT HOW TO REALLY AMPLIFY ALL VOICES IN OUR COMMUNITY. I EMPHASIZE THIS, THIS MORNING, IN THE ACADEMICS HEARING, BUT IT REALLY PLAYS OUT IN OUR ENGAGEMENT STRATEGY AS WELL. WHAT WE SEE THROUGHOUT THE DISTRICT AS POCKETS OF ENGAGEMENT EXCELLENCE AND WE HAVE A LOT OF THINGS, A NATIONALLY RENOWNED MODEL IN PARENT UNIVERSITY WHICH CONTINUES TO BE A PART OF PARENT ENGAGEMENT STRATEGY, WE HAVE SCHOOL COUNCILS RICH AND DIVERSE IN TERMS OF VOICES AND THE WAY THEY ENGAGE WITH THEIR COMMUNITIES, BUT WE HAVE OTH RAID THE LEVEL. SO IT'S IN ENSURING THAT WE HAVE THIS CONSISTENT LEVEL OF

EXCELLENCE ACROSS OUR ENGAGEMENT STRATEGIES THAT WE FORM OUR STRATEGY AND NOT THE FOCUS OF OUR STRATEGY FOR THIS YEAR. AND SO WHEN WE THINK ABOUT THIS AGAIN, THE FOUR COMPONENTS TO ALL OF OUR STRATEGIES, THE FIRST IS ENSURING PEOPLE ARE CLEAR ON WHAT THEY'RE BEING ASKED TO DO AND HOW THEY'RE ASKED TO WORK DIFFERENTLY.

>> YOU'RE GOING TO HEAR ABOUT MONICA ROBERTS OFFICE CAN. SECONDLY WE WANT TO MAKE SURE WE'RE DOING IT AND MONITORING FOR INFORMATION STABILITY. AND WE WILL MONITOR STUDENT OUTCOMES AND MAKING SURE THAT THE PLAN IS WORKING FOR ALL OF OUR STUDENTS THAT WANT COMES WITH HOW WE MEASURE STUDENT ENGAGEMENT AND HOW WE THINK ABOUT UNDERSTANDING PARENT VOICE AS FEEDBACK TO OUR PROCESS. AND THE FOURTH THING IS IT THAT WE'RE GOING TO ADJUST THE STRATEGY AND RETRAIN STAFF. THAT'S A BIG PART OF OUR COVID RESPONSE AND BIG PART OF OUR STRATEGY GOING FORWARD. >> STARTING BY LETTING A MAJOR INVESTMENT IN PARTNERING THE HOMESCHOOL PARTNERSHIP AS A CRITICAL LEVEL FOR ACADEMIC AND SCHOOL IMPROVEMENT. WITH 123 DISH SCHOOLS, COMPLEX SCHOOL SYSTEM, PROGRAM SHIFTS AND GREAT CONFIGURATION SHIFTS THAT ARE COMING FROM BPS, THE NEED FOR FAMILIES TO ADAPT TO ONLINE LEARNING AND GET INFORMATION, THE NEED CONNECT TO COMMUNITY RESOURCES INCLUDING THE RESILIENCE FUND SUPPORT. WHATEVER WE'RE LOOKING TO BE ABLE TO PARTNER WITH OUR COMMUNITY IN, THE CRITICAL ROLE OF THE FAMILY LIAISON IS WHAT WE'RE HOPING TO IMPLEMENT FORS IN NEXT YEAR. SO WE HAVE ASSIGNED AND NEW POSITIONS FOR ALL OF THESE SCHOOLS OUT OF THE SCHOOL FUNDING OVER AND ABOVE THE SCHOOL FUNDING THE SCHOOLS WOULD HAVE RECEIVED. AND AS PART OF OUR STRATEGY WE'RE ALSO MAKING SURE THAT THEY ARE HAVING STAFF PERSON IN THE SCHOOL CULTURALLY AND LINGUISTICALLY REPRESENTING THE COMMUNITIES THEY'RE SERVING. MANY OF THESE POSITIONS HAVE SPECIFIC REQUIREMENTS AROUND THE ABILITY TO SPEAK MULTIPLE LANGUAGES. UNIT THREE IS ABOUT ENGAGING YOUTH VOICE IN DECISION-MAKING. ONE OF THE COOL THINGS OUR SUPERINTENDENT HAD DOSSEN THIS YEAR, IS SHE STARTED A STUDENT EXECUTIVE CABINET. SO I HAVE BEEN PAIRED WITH MARCUS, WHO CAN PUT STUDENT CFO

ON HIS ALREADY IMPRESSIVE RES MAY. WHAT THIS ENSHEURSZ IS THAT ALL OF THE SENIOR LEADERS HAVE DIRECT TO AND ACTION WITH STUDENTS AND I HAVE HAD AND I HAVE APPROXIMATE TIPPED TO HAVE CONTACT WITH MARCUS. I HOPE HE HAS LEARNED A LITTLE FROM ME BUT I CAN TELL YOU WHAT HE HAS TAUGHT ME ABOUT THE

STUDENT AND BUDGET PROCESS HAS BEEN HELPFUL. ON A SYSTEM LEVEL WE HAVE THE BOSTON STUDENT ADVISORY COUNCI

BOSTON STUDENT ADVISORY COUNCIL WHICH IS CONNECTED TO HIGH SCHOOLS AND IT IS RESPONSIBLE FOR GETTING PARENT INPUT. AND THEN THEY'RE DOING MORE TOWN HALLS TO REALLY GET OUT STUDENT VOICE AND MAKE SURE IT'S A PART OF WHATEVER DECISION MAKING PROCESS WE HAVE.

I THINK THAT'S A REALLY EXCITING AND A REALLY IMPORTANT WAY TO INFUSE ENERGY IN OUR PROCESS AND MAKE SURE STUDENTS HAVE A REALLY STRONG VOICE WITH DECISIONS THAT WE MAKE.

SUPERINTENDENT MEET WITH THE CITYWIDE PARENT COUNSEL, THE DISTRICT ENGLISH LEARNER AND THE SPECIAL PARENT ADVISORY COUNCIL ON A QUARTERLY BASIS TO DISCUSS ISSUES RAISED AND GET FEEDBACK ON THE EFFORTS THAT THE DISTRICT IS UNDER TAKING.

PARTICULARLY THE BPS DEPARTMENTS ARE ENGAGING TO THE GROUPS, WHILE PLANNING IS IN PROCESS AND PRESENTATIONS AT REGULAR MEETINGS AS WELL AS DELEGATING ON THE WORKING GROUP.

WE ALSO OFFER STUDENT FAMILY AND COMMUNITY ADVANCEMENT AND OFFICE OF ENGLISH LEARNERS AND SUPPORT GROUPS WITH TRAINING ON THE MEETING FACILITYTATION AND ADULT

LEARNING DESIGN. WE PROVIDE FOOD FOR MEETINGS AND MAKE SURE THAT THEY HAVE WHAT WE NEED TO MAKE THEIR MEETING ACCEPTABLE AND SUCCESSFUL. AND WE HAVE CONTINUED TO ASK THE OFFICE TO LAUNCH REGIONAL SCHOOL PARENT COUNSELOR MEETINGS, TO PROVIDE THE STATE WITH PARENT LEADERSHIP GROUPS AND MEET WITH THE SCHOOL SUPERINTENDENTS AND KEY STAFF.

SO WE'RE TRYING TO PROVIDE BOTH TECHNICAL ASSISTANCE AND A STRUCTURE FEEDBACK PROCESS FOR FAMILY TO HAVE A VOICE FORMALLY AND INFORMALLY IN THE PROCESS.

AGAIN WE REALLY THINK PARENT ENGAGEMENT IS THE PILLAR OF STAYING FOR IMPROVEMENT. THIS IS NOT JUST RESPONDING TO COMMUNITIES BUT THIS IS WHERE WE REALLY KNOW THAT PARENTS HAVE AN IMPORTANT VOICE IN DRIVING SCHOOLS FOR IMPROVEMENT. SO WHAT WE HAVE IS A NATIONAL MODEL WITH PARENT UNIVERSITY WHERE WE'RE PROVIDING SUPPORT THROUGH THE MULTIPLE SESSIONS AND SINGLE LEARNING SESSIONS SO PEOPLE CAN LEARN TO LEVERAGE PARTNERS AND OFFER SESSIONS AND PEOPLE CAN BE TRAINED, PARENTS CAN BE TRAINED, PARTNERS CAN BE TRAINED IN THE CURRICULUM, IN SCHOOL GOVERNMENT SO THEY UNDERSTAND HOW TO BE SUPPORTIVE AND HOW TO BE INVOLVE IN OUR SYSTEM. BOSTON PUBLIC SCHOOL IS CONTINUING LIKE A BIG DISTRICT AT TIMES AND WE WANT TO MAKE TOUR SURE THAT PARENTS HAVE THE TOOLS AND KNOWLEDGE AND THE **RESOURCE THEY NEED TO ENGAGE** EFFECTIVELY. I MENTIONED THAT OUR ACCOUNTABILITY INCLUDES MONITORING OF OUTCOMES FOR ADJUSTING OUR -- OUR CHIEF OF ACCOUNTABILITY IS TURNING ON THE SCHOOL BOARD TO MAKE SURE WE'RE WATCHING THE STRATEGY WHILE THE GAME IS STIM BEING PLAYED N FAMILY ENGAGEMENT WE WANT TO INCREASE PARTICIPATION AND FEEDBACK BY MAKING IT EASIER AND

FRIENDLIER FOR PARENTS TO BE INVOLVED.

SO WE WANT TO LOWER THE BARRIER

TO PARTICIPATION, FIGURE OUT WHAT ARE THE WAYS THAT WE CAN NEONATAL WITH THE FAMILIES MORE GENERALLY AND MAKE THEM FEEL COMFORTABLE IN COMING TO US WITH THEIR FEEDBACK AS PART OF THE PROCESS SO WE CAN MONITOR TORE OURSELVES AND RESPOND TO THEIR INPUT.

THE FOUNDATION FOR THIS IS THE SCHOOL SIDE COUNSELS AND THE OFFICE OF STUDENT FAMILY COMMUNITY EP ADVANCEMENT AND BOSTON TEACHERS UNIT PROVIDING TRAINING IN THE FALL FOR THE BUDGET AND OVERSIGHT MANAGEMENT TO INTEGRATE FAMILY ENGAGEMENT IN QUALITY SCHOOL PLANS AND IN THE BUDGET PROCESS. THIS AN EXPLICIT STEP IN OUR BUDGET PROCESS WHEN WE START THE SCHOOL BASED BUDGET. KENNEDY ARE SCHOOLS THAT HAVE PHENOMENON GO GONE THROUGH THIS RIGOROUS PROCESS AND ARE OFFICIALLY STAMPED AS FAMILY-FRIENDLY SCHOOLS. AL ONE OF THE THINGS THAT MAKE BOSTON SUCH A RICH CITY IS OUR COMMUNITY-BASED PARTNERS, OUR CBO'S. FAITH-BASED PARTNERS AND OTHER CONNECTIONS WITH ACCESS TO FAMILIES AND IT HELPS SIGNIFICANTLY AS WE REACH DIVERSE POPULATIONS. THIS HASS BEEN CRITICAL DURING YOU DIMES TIMES MUCH COVID WHERE WE'RE CAN ACTIVATE THOSE PARTNERSHIPS BECAUSE IT'S BEEN A LONG-STANDING PART OF OUR PRACTICE. MONICA AND HER TEAMS HAVE CONTINUED TO NEONATAL WITH THESE PARTNERS SO THAT WE CAN REALLY LEVERAGE THEIR ACCESS TO FAMILIES AND GET FEEDBACK FROM THEM IN OUR PROCESS. IS. >> WE SHIFTED NOW HAD TO COMMITMENT FOUR AND CLOSE WITH A DISCUSSION OF EXPANDING OPPORTUNITY, IN PARTICULAR, WE'RE GOING TO BE FOCUSED ON BUILDING BPS AND SOME OF OUR CAPITAL PLAN INFORMATION FOR TODAY. THE FIRST THING I JUST WANT TO NOTE AS WE COME BEFORE YOU WITH A FRAMEWORK AROUND BPS AND THE DIFFERENT CATEGORIES OF PROJECTS THAT WILL BE KERD. THE FIRST IS NEW BUILDS AND

EXPANSIONS.

THESE ARE THE MAJOR PROJECTS THAT INCLUDE BOSTON ARTS ACADEMY. WHICH AS YOU KNOW WOULD TEAR DOWN COMPLETELY REBUILT NEW PROGRAMS. NEW BUILDING THAT WE'RE BUILDING IN PHENOL WAY. THE CARTER SCHOOL, WHICH AGAIN WILL BE A BRAND-NEW BUILDING BUT IT ALSO INCLUDES SCHOOLS LIKE, THE ELLIOT SCHOOL, WHICH WAS AN EXPANSION AND A RENOVATION. THAT PROJECT IS NOW COMPLETE. NEW BILLS INCLUDE SOME OF THE PROGRAM PLANNING CHAVEZ A TOPIC OF DISCUSSION AROUND WHAT IS THE FUTURE OF THE JACKSON MAN AND THE HORSEMAN, WHERE WILL THEY BE LOCATED AND WHAT WILL THOSE BUILDINGS HAVE. WE ARE ALSO EXCITED TO BE MAKING PROGRESS IN THE DESIGN PHASE AND THE UPPER SCHOOL IN CHINATOWN. THE NEXT CATEGORY IS REAL ESTATE MANAGEMENT. THAT IS THE ACQUISITION AND DISPOSAL OF PROPERTIES. THERE'S NO CURRENT PLAN IN FY21 SO WE WILL BE INTERESTED TO SEE WHAT THE REAL ESTATE MARKET LOOK LIKE AS A RESULT OF COVID AND THE LAST THREE CATEGORIES ARE **RENOVATION RECONFIGURATIONS.** THIS IS WHERE WE ARE CHANGING GRADE SPANS. THIS IS WHERE WE'RE MAKING MAJOR IMPROVEMENTS TO EXPANDING PROGRAMS WITH SPECIFIC SCHOOLS. DISTRICT-WIDE INVESTMENTS ARE THOSE INVESTMENTS WE'RE MAKING NOT JUST BASIC UPKEEP. THIS IS ABOUT IMPROVING THE SCHOOL QUALITY. THE FOCUS THIS YEAR IS ON **UPGRADING OUR -- THESE ARE** PROJECTS THAT WE'RE GETTING **READY TO START WITH THE** GOVERNOR'S ANNOUNCEMENT FOR THE CONSTRUCTION PROJECT CAN START AND BEGIN LOOKING AT MAKING EVEN MORE PROGRESS THIS SUMMER THAN

WE ARE ORIGINALLY PLANNED. DRAINGTS DRINKING WATER UPGRADE, ENTRYWAY UPGRADES, WE TALKED A

LOT ABOUT MAKING THESE JOYFUL LEARNING ENVIRONMENTS AND WELCOMING SCHOOLS. WE KNOW THAT IT STARTS WITH A WELCOMING ENTRYWAY. AND SOME OF OUR PROJECTS THAT HAVE BEEN LONG STANDING AND CONTINUE TO MAKE MAJOR IMPROVEMENTS, TECHNOLOGY SYSTEM IMPROVEMENTS, KITCHEN UPGRADES AT ALL OF OUR SCHOOLS AND SCHOOL YARD IMPROVEMENT. AND THE FINAL CATEGORY WHICH **DOES INCLUDE 45 MILLION IN** INVESTMENTS ON EXPENDITURES FOR FY21 IS WHAT SORT OF THE HEAT AND BOTH OF CAPITAL IMPROVEMENT. IT'S THE THINGS THAT ARE NOT NECESSARILY EXCITING BUT NECESSARY TO MAKE SURE THAT WE MAINTAIN OUR EXISTING INFRASTRUCTURE AND ON MAKING A STRONG INVESTMENT IN OUR SCHOOL. 0 YOU DON'T WANT HIGHLIGHT AGAIN ON THE OPERATING SIDE -- AND EDID TALK ABOUT THIS THIS MORNING BUT PART OF OUR GOAL RAISE THE BAR ON QUALITY LEARNING ENVIRONMENTS IS **INVESTING IN 25 NEW CUSTODIAL** POSITIONS TO BE ABLE TO PROVIDE A CLEANER BUDGET, A CLEANER SCHOOL ENVIRONMENT. THAT IS GOING TO BE SUPER CRITICAL WHEN WE GET BACK AND THINK ABOUT A COVID RESPONSE. AND IT IS A COMPETENT MEANT OF THIS OPERATING SIDE INVESTMENT AROUND CLEANLINESS AND UPKEEP THAT COPS WITH A REAL ESTATE INVESTMENT AND CAPITAL AFFAIRS AND CONTINUING TO IMPROVE THE BUILDING STOCK THROUGHOUT THE CITY THAT IS MAKING IT SO THAT WE CAN BE AT A PLACE WHERE OUR BUILD REHABILITATION A POINT OF PLAYED AND OUR STUDENTS HAVE ACCESS TO THE LATEST TECHNOLOGY FOR LEARNING NO, THE LATEST SCHOOL LEARNING ENVIRONMENTS THAT WE KNOW ARE CRITICAL AND IMPACT. WHAT WE WANT TO ENSURE IS THAT BOTH PLACES VOID A HIGH-QUALITY LEARNING EXPERIENCE AND THAT THE DISTRICT SHIFT IN POLICY AND CONFIGURATION IS NOT I'M GOING TO DISPROPORTIONATELY HARM A DISPROOP GROUP AT EITHER SCHOOL. >> SO WITH THAT I WILL END BY

NOTING A NUMBER OF RESOURCES ARE AVAILABLE ONLINE.

WHAT WE TALKED ABOUT THIS MORNING IS THAT WE REALLY HAVE TOO MUCH VARIABILITY ACROSS OUR SCHOOLS. IT'S VERY STARK IN TERMS OF OUR SCHOOL FACILITIES AND WE NEED TO MAKE CONSISTENT IMPROVEMENT ACROSS OUR BUILDING. IT'S APPARENT IN OUR ENGAGEMENT, AND INCONSISTENT ENGAGEMENT ACROSS OUR SCHOOL.

OUR JOB IS TO ENSURE THAT WE'RE BOTH RAISING EXPECTATIONS AND INCREASING SUPPORT TO MAKE SURE OF THAT.

SO WHAT WE'RE DOING IS MAYBE MAKING SURE WE'RE PROVIDING THE ASSISTANCE, THE INVESTMENT IN THE SCHOOLS THEN PROVIDING COACHING AND FEED BACKING ALONG THE WITH A TOY DEPUTY ON ON TO THEIR STRATEGY.

WITH THAT I THINK WE HAVE A FEW MORE HEARINGS.

RESILIENCES AND WE ARE RENOVATING OR REBUILDING ANY OF OUR SCHOOLS. ONE OF THE THINGS THAT'S COME UP OVER THE LAST FEW YEARS IS THE LACK OF A REALLY STRICT OR EVEN NOT SO STRICT TIME LINE. I'D REALLY LOVE TO SEE A TIMELINE OF WHAT THE BPS LOOKS LIKE IN THE NEXT COUPLE OF YEARS AND THEN ALSO WHAT THE NEXT **RENDITION OF BPS.** SO NOT NECESSARILY IN PHASE 2 AND THOSE CAME UP IN AN OVERVIEW OR CAPITAL HEARING. AND THE MONIES WILL COME FROM TO RENOVATE AND REBUILD OUR SCHOOLS. WHAT IS THE TIMELINE ON THE CURRENT BUILD BPS PLAN AND WHAT IS NEXT FOR BUILD BPS? >> I WILL SAY THEN IN A LITTLE **REVERSE ORDER AS YOU MAY KNOW** ONE OF THE SECRETS WE JUST **RECENTLY JOINED THE BPS TIME IS** McLAUGHLIN WHO WAS AT THE DEPARTMENT AT THE CITY AND WE'RE VERY LUCKY TO LEVERAGE HIS EXPERTISE. HE AND I HAVE BEEN IN A LOT OF CONVERSATIONS RECENTLY ABOUT THE WAY TO DO FACILITY ASSESSMENT IS NOT A SINGLE MAJOR AUDIT. WE HAD TO DO THAT WITH BUILD BPS BECAUSE WE HAD TO LET OUR SYSTEMS ATROPHY FOR SO LONG AND THIS ADMINISTRATION CAME IN AND PRIORITIZED THAT DATA GATHERING. ANY TIME FELL YOU THE INDEX OF WHERE THE BUILDINGS ARE SO I'M EXCITED ABOUT THAT: IN TERMS OF THE CLARITY OF THE PROCESS --WHAT MAKES DIFFERENT FOR US TO GIVE FIRM ANSWERS ON THAT AND WHERE WE'RE AT IN THE LEARNING PROCESS, SO MANY DIFFERENT VERSIONS OF WHAT CAN HAPPEN. AND THERE'S A PLACE WHERE THERE ARE ONLY A FEW OPTIONS THAT WE ARE CONSIDERING IN TERMS OF WHAT HAPPENS WITH THAT FACILITY. BUT THEY NEED TO DO LONG ENGAGEMENT BEFORE WE COME OUT AND SAY HERE IS WHAT IS GOING TO HAPPEN AT THIS PROPERTY. A LITTLING OUT A 10 YEAR PLAN MEANS THAT WE HAVE TO COME OUT AND BE MORE DESCRIPTIVE AND FELL TELL THEM THIS IS WHAT WE'RE USING, THESE ARE THE CHANGES THAT ARE HAPPENING TO OUR SCHOOLS. AND THE COMMUNITY IS NOT HE AS OPEN TO THAT. AND I WILL BE LOOKING FORWARD TO THE FEEDBACK WITH THE DO YOU HAVE ANY REASON TO BELIEVE AS FAR AS HOW TO BALANCE PARENT, IN EFFECT, ENGAGEMENT, COMMUNITY ENGAGEMENT, AND LAYOFF UNCERTAINTY AROUND WHAT THE PLANS ARE. THE SUPERINTENDENT CERTAINLY COULD HAVE BEEN MORE CLEAR WITH THE TIMELINE AND THE NEED TO FADE OUT OUR STAND ALONE MIDDLE SCHOOL: SHE SAID WE NEED TO BE MORE AGGRESSIVE, BECAUSE FAMILIES NEED CERTAINTY IN KNOWING WHAT IS HAPPENING WITH THEIR SCHOOLS. AND OUTLINE OF OUR PRIORITIES RIGHT NOW ARE SOLIDIFYING PATHWAY SO HE IS EVERY FAMILY KNOWS THEY HAVE ONE TRANSITION K-12. WHETHER IT'S K-6 OR K-8 OR 9 TO 12 AND THEN OUR SECOND **RESPONSIBILITY IS TO RULE OUT** EXACTLY WHAT YOU'RE TALKING ABOUT. A 10, 20, 30 YEAR PLAN TO SAY. EITHER WE JUST BUILD THE DEARBORN.

WHEN ARE WE PLANNING TO DO A MAKE RENOVATION TO THAT AND SCHEDULE IT OUT BECAUSE WE KNOW THESE THINGS ARE SLOW MOVING BUT VERY PREDICTABLE. OUR CAPITAL PLAN SOMETHING THAT COULD BE PUT ON A SCHEDULE. AND OBVIOUSLY TWEAKED FROM YEAR TO YEAR, BUT BRINGING THAT CLARITY FROM THE YEAR BEFORE. >> THAT'S IT FOR ME, MADAM WHAT I REMEMBER. I SHOULD BE PRETTY CLOSE. >> YOU'RE PRETTY CLOSE. >> THANK YOU VERY MUCH. NEXT UP IS COUNSEL PRESIDENT JANEY AND -->> THAT MUCH. Y TO START BY REALLY HIGHLIGHTING THE GOOD WORK OF MONICA ROBERTS, COMING FROM A GOOD FOUNDATION AND JUST IN IF HE DID OF HOW WE ENGAGE PARENTS IN THIS WORK AND THERE WERE BIG SHOES TO FILL, AND MONICA HAS DONE ENORMOUS WORK AND SHE'S BEEN STANDARD ASKED TO DO IT BY CLICKING ON SITES AND SO WIN QUESTION IS, YOU KNOW, WHAT HAS THAT IMPACT BEEN BUT THAT IS LESS IMPORTANT THAN FOLLOWING UP ON THE ISSUE THAT MY COLLEAGUES HE -- I THINK COUNSEL VERSE RAIDS THE CONCERN AND I SHARE THE CONCERN AROUND SEATS. THOSE ARE STRONG CONCERNS. THIS WAS AN ASSIGNMENT PLAN THAT WAS ADOPTED IN 20/14 AFTER A VERY ROCK PROCESS THAT I WAS VERY ACTIVELY INVOLVED IN AS WELL AS A NUMBER OF PARENTS ACROSS OUR SCHOOLS. AND WE ALL KNEW PRIOR TO THE SCHOOL COMMITTEE VOTE WHAT WOULD HAPPEN. WE -- PART OF THAT PROCESS WAS SUPPOSED TO INCLUDE ANNUAL **REVIEW WHICH DIDN'T HAPPEN.** FINALLY FAST-FORWARD AND THE SBARRE EVALUATION DID COME OUT AND SHOWED MOST NEIGHBORHOODS HAD FEWER THAT HE KNOW 2 TEARS 1 SCHOOLS ON AVERAGE AND PARTICULARLY FOR 6th GRADERS,

OVER 33 PERCENT LIVED IN ROXBURY AND OVER HALF IN -- AND RECEIVED ZERO TEARS 1 SCHOOLS. SO THE INEQUITIES ARE CLEAR. THE BARRE REPORT SHOWS AND THE QUESTION IS ME IS WHEN ARE WE GOING TO MOVE TOWARD SEATS INSTEAD OF SCHOOLS. AND IT'S PARTICULARLY IMPORTANT GIVEN THE UNEVENNESS THAT WE HAVE HAD IN OUR SYSTEM. WE KNOW THAT WE HAVE A NUMBER OF -- WE KNOW WE HAVE LARGER K-8 SCHOOLS K AND SO THERE ARE ISSUES AROUND TRANSITION BUT THERE'S ALSO ISSUE JUST AROUND OUALITY. SO PEOPLE HAVE BEEN BEATING THIS DRUM FOR YEARS. AND I THINK AT THIS POINT I'D JUST LIKE A CLEAR -- ARE WE GOING TO GET TO THE POINT WE LOOK AT -->> I THINK WE SHOULD LOOK AT THAT AS WE BEGIN TO THINK ABOUT HOW WE SHOULD REVOICE OR REFORM THE HOME BASED ASSIGNMENT SYSTEM. LIKE I SAID, EARLIER, I THINK IT'S GOING TO BE TIED INTO OUR SEI SEATS AND IT'S GOING TO BE TIED INTO OUR SPECIALIATION SEATS AND THE WAY THAT WE PROGRAM FOR THAT AND WE ARE NOW JUST BEGINNING TO STUDY THOSE PIECES AND ALL OF THAT WILL BE PART OF IT. AND I WILL PUT THIS ON THE LIST THE THINGS TO LOOK AT AND TO STUDY. I ALSO HAVE VOICED MY CONCERN WITH THE WAY THAT WE CATEGORIZE HE OUALITY FROM OUR SCHOOLS. AND WE HAVE AN OVER EMPHASIZE ON STANDARDIZED TESTING AND WE HAVE A HEAVYWEIGHTING STANDARDIZED TESTING IN THE QUALITY OF OUR --IN THE DESIGNATE QUALITY OF OUR SCHOOLS. WHICH MAKES IT HARD, WHEN YOU ASSIGN A SCHOOL ABCD THE F SCHOOL OR 12, 3, 4 OR SOME TYPE OF RATING BUT WHAT WU END YOU UP DOING. WHEN THE SCHOOLS ARE RATED LOW, THEY'RE VERY HARD

TO --

>> I CAN APPRECIATE THAT QUALITY IS DEFINED DIFFERENTLY BY DIFFERENT FOLKS AND HOW WE RATE QUALITY DOES MATTER. BUT I JUST WANT TO REMIND US WE HAVE BEEN HAVING THIS **CONVERSATION -- I APPRECIATE** THAT IT'S NEW FOR SOME BUT FOR MANY OF US THIS CONVERSATION PREDATES THE POLICY THAT WAS ADOPTED SIX FULL YEARS AGO. OUR STUDENTS DON'T HAVE SIX **OPPORTUNITIES TO GO TO 6th** GRADE. SO FOR ME, THERE'S A REAL SENSE OF URGENCY. BECAUSE MANY OF US HAVE KNOWN FOR YEARS THAT WE NEED TO BE LOOKING AT SEATS AND NOT SCHOOLS. SO THERE'S A REAL SENSE OF URGE SEIZE BECAUSE IT CONTINUANCES TO EXACERBATE THE INIQUITIES AND WE'RE NOT GOING TO CLOSE THE SEE THE ACHIEVEMENT GAP. WITH THE NUMBER OF UP RAISING THE ISSUE AND WHAT YEAR'S HEARING FROM ME IS A DEEP SENSE OF YOU DO URGENCY BECAUSE WE HAVE BEEN AT IT FOR A WHILE NOW. AND I THINK IT'S TIME TO DO SOMETHING DIFFERENT. THANK YOU. >> AND I THINK THAT'S REALLY IT FOR ME DURING THIS ROUND? >> I REALLY KIND OF WANTED TO EMPHASIZE THIS POINT BECAUSE IT REALLY IS THAT KEY WHEN WE WERE TALKING ABOUT QUALITY, WHO HAS ACCESS AND WHO DOESN'T. >> AGAIN I WANT TO COMMEND THE WORK OF THE TEAM. I KNOW EL THIS AREA IS SOMETHING THAT WE TALK ABOUT. I KNOW THERE'S INVESTMENT IN THE -- I THINK IT'S THE TRANSFORMATIONAL SCHOOLS AROUND THE FAMILY BASE POSITION, COORDINATOR POSITION, WHICH IS

REALLY EXCITING THIS IS KEY TO THE WORK AND I HAVE BEEN A BIG FAN OF AGAIN DR. ROBERTS AND I THINK IT IS KEY TO MOVING FORWARD AND I APPRECIATE THE EFFORTS UNDER WAY BUT I CAN'T EMPHASIZE ENOUGH THE IMPORTANCE OF LOOKING AT THE SEAT WHEN IT COMES TAKE ASSIGNMENT. >> I WOULD SAY ONE THING ON THE BPS.

THERE'S A LOT OF CONCERN THAT MADISON WASN'T INCLUDED WAY BACK WHEN SO SO I WANT TO CONTINUE TO LIFT UP MADISON AND THE NEED FOR CAPITAL IMPROVEMENT. I THINK THE GAVEL IS UP SO I JUST WANT TO LIFT THAT UP AND I KNOW WE HAVE BEEN TALKING AUNT IT EARLIER TODAY, BUT THE MORE THAT WE AND INVEST IN THAT SCHOOL AND I JUST HAVE CONCERNS ABOUT HOW WE DO THAT IN THE AGE OF COVID AND MEETING SWING STATES.

MANY OF THESE STEUPTSZ LIKE OUR STUDENTS WITH DISABILITIESESE YOU KNOW, ARE THEY REALLY GETTING -- IT'S HARD TO DELIVER HANDS ON LEARNING IN A VO-TECH SCHOOL THROUGH REMOTE CLASSROOM SETTING SO I WORRY ABOUT THAT AND I WANT TO LIFT THAT UP. THANK YOU.

I SEE THE GAVEL.

I'M DONE.

>> I KNOW THE REST OF MY COLLEAGUES WHO WILL FOLLOW ME WILL BRING IT ON HOME. SO --REALLY THIS JUST POPPED UP AND I SEE ED IS READY TO GO. >> THANK YOU MADAM CHAIR. >> THANK YOU SO MUCH. NEXT IS JOURNAL ED FLYNN TO BE FOLLOWED BY COUNSELOR MEJIA AT LARGE AND COUNSELOR FLYNN YOU HAVE THE FLOOR. >> THANK YOU COUNSELOR BOK AND THANK YOU SUPERINTENDENT AND YOUR TEAM FOR THE GREAT WORK YOU'RE DOING IN THE CITY. I KNOW YOU MENTIONED THE McKINLEY SCHOOL IN THE SOUTH BEND. CAN YOU TELL ME WHAT YOU'RE THINKING IN TERMS OF SHORT-TERM AND LONG-TERM PLANS AS IT **RELATES TO INFRASTRUCTURE**

IMPROVEMENTS, FACILITIES IMPROVEMENTS? CERTAINLY IT NEEDS SOME WORK BUT I JUST WANTED TO SEE WHAT YOUR THOUGHTS MIGHT BE ON THE McKINLEY SCHOOL. >> YES. THANK YOU FOR THAT. AND ALSO JUST THE CLASSROOMS AND THE SPACES THAT THEY ICE. YOU KNOW IN THE BUILDING BUILDING, AND THE ATTENTION THOSE IS REALLY, REALLY IMPORTANT, AND HAVING ACCESS TO GYMNASIUM AND PING ARTS AND VISUAL ARTS AND OPPORTUNITIES FORECAREER PATHWAYS AND **OPPORTUNITIES, I THINK IT'S IT'S** A POSSIBILITY AS WELL. IS THERE A -- I KNOW THE PLAN FOR THE THERAPEUTIC **REHABILITATION POOL BUT COULD**

THAT TYPE OF A PROJECT BE IN JEOPARDY BECAUSE OF THE ECONOMY OR STATE FINDING KNOWING THAT WE ARE EXPECTED TO GET SOME STATE FUNDING FOR IT?

OR A PERCENTAGE OF IT ANYWAY? HE.

>> BUT IT'S A DIFFERENT PART OF FUNDING SO I WILL LET NATE TALK ABOUT THE CAPITAL IMPROVEMENT SIDE OF THINGS AND THE CAPITAL BUCKET BUDGET.

>> AND THE REASON I WANTED TO --I APOLOGIZE FOR CUTTING YOU OFF. BUT IF THERE'S ANYTHING THAT THE COUNSEL CAN DO ESPECIALLY DURING THIS BUDGET PERIOD, YOU KNOW, WE ALL SHOULD BE INVESTING AND ADVOCATING FOR THE CARTER SCHOOL WITH THE TREMENDOUS WORK THEY DO.

THAT'S THE REASON I'M BRING IT UP.

I WANT TO MAYBE SURE IF THERE WERE ALREADY HOLES WE COULD WORK TOGETHER AS A TEAM.

>> YEAH, I DON'T WANT TO GET OUT OF MY TEAM TOO MUCH IN TERMS OF SPEAKING ON THE OVERALL CITY FINANCES.

I DO NOTE MCEA FUNDING IS PRIMARILY -- NOT PRIMARILY, BUT EXECUTIVES THROUGH SALES TAX AND WILL LIKELY BE AFFECTED BY ANY ECONOMIC DOWN TURN. WE LOOK TO OUR PARTNERS 0 FOR AND REALLY SPEAK TO THEM MORE CLEARLY. I JUST DON'T WANT TO SPEAK TOO MUCH ABOUT THAT BECAUSE I RELY ON THEM SO HEAVILY ON THE CONSENT AGENDA CAPITAL BUDGET BUT WE HAVE NOT HAD ANY APPROXIMATE INDICATION ON THAT. THE OTHER ISSUE I WANTED TO HIGHLIGHT IS THE PERKINS SCHOOL IN SOUTH BOSTON. IT'S AN EXCELLENT SCHOOL. HE AS YOU KNOW IT'S LOCATED IN THE MIDDLE OF OAK COLONY, BHA, AND IT'S ALSO -- THERE ON THE **OPPOSITE SIDE MARY ELLEN** McCARY AND ON THE WEST SIDE IS WEST BROADWAY AND THE ISSUE I HAVE WITH PERKINS IS A LOT OF KIDS ARE WALKING TO SCHOOL AND THE STREETS IN AND AROUND PERKINS, ESPECIALLY AROUND THE **ROTARY CAN BE DANGEROUS AT** TIMES, SO LET'S SEE IF I CAN WORK WITH YOU OVER THE SUMMER WITH TRANSPORTATION TO SEE IF WE CAN COME UP WITH A BETTER WALKING PLAN OAR APPROXIMATE **BETTER -- MAKING INFER** STRUCTURES IMPROVEMENT. HOURS I THINK THAT'S CRITICAL YOU SO THAT'S SOMETHING I WOULD LIKE TO WORK ON AND GET YOUR HELP ON THAT. >> I KNOW WE HAVE A PHYSICAL PROGRAM. AND WE WORK CLOSELY

PROGRAM, AND WE WORK CLOSELY WITH THE CITY PARTNERS AND CHANGES TO MAKE SIDEWALKS MORE ACCEPTABLE AND THOSE KINDS OF THINGS SO WE CAN MAKE SURE THAT PART OF THE CONVERSATION AS WELL.

>> MY FINAL POINT; I KNOW IT NEEDS DIFFICULT ECONOMIC TIMES BUT ONE THING I'M ALWAYS CONCERNED ARREST ADVOCACYING FOR IS OUR SCHOOLS THAT ARE LOCATED DIRECTLY INSIDE BHA DEVELOPMENTS. IF WE CAN CONTINUE TO PARTNER WITH BEFORE. HA AND BCYF AND OTHERS JUST TO GIVE OUR STUDENTS IN THE WHA DEVELOPMENT AS MUCH SUPPORT TO THEM AS THEIR FAMILIES AS WE CAN, CRUDING IN THE SUMMERTIME, SO MAYBE WE CAN TALK OFFLINE OVER THE NEXT WEEK OR SO, BUT I JUST WANTED TO PUT THAT ON YOUR RADAR AS WILL. >> AGAIN THANK YOU SUPERINTENDENT AND THANK YOU COUNSELOR BOK. >> THANK YOU SO MUCH COUNCILOR FLYNN AND I KNOW I HAVE BEEN TRACKING A LITTLE BIT, I THINK THE NFCA MADE A STATEMENT BACK IN EARLIER THIS MONTH SAYING THEIR CASH POSITION WAS REALLY STRONG AND THEY THOUGHT THAT WOULD PUT THEM IN A DECENT PLACE FOR FY20-21 BUT THE OVERALL **REVENUES ARE OBVIOUSLY TUMBLING RIGHT NOW SO MY IMPRESSION. SO I WANTED TO JUST QUICKLY GET BACK ON SOMETHING THAT HAS COME TO THE COUNSEL, WHEN WE WERE TAKING ABOUT THE ASSIGNMENT PLAN AND JUST THE FACT THAT I FEEL HAVING THE EDUCATION SPACE AND HAVING GRADUATED FROM THE BOSTON PLOOLINGS AND HAVING SURVIVED THE BUSING AREA THAT I'M SURE SEARCH FAMILIAR WITH, IT FEELS LIKE 40 SOMETHING YEARS LATER WE'RE STILL HAVING THE SAME CONVERSATIONAM AND THERE'S ALL OF THESE APPROXIMATE ALGORITHMS AND ALL OF THESE THINGS WE HAVE DONE TO ASSESS QUALITY AND GIVE PEOPLE YOU ACCESS TO QUALITY SCHOOLS BUT OFTENTIMES I FEEL LIKE IT'S -- IF YOU'RE A MILE AWAY FROM THE SCHOOL YOU WILL NOT GET INTO THE SCHOOL BECAUSE

SO YOU KNOW IT FEELS LIKE TO ME, THAT THE CHOICE OF SOME -- THE EGG BASKET IS ALWAYS STACKED UHM TO ENSURE THAT BLACK AND BROWN STUDENTS STAY IN BLACK AND BROWN NEIGHBORHOODS AND AREAS RIGHT? AND THAT'S JUST -- I'M MAKING THAT ASSUMPTIONTION BECAUSE THAT'S JUST WHAT IT SEEMS LIKE TO ME IN TERMS OF MOTIVATING THE CHOICE FOR AN AREA AND I THINK WE HAVE AN AMAZING OPPORTUNITY, ESPECIALLY WITH A LOT OF THE WORK ON THE COMMITTEE THAT IS REALLY EXCITING IN TERMS OF MAKING THIS EQUITABLE. AND I SHARE THE FRUSTRATION THAT WE NEED -- THIS BASE SIX YEAR AGO THAT WE WENT THROUGH THE WHOLE PROCESS AND YET WE ARE HERE TRYING TO GET ACCESS TO QUALITY SCHOOLS. IT AND SHOULDN'T SHOULDN'T JUST BE THE TRANSFORMATIONAL SCHOOLS OR THE EXCELLENCE FOR ALL SCHOOLS THAT IS IT THE EAR MARKET. AND I THINK THERE'S A LOT OF LAYERS OF THAT IN ORDER TO MAKE BOTH THINGS HAPPEN I THINK A LOT OF IT ENDS AND BEGINS WITH THE LEVEL ENGAGEMENT FOR FAMILIES AND THE THAT FAMILY PLAYED IN THAT PROCESS, SO I'M REALLY GRATEFUL TO DR. K FOR HER 0 WORK AND VOICE AND THAT IS REALLY KEY TO THIS WORK. SO NOW THAT I GOT OFF MY LITTLE SOAPBOX, I'M GOING TO ASK MY QUESTION. BUT I'M CONSUMER I COULDN'T SAY,

WHAT OPPORTUNITIES OF DO WE HAVE TO LET STUDENTS AND PARENTS LEAD THE CONVERSATION IN TERMS OF LETTING THEM SUPPORT THE RESOURCES THEY NEED? WHAT INFRASTRUCTURE BESIDES SURVEYS AND AFTER WE AND DEEPER INTO THE ENGAGEMENT, LET'S GOES BACK TO THE QUESTION ON QUALITY AND HOW WE DEFINE QUALITY. WHAT ROLE ARE WE CREATING FOR PARENTS AND STUDENTS TO REALLY DIVINE THAT THAT QUALITY LOOK LIKE IS.

>> SO THERE WERE A NUMBER OF THINGS COUNSELOR ON THE ACTUAL PENTAGON THAT TALK TALK TO THIS XEES THAT IS REALLY ABOUT CITYWIDE PARENT GROUP THAT WE'RE ENGAGING W WE'RE ENGAGING WITH PARENT COUNSELORS AND THERE'S TRAINING FOR THOSE GROUPS. WE'RE ENGAGING WITH THE YOUTH COUNSEL, THE CABINET, TO WORK WITH THEM.

SURVEYS ARE A VERY IMPORTANT PIECE FOR US TO GET A BROADER INPUT AROUND HOW PARENTS ARE FEELING, HOW WE JUST DID ONE -->> MY UNDERSTANDING IN TERMS OF THE FORMAL PROCESSES AND THE FORMAL VOICES THAT YOU HAVE, I'M CURIOUS THOUGH IN TERMS OF THE NONTRADITIONAL VOICES. PARENT WHOSE ARE NOT PART OF THE PARENT CONFERENCE, STUDENTS WOULD ARE NOT PART OF THE -- I'M SPEAKING ABOUT THOSE HARDEST TO REACH, AND THOSE MOST -- THOSE LIKELY TO BE ENGAGED ARE THE ONES THAT PROBABLY WOULD PROVIDE ADDITIONAL INSIGHTS. I'M JUST CURIOUS ABOUT WHAT ARE WE DOING TO ENGAGE THOSE FOLKS. >> YEAH. SO WE HAVE BEEN DOING THOSE MEETINGS IN COMMUNITIES WE'RE

MEETINGS IN COMMUNITIES WE'RE INITIATING NEXT YEAR SUPERINTENDENTS MEETING WITH COMMUNITIES AND COMMUNITY AREAS AND WORKING WITH OUR NONPROPERTY COMMUNITY PARTNERS TO HELP US GET THAT WORD OUT. ALSO MARKETING TO COMMUNITIES OF COLOR AND THEIR MEDIA OUTLETS AS WELL.

I WILL LET MONICA TALK A LITTLE BIT ABOUT HOW THE FAITH FAITH-BASED COMMUNITY AND OTHERS ADD TO THIS.

>> SO I THINK ONE OF THE THINGS AS -- ONE OF THE THINGS THAT WE DID IS LEVERAGE OUR COMMUNITY BASED ORGANIZATIONS PARTICULARLY THOSE WORKING WITH ETHNIC AND LINGUISTIC GROUPS TO INCREASE OUR REACH AND I WORK WITH UNDOCUMENTED FAMILIES. SO WE KNOW THERE'S A LEVEL OF KISS TRUST WITH THE DISTRICT THAT WE'RE WORKING TO BRIDGE AND PART OF THAT BRIDGING IS WORKING THE ONLY COMMUNITY PARTNERS. WE HAVE THEM HAD THE TABLE ONCE THIS YEAR FOR THEIR PERSPECTIVE OF WHAT WE NEED TO BE WORKING ON BECAUSE THEY'RE WORKING ON IT NOW WITH FAMILIES.

AND ALSO BRINGING FAMILIES TO THE TABLE.

SO I THINK IN ALL OF OUR EFFORTS WITH EACH VARIOUS MEETING, WE GENERALLY WOULD HAVE 80 TO A HUNDRED FOLKS THAT CAME OF CAME OUT AND WE HAD PARTNERS AT THE TABLE THAT HE BROUGHT US TRUST THERE.

WE'RE ALSO LOOKING TO DO A LOT MORE OUTDOOR REACH USING I TRADITIONAL HE MECHANISMS AND THINKING ABOUT -- WE A LOT OF **OUR CONVERSATIONS HE WITH FOCUS** SAID WE'RE NOT USING BPS MEDIA. WE JUST DID A RADIO TO DO WORK AND WE'RE DOING MORE CONNECTION WITH THOSE SORT OF ORGANIZATIONS THAT ARE NOT -- THAT ARE TYPICALLY KEL PLACES TO GET DATA BECAUSE WE DON'T HAVE LEFF WEDGE WITH THEM AS WELL. >> I'M CURIOUS ABOUT SOME OF THE WORK --- I'M WONDERING WHETHER OR NOT THERE'S ANY OPPORTUNITY TO HAVE A BUDGET INCREASE IN PROVIDING PROFESSIONAL DEVELOPMENT TO PARENTS SO THAT THEY CAN BE MORE ENGAGED. I KNOW WE DO HAVE -- I'M JUST

CURIOUS, ARE THERE OPPORTUNITIES TO STIPEND PARENTS TO CREATE MAYBE -- TO MAYBE EMPLOYMENT **OPPORTUNITIES FOR PARENTS WITHIN** BPS? >> TO TWO THINGS. WE ACTUALLY DO SUPPORT WITH SCHOOL SITES AND WE HAVE **OBSERVATIONS AND PROVIDE SUPPORT** AROUND TREATMENT AND THE ELECTION PROCESS. WE WORK WITH THE OFFICE ON HUMAN CAPITAL. THAT WAS A COMMUNITY SCARE PIPELINE AND COMMUNITY TO TEACHER PIPELINE THAT WE WERE LOOKING AT LAUNCHING SO MANY OF OUR FAMILIES WERE IN THE PRINE AND ABLE TO JOIN AS EMPLOYEES AFTER THEY LEAVE THAT PROGRAM SO THEY'RE LOOKING -- I THINK IT'S NOT BEEN IN OPERATION FOR ABOUT A YEAR OR TWO AND SO WE'RE LOOKING DO REPORT WITH THAT. >> AND I KNOW THAT MY TIME IS UP. WE MUST BE ON ROUND TWO. THANK YOU. >> THANK YOU COUNCILOR MEJIA. NEXT UP IS COUNCILOR ARROYO. >> CAN YOU HEAR ME? >> I CAN HEAR YOU GREAT. PERFECT. >> LET ME GO THROUGH MY OUESTIONS. ONE SECOND. HE THE FIRST ONE IS, I KNOW TABLESPOON IS CHANGING THE GRADE STRUCTURE K-5 TO K-6. >> DID WE LOSE YOU OR DID YOU JUST END ON THAT QUESTION. >> I'M BASICALLY ASKING EACH **QUESTION**. >> AWESOME. 0 THEY DID PROVIDE SOME MATERIALS AT THE BEGINNING ABOUT THE FACT IS STILL ON. HOW MANY SCHOOLS IS IT. NATE? >> TYPICALLY SCHOOLS WOULD BE ADDING SIX GRADES FOR THIS PHARMACEUTICAL WITH THE PLAN TO YOU FIGURE OUT OVER THE NEXT FEW YEARS. >> AND YOU MIGHT HAVE ACTUALLY

ANSWERED THIS BUT WILL WILL BE A TIMELINE IF YOU DO NOT GO TRUE GLPS WE HAVE A BUDGET FOR CASH FLOW THAT WE WILL BE WORKING WITH OBM TO UPDATE YOU ON. AS **RESPONSE TO THIS HEARING.** IN TERMS OF THE HYME TIMELINE, I THINK WE'RE IN A LITTLE BIT OF A -- WE'RE TRYING TO FIGURE OUT THE RIGHT TIME TO ENGAGE AND WHEN WE HAVE A SPECIFIC PLAN THAT WANT WE WOULD LIKE TO ROLL IT, I THINK WHEN WE ROLL OUT SPECIFICS GET KNOCKED FOR NOT ENGAGING WITH THE COMMUNITY ON THE HOME PROPOSAL AND JUST COME OUT AND ASK FOR SORT OF **BROAD-BASED FEEDBACK AND WE WILL** SOLIDIFY THE PLANS GOING FORWARD TO CREATE MORE TRANSPARENCY AROUND PARTICULAR FAMILIES. >> AND ON THAT I HAVE HEARD A BUNCH THE ANSWERS OTHER FOLKS HAVE ASKED YOU AND QUESTIONS THAT I WOULD HAVE ASKED, BUT ONE OF THEM FOR ME IS, WHEN WE TALK ABOUT.EXAM SCHOOL IN TERMS OF EXAMINATION METRIC, I'M MORE IN THE PROCESS OF WHAT OTHER CRITERIA ARE WE DISCUSSING FOR ENTRY INTO THOSE SCHOOLS BESIDES EXAM DATE ENTRY, IF AT ALL? >> THE OTHER THING THAT IS IN **CONSIDERATION IS --**>> THE REASON I ASK THAT IS CLEARLY -- PAROCHIAL SCHOOLS AND PRIVATE SCHOOLS HAVE CONVERSATION DUE TO RECENT STUDIES THAT MORE SO IN PLACE AND THEY'RE KIND OF -- ARE THEY GOING TO WAIT THAT OR IS THERE ANY CONVERSATION ABOUT, YOU KNOW, ONE OF THE PROPOSALS THAT'S NOT NEW, MY FATHER WAS ON THE SCHOOL COMMITTEE IN EARLY '90S WAS IDEA OF TAKING SAY THE TOP FIVE. IT'S SIMILAR TO THE UNIVERSITY OF TEXAS SYSTEM WHERE YOU TAKE THE TOP FIVE, 10 PERCENT OF THE SCHOOL AND THEY'RE ELIGIBLE TO GET INTO THE EXAM SCHOOLS AT THE STATE SCHOOLS AND THAT'S HOW THEY DO IT. HAS THERE BEEN ANY DISCUSSION

ABOUT SOMETHING SIMILAR HERE NECESSARILY BUT MAKING SORT OF A PRIORITY.

>> THEY HAVE BEEN LOOKING AT CRITERIA AND THERE HAVE BEEN **RECOMMENDATIONS MADE BY** STAKEHOLDERS OUT IN THE COMMUNITY ABOUT BETTER WAYS TO ATTRACT DIVERSITY IN OUR EXAMS AND ALL OF THAT . . . WHAT I HAVE CURRENTLY DONE WAS MY APPROACH TO EXAM SCHOOLS AT THIS POINT WAS TO CREATE -- YOU KNOW TAKE ONE OF THE RECOMMENDATIONS WHICH IS TO CREATE A FAIR TEST. AND -- THEN TO MAKE SURE OUR CURRICULUM IS ALIGNED AND COHERENT THROUGHOUT THE DISTRICT SO THAT STUDENTS DO BETTER ON THE TEST.

AND THEN EXPANDING OUR ESI EFFORTS.

>> THEY'RE TRYING TO -- THE TEST BY ITSELF WHAT WE DO WITH THE LACK OF DIVERSITY MIRRORS WHAT WE SEE WITH SOCIOECONOMIC ISSUES SO LESS LIKELY TO HAVE PRIORITY PRIVATE TUTORING OR EXAM OR SCHOOLS THAT ARE TAILORMADE TO WORK IN THE PREPARATORY SCHOOLS TO GET INTO OUR EXAM SCHOOL SO WHEN WE ARE TRYING TO COMBAT THAT, I FIGURE -- I SEE IT FROM A RACIAL EQUITY STANDPOINT AND ALSO AN ECONOMIC EQUITY STANDPOINT AND THE QUESTION IS HOW ARE WE MOVING FORWARD IN WAYS THAT ADDRESS HE RACIAL SECRETARY AND WITH SO MANY OF OUR BPS KIDS ON THE LOWER SOCIOECONOMIC STATUS, WHAT ARE WE DOING TO KIND OF ADDRESS THAT AS WELL IN A WAY THAT IS EOUITABLE? IT'S NOT ENOUGH TO HAVE A FAIR TEST AND SAY THE TEST FAIR, BECAUSE, YOU KNOW, IT'S MORE FAIR AS A TEST WITHOUT ACCOUNTING FOR THE OTHER WAYS IN WHICH KIDS WHO HAVE ATTENDED BPS OR KIDS IN MOORE COMMUNITIES DON'T MATCH UP WITH THE **RESOURCES FROM CHILDREN WITH** MORE WEALTHY COMMUNITIES

CHILDREN WHO HAVE BEEN GOING TO PRIVATE SCHOOLS AND CATHOLIC COOLS COOLS AND ALL OF THESE DIFFERENT SCHOOLS THEIR ENTIRE LIFE. SO I GUESS MY CONCERN IS. YOU KNOW, THIS IS A LONG-STANDING ISSUE IF IT DATES BACK TO AT LEAST THE '90S TO MY **RECOLLECTION, PROBABLY BEFORE** THAT, JUST WHAT ARE WE DOING BESIDES WITH TESTINGS AND THE PREPARE STORY STUFF? ARE YOU SAYING SCHOOLS LIKE HARVARD ARE NO LONGER USING DRE'S AND DENCH -- THERE'S A STEP AWAY FROM STANDARDIZED **TESTING FOR ENTRANCE EXAMINATION** AND I WANT TO SEE HOW OUR EXAM SCHOOLS ARE REFLECTING THAT CONSCIOUSNESS THAT'S BEING SHOWN IN UPPER AND HE HAD HIGHER ED WITH STANDARDIZED TESTING AND IT IS NOT NECESSARY PLAY BAROMETER OF STUDENTS' SUCCESS, BOTH FUTURE AND PRESENT. >> SO I'LL JUST ANSWER BRIEFLY, AND I THINK I SAID THIS AT THE EARLIER HEARING AS WELL. THERE ARE SEVERAL THINGS WE'RE DOING SYSTEMICALLY FOR IN ECKS WITHIN THE SYSTEM THAT WOULD NOT ONLY HELP STUDENTS BETTER PREPARE FOR EXAMS BUT HAVE STUDENTS BETTER PREPARED FOR ALL HIGH SCHOOLS AND BETTER PREPARED FOR COLLEGE AND THE **OPPORTUNITIES THAT THEY LEAVE** WITH FOR SCHOOL. AND ONE IS EMPHASIZE ON PRESCHOOL AND THE OTHER IS ON OUR NEW LITERACY CURRICULUM. THE OTHER IS ON THE 33 MOST UNDER PERFORMING SCHOOLS AND OUR HIGH SCHOOL REDESIGN EFFORTS AND THEN CREATING STRONGER PATHWAYS 7-12 FOR OUR SCHOOLS AND THE OTHER IS LOOKING -- JUST PHYSICALLY IN TERMS OF THE EXAM AND THE EXAM SCHOOLS. IS LOOKING AT EXPANDING TUTORING AND **OPPORTUNITIES REMOTELY. WITH THE** EXAM SCHOOL INITIATIVE. EXCELLENCE FOR ALL.

AND THEN THE ADDITION ADDITION OF RIGORACCESS TO TAKING THE TEST ON CAMPUS. AND THEN OF COURSE NOW WITH OUR FAIR TESTS. I THINK THOSE ARE ALL THINGS THAT GET AT THE INEQUALITIES THAT WE ARE SEEING BUT I THINK THE BROADER QUESTION IS IT'S GOING TO TAKE A SYSTEMIC APPROACH AND THERE SHOULD BE MORE OPPORTUNITIES THAN JUST THREE SCHOOLS THAT ARE PERCEIVED IN THE DISTRICT AS RIGOROUS. >> I AGREE WITH THAT. THANK YOU SO MUCH FOR THAT ANSWER. DIFFICULT TO KIND OF PHRASE THAT WITH THE COMPLEXITY I THINK THE ISSUE MERITS THE QUESTION IN THE SETTING. THANK YOU FOR ANSWERING THAT AND **REALLY FOCUSING ON WAYS WE COULD** REALLY MOVE FORWARD. I LOOK FORWARD TO WORKING TOGETHER FOR THOSE KIND OF SOLUTIONS THAT REALLY AFFECT ALL OUR CHILDREN IN THE DISTRICT. SO THANK YOU SO MUCH. >> GREAT. THANK YOU COUNCILOR ARROYO. ALL RIGHT, NEXT UP I'M GOING TO ASK SOME QUESTIONS AND THEN WE'LL GO BACK UP TO THE TOP. SO DOCTOR, YOU MENTIONED MCKINLEY AND COUNCILOR FLYNN ASKED ABOUT THE SOUTH END PIECE OF MICK KIN THREE AND I WANTED TO ASK ABOUT THE FENWAY AND AUDUBON CIRCLE PIECES. SO I MEAN EYE MENTIONED A NUMBER OF TIMES MY DISTRICT REALLY DOESN'T HAVE THE ELEMENTARY SCHOOL OUTSIDE OF THE [INDISCERNIBLE] IN MISSION HIM AND AS WE'VE SEEN A BUNCH MORE HOUSING COME TO THE FENWAY IS A LOT MORE YOUNG FAMILIES THERE [INDISCERNIBLE] IN THAT PART OF THE DISTRICT QUITE ACUTELY. THERE'S A LOT OF INTEREST **BUBBLING UP ABOUT THE QUESTION** OF I THINK EVERYBODY KNOWS THAT THE MCKINLEY BUILDING ON [INDISCERNIBLE] STREET AND AT

THE AUDUBON CIRCLE NEEDS A LOT OF WORK AND SUPPORT AND ESPECIALLY SUPPORT OF THE PROGRAM THAT ARE IN THEM. AND ALSO AT LEAST CERTAINLY FOR THE PETERBERG BUILDING AND I'M LESS SURE ABOUT THE OTHER THAT THOSE PROGRAMS ARE NOT USING THE FULL SPACE. AND BOTH BUILDINGS ARE SURROUNDED BY ANYWHERELY LARGE PARKING LOTS THAT GO LARGELY UNDER UTILIZED. THE ISSUES COME UP ORGANICALLY LIKE COULD WE DO SOMETHING ABOUT THE HOUSING ON PUBLIC ACCESS WHERE YOU BUILD HOUSING ON SOME OF THE PARKING TO SUBSIDIZE A FULL RENOVATION. IS THERE A WAY IN TO GO SOME KIND OF MAJOR FULL RENOVATION TO CREATE THE SPACE IN THE MCKINLEY PROGRAM AND BRINGING ELEMENTARY SCHOOLS BACK TO THE NEIGHBORHOODS. THESE ARE THE QUESTIONS THAT MY DISTRICT IS REALLY ASKING. I THINK I'VE HEARD YOU SAY AGAIN AND AGAIN THE IMPORTANCE OF HAVING SCHOOLS THAT ARE GOOD SCHOOLS IN EVERY NEIGHBORHOOD AND A PIECE OF THAT IS ABOUT MAKING THE SCHOOLS THAT WE HAVE HIGH QUALITY IN EVERY NEIGHBORHOOD. A PIECE OF THAT IS ABOUT HAVING SCHOOLS IN EVERY NEIGHBORHOOD AND IT JUST, IT'S REALLY HARD TO SEE THE KIND OF CHRONIC LIKE CHRONIC DISAPPOINTMENT OF PARENTS IN MY DISTRICT NOT EVEN NOT GETTING INTO A PARTICULAR SCHOOL THAT THEY WANT OR DON'T WANT BUT LIKE JUST NOT EVEN HAVING AN OPTION THAT WOULD ALLOW THEM TO ROLL THE DICE AND MAYBE WALK THEIR KIDS TO SCHOOL. SO I JUST WONDER IF YOU COULD SPEAK A LITTLE BIT ABOUT WHETHER YOU THOUGHT ABOUT THE MCKINLEY BUILDING AND GENERALLY KIND OF WHAT THE STRATEGY WOULD BE FOR SCHOOL BUILDINGS THAT WE SAY [INDISCERNIBLE]

>> SO YEAH. I THINK I MAY HAVE SOMETHING TO ADHERE TOO BECAUSE OF AN HISTORICAL PERSPECTIVE OF THE COMMUNITY AS A NEW COMER. I'M STILL LEARNING. FENWAY STUDENTS TOLD ME WHEN I WAS IN THAT AREA THAT THEY ARE SEEKING A SCHOOL BUILDING OR SOME PLACE TO SEND THEIR CHILDREN TO. SO THAT IS A CONCERN. WITH THE MCKINLEY SCHOOLS IN PARTICULAR, THEY ARE A DAY SCHOOL AND I SEE THEM AS MOST DESERVING SO I WANT TO TAKE KIDS THAT YOU KNOW NEED MORE AND I WANT TO GIVE THEM MORE. AND SO THOSE SCHOOLS JUST NEED A LITTLE BIT OF A LOVING TOUCH AND **RENOVATION AND I WANT TO GIVE** THAT SOME THOUGHT AS PART OF OUR BUILD BPS PROCESS MOVING FORWARD AND THAT WOULD INCLUDE THE COMMUNITY AS WELL. WE CAN PULL FROM MULTIPLE COMMUNITIES FOR THAT SCHOOL SO THERE SEEMS TO BE A COMMUNITY FOR THAT SCHOOL. DO YOU HAVE ANYTHING TO ADD? >> I'LL JUST DOUBLE DOWN, WE'VE HAD CONVERSATIONS ABOUT THE COMMUNITY HOUSING AND ASSETS AND HAVING INITIAL CONVERSATIONS WITH PEOPLE. I THINK ONE OF THE THINGS WE WANT TO EMPHASIZE IS WHEN WE TALK ABOUT INVESTMENT IN THE [INDISCERNIBLE] WE'RE TALKING ABOUT INVESTMENT IN THE SCHOOLS FOR STUDENTS WHO ATTEND THE MCKINLEY AND THAT PLAN FOR ANY GENERAL EDUCATION PIECE OR ELEMENTARY SCHOOL ON ONE OF THOSE SITES WOULD COME ONLY AFTER WE FOUND BETTER AND MORE APPROPRIATE SETTING FOR THE STUDENTS THAT ARE THERE. THE SECOND THING IS BPS THE LAST **REPORT THAT WAS PUBLISHED DATA** INCLUDED ANALYSIS OF ACCESS TO SEAT. AND IT'S THAT DATA THAT WAS DRIVING THE PRIORITIES FOR BUILD

BPS INVESTMENTS IN ELEMENTARY SEATS.

I TO THINK ONE OF THE CHALLENGES THAT WE HAVE IS WITHOUT A **BUILDING BEING IN DOWNTOWN AS** SORT OF THE IN THE BACK BAY FENWAY AREA, YOU KNOW, WE'RE LOOKING AT WHERE DO OUR CURRENT BPS STUDENT NOT HAVE ACCESS TO SCHOOL CLOSE TO HOME. WE KNOW WHEN WE START LOOKING AT WHERE DO WE NOT HAVE ENOUGH SPACE TO SERVE ALL STUDENTS WHO LIVE IN BOSTON CLOSE TO HOME THAT IT DOES SHIFT OUR ANALYSIS TO DIFFERENT LOCATIONS BUT THAT WE ARE LEADING WITH THE DATA THAT WHERE DO WE NEED ACCESS FOR OUR CURRENT BPS STUDENTS FOR THOSE KIDS WHO NEED PUBLIC EDUCATION THE MOST. WE ARE PARTNERING WITH BPA TO CONTINUALLY UPDATE TO MAKE SURE OUR DATA IS NOT LAGGING AND WE'RE NOT IGNORING NEW HOUSING DEVELOPMENTS AND NEW HOUSING STARTS IN DIFFERENT NEIGHBORHOODS AND THAT WILL BE SORT OF THE LEAD IN HOW WE DECIDE WHERE NEW ELEMENTARY SCHOOLS OR STANDARD ELEMENTARY SCHOOLS NEED TO BE ADDED. I'LL ALSO JUST NOTE SCHOOLS IN EVERY NEIGHBORHOOD DEPENDS OF COURSE ON HAVE INVESTIGATORS OF THE NEIGHBORHOOD YOU'RE TALKING ABOUT. WE WON'T REMOVE THE DISTRICTS FROM THE DOWNTOWN CROSSING IN THIS CASE. WHAT WE'RE TALKING ABOUT DOING IS REALLY SAYING THAT IT'S SHORTHAND FOR GEOGRAPHIC DISBURSEMENT. TO YOUR POINT, ALL STUDENTS HAVE ACCESS TO BUILDINGS WHERE THEY CAN WALK TO IT. >> SURE. I REPRESENT FIVE NEIGHBORHOODS WHICH DON'T HAVE A SCHOOL BUT I THINK EVEN WITHOUT US DRAWING THE LINES TOO TIGHTLY THERE'S

STILL AN ISSUE HERE.

BY THE WAY I WANT TO SAY I

TOTALLY I AGREE. I THINK THE BEST PRIORITY HAS TO BE HOW WE HAVE THE MCKINLEY SCHOOL COMMUNITIES [INDISCERNIBLE] BUYS DILL TEASE, NO -- DISABILITIES. SEPARATE FROM THE QUESTION OF IMPROVING THE HALL WAYS AND CUT THE SMALL BUT IMPACTFUL PROJECTS YOU GUYS ARE TALKING ABOUT. ONCE YOU GIVE ME [INDISCERNIBLE] THE OPPORTUNITY IS TO THINK ABOUT HOW DO YOU SOLVE MULTIPLE PROBLEMS AT ONCE MAKES A LOT OF SENSE. AND I THINK IT'S IMPORTANT TO HAVE, IT'S IMPORTANT NOT JUST TO HAVE ANY COMMUNITY INVOLVEMENT IT'S IMPORTANT TO HAVE THEM INVOLVED. I'M ABOUT TO GET UP TO MY OWN TIME SO I'LL REMARK ON THE FACT THAT I THINK ONE OF THE STRENGTHS OF GOOD PUBLIC EDUCATION IS HAVING EVERYBODY IN A COMMUNITY IN THE MIX. I THINK THAT WE SEE THAT WITH PUBLISH LIBRARIES. I THINK THAT PUBLIC LIBRARIES, THEY DO A HUGE AMOUNT TO SERVE THE PEOPLE WHO NEED IT THE MOST IN THE COMMUNITY BUT PART OF WHAT MAKES THEM SO STRONG IS THAT EVERYONE IN THE COMMUNITY **REGARDS THEM AS SOMETHING THAT** THEY'RE PART OF. I THINK THAT WHEN WE THINK ABOUT WHAT ARE THE ROBUST BPS SYSTEM LOOK LIKE THAT HAS A QUALITY SCHOOL FOR EVERY KID THAT LIKE THE WHOLE COMMUNITY OF BOSTON HAS INVESTED IN. FRANKLY IT'S INCREASINGLY UNEQUAL BOSTON. LIKE I THINK THAT NOT KIND OF HAVING PROJECTIONS AND STRATEGIES THAT HAVE TO DO WITH **BRINGING SOME FAMILIES LIKE IF I** THINK IS A MISTAKE. SO I JUST WANT TO RAISE THE FACT THAT TO ME THAT IS AN EQUITY ISSUE. I THINK IT'S REALLY IMPORTANT THAT YOU DO THAT IN A WAY THAT

ISN'T ABOUT PROVIDING FAMILIES WITHIN HIGHER INCOME NEIGHBORHOODS WITH SPECIAL ACCESS TO SCHOOLS THAT OTHER FAMILIES CAN'T GET INTO WHICH IS A REALLY IMPORTANT CONCERN. BUT I THINK THAT IT'S A MISTAKE FOR US TO DRIVE IN THE DIRECTION OF SAYING WE'RE GOING TO BE INCREASINGLY AN EQUAL CITY AND OUR PUBLIC EDUCATION SYSTEM ISN'T GOING TO BE TARGETED AT SERVING ALL FOLK. THAT'S JUST MY TWO CENTS. BACK UP TO THE TOP. COUNCILOR BREADON, YOU HAVE THE FLOOR AND THEN IT'S COUNCILOR CAMPBELL. COUNCILOR BREADON. >> THANK YOU. THIS IS A REALLY IMPORTANT CONVERSATION WE'RE HAVING. IN TERMS OF CHOICES FOR FAMILIES. I REALLY THINK THE MARKETPLACE WE'RE COMPETING WITH ESPECIALLY WITH [INDISCERNIBLE] WE'RE COMPETING WITH PAROCHIAL SCHOOLS AND INDEPENDENT SCHOOLS TO GET THOSE KIDS IN THE DOOR EARLY AND GET THOSE PARENTS STRONG ADVOCATE FOR OUR PUBLIC SCHOOL SYSTEM. AND I THINK HERE IN AUSTIN BRIGHTON WE HAVE, FOLKS AND THE CHOICES, THE ABILITY TO GET INTO THE ELEMENTARY SCHOOL OF A CHOICE WHEN THEIR CHILD IS READY AND ALSO TO GET INTO EARLY EDUCATION IN A LEARNING CENTER IS SORT OF CRITICAL TO GET THE STUDENTS, THOSE PARENTS, THOSE FAMILIES BECOME STRONG ADVOCATES AND ENGAGE ADVOCATES IN OUR PUBLIC KNOWLEDGE CASE IN THE BOSTON PUBLIC SCHOOLS. IT REALLY WORRIES ME THAT YOU KNOW WE HAVE TO THINK ABOUT IT AS A MARKETING ISSUE AND TRY AND GRAB THOSE FAMILIES AND REALLY SELL IT TO THEM BUT THIS IS A REALLY GOOD OPTION THAT WE CAN WORK TOGETHER TO BUILD AN EVEN BETTER STRONGER AND MORE DIVERSE SCHOOL SYSTEM THAT IS DELIVERING

FOR ALL OF OUR CHILDREN ACROSS THE DISTRICT. AUSTIN BRIGHTON HAS SEEN A HUGE AMOUNT OF NEW DEVELOPMENT. WE HAVE A LOT OF YOUNG PROFESSIONALS WHO ARE IN THEIR 30'S NOW AND I'M ANTICIPATING A SCENARIO LIKE COUNCILOR BOK THAT THOSE FAMILIES WILL NOT BE ABLE TO FIND [INDISCERNIBLE] WHEN THEY START TO HAVE FAMILIES, THEY WILL BE ABLE TO HAVE CHILDREN THERE IN THE NEIGHBORHOOD. SO IT ONE OF THOSE THINGS I WORRY WHEN WE TALK ABOUT THE **BPBA IS GUIDING OUR THINKING** ABOUT PLANNING. WHY THE THEY DO PLANNING VERY WELL AND I WOULD HOPE THAT WE'RE **REALLY CREATING SPACE AND** PUTTING SCHOOLS INTO THE PLAN FROM THE BPBA POINT OF VIEW I THINK THEY'VE COME TO THEIR SORT OF [INDISCERNIBLE] AND ONE OF THE ISSUES I HAVE IS THEY PROVIDE LITTLE DEVELOPMENT THAT CATERS. IN OUR DISTRICT THEY DON'T CATER TO FAMILIES OF LOWER INCOME. IT'S A DETRIMENT OF OUR NEIGHBORHOOD AND DETRIMENT TO THE SCHOOLS IN OUR DISTRICT. IF THAT FAMILY POPULATION DECLINES I THINK INEVITABLY YOU FOLKS [INDISCERNIBLE] WE DON'T NEED SO MANY SCHOOLS. IT'S LIKE A CHICKEN AND EGG SITUATION. IT'S REALLY MORE OF A CONCERN MORE THAN A QUESTION. JUST TO SAY IT'S REALLY COMPLICATED, THEY REALLY APPRECIATE THE NUANCES OF THIS CONVERSATION. THANK YOU. >> I JUST HAD A COUPLE POINTS OF CLARIFICATION. **BPBA PART SHINE IS ABOUT GETTING** BETTER DEMONSTRATE GRAPHIC PROJECTIONS. WE'VE BEEN PARTNERING WITH THE RESEARCH TEAM TO UNDERSTAND HOW THE PLAN NEW DEVELOPMENTS ARE

GOING GOAL LONG ONE PLANS FOR OUR DISTRICT. WE'RE UNDERSTANDING WHAT NEW BUILDINGS ARE BEING PUT UP. WHEN BUILDINGS ARE BEING OPEN, WHAT TYPES OF BUILDINGS THEY ARE AND WHETHER OR NOT WE ANTICIPATE THEY WILL NET ADDITIONAL CHILDREN. WE'RE ALSO WORKING WITH THEM ON A PARTNER HOW WE INCORPORATE **BROADER DEMOGRAPHIC TRENDS IN** THE REGION TO MAKE SURE WE'RE BEING RESPONSIVE TO WHAT THEY SEE AT A LOCAL LEVEL AROUND SHIFT IN DEMOGRAPHICS. ALL OF WHICH OF COURSE ARE A STARTING POINT OR AN INPUT TO OUR PLAFNING PROCESS BUT ROLE IS SECOND TO THE EDUCATION VISION. I JUST WANT TO NOTE FOR YOU IN PARTICULAR IN AUSTIN BRIGHTON WE FIND WE HAVE OVER ONE AND-A-HALF FEET PER KID IN ELEMENTARY SCHOOLS IN AUSTIN BRIGHTON. YOU CAN TELL FAMILIES WE'LL GET A SEAT CLOSE TO HOME. IN THE FIRST ROUND 55% OF FAMILIES WHEN THEY REGISTER FOR K2 GET THEIR FIRST CHOICE. 61% OF FAMILIES IN K1 GET THEIR FIRST CHOICE. 85% DISTRICT LIVE ONE OF THEIR TOP THREE CHOICES IN K2. AND 87% OF FAMILIES GET THE FIRST CHOICE IN K1. NOW WHAT THAT TELLS US IS THAT WHEN PEOPLE MISS OUT ON THE SEATS. IT IS A TRAUMATIC EXPERIENCE. I'VE GONE THROUGH IT. I KNOW WHAT IT'S LIKE THROUGH SCHOOLS AND I WONDER WHAT'S GOING TO HAPPEN TO HAVE TO LOOK AT ANOTHER OPTION. WHEN I GOT TO SEE IT I DIDN'T GO AROUND THE PLAYGROUND FRIGHTENING ANYBODY TO SEE YOU'RE THE 15% THAT MISSED OUT. THE CONVERSATION IS GOING TO SKEW TOWARDS THOSE THAT DON'T GET THE SEAT THE OTHER THING WE TALK ABOUT EQUITY OF THE STUDENT ASSIGNMENT PLAN WE NEED FAMILIES

TO GET THE MESSAGE OUT AND REGISTER EARLY IN ROUND ONE. A LOT OF FAMILIES DON'T GET THE SEATS IN THE SCHOOLS THEY WANT ARE REGISTERING IN ROUND TWO AND BEYOND WHERE ACT IS HE IS MUCH MORE LIMITED. **IT'S REALLY ABOUT GETTING** FAMILIES TO REGISTER IN THE EARLY SCHEDULE. I DON'T WANT TO BE HIT WITH THE HAMMER. >> YES, I KNOW. IT'S NOT YOUR PROBLEM, I THINK IT'S THE BPBA AND THE WHOLE DEVELOPMENT THAT WE SKEW OUR POPULATION EXCUSE YOUNGER. WE HAVE A HUGE NUMBER OF PEOPLE **UNDER 35 AND WE'RE DEBATING** HOUSING FOR YOUNG PROFESSIONALS WITHSTOOD OHS AND ONE BEDROOMS THAT ARE NOT FAMILY HOUSING AND [INDISCERNIBLE] IF WE DON'T HAVE A MORE INCLUSIVE AND DIVERSE APPROACH TO OUR HOUSING SITUATION AND WHAT WE'RE BUILDING. THIS IS THE CONVERSATION FOR ANOTHER COMMITTEE, I UNDERSTAND THAT. SO THANK YOU SO MUCH. IN TERMS OF REGISTERING TELLER [INDISCERNIBLE] CHOICES, IS THERE MORE ABOUT THE TIMETABLE AND HOW TO PROMOTE THAT AND TELL PEOPLE GET IF YOU WANT SOMETHING YOU HAVE TO BE MORE PROACTIVE AND GO FOR IT, YOU KNOW. THANK YOU. >> COUNCILOR CAMPBELL. >> THANK YOU COUNCILOR BOK. TIME IS OF THE ESSENCE AND I CAN FOLLOW UP BUT I WANT TO YOWSH BUILD BPS THAT CAME UP QUITE A BIT OF CONSTITUENTS MUCH THE MICK KINALLY SCHOOL I APPRECIATE THE SUPERINTENDENT RAISING THE MCKINLEY SCHOOLS. YOU SAID EARLIER ABOUT MADISON PARK TELLING THEIR STORIES I THINK THE SAME IS TRUE FOR MCKINLEY SCHOOL TELLING THEIR STEERS. MY BROTHERS WENT THROUGH THE

SYSTEM AND HAD INCREDIBLE SYSTEMS AND THERE ARE TEACHERS WHO STILL WORK IN THOSE SYSTEMS. I KNOW IN EVERY SCHOOL SOMETIMES ISN'T THE BEST FIT FOR THESE FAMILIES BETHERE'S INTENTIONALITY ON SOCIAL LEARNING SUPPORT WORKING WITH CHILDREN WHO HAVE TREMENDOUS NEED SO THEIR STORY IS UNTOLD FOR ANY SUPPORT FOR THAT SYSTEM I THINK IT'S CRITICALLY IMPORTANT. GIVEN THE LIMITED PROGRAM, THE LIMITED SCHOOLS DOING SUCH INTENSE PROGRAMMING THAT THEY DO. SO A COUPLE OF FOLLOW UP QUESTIONS. ONE IS THE EXAMS ISSUED IN TERMS OF LACK OF DIVERSITY CARE DEEPLY ABOUT COUNCILOR JANEY I HELD SOME HEARINGS ON THIS. WE MET WITH THE PRINCIPALS OF THE THREE EXAM SCHOOLS, KNOW THEM ALL WELL AND I THINK IN ONE OF THE CONVERSATIONS WE HAD WITH THE PRINCIPALS [INDISCERNIBLE] WHO I WANT TO LATIN SCHOOL WITH THAT DIVERSITY ISSUES WE'RE TALKING ABOUT AREN'T THOSE SCHOOLS. WE LUMP THE SCHOOLS TOGETHER AND WE HAVE TO BE CAREFUL. EACH SCHOOL IS DIFFERENT, THE DEMOGRAPHICS LOOK DIFFERENT. OFTEN TIMES WE'RE TALKING ABOUT LATIN SCHOOLS. SO I KNOW THAT YOU ARE DOING YOUR BEST TO BE AS EXPANSIVE IN THE SORT OF APPROACH TO EXPAND DIVERSITY AND IT DOES INVOLVE PRE-K. THOSE PROMISES DO THE SAME THING, GETTING PREPARED EARLY ON, HAVING GOODELL MEN TREE EXPERIENCE, GOOD FIFTH GREAT EXPERIENCE LEARNING WHAT THEY NEED TO LEARN TO TAKE A TEST AND ALL OF THAT ROUTINE, EXAM PREPS, ETCETERA. I WANT TO SAY IN ORDER TO GET THAT SYSTEM TO TRANSFORM IN SUCH A WAY THAT THE NUMBERS ARE

REFLECTIVE OF THE DISTRICT, IT'S GOING TO HAVE A LOT OF THINGS WORKING IN DIFFERENT, A LOT OF MOVING PIECES WORKING AT THE SAME TIME.

THE EXAM ALONE AND CHANGING THE EXAM ALONE WILL NOT GET US THE NUMBERS WE WANT TO SEE THERE. EXAM PREPS WILL NOT GET US THE NUMBERS, THERE'S A LOT MORE WE NEED TO DO.

ONE THIN THAT CAME UP OVER THE HAS FEW YEARS IS THE GRADING PIECE.

PRIVATE SCHOOL'S DOING NUMBERS AND THEN THESE ANOTHER SYSTEM OF ACTUAL GRADES.

WITH THE UPDATE THERE I KNOW HOW SOME OTHERS WERE WORKING ON THAT AND I'M CURIOUS WHERE WE ARE WITH THAT PIECE OF THIS. THEN MY SECOND QUESTION HAS TO DO WITH BUILD BPS AND WE HAVE THE STAND-ALONE MIDDLE SCHOOLS WITH A QUESTION MARK GIVEN THE K-6. K-8 TRANSITION THAT THE DISTRICT WILL GO THROUGH. SO WHAT DO WE DO WITH THE STAND-ALONE MIDDLE SCHOOLS. I APPRECIATE WHAT NATE WAS SAYING WHERE THE COUNCIL CAN BE HELPFUL IS THE POLITICAL PROCESS, FAMILIES LIKE YOU SAID WANT CERTAINTY. THEY WANT TO KNOW IF I'M GOING TO STAND-ALONE IN MIDDLE SCHOOLS AT TIMITY FOR EXAMPLE OR EDWARDS GOING FROM K-6 AND K-8 AND THESE SCHOOLS ARE NOT GOING TO BE IN THAT TRAJECTORY, WHAT DO WE DO. WHEN DOES THE FAMILY ENGAGEMENT PROCESS STARTS WITH FAMILIES THAT ARE THERE AND BEING ENROLLED THERE SAYING WE HAVE TO HAVE A SIT DOWN CONVERSATION ABOUT WHERE WE GO. IT BECAME CLEAR AT LEAST TO ME WE WILL NEVER HAVE ENOUGH **RESOURCES TO POWER INTO THOSE** MIDDLE SCHOOLS TO GIVE THEM ALL OF THE ROBUST PROGRAMMING THAT FAMILIES WOULD LIKE TO SEE, THE SPECIAL NEEDS STUDENTS IN THE LANGUAGE LEARNERS, THE ARTS,

MUSIC, ACADEMIC, AFTER SCHOOL PROGRAM, YOU NAME IT. SO THE QUESTION IS REALLY URGENT AS TO WITH A WE'RE GOING TO DO THERE. THOSE ARE MY QUESTIONS, THANK YOU. >> SO AS WE MOVE TO FULLY REALIZE THE BUILD BPS WAS

ACTUALLY ASKED ONE OF THESE QUESTIONS IN PIE INTERVIEW LAST SUMMER IS WILL YOU SUPPORT THE 7-12 MODEL IN THE K8, 9, 12 MODEL.

I COME WITH A STRONG PREFERENCE TO FIXATE MIDST SCHOOLS. JUST BECAUSE MY HISTORY IS IN MIDDLE SCHOOL AND I SAID I WOULD.

I WASN'T GOING TO SIT AROUND AND ALLOW FOR THE KIDS IN THE MIDDLE SCHOOLS TO NOT HAVE THE SAME KIND OF EQUITY PROGRAMMING I KNEW WOULD BE AVAILABLE IF WE MOVE TO 7-12 BECAUSE PEOPLE WILL SELECT.

WE ALREADY LOSE STUDENTS AT SEVENTH GRADE HEN THEY GO TO EXAM SCHOOLS AND SO THEN YOU HAVE, YOU KNOW, THE K-8'S AND THE DEMOGRAPHICS AND THE K-8'S LOOK VERY DIFFERENT AND THEY LOOK IN OUR K-5 OR K-6'S. SO WE WANT TO CREATE BETTER EQUITY ACROSS THE BOARD BY DOING THIS ALL AT ONE TIME AND I PLAN ON TALKING TO THE SCHOOL COMMITTEE THE I WAS MANNING ON TALKING AND STARTING WITH THE COMMUNITY OF THESE MIDDLE SCHOOLS BACK PRIOR TO COVID. I TALKED WITH THE SCHOOL LEADERS ALREADY AND WANT TO THEN START THE COMMUNITY PROCESS THAT THEN BECAME VERY CHALLENGING UNTIL COVID BECAUSE OF PREPARING TO FEED OUR CHILDREN AND SOME OF THE OTHER STUFF SO WE PUT SOME OF THIS WORK ON HOLD. I PLAN ON RESTARTING THOSE CONVERSATIONS WITH THE COMMON THEY ABOUT THE MIDDLE SCHOOLS. **OBVIOUSLY I WANT THEM TO MOVE AT** THE SAME TIME EXPANDING TO K6'S

AND 7-12 SO AS NOT TO GET LOST IN THE SHUFFLE. SO THAT CONVERSATION IS COMING AND WILL BEGIN NEXT WEEK WHEN I TALK TO SCHOOL COMMITTEE AROUND **THE REDESIGN AROUND 7-12** PATHWAYS. I ALSO WILL BE COMMENTING ON THOSE SCHOOLS AT THAT TIME. >> THANK YOU. >> YOU ASKED ABOUT THE GRADING PIECE. >> SO YOU KNOW, THIS IS SOMETHING WE'RE JUST HONESTLY GOING TO HAVE TO LOOK AT THIS YEAR BECAUSE WE ARE GRADING VERY DIFFERENTLY THIS YEAR AND OUR PRIVATE SCHOOLS ARE TOO. AND SO WE HAVE TO FIND A SOLUTION AND I PLAN ON ADDRESSING THAT THIS SUMMER. **OBVIOUSLY WE HAVE SOME TIME TO** HAVE A STAKEHOLDER GROUP AROUND HOW WE RESOLVE THIS ISSUE. THERE ARE PREVIOUS GRADES THAT WERE GIVEN PRIOR TO COVID SO WE MAY BE ABLE TO USE SOME OF THAT BUT THIS THIRD TERM IS AN ISSUE AND QUITE HONESTLY THE LEARNING LOSS OUR STUDENTS, EXPERIENCING NOW AND SOME OF OUR GROUPS THAT WE ANTICIPATE WILL BE THAT THERE HAD BEEN LEARNING LOSS WHETHER THEY ARE AT PUBLIC SCHOOLS OR RIGHT SCHOOL OR CHAWSHTER. WE KNOW THERE ARE SOME STUDENTS WHO ARE STRUGGLING IN THIS REMOTE LEARNING ENVIRONMENT AND FAMILIES THAT ARE STRUGGLING TOO. THOSE ARE GOING TO BE LASTING AND [INDISCERNIBLE] REALLY STRONG AS WELL AS HOW WE PREPARE FOR THEM. >> ONE POINT OF CLARIFICATION, COUNCILOR BOK. JERI HOLLAND DID SOME REALLY **INCREDIBLE WORK AND REALLY** LOOKING AT THE EXAM SCHOOLS, THE EXAM AND THEN YOUR GRADE IN DETERMINING ACCESS. THAT WAS A CRITERIA. IT LOOKS LIKE BOSTON STUDENTS MIGHT HAVE BEEN, THOSE IN BPS BY

THE GRADING SYSTEM WHICH IS A **BIG PIECE OF THE ADMISSION** PROCESS. SO ONE IS UPDATE SPECIFICALLY ON THAT PIECE WITH RESPECT TO THE DIVERSITY CONVERSATION. >> YES. TALKING ABOUT WE HAVE TO LOOK AT THE OVERALL GRADING PIECE **BECAUSE WE'RE GRADING** DIFFERENTLY NOW DURING THIS THIRD TERM. >> THANK YOU COUNCILOR BOK JOARKS THANK YOU SO MUCH COUNCILOR CAMPBELL. NEXT UP IS COUNCILOR ESSAIBI-GEORGE AND THEN IT WILL **BE COUNCILOR JANEY.** COUNCILOR SEERNL. >> THANK YOU AGAIN MADAM CHAIR AND THANK YOU TO THE TEACH FOR A VERY LONG DAY WITHOUT THE ABILITY TO COME OFF CAMERA FOR A LITTLE BIT. I WANT TO STATE MY APPRECIATION. WE TALKED A LITTLE BIT IN THIS SESSION ABOUT STUDENT INVOLVEMENT. WHEN I WAS IN HIGH SCHOOL I WAS ON THE BOSTON STUDENT ADVISORY COUNCIL AND REALLY IMPRESSED WITH THE LEVEL THAT THE YOUTHS HAVE BEEN DOING WITH THE STUDENT TO ENGAGE THEM ESPECIALLY DURING THIS TIME AND WE HAVE WEEKLY MEETINGS WITH THEM AND DEVELOP A GREAT RELATIONSHIP WITH OUR KIDS AND THAT'S REALLY IMPORTANT FOR THEM AND REALLY IMPORTANT FOR OUR SYSTEM MANY SOMETHING WE'RE LOOKING TO DO WITH MY WORK ON THE COUNCIL IS TO REALLY ELEVATE THAT POSITION OF THE STUDENTS UP TO THE SCHOOL COMMITTEE. WE'RE LOOKING AT WHAT **OPPORTUNITY THERE IS FOR THAT** STUDENT TO BE A VOTING MEMBER OF THE SCHOOL COMMITTEE BUT MORE **IMPORTANTLY -- NOT MORE** IMPORTANTLY BUT PROBABLY A LITTLE BIT EASIER WOULD BE TO HAVE THAT STUDENT AT THE VERY LEAST RECEIVE THE STIPEND AND THE SAME STIPEND AS OTHER

ACCESS.

THAT'S SOMETHING I WOULD LIKE TO ADVOCATE FOR HERE AND DO IT THROUGH SOME OTHER HE WAS IN SOME MEETINGS THAT WE'LL ADDRESS IT AND GET FEEDBACK. IN THE MEANTIME I WOULD LOVE YOU TALK MORE, I KNOW IT WAS MENTION IN THE PRESENTATION ABOUT THE WORK HAPPENING BETWEEN THE BOSTON STUDENT ADD VOICES RE COUNCIL AND YOU AND YOUR EFFORT AND THEIR INVOLVEMENT WITH SOME OF THE WORK THAT YOU'VE UNDERTAKEN ESPECIALLY IN YOUR STRATEGIC PLANNING BUT MORE RECENTLY DURING THIS SORT OF UNCERTAIN TIMES. >> YES, THANK YOU COUNCILOR. IT'S BEEN GREAT, THE JOY OF MY WEEK IS TO MEET WITH THE BOSTON STUDENT ADVISORY COUNCIL AND MY CABINET. THEY'VE BEEN WONDERFUL AND I KNOW MR. COOTER SAID YOU HAVE THESE WONDERFUL STUDENT THAT FOLLOW YOU. EL VIN IS MY INTERN AND I CONNECT WITH HIM REGULARLY AND CONNECT WITH THE YOUTH CABINET ON IDEAS AND PROJECTS. THEY JUST HAVE INCREDIBLE IDEAS. SO THEY CONTRIBUTED TO THE REMOTE LEARNING PLAN. THEY GAVE FEEDBACK ON GRADING. THEY GAVE FEEDBACK ON MASTER SCHEDULING, HOW IT WAS HARD TO GET DUPLICATED INFORMATION FROM ZOOM LINKS AND THINGS. THEY WOULD GO TO ONE CLASS AND HAVE ANOTHER CLASS AT THE SAME TIME. THEY PROVIDED INFORMATION ON GRADUATION AND HOW TO DO GRADUATION. THE YOUTH CABINET IS WORKING ON A SPECIAL WRONG FOR THE MBTA AND KIND OF HIKE A PECKER'S PASS FOR KID AFNED AWE TENDANCE AND QURAN YOU CAN AWE TENDANCE. IT'S JUST ENDLESS. THEY HAVE A VIDEO THAT THEY PRODUCE AROUND THEIR REMOTE LEARNING EXPERIENCES AND THEY

HELP US WITH MARKETING VIDEOS AND TRANSLATIONS AND NOW THE NEXT IDEA THAT THEY HAVE [INDISCERNIBLE] IS GOING TO BE SPEAR HEADING A NEWSLETTER, REMOTE NEWSLETTER FOR STUDENT BECAUSE THEY WERE AFRAID THAT PEOPLE WEREN'T GETTING THE REAL STORY WHAT WAS HAPPENING AND THAT SOMETIMES YOUTHS ARE MISINFORMED OF WHAT'S REALLY GOING ON IN THE DIRECT BECAUSE THEY HAVE AN EYE TOWARD THE POLICY AND TOWARD ALL OF THE WORK. THEY HEAR IT DIRECTLY FROM ME EVERY WEEK. THEY WANT TO BE ABLE TO TELL THE ACCURATE STORY TO THE YOUTH AND GET IT OUT THERE. I HAVE AN INSTAGRAM NOW WITH THEM. I HAVE CHALLENGES WITH THEM AND I KNOW YOU'VE JOINED ME WITH CHALLENGES AS WELL. IT'S AN INCREDIBLE YOUTH OF YOUNG PEOPLE. THEY'VE BEEN ADD INDICATING FOR THE [INDISCERNIBLE] THIS IS A **BIG ISSUE, VOTE IS A BIG ISSUE** FOR THEM. IT'S NOT SOMETHING THAT I CAN, THAT'S IN MY HANDS BUT CERTAINLY SOMETHING THAT THEY ARE ADVOCATING FOR. >> THIS ISN'T A QUESTION BUT **REPEAT SOME OF MY COLLEAGUES** ABOUT BUILD BPA AND MADISON INCLUDED IN THAT I'LL ADD TO MY COMMENTS. LOOK TO THE WORK LEFT UNDONE AT MADISON AND LEFT UNDONE IN THE WHOLE BPS PROCESS WOULD REALLY LOVE TO SEE MADISON A PART OF THAT AND PRECIOUS SPECIALLY COUNCILOR JANEY'S COMMENTS AROUND THE DIFFICULTY IN DOING SCHOOL FROM HOME WHEN IT'S VOCATIONAL TECHNICAL EDUCATION IN PARTICULAR. WE KNOW MANY OF OUR FAMILIES HAVE A DIFFICULT TIME WITH SOME OF THE MAPS. NEVER MIND THE TEXT. WE APPRECIATE THOSE EFFORTS AND

KNOW IT'S AN UNUSUAL TIME FOR EVERYBODY. THANK YOU MADAM CHAIR. THAT'S IT FOR ME TODAY. >> GREAT THANK YOU SO MUCH COUNCILOR SEERNL. SEERNL -- SEERNLT. ESSAIBI-GEORGE. COUNCILOR JANEY. >> I WANTED TO HIGHLIGHT EARLIER AND THANK YOU FOR THE INVESTMENT IN THE CARTER. THAT'S REALLY IMPORTANT. THERE ARE SOME GOOD THINGS TO HIGHLIGHT. I KNOW WE'RE SPENDING A LOT OF OUR TIME NOTING WHAT NEEDS TO BE IMPROVED BUT WANT TO GIVE A SHOUTOUT FOR THAT. IN TERMS OF THINGS THAT NEED TO BE IMPROVED LOOKING FORWARD TO CONTINUING THE CONVERSATION. I WANT TO INCLUDE THE REPORT THAT I REFERENCED EARLIER. THE [INDISCERNIBLE] REPORT IN THE LINK SO IT CAN BE SHARED MORE BROADLY AND HOPING THAT CAN BE PART OF THE PUBLIC RECORD AS WELL. IN THAT REPORT AGAIN, I WANT TO HIGHLIGHT THIS IS BACK TO HOME BASE PLAN AND THE NEEDS WHERE YOU HAVE URGENT ACTIONS TO FOLLOW UP THIS CONVERSATION TO ADDRESS SOME OF THE CONCERNS THAT ARE OUT STANDING ON FINDING NUMBER FOUR WHICH WAS THE CRITICAL ROLE OF GEOGRAPHY IN THE REPORT. IT SHOWS AT THE BOTTOM OF THAT PAGE AND THESE NO PAGE NUMBER HERE BUT IT SHOWS THAT BLACK STUDENTS HAD THE FEWEST HIGH QUALITY SEAT NEARBY IN TERMS OF GEOGRAPHY AND ASIAN AND WHITE STUDENTS HAD THE MOST. AND THEN THERE'S BREAKDOWNS BY NEIGHBORHOOD AND YOU GO BY NEIGHBORHOOD AND YOU CAN SEE CERTAIN NEIGHBORHOODS HAD NO ACCESS. SO AGAIN I JUST WANTED TO EMPHASIZE THE IMPORTANCE AGAIN AND THE URGE SEE OF ROUNDS

MOVING FORWARD BECAUSE I THINK IT IS ESSENTIAL TO THE WORK WE'RE TALKING ABOUT WHEN WE'RE LOOKING TO ELIMINATE OPPORTUNITY IN THE ACHIEVEMENT GAP ALONG WITH ALL OF THE MANY THINGS THAT WE DISCUSSED TODAY. SO I REALLY APPRECIATE THE WORK AND LOOK FORWARD TO FOLLOWING UP ON THE HOME BASE ASSIGNMENTS, THE SEATS, ON THE IMPORTANT CONVERSATION THAT WE HAD EARLIER. I HEARD MY COLLEAGUES CHIMING IN AROUND THE SCHOOL ADMISSIONS. YOU POINTING OUT THAT WE CAN'T REALLY HAVE EQUITY OR MERITOCRACY IF WE'RE NOT **REMOVING THESE BEAR YEAHS.** I APPRECIATE THE -- BARRIERS. I APPRECIATE THE WORK AND NEXT TIME I HOPE WE CAN HAVE ACTIONS ON MOVING FORWARD. THANK YOU SUPERINTENDENT, THANK YOU MADAM CHAIR. THANKS TO THE TEAM. >> THANK YOU SO MUCH PRESIDENT JANEY. ALL RIGHT NEXT UP COUNCILOR FLYNN AND THEN THE COUNCILOR MEJIA. COUNCILOR FLYNN. >> THANK YOU COUNCILOR BOK AND THANK YOU TO THE SUPERINTENDENT AND HER TEAM. I JUST HAVE ONE PREQUESTION. SUPERINTENDENT, CAN YOU TALK ABOUT YOUR PHILOSOPHY ON WHAT YOU ENVISION IN TERMS OF OUR ATHLETIC PROGRAM OR THE SPORTS PROGRAMS AND MAYBE AFTER SCHOOL PROGRAMS WITH YOU'RE THINKING ABOUT IN TERMS OF THIS UP COMING SCHOOL YEAR. >> YOU SAW A BIG SMILE ON MY CASE BECAUSE ATHLETIC PROGRAMS IN TERMS OF THIS YEAR AND COVID I FEEL LIKE IT MIGHT BE A BIT STRESSED QUITE HONESTLY JUST TO PUT IT OUT THERE AND START MANAGING EXPECTATIONS. UNLESS WE HAVE A VACCINE, I THINK IT'S GOING TO BE REALLY HARD TO DO TEAM SPORTS.

ALREADY PRO SPORTS ARE HAVING VERY SERIOUS CONVERSATION ABOUT WHETHER THEY WILL BE ABLE TO COME BACK OR NOT. SO WE'LL BE WATCHING THAT MOSTLY AND WORKING WITH OUR MIA PARTNERS. THERE MAY BE SOME SPORTS THAT ARE NOT CONTACT SPORTS THAT COULD COME BACK EARLIER. I JUST DON'T KNOW IF WE COULD DO

THAT WITH SOCIAL DISTANCING AND PPE AND WHAT WOULD BE REQUIRED. SO WE ARE STILL LOOKING INTO THAT AND THE AT HETEROTIC DIRECTOR IS REALLY LOOKING INTO IT.

BUT IN TERMS OF THE OVERALL VISION FOR HIGH SCHOOL REDESIGN, IT'S A HUGE PIECE OF WHAT I WANT TO HAVE AS PART OF THE HIGH SCHOOL REDESIGN OF THE SEVEN HIGH SCHOOLS AND PART OF THIS SECOND BUDGET, THE SECOND YEAR OF THIS BUDGET YOU CAN EXPECT ME TO BE BRINGING FORWARD SOME AT SOME@LETTIC INVESTMENTS. BECAUSE ATHLETICS IS GOOD FOR THE MIND AND SOUL AND YOU HAVE TO BE COLLEGE READY AND IT ALSO GIVES YOU A GOOD STRONG PEER GROUP IN WHICH TO BE HELD ACCOUNTABLE TO AND TO HOLD YOURSELF ACCOUNTABLE TO IN TERMS OF THE LEARNING AND IN TERMS OF THE EXPECTATIONS FOR BEHAVIOR IN SCHOOL AND WITHIN YOUR COMMUNITY AS A ROLE MODEL AND AS A STUDENT ATHLETE. SO I THINK IT'S ROLE REALLY IMPORTANT TO WELL ROUNDED EDUCATION. >> THANK YOU SUPERINTENDENT. THAT'S ALL I HAVE. I APPRECIATE YOUR COMMENTS, SUPERINTENDENT. THANK YOU. THANK YOU COUNCILOR BOK. >> THANKS SO MUCH, COUNCILOR FLYNN. ALL RIGHT NEXT UP IS COUNCILOR MAHI CRAW. >> COULD I SAY ONE MORE THING TO

COUNCILOR FLYNN.

IT'S THE SAME THING FOR -- I'M SORRY START THE CLOCK OVER. IT'S FOR CO-CURRICULUM AND PERFORMING ARTS AS WELL. I HAVE YOWSH YOU SEE THE PORTRAITS IN THE BACK WITH MY DAUGHTER IN THE MIDDLE AND HER TWO BROTHERS ON THE SIDE SHE DID THAT WORK AND ALL THREE OF MY CHILDREN ARE ARTISTS AND SO IT'S **REALLY IMPORTANT FOR FAMILIES TO** HAVE THEIR CHILDREN GET A WELL ROUNDED EDUCATION. >> I APPRECIATE THOSE COMMENTS, SUPERINTENDENT. WHEN I WAS YOUNG, WE WEREN'T EXPOSED ALL THAT MUCH INTO MUSIC OR THE ARTS BUT THAT'S WHAT MY WIFE AND I ARE TRYING TO DO WITH OUR KIDS. I ESPECIALLY LOVE SEEK THE BPS KIDS ENGAGED IN THE MUSIC PROGRAM OR ARTS PROGRAM AT VARIOUS SCHOOLS. THAT PLAYS A KEY ROLE SO THANK YOU TO THE BPS TEAM FOR DOING INCREDIBLE WORK IN THE ARTS AND MUSIC AND CULTURAL AS WELL. >> THANK YOU SO MUCH COUNCILOR FLYNN AND SUPERINTENDENT. COUNCILOR MEJIA. >> SO I DON'T KNOW WHAT [INDISCERNIBLE] BUT WHEN I WAS IN SCHOOL, I HAD A [INDISCERNIBLE] I HAD IT ALL. AND I STILL STRUGGLED BUT AT LEAST WE HAD THINGS AND THIS IS WHY THIS CONVERSATION IS MAKING ME SAD THAT EVERY YEAR OUR SCHOOLS GET STRIND AWAY FROM ALL OF THE RESOURCES AND WE EXPECT TEACHERS TO DO MORE WITH LESS. AND THEN WE'RE NOT PROVIDING OUR CHILDREN WITH A FULL ROUNDED, FULL CHILD EDUCATIONAL EXPERIENCE. IT MAKES ME REALLY SAD TO KNOW THAT HERE I AM A CITY COUNCILOR TODAY AND I FEEL LIKE I HAVE AN OF A RESPONSIBILITY AND AN **OPPORTUNITY TO REALLY MOVE THIS** CONVERSATION FORWARD. SO I RECOGNIZE THE RESPONSIBILITY THAT I HAVE.

SO I HOPE YOU KNOW THESE QUESTIONS COME FROM A PLACE OF KNOWING THAT YOU ARE TRYING REALLY HARD, DOCTOR, AND I KNOW YOU HAVE INHERITED, YOU KNOW, IT WAS PASSED DOWN TO YOU. SO IN.

WAYS YOU WERE TRYING TO WORK WITH WHAT YOU HAVE AND FIX THIS AND TRYING TO RIGHT A WRONG AND I DO APPRECIATE ALL OF IT. I HAVE SOME QUESTIONS GOING BACK TO THE CHOICE CONVERSATION AND I WANT TO CONTINUE ON MY PREVIOUS POINT ABOUT SCHOOL CHOICE. THERE SEEMS TO BE NOT JUST FEWER HIGH QUALITY SEATS FOR THE CHOICE LIST BUT BLACK AND BROWN STUDENTS AS WELL AS IN LOW INCOME NEIGHBORHOODS BUT THEY TEND TO BE SMALLER SIZE. THEY HAVE FEWER SEATS AVAILABLE. SO I'M JUST CURIOUS TO CONTINUE ON COUNCILOR CAMPBELLED PREVIOUS OUESTION. YOU MENTIONED THAT THERE WOULD **BE SOMETHING IN MACE TO ADJUST** THE ISSUES OF SEATS. CAN YOU TALK ABOUT WHAT THE OUTREACH WILL LOOK LIKE AND HOW WE ARE INVOLVING THE COMMUNITY ON THAT PROCESS. >> SO I THINK THAT MR. COOTER CAN PROBABLY TALK REALLY WELL ABOUT THE QUESTIONS THAT YOU JUST RAISED IN TERMS OF THE SMALL SCHOOLS AND THE INEQUALITIES WE SEE IN OUR SMALL SCHOOLS ESPECIALLY WHERE THEY ARE POWKSED WITHIN THE CITY AND HE'S TALKED ABOUT THAT AT HEARINGS BEFORE. BUT IN TERMS OF THE PROCESS I'M SURE IT WILL BE WHERE I ENGAGE WITH THE COMMUNITY SUM HER WITH WHAT I DID WITH THE STRATEGIC PLANNING PROCESS AND WHAT WE WERE DOING WITH JACKSON MANN HAVING COMMUNITY MEETINGS AND STAFF AND FACULTY MEETING WITH THE PARENT COUNCIL, THOSE DIFFERENT GROUPS. WE WERE DOING SURVEYS AS WELL AROUND PROPOSALS AND GETTING A

CONSENSUS AND BUILDING CONSENSUS AROUND STRATEGIES WITHIN THOSE SCHOOL.

THAT'S THE PROCESS I WOULD LIKE TO TAKE IN TERMS OF THE COMMUNITY AND HOW THOSE SCHOOLS ARE WITHIN THOSE COMMUNITIES. DO YOU WANT TO DOCK A BIT &BOUT OR SMALL SCHOOLS AND THE DEMOGRAPHICS AND HOW THAT SHOWS UP?

>> YES.

ONE OF THE THINGS AND IT'S SO INTERCONNECTED ON A NUMBER OF DIFFERENT FACTORS THE STUDENT TIMING SYSTEM SCHOOL SIZE. WE ALREADY MENTIONED THAT BEING IN ROUND ONE IS AN IMPORTANT ROUND FOR YOU TO HAVE ACCESS TO QUALITY SCHOOLS .

WE KNOW THAT ROUND ONE TENDS TO BE MORE DEMOGRAPHICALLY SKEWED IN ONE DIRECTION WITH STUDENTS OF NEEDS.

IN SMALL SCHOOLS THEY FILL UP IN ROUND ONE.

>> WAIT.

IF HE WITH A KNOW THAT TO BE THE CASE BECAUSE I'VE WORKED ON THESE PLACES AND I DO KNOW THAT PARENTS WERE MORE HIVE ME ENGAGED WERE THE ONES THAT AWE MAY AROUND ONE.

IF WE KNOW THAT IS THE TREND, IS THIS A WAY KNOWING THAT WE ARE TRYING TO RIGHT THE WRONG. CAN WE ADDRESS THAT, ROUND ONE ROUND TWO.

I'M JUST CURIOUS.

>> FOR CHANGES TO THE STUDENT TIME AND PLAN WHERE AS PART OF BEFORE WE CAME WITH THE PLAN THE STUDENTS ASKED TO DO EQUITY IN REFERENCE A COUPLE TIMES IN THIS HEARING.

AS A FOLLOW-UP WE DID MAKE A COMEAL CHANGES PARTICULARLY AROUND THE SIXTH GRADE ACCESS ISSUE.

AND SO WE HAVE PLANS TO [INDISCERNIBLE] THE SUPERINTENDENT MENTIONED THE EQUITY OFFICE AND DO ANOTHER, TEST ANOTHER AND THEN PROVIDE PROPOSALS. THERE WILL BE BUILDING UPON QUALITY SCHOOLS AND EXPANDING THOSE QUALITY SCHOOLS. >> COULD YOU GIVE ME A TIME LINE FOR THAT. I'M JUST CURIOUS BECAUSE WHAT I'M HEARING AND WHAT I'VE BEEN SEEING THERE'S AN ASSESSMENT, THERE'S A STUDY, A SURVEY. THERE'S A LOT OF THINGS THAT HAPPEN BEFORE WE MAKE A DECISION BUT TRYING TO FIND OUT IN TERMS OF THE TIME LINE. ARE WE LOOKING AT THE NEXT YEAR IN TERMS OF IMPROVING THE SCENARIO. AT WHAT POINT ARE WE GOING TO START SEEING SOME OF THE OUT COMES OF ALL THESE STUDIES. >> LET ME JUST QUICK ME SAY THAT ONE THE BUILD BPA QUESTION IS WE NEED TO FIRST START THAT PROCESS GOING WITH THE COMMUNITY AND GET THOSE PATHWAYS SOLID. THE SECOND PIECE I SHARED EARLIER IN THE EARLIER HEARING IS REALLY UNDERSTANDING EL SEATS, UNDERSTANDING OUR SPECIAL ED SEATS AS PART OF THE PROGRAMMING ACROSS THE CITY AND THEN ALSO OUR HIGH SCHOOL REDESIGN. ALL OF THAT IS GOING TO HAPPEN NEXT YEAR. THEN WE NEED TO BE LOOKING OKAY AFTER WE'VE DONE THAT IN THE COMMUNITY ENGAGEMENT HOW DOES CHOICE FIT INTO THAT NOW. >> WHAT ARE WE LOOKING AT. WHEN A PARENT ASKS ME AT WHAT POINT AM I GOING TO BE ABLE TO CHOOSE A QUALITY SCHOOL IN MY NEIGHBORHOOD. IS IT GOING TO HAPPEN IN THE NEXT TWO YEARS, NEXT THEY YEARS? HELP ME UNDERSTAND HOW I CAN **REPLY TO SOMEONE ABOUT THEIR** EXPECTATIONS. >> YES, THAT'S GOOD. NEXT YEAR IS A PLANNING YEAR FOR US AND ALL OF THOSE PIECES AND WE'LL BE IMPLEMENTING AS WE GO ALONG IF WE CAN FIND SOMETHING

WITH SPECIAL ED TO FIX WE'LL FIX IT.

IF YOU FIND SOMETHING WITH EL, WE HAVE OUR BILINGUAL AND DUAL LANGUAGE PROGRAM AND WE'LL BE BUILDING.

THIS IS A FIVE YEAR STRATEGIC PLAN AND OVER THESE NEXT FIVE YEARS WE NEED THESE INVESTMENTS, THE HUNDRED MILLION DOLLARS THAT THE MAYOR HAS COMMITTED IN ORDER TO ROLL OUT THIS PROCESS. FIRST YEAR IS TO FOCUS ON THE 33 DIFFERENT PERFORMING SCHOOLS. THOSE ARE IN EVERY NEIGHBORHOOD THEY TOUCH JUST ABOUT EVERY NEIGHBORHOOD AND THEN WE HAVE THE HIGH SCHOOL AND THE MIDDLE SCHOOL REFORM THAT WILL BE HAPPENING YEAR TWO.

THAT WILL ROLE OUT AND THEN YEAR THREE WILL TAKE THE NEXT SET OF SCHOOLS.

>> [INDISCERNIBLE] IN EVERY NEIGHBORHOOD.

>> WHAT IS HAPPENING IN THE MEANTIME FOR STUDENTS SITTING IN

THESE CHAS ROOMS.

>> YOWSH ELEMENTS, WE HAVE THE LITERACY INITIATIVE.

WE HAVE THE SIX EXPANSIONS WORE DOING IN THE 16 SCWOLZ. WE HAVE THE CAPITAL IMPROVEMENT WE'RE DOING NOW IN THE PHYSICAL

SPACE AND AUDITS THAT WE'RE TO GO.

ALL OF THAT IS HAPPENING RIOT NOW TO IMPROVE THE EDUCATION FOR THE CHILDREN.

>> I'LL LET EVERYBODY KNOW T. >> THANK YOU COUNCILOR MEJIA. I'M GOING TO DO MY SECOND ROUND QUESTIONS AND THEN I'M ONLY GOING TO DO BURNING QUESTIONS. IF ANYONE HAS A BURNING QUESTION, RAISE YOUR BLUE HAND OTHERWISE WE'LL WRAP UP. I THOUGHT I SHOULD ASK A FEW QUESTIONS ABOUT THE [INDISCERNIBLE] FUNDS WHEN WIRE ALSO LOOKING AT RIGHT NOW. SO ONE QUESTION IS JUST WE'RE DOUBLING THE MAXIMUM AUTHORIZATION TO TWO MILLION FOR THE TECHNOLOGY FUND. CAN YOU SPEAK TO WHAT [INDISCERNIBLE] IT JUST SEEMS THESE VARIABLE LIKE IN FY19 ARE WE'RE DEALING WITH A MILLION DOLLARS AND LAST YEAR IT WAS A HUNDRED THOUSAND. CAN YOU ARE JUST SPEAK TO THAT. >> WE HAVE TECHNOLOGY WITH ALL OF THE ACCOUNTS TO DO THE SALES OF OUR TEACHER [INDISCERNIBLE]. WE BUY NEW TEACHER LAPTOPS EVERY THREE TO FOUR YEARS DEPENDING ON THE MARKET AND WHAT THE DEVICES ARE DOING AND THINGS LIKE THAT. BECAUSE WE'RE PRESSURE SO QUICKLY, THE DEVICES STILL HAVE A FAIR AMOUNT OF VALUE WHEN WE SELL THEM. LET'S WITH A GOES INTO THE **REVOLVING ACCOUNT USED TO PAY** FOR SOME OF THE DEVOICES. WE ARE JUST EXPECTING THE VALUES TO BE HIGHER THE NEXT TIME WE DO A SALE WHICH WHICH WE MIGHT DO AT THE END OF NEXT YEAR SO WE NEED THE REVOLVING TO HAVE A HIGHER LIMIT IN CASE WE DO IT AT THE END OF NEXT YEAR OR IT MIGHT PEA AT THE START OF THE YEAR. THEND OF FY21 STARTED FY22. THIS INCREASE WILL HAVE US PRESENTED TO TAKE ADDITIONAL MONEY FROM THE SALE OF THOSE FUNDS. >> GOT IT. IT LOOKS LIKE THERE'S A DECREASE IN THE FACILITIES REVOLVING BOTH IN TERMS OF THIS YEAR AND EFFECTIVE FOR NEXT YEAR. IS THAT REFLECTING COVID OR **REFLECTING SOMETHING ELSE?** >> SO, I WILL DOUBLE CHECK TO CONTERM. I THINK OUR INTENTION WAS IN TERMS OF THE AUTHORIZATION AMOUNT, WE'LL LEAVE THAT. WE ARE SEEING A DECREASE IN **REVENUES THIS YEAR RELATED TO** COVID BECAUSE THE MAIN SOURCE OF **REVENUE FOR OUR FACILITIES IS** RENTAL AND LEASE THE DISTRICT **BUILDING FOR EVENTS.** AND SO OBVIOUSLY WE'RE SEEING A

DECREASE THERE. IN REVENUE AND THAT WILL PROBABLY CONTINUE INTO FY21 AS THINGS CONTINUE AND WE HAVE YOWSH. BUT THERE ARE DECREASE EXPENDITURES ALONG WITH THOSE DECREASE REVENUES T. >> COULD YOU SPEAK TO -- IT LOOKS LIKE THE TRANSPORTATION ONE MIGHT BE RUNNING A DEFICIT. ONE OF THE THINGS OF REVOLVING FUNDS TO REALLY DO. >> YES. I WAS CHECKING INTO THAT AS WELL. THE ISSUE I BELIEVE WITH THE TRANSPORTATION REVOLVING FUNDS IS THAT WE CAN [INDISCERNIBLE] AROUND TIMING OF SPENDING IN FY19. IT'S NOT ACTUALLY -- WE ARE SPENDING MORE THAN WE RECEIVE BUT IT IS NOT CREATING A DEFICIT IN THE REVOLVING ACCOUNT. >> I WOULD JUST SUGGEST FOR THE FUTURE THAT IT WOULD BE GOOD FOR THE COUNCIL WHEN WE GET INFORMATION TO GET THE FULL AMOUNT SITTING IN THE REVOLVING FUND IF IT'S GOING TO BE USED AS A BALANCE OR WITHDRAWING. IT LOOKS LIKE AN ANTICIPATED EXPENDITURE FOR NEXT YEAR THAT'S ALSO LIKE 330,000 BUT ONLY RECEIVE A HUNDRED THOUSAND. JUST SEND OUT A BALANCE. >> LEFT ME CONFIRM THAT. I BELIEVE SO. **OUR INTENTION IS NOT -- OUR PROJECTION IS NOT TO** [INDISCERNIBLE]. >> OKAY, GREAT. WE WOULD LOVE SOME FOLLOW UP. SOME MORE CAPITAL QUESTIONS. I KNOW THERE'S A LOT OF EXPENSE ABOUT WHETHER OR NOT THE BOSTON ARTS ACADEMY WILL BE READY FOR SEPTEMBER OF 2021 GIVEN THE CONSTRUCTION COSTS. THAT'S A BIG QUESTION MARK AND NOW THAT WE CERTAIN OF STARTING CONSTRUCTION UP AGAIN I GUESS MY **QUESTION WOULD BE IF YOU OR**

ANYBODY HAD INFORMATION ABOUT DOES IT LOOK LIKE WE'RE EVEN STARTING CONSTRUCTION EVEN NOW, WE HAVE THE PROCESS SPECT OF FULFILLING THAT DEAD LINE OR NOT? >> I THINK IN THE SINCE PLUS CASE THE SHUT DOWN DID PUT A TIME LINE AT RISK. WE ARE EVALUATING WAYS TO OPEN IN THAT SCHOOL YEAR BUT THAT WE'RE UNLIKELY TO BE ABLE TO OPEN IT FOR THE FALL OF THAT YEAR. THAT'S SOMETHING THAT'S BEING WORKED ON SO WE KNOW THE TIME LINE TO BEGIN CONSTRUCTION AGAIN. WE CAN GET A MORE ACCURATIAN DATE ABOUT WHEN THE -- ACCURATE DATE WHEN IT WILL BE FINISHED. >> THE BAD SCENARIO WHICH WE KNOW IS NOT THE CASE IS THE SUBSTANTIAL AMOUNT OF THE FALL SEMESTER THAT HAS TO BE CAUGHT REMOTELY. IT SEEMS LIKE IF THAT HAPPENS THE OPPORTUNITY TO ACCELERATE THE CAPITAL WORK IN OUR SCHOOL **BUILDINGS WOULD BE POTENTIAL** SILVER LINING AND ESPECIALLY GIVEN THE NUMBER OF SORT OF SMALLER PROJECTS THAT THE SUPERINTENDENT HAS ADDED TO THE CUE. CUE -- QUEUE. LIKE THE CAPITAL MONEY THERE'S A LOT OF MOVES TO MAKE IN ORDER TO HOCKEY THAT POSSIBLE. I WONDER IF YOU STARTED TO PUT THINGS IN MOTION IN CASE OF EVENTUALITY. >> THE FIRST THING WE STARTED TO DO IS ACCELERATE PROJECTS WE WERE THINKING ABOUT DOING POTENTIALLY AS A MULTIPLE SUMMER TO TRY TO GET MORE OF THEM DONE THIS SUMMER. THE BIG ONES ARE BATHROOM PROJECTS, REALLY ACCELERATING THAT SO WE'RE STARTING WITH THE PROJECT WE HAD IN THE QUEUE TO DO THIS SUMMER AND THEN MOVING THEM UP AND DOING THE FIRST

WHILE WE SCOPE OUT THE PROJECTS FOR FUTURE CAFE TO ACCELERATE THOSE KITCHEN PROJECTS DONE. AS BOTH A PARENT AND SOMEBODY WHO IS ADMINISTERING IN BPS I REALLY DON'T WANT TO THINK ABOUT THE IDEA WE WOULD HAVE MORE TIME IN THE FALL BUT I CAN SAY BOTH [INDISCERNIBLE] PUBLIC FACILITIES SIDE AND OUR TEAM HAS ALL BEEN LOOKING AT WAYS TO LEVERAGE THIS TIME SO THAT WHEN STUDENTS COME BACK THEY'RE COMING BACK TO BUILDINGS THAT UPGRADED AND CLEANER AND YOU KNOW TO NOT WASTE THE SORT OF **OPPORTUNITY WITH THE BUILDINGS** BEING EMPTY ALL SUMMER. WE ARE OPERATING SUMMER PROGRAMS WHICH IS DIFFICULT FOR US TO GET THESE PROJECTS DONE. WE'RE RUNNING FULL SPEED ON THAT. >> SPECIFICALLY IT'S A VERY TECHNICAL SMALL THING BUT WITH THAT, I IF YOU THERE'S BEEN SOME QUESTION ABOUT SOME OF THEM NOT HAVING ACCESS TO HOT WATER AND WITH THE HAND WASHING HAS ALWAYS BEEN IMPORTANT BUT IT IS IMPORTANT NOW ASK OBVIOUSLY HOT WATER IS PREFERRABLE FOR THAT PURPOSE. IS THAT IN PEOPLE'S HEAD SPACE. >> ABSOLUTELY. NOT JUST ABOUT THE PROCESS IN THE BATHROOMS BUT THINKING ABOUT **EXTENDING ACCESS TO WASHING** ADMINISTRATES IN THE BUILDINGS AND EXPANDING ACCESS TO MY [INDISCERNIBLE] >> SANITIZING STATIONS. >> THANK YOU. HAND SANITIZING STATIONS AS WELL. SO I KNOW THAT'S SOMETHING THAT WE'RE CONSIDERING AND LOOKING INTO COST IMMA CASES, MAKING THEM AVAILABLE FOR STUDENTS. >> ONE QUICK QUESTION AND IT'S ATHLETIC SO IT'S KIND OF THE LAST ONE. IT DOES SEEM SUPERINTENDENT YOU'RE REFERENCING TO MEET

[INDISCERNIBLE] WE DON'T HAVE FACILITIES FOR OUR SCHOOLS AND LOOKING HOW TO DO THAT CREATIVELY. IT SEEMS LIKE AGAIN I'M SEARCHING FOR SILVER LIKING HERE IN A HARD SITUATION. IT SEEMS LIKE THIS MIGHT BE A YEAR WHERE WE NEED TO PIONEER AND DO MORE P.E. ACTIVITIES OUTDOORS JUST IN AGAIN GIVEN WHAT WE KNOW ABOUT THE DISEASE. I WONDER IF THESE AN OPPORTUNITY TO WORK CREATIVELY HOW WE HAVE OUTDOOR PHYSICAL EDUCATION. >> ABSOLUTELY. OUTDOOR, ON-LINE, HOWEVER WE CAN DO IT BECAUSE IT'S REALLY IMPORTANT TO OUR CHILDREN'S HEALTH AND WELL BEING. >> GREAT. AND THEN ONE THING TO START GOING BACK ON THE QUESTION I WAS ASKING ABOUT THE CAPITAL PLAN AND THE QUESTION OF LIKE WHERE THERE ARE GAPS. THE SAME REPORT THAT COUNCIL PRESIDENT JANEY HAS BEEN REVVING TO RIGHT IS ONE OF THE PLACES THAT SHOWS YOU THAT KIND OF FENWAY UPPER BACK BAY IS ONE OF THE HOLES IN THE CITY WHERE YOU'VE GOT GREATEST [INDISCERNIBLE] I JUST WONDER LIKE, I WOULD LOVE TO BE A PART OF THE CONVERSATION BUT ALSO I JUST WONDER WHAT BPS'S APPETITE UNDER YOUR LEADERSHIP, SUPERINTENDENT, IS FOR IF THERE'S A BIG PUBLIC OR PRIVATE PARCEL THAT'S KIND OF YOU KNOW PART OF A PUBLIC PRIVATE CONVERSATION. I THINK IF MY DISTRICT THERE ARE CONVERSATIONS HAPPENING ABOUT THE HINES ABOUT THE HURLY BUILDING. AND OBVIOUSLY EXACTLY IT ALL TOUCHED ON THE CONVERSATIONS WHEN IT'S UP IN THE YEAR BECAUSE OF COVID. I JUST WONDER WHETHER THERE'S AN APPETITE ON THE BPS SIDE. THERE DUFLTLY IS IN EYE DISTRICT TO

KIND OF LOOK AT THE OPPORTUNITY FOR PARTNERSHIPS TO GET TIGHT IN MANY SOME OF THOSE HOLES. >> YES, THERE IS, ACTUALLY. WE'RE ALWAYS LOOKING FOR **OPPORTUNITIES.** THIS IS TRUE IN THE MATTAPAN AREA AS WELL I THINK CHAS COUNCILOR CAMPBELL'S -- I THINK WHICH IS COUNCILOR CAMPBELL'S AREA. THIS IS TO FIND ONE INY NEIGHBORHOOD AND EFFICIENCY IN SPACE AS WELL. >> GREAT. I LOOK FORWARD TO BEING A PARTNER ON THAT FRONT. NOW I'M JUST GOING, I'M JUST GOING TO SCAN TO SEE. COUNCILOR CAMPBELL JUST CAME BACK ON. I SEE A PHYSICAL HAND RAISED SO I WILL CUT TO HER. >> I CAN'T FIND THE BLUE HAND. I JUST HAVE ONE QUICK QUESTION AND THIS IS AND MAYBE I MISSED IT. THE REMOTE LEARNING DATA DASHBOARD. WHEN IS THE PLAN TO RELEASE THAT AND WHEN DOES THAT GO ON-LINE. WHEN DOES THAT COME UP AND THANK YOU YOU GUYS FOR THE ROBUST CONVERSATION TODAY. >> YES, I APPRECIATE THAT QUESTION, COUNCILOR. AS YOU KNOW, WE'VE BEEN WORKING ON GETTING A NEW DATA SYSTEM AND MY GRAFTING THE NEW SIST FULL --AND MIGRATING THE NEW SYSTEM. WE ARE COUNTING THOSE AND I KNOW THEY WROTE A LETTER TO YOU. THERE IS -->> I DON'T KNOW IF THERE WAS A LETTER BUT ANYWAY. I'M JUST SAYING THAT. >> OKAY.WELL I KNOW WE ARE ADDING TEACHERS ON THE DATA INTEGRITY SIDE BECAUSE OBVIOUSLY THEY HAVE MULTIPLE MODES FOR HOW THEY ARE CONTACTING FAMILIES AND ENGAGING STUDENTS ON PAPER BASE AND PROJECT BASE AND ON-LINE AND

ASYNCHRONOUSLY. I HAVE TO SAY QUITE HONESTLY I JUST LEARNED ABOUT SYNCHRONOUS AND ASYNCHRONOUS LEARNING BEFORE COVID THE WAY I KNOW ABOUT IT NOW. WE ARE BEING CLOSE TO RELEASE THAT, TALKING TO RELEASING DATA TO OUR EQUITY ROUND TABLE AND OUR FOOD DISTRIBUTION AND OUR HOME DISTRIBUTION AND WI-FI DISTRIBUTION. BUT NOW WITH THE REMOTE LEARNING WE'LL HAVE THAT HONEFULLY AVAILABLE WITHIN THE NEXT WEEK OR SO TO BE ABLE TO PROVIDE SOME DATA TO THE PUBLIC AND TO THE COUNCILORS I KNOW YOU'VE BEEN **REQUESTING IT.** SO WE'LL HAVE THAT. WE DIDN'T START TAKING ATTENDANCE UNTIL MAY 4TH AND SO WE HAVE TEACHERS TENANTS AND DO YOU WANT TENANTS AS WELL. >> IT'S NOT MY JOB TO MAKE IT HARDER. IT'S TO WORK IN PART SHINE WITH YOU. THANK YOU FOR THE LONG HEARING AND PARTICIPATING ALL DAY. THANK YOU COUNCILOR BOK. >> ONE OTHER PIECE TO THAT TOO, WE HAVE BEEN PROVIDING DATA THE OUR SCHOOL LEADERS AND EOUITY ROUND TABLE THAT COUNCILOR EDWARDS TALKED ABOUT. SO AWE TENDING THOSE MEETINGS IS REALLY A GREAT WAY TO REALLY GET TO THE GRANULAR LEVEL OF HOW WE CAN ACTUALLY PROBLEM SOLVE THAT SCHOOL WITH SCHOOL LEADERS AND TEACHERS AT THOSE SCHOOLS. >> WHAT WOULD BE HELPFUL IS SOMETIMES OUR SCHEDULES DON'T ALLOW US TO PARTICIPATE IN SOME OF THOSE MEETINGS. SOME OF MY SCHOOLS ARE DOING GREAT JOBS. I'LL JOIN ONE TOMORROW AND I HAVE TO LEAVE THE BUDGET MEETING EARLY TO DO THAT. IF IT CAN COME TO ALL OF US IT WOULD BE HELPFUL BUT SOMETIMES IT'S REALLY DIFFICULT.

I APPRECIATE OF THE ROUNDTABLE SCEKSZ AS WELL AND MY [INDISCERNIBLE] ALSO JOINED. SO THANKS TO YOU GOES AND STAY HEALTHY. >> THANK YOU SO MUCH COUNCILOR CAMPBELL. I'M SORRY I HAVE ONE MORE LITTLE **QUESTION WHICH IS JUST ON** LIBRARIES. I KNOW WE HAD A LIBRARY STRATEGIC PLAN I THINK WE'RE STILL TECHNICALLY IN ITS WINDOW BUT IS THERE A NEW LIBRARY STRATEGIC PLAN COMING DOWN THE PIKE AND IS THERE A MAP OF KIND OF WHAT OUR RELATIVE LIBRARY PROVISIONS IN TERMS OF THE CAPITAL SIDE LIKE WHOSE GOT A BOOK, WHOSE GOT A CART, WHO HAS A PROPER LIBRARY THAT JUST NEEDS STAFFING. DOES THAT EXIST AND IS THAT PART OF THE CAPITAL PLANNING **CONVERSATION?** >> SO I GOT TO SAY MY PHILOSOPHY IS A LIBRARIAN IN EVERY SCHOOL. I CRUDE TO SUPERVISE THE LIBRARIANS WHEN I WAS IN EDUCATION AND I HAVE A HEALTHY **RESPECT FOR LIBRARIANS AND THE** ROLE THEY PLAY IN THE SCHOOLS AND COMMUNITY. I LOOKED TO DAVID LEONARD TO SEE HOW WE COULD WORK MORE CLOSELY WITH THE BOSTON PUBLIC LIBRARY. HIS FACILITIES ARE BEING RENOVATED ALSO ASK TYING THAT INTO THE WORK AND HOW WE ARE CONNECTING THEM TO OUR SCHOOLS AND OUR SCHOOL LIBRARIES AS WELL. >> THAT'S GREAT. LIBRARIES AND IT'S EASY FOR PEOPLE TO SEE IF IT'S PART OF THE TRANSPARENCY WE WANT TO BRING. >> YES, I THINK THAT'S IMPORTANT FOR LIBRARIES. I DO THINK ON THE PARTNERSHIP'S FRONT ESPECIALLY THE [INDISCERNIBLE] IN MY DISTRICT MAKES USE OF THE CENTRAL BRANCH LIBRARY AS KIND OF THE HOME BASE AND THAT'S A REALLY GREAT PARTNERSHIP AND ANY OPPORTUNITY FOR [INDISCERNIBLE] I THINK AS A KID HAVING A LIBRARY YOU CAN WALK AROUND A CORNER TO DOWN THE HALLWAY IN YOUR SCHOOL MEANS A LOT. ALL RIGHT T TO TAKE PUBLIC TESTIMONY I DON'T SEE ANYONE IN THE ZOOM. IF YOU WANT TO TESTIFY YOU CAN SEND IT TO BOSTON.GOV OUR STATE BUDGET WEBSITE FOR YOUR PUBLIC TESTIMONY THAT WAY. I WANT TO THANK THE BPS TEAM FOR ANOTHER MARATHON DAY AND TO SAY THAT WE'LL BE SEEING YOU MORE SHORTLY THAN LAST TIME. NOW I THINK WE'RE SEEING EACH OTHER AGAIN NEXT WEEK AND LOOKING FORWARD TO THAT AND REALLY APPRECIATE YOU ALL AND
