**Proposed Work:** At Front and side elevations replace wood sidewall shingles in kind, construct a 2 ½ floor addition at rear of structure.

Commission staff will accordingly authorize the execution of the work, attaching any applicable provisos, reflecting the relevant quidelines and precedents.

The applicant is required to notify the commission of any project changes; failure to do so may affect the status of the approval.
