Brograamka Hagaajinta Guriga Waayeelka ee Xarunta Guriga Boston wuxuu adeegyada hagaajinta guriga siiyaa milkiileyaasha guriga wayeelka, kuwa daggan Boston, ee dakhli ahaan xaq u yeesha. Brograamka Waaxda Horumarinta Xaafadda (Department of Neighborhood Development) (DND), waxay bixisaa deyn gadaal loo dhigo si loo kaalmeeyo waayeelka, dakhli ahaan, xaq u yeesha, ee daggan hantida guryaha 1-4, lagana helo maaliyadda Deeqda Horumarinta Bulshada (Community Development Block Grant funds) ay bixiso Waaxda Guriyeynta iyo Horumarinta Magaalada Mareykanka (U.S. Department of Housing and Urban Development) (HUD) lana siiyo Magaalada Boston. Waa in la saxiixo kashifaaddaan waqtiga arjiga; waxaa la saxiixi doonaa warqadda Qodobada iyo Sharuudaha (Terms and Conditions) waqtiga ballanka maalgelinta. Brograamkaan wuxuu hoos yimaadaa hadba sida loo helo maalgelin.

- C. Aniga waxaan fahamsanahay in bacdamaa aan ahay Qaataha brograamka, waxaan u hoggaansami doonaa tilmaamaha iyo sharciyada la xariira guryaha iyo dagmooyinka ku qoran Diiwaanka Meelaha Taariikhda Leh ee Qaranka (National Register of Historic Places) ama Guddiga Taariikhda Gobolka (State Historical Commission) ama Guddiga Astaamaha Magaalada Boston ku tilmaantay in ay yahiin Astaanta Dhulka (Land Mark District). U-hoggaansami la'aanta waxay dhallin doontaa xaq u yeelasho la'aanta qeybtaas shaqada loo rabo kaalmo.
- D. Aniga waxaan fahamsanahay in bacdamaa aan ahay Qaataha brograamka, in aan u baahan doono in aan fiiriyo iyo in aan ogolaado Tafaasiisha Hore Fullinta Hawsha (Preliminary Specifications) iyo qiyaasta Kharashka ka hor inta qandaraasleyaasha aan laga codsanin in ay soo gudbiyaan qiyaastooda kharashka ku baxa.
- E. Aniga waxaan fahamsanahay in bacdamaa aan ahay Qaataha brograamka, in aan ruqsad ku bixin doono in la fattasho shaqada lagu fullin doono waqtiga iyo taariikhda ay ku heshiyeen qandaraasleyaasha/tartameyaasha suurtoogalka ah.
