The subject of the hearing is:

***Docket #01075- Order for a hearing regarding the review of Curriculum Standards and Resources in the Boston Public Schools. Docket #1076 - Order for a hearing regarding the Implementation of an Ethnic Studies Curriculum in the Boston Public Schools.***

These matters were sponsored by Councilors Annessa Essaibi-George and Kim Janey, and referred to the Committee on October 28, 2020.
