

**BAYAANKA LOOGU TALOGALAY XARUMAHA KANTAROOKKA  
IYO KA-HORTAGGA  
KU MEEL GAARKA AH JOOJIYAAN KA-SAARIDDA GURIGA SI LOOGA  
HORTAGO IN CUDURKA COVID-19 UUSAN SII FAAFIN.**

Bayaankaan waxaa loogu talagalay dagganeyaasha, kiresteyaasha, ama dagganeyaasha hantida hoos timaado ammarka CDC in si ku meel gaar ah looga joojiyo ka-saaridda guryaha (kuma jiraan xaraashka guryaha deynta) si looga hortago in COVID-19 uusan sii faafin. Sida hoos timaado ammarka CDC, waa in aad koobiga bayaankaan siisid milkiilaha hantida, milkiilaha hantida meesha aad daggan tahay, ama qof kale oo awood u leh in lagaa saaro guriga ama lagaa barakiciyo meesha aad daggan tahay. Qaangaar kasta oo ku qoran heshiiska muddada dheer, heshiiska muddada gaaban, ama heshiiska guriyeynta waa in uu buuxiyo bayaankaan. Haddii ammarka CDC aan la fidinin, ama la soo afjarin, ammarka wuxuu adiga kaa celinaa in lagaa saaro guriga ama in lagaa barakiciyo meesha aad daggan tahay ilaa laga gaaro Juunyo 30, 2021. Weli waxaa lagaa rabaa in aad bixisid kirada iyo in aad raacdid dhamaan qodobada kale heshiiska kirada iyo sharciyada ka jira meesha aad daggan tahay. Waxaa kaloo dhici karto in weli guriga lagaaga saaro asbaab ka duwan bixin la'aanta kirada ama bixin la'aanta kharashka guriga.

Aniga waxaan caddeynaa in wararka la soo sheegay yahiin run iyo sax taasoo hoos timaada ciqaabta been abuurka:

- Haddii leyga saaro guriga, waxay u badan tahay in Aniga aan noqdo guri laawe, in aan u baahdo in aan u guuro hooyga guri laaweyaasha, ama in aan u guuro guri cusub aan la wadaago dad kale oo daggan guri cariiri ah maxaa yeeay ma heli kari guri kale aan daggi karo.
- Aniga waxaan filaa in aan shaqeysto xisaab aan ka badneen \$99,000 oo ah dakhliga Sannadka Kalendarka 2020 (ama xisaab aan ka badneen \$198,000 haddii aan si wadajir u soo gudbino canshuur celinta), leyga rabin in aan dakhligeyga u sheego Adeegga Aruurinta Gudaha (Internal Revenue Service) ee Mareykanka, ama aan qaatay Lacagta Saamaynta Dhaqaalaha (Economic Impact Payment loona yaqaan jeegga kicinta dhaqaalaha) sida waafaqsan Qeybta 2201 Sharciiga CARES (Section 2201 of the CARES Act);
- Aniga waxaan sida ugu fiican ku dadaalay in aan helo dhamaan kaalmada dawladda ku bixiso kirada ama guriyeynta;
- Aniga ma awoodo in aan bixiyo kirada oo idil ama ma awoodo in aan bixiyo kharashka guriga oo buuxa taasoo ugu wacan in aan lumiyay dakhliga soo gala reerka, in aan lumiyay saacadaha la shaqeyo ama mushaar, shaqo ka-fadhiisin, ama kharashka caafimaadka dheeraadka aan ka bixiya bixiyay jeebkeyta; iyo
- Aniga waxaan sida ugu fiican ku dadaalay in aan waqtiyo go'an ku bixiyo qeybo ka tirsan una dhaw lacag bixinta ilaa aan ka bixiyo lacagta oo idil sida daruufaha saamaxaan, lana tixgeliyo kharashka kale aan loo baahneyn.

**DECLARATION FOR THE CENTERS FOR DISEASE CONTROL  
AND PREVENTION'S TEMPORARY  
HALT IN EVICTIONS TO PREVENT FURTHER SPREAD OF COVID-19**

This declaration is for tenants, lessees, or residents of residential properties who are covered by the CDC's order temporarily halting residential evictions (not including foreclosures on home mortgages) to prevent the further spread of COVID-19. Under the CDC's order you must provide a copy of this declaration to your landlord, owner of the residential property where you live, or other person who has a right to have you evicted or removed from where you live. Each adult listed on the lease, rental agreement, or housing contract should complete this declaration. Unless the CDC order is extended, changed, or ended, the order prevents you from being evicted or removed from where you are living through June 30, 2021. You are still required to pay rent and follow all the other terms of your lease and rules of the place where you live. You may also still be evicted for reasons other than not paying rent or making a housing payment.

I certify under penalty of perjury that the foregoing are true and correct:

- If evicted I would likely become homeless, need to move into a homeless shelter, or need to move into a new residence shared by other people who live in close quarters because I have no other available housing options.
- I either expect to earn no more than \$99,000 in annual income for Calendar Year 2020 (or no more than \$198,000 if filing a joint tax return), was not required to report any income in 2019 to the U.S. Internal Revenue Service, or received an Economic Impact Payment (stimulus check) pursuant to Section 2201 of the CARES Act;
- I have used best efforts to obtain all available government assistance for rent or housing;
- I am unable to pay my full rent or make a full housing payment due to substantial loss of household income, loss of compensable hours of work or wages, lay-offs, or extraordinary out-of-pocket medical expenses; and
- I am using best efforts to make timely partial payments that are as close to the full payment as the individual's circumstances may permit, taking into account other non-discretionary expenses.
