Brograamka Deynta Ku Soo Siyaadda Qiimaha Guriga ee Xarunta Guriga Boston (Boston Home Center's Home Equity Loan Program) (HELP) wuxuu milkiileyaasha guryaha Magaalada Boston ku kaalmeeyaa talo kale oo la awoodo si loo maalgeliyo hagaajinta looga baahan yahay guryahooda, taasoo horumarisa dib u maalgelin la arki karo oo ka socdo xaafadaha Boston. Brograamka waxaa la fulliyaa hadba sida loo helo maalgelin.

SHARUUDAHA XAQ U YEELASHADA

Si aad xaq ugu yeelatid HomeWorks HELP, waa in aad la kullantid DHAMAAN sharuudaha soo socdo:

- In aad ahaatid milkiile daggan hantida ka kooban 1-4 qoys oo ku taal Magaalada Boston, kana mid ah guryaha kondominium iyo ururada kondominiumka (ilaa lex guri keliya), oo hagaajin ka fulliyo meelaha dadka ka dhexeeyo;
- Dakhliga Ugu Badan Reerka Kama Badnaan Karo 135% Dakhliga Dhexe Xaafadda (Area Median Income) (AMI) sida ay u xisaabtay Waaxda Guriyeynta iyo Horumarinta Magaalada Mareykanka (U.S. Department of Housing and Urban Development) (HUD) kuna saleysan tirada reerka. (Fiiri jaantuska hoose);
- Milkiileyaasha dakhligooda ugu badan ka sareeyo 120% AMI sida Hud xisaabtay waxay xaq u leeyahiin deynta Magaalada oo gaarta ilaa 50% kharashka (ilaa deynta ugu badan) xagga hagaajinta loo ogol yahay lana timaado maaliyadda 50% ama doolar-ilaa-doolar (1:1) maaliyadooda ama deynta bangiga. Waxaad xuduudda dakhliga iminka jira ka heli kartaa halkaan.

- In aad haysatid in ka yar \$75,000 hantida maaliyadda. Dhamaan hantida, haddii ay tahay lacagta caddaanka, qiimaha ku soo siyaada hantida ma guuraanka aasaasiga, maaliyadda maalgelinta, ama shay kale oo qiimo leh, waxaa lagu darri doonaa xisaabinta hantida. Haddii hantida ay lagama maarmaan u tahay ilaha dakhliga aasaasiga ee milkiilaha, sida milkiyadda ganacsiga, waxaa dhici karto in qaar ama dhamaan hantida laga dhaafo xisaabinta, balse ilaa heerka loo baahan yahay si uu u sii socodo dakhliga milkiilaha;
- Waa in la bixiyo dhamaan xisaabaadka Magaalada Boston iyo deynta guriga, kana mid ah canshuurta hantida iyo biilasha biyaha;
- Waa in la bixiyo dhamaan deynta iyo ceymiska milkiilaha guriga;
- Waxaa dhici karto in aadan qaadanin kaalmada maaliyadda hagaajinta guriga ee laga qaato brograamka Magaalada Boston tobankii (10) sanno ee la soo dhaafay, marka laga reebo maaliyadda ku baxda fiiqidda macdanta "lead".

QODOBADA IYO SHARUUDAHA

- Dakhiga reerka uu soo gudbiyay Milkiilaha guriga waxaa soo gala dhamaan dadka daggan guriga uu daggan yahay milkiilaha guriga iyo waxaa ka mid ah ilaha dakhliga ee dhamaan dadka daggan (dakhliga la canshuuro iyo dakhliga aan la canshuurin), sida balse kuma eka: lacagta la shaqeysto, saacadaha dheeraadka, qeybsiga IRA, gunnada qeyb ka mid ah shaqada, maalgelinta la qeybsado, korsaarka, maalgelinta sannadka (annuities), xaqa, magta Maamulka Ciidadamada (Veteran Administration VA), dakhliga guud ee laga qaato kirada muddada dheer iyo dakhliga guud ee laga qaato kirada muddada gaaban, khidmadda, dakhliga gadaal loo dhigay, kharashka ceydha, manaafacaadka soshal sekuritiga, kharashka itaal darrida, taakuleynta xaaska, kaalmada dadweynaha, mushaarka fasaxa bukaanka, magta shaqo la'aanta, iyo dakhliga laga helo ammaanada, hawlaha ganacsiga, iyo maalgelinta.
- Ma jirto lacag bil kasta lagu bixiyo deynta mana leyska rabo in dib loo bixiyo ilaa milkiilaha ka guuro, iibiyo, ama wareejiyo milkiyadda hantida, ama ku dhaqaaqo dib u maalgelinta lacagta caddaanka guriga. Deynta Magaalada waxaa suga Deynta Guriga (Mortgage) iyo Warqadda (Promissory Note). Deynta Guriga (Mortgage) waxay ahaan doontaa qaan saaran hantida oo la geliyo diiwaanka barwaaqo sooranka Commonwealth of Massachusetts Suffolk Registry of Deeds (Diiwaangelinta Heshiisyada).
- Mas'uuliyadda qareenka ka saaran bixiyaha deynta guriga waxay tahay in uu badbaadiyo masraxadda bixiyaha deynta.
- Qaateyaasha deynta waxay kharashkooda ku qabsan karaa qareen ay doortaan oo matalaa masraxadooda ganacsiga.

- Ka hor inta aan la helin kaalmada maaliyadda, Milkiilaha Guriga waxaa laga rabaa in uu saxiixo Qodobada iyo Sharuudaha brograamka, warqadda Promissory Note, Deynta Guriga, iyo warqadaha la xariira deynta.
- Ugu yaraan hal meel saddax (1/3) maaliyadda Magaalada waa in loo isticmaalo hagaajinta dibadda loona baahan yahay in laga arki karo jidka.
- Milkiilaha guriga wuxuu u ogolaan doonaa wakiilka Qeybta Xarunta Guriga Boston DND (DND Boston Home Center Division) in uu fattasho iyo baaro dibadda iyo gudaha dhismaha, sida qeybaha lagu nool yahay.
- Milkiilaha waxaa la siin doonaa kaalmo farsamo lacag la'aan ah iyo fiirinta xisaabta qandaraaslaha uu milkiilaha soo xushay iyo fattashaadda shaqada la dhamaystiray si uu u sugo tayada. Milkiileyaasha guriga waa in ay labo (2) xisaab qoran ka keenaan qandaraasleyaal ku jira diiwaanka, waa in uu haysto shahaado, iyo waa in uu haysto ceymis.
- Sida uu tilmaamo Ku-Takhasusaha Dhismaha DND, dhamaan hagaajinta degdegga iyo hagaajinta ammaanka waa in la fulliyo ka hor inta aan la maalgelinin hagaajinta noocyada kale.
- Waxaa dhici karto in maalgelinta fiiqidada rinjiga macdanta "lead" ka badan tahay HomeWorks HELP deynta Magaalada ee la siiyo milkiileyaasha dakhli ahaan xaqa u yeesha iyo haysta caruur ka yar lex sanno. Dhamaan hantida, meesha uu daggan yahay cunugga ka yar lex (6) sanno waa in uu u hoggaansamo sharciyada u qoran Waaxda Caafimaadka Dadweynaha Massachusetts (Massachusetts Department of Public Health) ee 105 CMR 460,000 "Ka Hortagga iyo Kantaroolka Sunta Macdanta "Lead" ("Lead Poisoning Prevention and Control").
- Hagaajinta dibadda ee loo aqoonsado qodobka 1/3 waxaa ka mid ah, balse kuma eka: rinji marrinta, hagaajinta looxa dhinacyada iyo dhinacyada ka samaysan "vinyl", dhagax, dariishadaha, fadhiyada dibadda, iyo saqaafka.
- Haaginta gudaha waxaa ka mid ah, balse kuma eka: jikkada, musqulada, meelaha la marro, qolalka jiifka, kabbisyada, darbiyada, iyo saqaafyada, siistemyada kululeynta, kor u kicinta korantada iyo biyo gelinta, ka hortagga cimilada iyo horumarinta dhaqaaleynta quwadda iyo ka hortagga biyaha soo gala dabaqa dhulka hoose.
- Maaliyadda Magaalada looma isticmaali karo hagaajinta soo socoto, sida, balse kuma eka: qalabka, qurxinta kore, ama waxyaabaha la adeegsado, tusaale ahaan, marmarka miisaska, saxanta qabeyska "jet", leexadka laga soo galo guryaha ama hagaajinta dhulka dibadda; darbiyada celiya ciidda; waxyaabaha dheeraadka, sida qurxinta dabaqa dhulka hoose ama meelaha ka banaan saqaafyada.

- Hagaajinta guriga waa in ay u hoggaansan tahay dhamaan tilmaamaha lagu dabaqi karo iyo sharciyada la xariira guryaha iyo dagmooyinka ku qoran Diiwaanka Qaranka Meelaha Taariikhda (National Register of Historic Place), ama Guddiga Taariikhda Gobolka (State Historical Commission), ama Guddiga Astaamaha Magaalada Boston ku magacawday Astaanta Dagmada (Landmark District).
- Milkiilaha guriga wuxuu caddeynaa in iyaga, ama xubin kale oo ka tirsan qoyska sokke, uu iminka ama horay u ahayn toban iyo labdii bil (12) la soo dhaafay, shaqaale, wakiil, la-talliye, sarkaal ama sarkaal la doortay lana magacaabay ee Waaxda Horumarinta Xaafadda Magaalada Boston (City of Boston Department of Neighborhood Development). Marka laga hadlo kashifaaddaan "xubinta qoyska sokke" waxaa ka mid ah waalidiinta, xaaska, walaalaha, ama caruurta, iyadoo aan la fiirinin meesha ay daggan yahiiin.
- Milkiileyaasha waa in aan lagu xakumin kadeedka dagganaha, ama aan lagu helin in uu jebiyay Sharciyada Caddaaladda Guriyeynta (Fair Housing Laws).
- Milkiilaha guriga waa in uusan ahayn eedeysane ku lug leh ashtako dambi ka socdo Maxkamadda Guriyeynta, ama dhexdhexaadin ay waddo Guddiga Caddaaladda Guriyeynta Boston (Boston Fair Housing Commission) ama Guddiga Ka Soo Horjeedo Takoorka Massachusetts (Massachusetts Commission of Discrimination).
- Milkiilaha guriga waa in uusan iminka qeyb ka ahayn dacwad kiis iminka socda oo ku saabsan burbur dhaqaale (bankruptcy case). Haddii milkiilaha guriga uu horay qeyb ka ahaa dacwad la xariirta burburka dhaqaalaha, Maxkamadda Burburka (Bankruptcy Court) waa in ay dacwadaas soo afjarto ama dibadda u tuurto kaddibna muddada racfaan kasta oo lagu dabaqi karo waa in ay dhamaato.
- Milkiilaha guriga wuxuu waafaqsan yahay in uu la hadlo saxaafadda, haddii la weydiiyo in uu ka qeybgalo munaasabadda saxaafadda iyo/ama xayaysiin kale oo la xariirto xayaysiinta iyo/ama soo sheegidda manaafacaadka brograamka dayactirka.
- Milkiilaha guriga wuxuu waafagsan yahay in uu dhigo calaamad muujisa in Waaxda Horumarinta Xaafadda (Department of Neighborhood Development) dayactirto hantida iyo in calaamadda noocaas jiri doonto ilaa inta uu socdo dhismaha iyo muddo soddon (30) maalin kaddib.
