Option 1 – Likes

Option 1 – Questions, Concerns & Suggestions

- Kiosk was suggested as a food and vending amenity. It is different than a shed for storage. Vending is a separate program and a vending meeting is being arranged.
- Landscape area with flowers, not only evergreens. Natural color to be brought into the park
- Why isn't dog park available? One of the options does include a dog park
- Are there flowering trees? Yes!
- Is the current dead space in the park being used?
- Games tables to be considered
- Breaking stairs for resting spot and have landing with seating options halfway up the stairs
- Rock climbing equipment

Option 2 - Likes

- Dog Park is important and there are dog owners in the neighborhood Design team to look at size comparisons of other dog parks
- Upper terrace design
- Maximized view

Option 2 – Questions, Concerns & Suggestions

- Bring in loop path for tricycles
- Yoga lawn appears too small (15 people yoga class)
- No breakup of the stairs
- Dog enclosure isn't that big compared to nearby dog parks, and dogs need space to run and chase off leash.
- Small dog park that takes space from other activities isn't worth it.
- Little slope activity
- No passive adult exercise equipment
- Existing upper plaza has been used for yoga
- It would be better to have dog park space be a yoga lawn
- Dog Park isn't that important
- Upper terrace could have children's play area for those parents not able to go to the bottom of the hill
- Have larger play area for children

• Accessibility important to community

Option 3 – Questions, Concerns & Suggestions

- Is it possible to have swings similar to the ones that are at Lawn on the D in the park?
- It is important that the park have a large playground and water play
- Incorporating existing community elements (especially on Washington Street into the park to make it more welcoming to the community. (like Snap Chef)
- Feels like an adult park and not a place for kids?
- Would ramp runs be concrete, or elevated decking?
- There are young families and new babies in the community, play space is essential for this community park
- Is there another accessible route from Claybourne Street to Washington Street?
- This plan feels like a plan that breaks the current uses of the park
- Ramp seems cumbersome to me, and I wonder if people using wheelchairs could have some input on this ramp design

General Comments After Presentation

- What are the community priorities?
- Leave space on side for later establishment of elevator for accessibility?
- Option of connecting Snap Chef to the park so it would be more open to the community.
- Is along the slope a possibility to provide accessibility option so it doesn't take over the entire park?
- Request for grills
- Things our household would use: kiddie things, amphitheater, lawn for picnics, water play, and picnic tables/grills.
- Compare dog park size to Ronan / Garvey Park
