COMMITTEE HEARING NOTICE - Virtual Hearing

November 19, 2021

The Boston City Council's Committee on Boston's COVID-19 Recovery will hold a public hearing on Monday, November 29, 2021 at 10:00 AM. This hearing will be held virtually via Zoom. The subject of the hearing is:

Docket #1205, message and order authorizing the City of Boston to accept and expend the amount of Eight Million Dollars (\$8,000,000) in the form of a grant, awarded by the United States Department of the Treasury, to be administered by the City of Boston's Chief Financial Officer/Collector Treasurer. The grant will fund the expansion of the fare free transit program. This grant payment is made from the Coronavirus State and Local Fiscal Recovery Fund (CLFRF) in the Treasury of the United States established by Section 9901 of the American Rescue Plan Act of 2021 (ARPA).

This order was sponsored by Mayor Wu and was referred to the Committee on November 17, 2021.

NOTICE: The Boston City Council may have a quorum participating due to standing committees of the City Council consisting of both voting and non-voting members. However, members participating in this duly posted meeting are participating and deliberating only in conjunction with the business of the standing committee.

Attendance In accordance with Chapter 20 of the Acts of 2021 modifying certain requirements of the Open Meeting Law and relieving public bodies of certain requirements, including the requirement that public bodies conduct its meetings in a public place that is open and physically accessible to the public, the City Council will be conducting this hearing virtually. This enables the City Council to carry out its responsibilities while adhering to public health accommodations and ensuring public access to its deliberations through adequate, alternative means.
