






### **THE SITE: 332 CONGRESS**



<u>Design Brief:</u> Update the street level presence of the historic building by removing the ornamental steel arch and adding new architectural detailing and lighting to emphasize the recessed building entry (which is not original to the building). Install new building identification signage in place of the ornamental arch, and remove existing tenant signage at upper storefront bays. Replace tenant signage (awnings and backlit sign) with transom windows to allow more light into the ground floor level. Upgrade storefront system at entries to replace existing tenant and building entry doors to provide a more symmetrical elevation cohesive with the overall building design.

**EXISTING ELEVATION** 






## **DESIGN INSPIRATION- RECTILINEAR EXTRUSION**



#### **EXTRUDED ENTRY THRESHOLD**


A NEW ARCHITECTURAL THRESHOLD IS PROPOSED AT THE RECESSED ENTRYWAY, WHICH IS A PORTION OF THE GROUND LEVEL DESIGN THAT IS NOT ORIGINAL TO THE HISTORIC BUILDING. THE DEPTH OF THE THRESHOLD IS ALIGNED AT THE BACK WITH THE COLUMNS, BUT PROTRUDES SLIGHTLY FROM THE FACE OF THE COLUMNS ON THE STREET SIDE SO A SLIVER OF THE CONTRASTING MATERIAL IS VISIBLE TO PEDESTRIANS AS THEY APPROACH THE BUILDING.

THE THRESHOLD IS ARTICULATED WITH A CLEAN, MINIMAL BAND OF CONTRASTING MATERIAL, WITH ARCHITECTURAL LIGHTING INTEGRATED INTO THE FORM TO EMPHASIZE THE ENTRYWAY FROM THE STREET SIDE. THE LIGHT SOURCE IS HIDDEN FROM VIEW SO THAT IT CREATES A DIFFUSE GLOW THAT REFLECTS OFF THE INTERIOR SURFACE OF THE EXTRUSION.



### PROPOSED MATERIAL PALETTE

**TEAK WITH NATURAL OIL FINISH** WOOD PLANK CEILINGS CAN BE FOUND THROUGHOUT THE NEIGHBORHOOD AND ADD WARMTH TO THE ENTRY WAYS. THE WARM TONE COMPLEMENTS THE LIGHTER BRICK OF THE FACADE.

#### **ANTIQUE BRASS**

THE ANTIQUE BRASS FINISH ECHOES THE FINISH OF THE HISTORIC GLAZED CLAY TILE DATE SIGNAGE FOUND IN THE UPPER PORTION OF THE BUILDING AND HIGHLIGHTS THE RECESSED ENTRYWAY

### ALUMINUM FRAMED STOREFRONT SYSTEM

THE INTERIOR AND SIDE ELEVATIONS OF THE RECESSED ENTRY NICHE WILL BE REPLACED WITH A NEW STOREFRONT SYSTEM IN A FINISH TO MATCH THAT OF THE EXISTING STREET-FACING STOREFRONT.




#### **BUILDING SIGNAGE**

THE EXISTING ORNAMENTAL ARCH WILL BE REPLACED WITH A MINIMAL ARCHITECTURAL FRAME THAT ACCENTUATES THE BUILDING ENTRY AND SUPPORTS TOP-MOUNTED DIMENSIONAL ADDRESS SIGNAGE TO IDENTIFY THE BUILDING. THE SIGNAGE WILL BE EDGE LIT, WITH THE FRONT AND BACK FACES OF THE DIMENSIONAL NUMBERS MATCHING THE ANTIQUE BRASS FINISH OF THE ARCHITECTURAL FRAME.

THE INTERNAL LIGHTING WITHIN THE DIMENSIONAL LETTERS IS LED AND WILL BE TUNED TO THE SAME COLOR TEMPERATURE AS THE CONCEALED LED LIGHTING IN THE ARCHITECTURAL FRAME. THE CENTER OF THE DIMENSIONAL LETTER CONSISTS OF A FROSTED ACRYLIC STRIP THAT WILL PROVIDE A DIFFUSE GLOW OF LIGHT AROUND THE ADDRESS SIGNAGE.





