Applicant: Daniel Connolly **Proposed work**: Exterior work including seating area with trellis and new signage.

22.0662.0042 - Franklin Park, 2154 Forest Hills Drive

Applicant: Tess Paganelli

Proposed work: Relocation of the Circuit Drive at Shattuck Hospital (MBTA ID No. 522) and Circuit Drive opposite Shattuck Hospital (MBTA ID No. 21587) bus stops approximately 180 feet to the west of their current location, where new stops will be constructed. Work includes new sidewalks, landing areas, crosswalks and curb ramps.

22.0645.0245 – Harvard Medical School, Goldson Building – 220 Longwood Avenue Applicant: Meaghan Doyle Proposed work: Install two new rooftop air handling units and an exhaust fan system.

II. (To avoid potential confusion, the text of your building-permit application should be consistent with the project description given below.) Commission staff will accordingly authorize the execution of
