- *Docket #0498, message and order authorizing a limit for the Environment Conservation Commission revolving fund for the Fiscal Year 2023 for the purpose of securing outside consultants including engineers, wetlands scientists, wildlife biologists, or other experts in order to aid in the review of proposed projects to the Commission, per the city's ordinance protecting local wetland and promoting climate change adaptation, with expenditures not to exceed Fifty Thousand Dollars (\$50,000.00).*


