Re: Violation Notice / VIO.23.0641
This memo is in response to Violation Notice VIO.23.0641 for the intercom panel at 87 Beacon Street. The intercom was installed without first proposing replacement of the former intercom system via a "Certificate of Appropriateness" application process. We understand now that the "Historic Beacon Hill District Architectural Guidelines" state the following in Item 7 of Paragraph E - Doors and Entries:

Buzzers, key keepers, and intercom panels shall be contained if possible within the entryway of the building, and preferably shall be flush-mounted in the wood trim. Such panels shall have brass or bronze faces. Lighted or backlit buzzers and intercom panels shall not be allowed. Individualized buzzers are more appropriate than large panels.

While the intercom panel is flush mounted in the wood trim and contained within the entryway, it does not conform to the allowed materials, absence of illumination, or individualized buzzers. The intercom has an interactive visual display panel in a stainless steel flush enclosure and is attached to an oversized brushed stainless steel base plate to conceal the wood cutout for the former intercom. We propose to correct this violation by providing a hinged brass cover per the attached drawings:

The proposed hinged cover will be fabricated of solid brass and satin finished to conceal the intercom panel. Also, the key keeper in the panel below the intercom will be painted to match the wood. Please let us know if this approach will meet the guidelines in response to the violation notice.
