### OGEYSIISKA KA-SAARIDDA (NOTICE TO QUIT)

**Milkiilaha hantida wuxuu dagganaha siiyaa Ogeysiiska Ka Saaridda (Notice to Quit) (inta badan kiisaska)**

- Waa isbaddali doontaa tirada ogeysiiska taasoo ku xeran nooca dagganaashada. Inta badan kiisaska, waxay qaadan doontaa 14 ilaa 30 maalin ama ogeysiiska muddada kirada.

### ASHTAKADA MAXKAMADDA

**Milkiilaha Hantida wuxuu dagganaha siin doonaa soo koobidda Ashtakada**

- U Yeeridda iyo Ashtakada (Summons and Complaint) waxaa gacanta ku geyn doono sarkaalka maxkamadda/shariifka AMA waxaa lagu dhaafi doonaa abarmanka dagganaha kaddibna waxaana lagu diri doonaa warqadaha boostada darajada kowaad.
- U Yeeridda (Summons) Maxkamadda waxay soo qori doontaa goobta lagu qaban doono dacwadda, waxaa lagu soo diri doonaa ogeysiiska maxkamadda, taariikhda iyo waqtiga la dhageysan doono dacwadda goor dambe. **LA SOCO TAARIIKHDAAN - IN AAD GAFTID IMAASHADA MAXKAMADDA WAXAY DHALLIN KARTAA IN TOOS LOO QAATO GO'AAN ADIGA KAA SOO HORJEEDO.**
- Dhageysiyada qaar waxaa lagu qaban doonaa Zoom. Haddii aad dooneysid in aad ka gashid kombuyutar, fadlan wac mid ka mid ah ilaha sharciga ee ku qoran kor.

### GUDBINTA JAWAABTA IYO DALABKA DACWADDA GUDIIGA (ANSWER AND DEMAND FOR JURY TRIAL)

**Dagganaha wuxuu xaq u leeyahay in uu soo gudbiyo Jawaabta iyo Dalabka Dacwadda Guddiga Dhageysato (Answer and Demand for Jury Trial), iyo warqado kale ugu dambayn taariikhda loo qabtay ("Taariikhda Jawaabta") sida ku qoran Ashtakada (Complaint)**

- Dagganaha waa in uu maxkamadda u soo gudbiyo iyo waa in uu milkiilaha hantida (ama qareenka milkiilaha hantida) siiyo Jawaab iyo Codsii uu guddi ku dhageysto dacwadda (Trial) muddo saddax maalin ka hor inta aan la qabanin munaasabadda Maxkamadda kowaad.
- Jawaabta waxay sharaxdaa difaac kasta ama sheegashooyinka ka soo horjeedo uu dagganaha ka haysto sheegashada milkiilaha hantida xagga haysashada, kirada leyska rabo, iyo jebinta heshiiska kirada. Sheegashooyinka ka soo horjeedo waa sheegashooyin uu dagganaha uga soo horjeedo milkiilaha hantida sida xaaladaha xun ama sida qaldan ee loo qabto curaarta la dhigo.
- Isla waqtigaas ugu dambeeyo, dagganaha wuxuu xaq u leeyahay in uu soo gudbiyo iyo in uu soo jeediyo codsiyo uu ku ogaado (codsiyada macluumaadka laga dalbado milkiilaha hantida ee ku saabsan kiiska) iyo Dalabka in la qabto Dacwadda Guddiga (Demand for Jury Trial).
