

The purpose of this Request for Proposals ("RFP") is to solicit proposals for the redevelopment and long-term ground lease of the Austin Street Parking Lots owned by the Boston Redevelopment Authority ("BRA") doing business as the Boston Planning & Development Agency ("BPDA"). The Austin Street Parking Lots include Parcel P-15b Parcel ID 0203964000 known as 0 Rutherford Ave, and Parcel ID 0203963050, known as 0 Austin Street ("Property").

The BPDA seeks to convey the Property to allow mixed-use development that, in conformance with PLAN Charlestown, will bring a mix of housing, with an emphasis on affordability, to the Charlestown area along with community-driven ground floor activation and open space.
