Below is a summary of feedback received at this meeting.

 Could the location of the proposed drinking fountain in the Victory Garden be moved to the central lawn instead of being along the Boylston Street/Park Drive sidewalk? Fountain should include a bottle filler.

The fountain location can be moved there and will include a bottle filler.

- 2. Will the access for the Victory Garden vehicular route have curb ramps on both ends? *Yes*
- 3. Will trash receptacles be proposed in the Victory Garden central lawn area? and can they be nicer than the steel barrels?
 - Trash receptacles will be proposed in this area and will be the BPRD standard (not the steel barrel).
- 4. Are any benches proposed along the path closest to the Muddy River?

 No benches are proposed currently. When the temporary fence for the Muddy River project is removed there will be more bench location opportunities.
- 5. The Fenway Victory Garden had previously seen more design options for the garden entry, are they being considering any more? Can a bench with shade be added?

 After review with BPRD staff, it was decided the simplest option was the most in keeping with the character of this historic park. We will look at adding seating.
- 6. Will gardeners be able to drive on the interior paths or just the path near the river?

 Gardeners can still drive on the interior paths, we are only restricting vehicular traffic from the pedestrian entrance on Boylston Street.
- 7. Will the cobrahead light at the O'Reilly Memorial be replaced?

 That light is owned by DCR so it would not be replaced in the BPRD project.
- 8. The funding for O'Reilly that Fenway Civic helped to secure was for improved access, uplighting and landscaping. Will the designs include all of these? How do we prevent skateboarders or bikes using the back stairs as jumps?
 - Landscaping improvements are being considered. Uplighting is not something BPRD can do unless there is a friends group who can maintain them. We will study what can be done about the potential jumping of the stairs.



- 9. As a cyclist I am happy to see the granite pavers being removed at the O'Reilly sidewalk. Beyond the O'Reilly project area, how can the sidewalks be improved for bicyclists and pedestrians to coexist?
 - The sidewalks are owned by DCR, so any improvements would be determined by them.
- 10. I remember seeing a previous O'Reilly option with a speed table in the road, is that still being considered?
 - The option that regraded the road (but not as a speed table) involved too much work outside of BPRD property, so it isn't being considered.
- 11. Can the steel barrels for trash be replaced with better trash and recycling receptacles?

 The BPRD standard trash receptacle can be installed. Currently BPRD does not offer recycling in all of the parks.
- 12. At the crosswalk by the O'Reilly the detectable warning tiles are broken, will those be addressed?
 - The City of Boston standard recently changed to cast iron tiles instead of plastic. We will consult with DCR on what tiles to use since they own that curb ramp.
- 13. I like the proposed meadow, bench locations, bike racks, and regrading of the path leading to the southern footbridge.
- 14. I like the War Memorial option 3NR.
- 15. At the Victory Garden there is a group of trees along the path near the river that will need to be protected during construction.
 - We will review those trees and provide the appropriate protection.
- 16. Will the stone seatwall near Agassiz Road and the Fenway be removed? *Yes, we have determined it is not historic.*
- 17. Will seating be added near the Robert Burns memorial? We are looking at seating locations near there.
- 18. Will new tree be proposed?
 - Yes, we are reviewing the existing trees and proposed tree planting.
- 19. In the proposed meadow will the 3 existing Willow Oaks remain? Yes
- 20. Several trees were planted for Arbor Day this year. Are those in the tree inventory? We have to confirm if those were inventoried, but we are aware of those new trees.
- 21. Will age friendly benches be used?

 Benches will have armrests, backs and have a companion space to the side.
- 22. Can a bike rack be proposed for the Victory Garden?

 Yes
- 23. Where will the accessible bulletin board be located?

 It is shown near the proposed path to the Herb and Medicinal Garden. We will develop the details more to share.
- 24. The Fenway Victory Garden was shown proposed meadow locations between the gardens and path A, are those still being considered? Is the fencing at the composting still being proposed?



Yes, both are still proposed-we weren't able to show that at tonight's meeting given the quantity of topics to cover.

- 25. Can wifi be added in the Victory Garden? We can look into that.
- 26. Will stabilized stonedust be used on the stonedust paths?

 The Muddy River project installed unstabilized stonedust and BPRD is not planning on replacing the new paths.
- 27. What bike facilities are being proposed on Agassiz Road?

 We know DCR and the ACOE were discussing, but we have not heard what the final decision is.
- 28. Will the project include soil stabilization around the mature trees behind the O'Reilly?

 As we further develop the project documents we can determine what fits into the scope/budget.
