**II. (To avoid potential confusion, the text of your building-permit application should be consistent with the project description given below.) Commission staff will accordingly authorize the execution of the work, attaching any applicable provisos, reflecting the relevant guidelines and precedents.

The electronic building-permit application as annotated by commission staff will constitute your Certificate of Appropriateness;
