COMMITTEE HEARING NOTICE

March 8, 2024

The Boston City Council's Committee on Ways & Means will hold a hearing on Tuesday, March 19, 2024 at 2:00 pm in the Iannella Chamber, 5th floor, Boston City Hall.

The subjects of the hearing are:

Docket #0338: Message and order for your approval, an Order to reduce the FY24 appropriation for the Reserve for Collective Bargaining by One Million Two Hundred and Three Thousand Seven Hundred Fifty-One Dollars (\$1,203,751.00) to provide funding for various City Departments for the FY24 increases contained within the collective bargaining agreements between the City of Boston and the American Federation of State, County & Municipal Employees, Council 93.

Docket #0339: Message and order for a supplemental appropriation Order for various departments for the FY24 in the amount of One Million Two Hundred and Three Thousand Seven Hundred Fifty-One Dollars (\$1,203,751.00) to cover the FY24 cost tiems contained within the collective bargaining agreements between the City of Boston and the American Federation of State, County & Municipal Employees, Council 93. The terms of the contract are July 1, 2023 through June 30, 2027. The major provisions for the contract include base wage increases of 2% to be given in July of each fiscal year of the contract term and flat amounts of \$500, \$250, \$900, \$800 to be added to annual salaries in January of each fiscal year. The agreement also includes changes to personal days, an increase in the clothing allowance and training funds, and increases to certain differentials.

Docket #0340: Message and order for your approval, an Order to reduce the FY24 appropriation for the Reserve for Collective Bargaining by Six Hundred Forty-Seven Thousand Two Hundred Fifty-Four Dollars (\$647,254.00) to provide funding for various City Departments for the FY24 increases contained within the collective bargaining agreements between the City of Boston and the Service Employees International Union, Local 888.

Docket #0341: Message and order for a supplemental appropriation Order for various departments for the FY24 in the amount of Six Hundred Forty-Seven Thousand Two Hundred Fifty-Four Dollars (\$647,254.00) to cover the FY24 cost items contained with the collective bargaining agreements between the City of Boston and the Service Employees International Union. The terms of the contract are July 1, 2023 through June 30, 2027. The major provisions for the contract include base wage increases of 2% to be given in January of each fiscal year of the contract term and flat amount of \$500, \$250, \$900, \$750 to be added to annual salaries in January of each fiscal year after the percentage increase. The agreement also includes an expansion of the clothing allowance, an increase

Docket #0459: Message and order for your approval, an Order to reduce the FY24 appropriation for the Reserve for Collective Bargaining by Two Thousand Nine Hundred Forty-Five Dollars (\$2,945.00) to provide funding for the Boston Police Department for the FY24 increases contained within the collective bargaining agreements between the City of Boston and the New York Typographical Union CWA Local 14156.

Docket #0460: Message and order for a supplemental appropriation Order for the FY24 in the amount of Two Thousand Nine Hundred Forty-Five Dollars (\$2,945.00) to cover the FY24 cost items contained with the collective bargaining agreements between the City of Boston and the New York Typographical Union CWA Local 14156. The terms of the contract are July 1, 2023 through June 30, 2027. The major provisions of the contract include base wage increases of 2% to be given in January of each fiscal year of the contract term and a flat amount of \$500, \$250, \$900 and \$800 to be added to annual salaries in January of each fiscal year, after the 2% increase. Filed in the Office of the City Clerk on March 4, 2024.
