### Meeting Notes Franklin Park Bear Dens Safety Improvements Meeting #2

March 14, 2024

Below is a summary of the feedback received at this meeting:

#### Summary

Community Meeting #2 was a comprehensive presentation of the proposed work, addressing the cost estimate as it relates to the allotted construction budget, and assigning priorities to each of the proposed conditions for the Bear Dens in Franklin Park.

#### Accessibility and Circulation

Several participants asked questions related to circulation and general accessibility.

Due to the limited access in Cage #1, the design team has proposed removing an existing panel to provide additional egress in and out of the cage.

While this project is limited to making the space safe, Boston Parks and Recreation (BPRD) has been in discussions with the City of Boston Disabilities Commission about accessibility. BPRD will request a time variance stating accessibility improvements will be addressed when the site is programmed with its desired use.

Holes and large cracks in pavement and stairs will be addressed as part of this project. Stair repairs will match the color and texture as much as possible.

#### **Existing Pools**

The existing pools generated a lot of great questions and feedback. Several participants discussed the possibility of alternatives to filling the pools with gravel i.e. wood decking, playground surfacing. Ultimately, a gravel fill is the most economical solution to temporarily fill

in these structures and make them safe. There could be the opportunity to incorporate filter fabric, topsoil, and some type of plantings, such as annuals, if someone could maintain them. Plantings trees in the pools is not recommended because BPRD is hesitant to get trees established in the pools and then possibly need to remove them in 5+ years when the future programming is designed.

#### Graffiti

Only in cage #4 is graffiti removal recommended, because public access will be restricted to this cage. Graffiti in cages 1, 2 and 3 will remain until the future program is determined. It was suggested that an artist could paint on top of the graffiti for something more positive (this idea will need to be reviewed and approved by Boston Landmarks Commission).

When graffiti is removed, an anti-graffiti coating can be applied to the stone that makes removal of graffiti easier.

#### **Timeline and Land Transfer**

The project remains on schedule with construction documents to be produced this Spring, bidding in May, and an anticipated construction start in July. Spring 2025 completion is a realistic goal. All of these dates are dependent on the land transfer from DCR to BPRD, which is still progressing.

On March 26<sup>th</sup> the project will be reviewed by the Boston Landmarks Commission.

#### **Funding Opportunities**

There were several comments and questions about additional funding opportunities. Funding from the State and CPA are possible sources. These sources may not be available in time for this phase of work.

#### Signage

Interpretive signage addressing the history of this space and connection with the zoo was suggested.

In general, signage has been a part of a larger discussion with the Franklin Park Action Plan and will likely be part of the future phase of Bear Dens work.

#### Access during Construction:

Construction fencing will enclose the work area restricting public access during construction.

#### Miscellaneous:

There are no issues with the bear dens themselves. The roof and walls were inspected and the repairs will be limited to debris and vegetation removal from the roof.

#### Volunteer Efforts:

Franklin Park Coalition and the Emerald Necklace Conservancy lead volunteer groups that can clean up and manage vegetation around the Bear Dens.
