**NOTE:** ThyThy Le noted for the record, "I'd like to call to your attention, Commissioners, votes one (1) and two (2) are both requests for amendments of the votes of November 15, 2023 to amend the consultant contracts for the 2022 Massachusetts School Building Authority's (MSBA) Accelerated Repairs Program (ARP) at four (4) Boston Public Schools projects located in Dorchester, Jamaica Plain and Roslindale managed by PFD. As a result, there is a request to the commission to allow the Project Manager to present votes one (1) and two (2) jointly, with a separate roll call for each vote thereafter."
