## INSTRUCTIONS FOR LODGING HOUSE <br> LICENSES (Revised 5/2024)

* A Lodging House is where lodgings are let to four or more person not within second degree of kindred to the person conducting it. Lodging Houses are regulated pursuant to G. L. c. 140, § 22, et al., and the Rules of the Board.
* In accordance to G. L. c. 140, § 27, and the Rules of the Board, all Lodging Houses must keep in permanent form a register which shall record the true name and residence of every person engaging or occupying a private room. Such register shall be kept for period of one year after the last entry therein, and shall be made available for inspection to the Licensing Board and/or its agents.
* Lodging House Licenses must be renewed annually in the month of April. Fees are contingent upon the number of rooms: 0-9 rooms, $\mathbf{\$ 7 5 . 0 0 / y e a r ; ~ 1 0 - 1 9 ~ r o o m s , ~ \$ 1 5 0 . 0 0 / y e a r ; ~ 2 0 - 2 9 ~ r o o m s , ~ \$ 2 2 5 . 0 0 / y e a r ; ~ 3 0 - 3 9 ~}$ rooms, $\$ 300.00 / y e a r ;$ and any Lodging House containing more than 39 rooms, $\$ 300.00$ plus $\$ 4$ for each additional room/year.

1. Make sure the proposed location is zoned for a lodging house. If it is not, you must go to the Zoning Board and obtain approval to change the zoning use.
2. Meet with the local Neighborhood Association (http://www.cityofboston.gov/ons/coor list.asp), and speak with the City Councilor for the District (http://www.cityofboston.gov/citycouncil/councillors/) prior to the hearing before the Licensing Board.
3. File the completed application with: a copy of the lease agreement (in the applicant's name); an $81 / 2 x$ 11 floor plan of each floor; and completed Personal Information Form(s) and Criminal Record Information Form(s) for all owner(s), shareholder(s), officer(s), manager(s), and person(s) with a financial interest in the business. Corporations should also submit a printout of the summary screen generated by the state's corporation database containing the corporation's general information (http://corp.sec.state.ma.us/corp/corpsearch/corpsearchinput.asp).
4. Appear at the hearing before the Licensing Board.
5. If the License is granted, you will receive an email notification along with an invoice and instructions on how to pay. Prior to the license being issued, you must go to the Inspectional Services Department and obtain a current Building Inspection Certificate (white paper with gold seal). If you have a place of assembly (i.e. function room) and the capacity of that space is more than 50 , you must also obtain a Fire Assembly permit from the Fire Department. Both of these Departments are located at 1010 Massachusetts Avenue (4th Floor).
