## COMMITTEE HEARING NOTICE

February 18, 2025

The Boston City Council's Committee on Planning, Development and Transportation will hold a hearing on **Thursday, February 20, 2025 at 2:00 pm** in the **Iannella Chamber, 5th Floor, Boston City Hall**.

The subjects of the hearing are:

***Docket #0396, Message and order authorizing the City of Boston to accept and expend the amount of Seven Hundred Seventy-Five Thousand Eight Hundred Fifty-Five Dollars (\$775,855.00) in the form of a grant for the 2025 Community Connections Program Grant, awarded by the Massachusetts Department of Transportation, passed through the Boston Regional Metropolitan Planning Organization, to be administered by the Transportation Department. The grant will fund the replacement and electrification of Blue Bikes Stations and repurpose single space parking meter poles for 1600 with bicycle racks.***

***Docket #0448, Order authorizing the City of Boston to accept and expend the amount of Fourteen Million Four Hundred Thousand Dollars (\$14,400,000.00) in the form of a grant, Safe Streets and Roads for all, awarded by US DOT National Highway Traffic Safety Administration, passed through the Massachusetts Department of Transportation, to be administered by the Transportation Department. The grant will fund systemic safety improvements to traffic signals at 50 locations across the City of Boston.***

These matters were sponsored by Mayor Michelle Wu and were referred to the Committee on February 5, 2025 (Docket #0396) and February 12, 2025 (Docket #0448) .
