NOTE: Colleen Daley performed the roll call and confirmed the individuals in attendance.

NOTE: ThyThy Le noted for the record draft meeting minutes from the meetings of October 23, 2024, for the Public Facilities Department and Mayor's Office of Housing. She then asked for a motion to approve.

NOTE: On a motion duly made and seconded, the October 23, 2024 meeting minutes for the Public Facilities Department and Mayor's Office of Housing were unanimously approved.

Amendment to the vote of November 15, 2023: Regarding a contract with Jones Architecture, Inc. to provide design services including schematic design through the end of design development

for the renovation or new construction of the east grandstand and track and field associated with the White Stadium project located at 450 Walnut Avenue, Jamaica Plain.

Increase of \$6,977,289 and Time Extension

That the vote of this Commission at its meeting of November 15, 2023, regarding a contract with Jones Architecture, Inc. to provide design services including schematic design through the end of design development for the renovation or new construction of the east grandstand and track and field associated with the White Stadium project located at 450 Walnut Avenue, Jamaica Plain;

be, and hereby is, amended as follows:

By deleting the following words: "to provide design services including schematic design through the end of design development" and substituting in place thereof the following: "for completion of design services from construction documents through construction administration;"

and, also, by deleting the following words and figures: "July 2, 2024, a cost not to exceed \$2,750,920, including \$1,733,090 for base services and \$1,017,830 for additional services" and substituting in place thereof the following figures: "August 15, 2027, at a contract cost not to exceed \$9,728,209, including \$6,977,289 for total amended services consisting of \$4,073,806 for amended base services and \$2,903,483 for amended additional services."

The Director is, also, authorized to execute such contract amendment, in the name and on behalf of the Commission, upon receipt of said written authority from the Mayor.

NOTE: Brian Melia addressed the Commission and provided an overview of the project.

NOTE: Commissioner Mammoli asked, "Just one quick question, what's the estimated construction cost for this project?"

NOTE: Brian Melia replied, "Right now we're at \$90 million. We've actually gone through the design development phase. We're just getting that in now, so the concept drawings you saw are still being developed as we continue to work through the design."

NOTE: Commissioner Wright stated, "No questions, thank you."

NOTE: On a motion duly made and seconded, the vote was unanimously approved.
