On a petition by OTD D2 Title LLC for the **Widening & Relocation** of the existing right-of-way lines of **Dorchester Avenue** (public way), South Boston, as well as for the acceptance of a Highway Easement, located on its westerly side at address no. 495, generally between Alger Street and Woodward Street.
