The Boston City Council's Committee on Public Safety and Criminal Justice hearing scheduled for **Thursday, April 3, 2025 at 2:00 pm** in the **Iannella Chamber, 5th Floor, Boston City Hall** has been canceled and will be rescheduled for Thursday, June 5, 2025 at 10am.

The subject of the hearing is:

***Docket #0394, Message and order authorizing the City of Boston to accept and expend the amount of One Million Seven Hundred Thirty-Five Thousand One Hundred Seven Dollars and Thirty-Nine Cents (\$1,735,107.39) in the form of a grant, for the FY25 Senator Charles E. Shannon Jr. Community Safety Initiative Grant awarded by MA Executive Office of Public Safety & Security to be administered by the Police Department. The grant will fund regional and multi-disciplinary approaches to combat gang violence through coordinated prevention and intervention, law enforcement, prosecution, and reintegration programs.***

This matter was sponsored by Mayor Michelle Wu and was referred to the Committee on February 5, 2025.

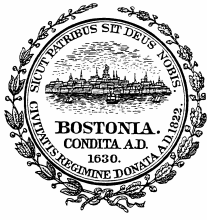
