Year Established: 2005

**Purpose:** To provide AFSCME employees assistance with the high cost of housing in the form of rental payment assistance, housing purchase assistance and home improvement assistance.

Name: Alfred V. Lincoln Fund

Year Established: 1924

**Purpose:** "...Ten years after my death, I direct my Trustees to pay Charlestown Five Cent Savings Bank the sum of seventy-five hundred dollars (\$7,500.00), which amount is to be held by them in trust for a period of 90 years, at the end of which time the yearly interest is to be used by the Trustees appointed by them for planting, care and protection of shade trees to be planted on the streets (not on any public squares) of that part of Boston called Charlestown, and no part of the above Fund is ever to be used for the care and protection of other trees than those planted by this fund. A Metallic tag, properly marked, shall be put on each tree when planted and kept on as long as the tree lives in order to distinguish it from others..."

#### Year Established:

**Purpose:** "Section 1. The City of Boston, acting by its Collector-Treasurer, shall set up and maintain as a fund, separate from all other money and accounts of said City, all sums hereafter received by the City in the management of cemeteries owned by it or in its charge, excluding deposits for the perpetual care but including proceeds from the sales of lots or rights of burial, charges paid for the opening of graves, the construction on monument foundations, and the use of cemetery facilities and devices, and interest and income from the investment of said fund thereof. Said City acting as aforesaid, shall forthwith transfer to said fund all moneys now held under chapter one hundred seventeen of the acts of nineteen hundred and thirteen, including all unappropriated income therefrom. Annually or oftener sums may be appropriated out of said fund pursuant to the provisions of section three of chapter four hundred and eighty-six of the acts of nineteen hundred and nine to defray in whole or in part so much of maintaining, improving and embellishing said cemeteries as is not met by income of deposits for perpetual care. Section 2. Chapter one hundred and seventeen of the acts of nineteen hundred and thirteen is hereby repealed. Section 3. This act shall take effect upon the acceptance by vote of the City Council of said City, subject to the provisions of its charter."

Name: Coppenhagen Fund

Year Established: 1913

**Purpose:** "Article Fourth: I give and bequeath to the... City of Boston .... to create a fund to be known as the 'Coppenhagen Fund', of which five thousand dollars (\$5,000.00) are to be used for the purchase, if necessary, of a site, and for the erection thereon, as early as possible, of a drinking fountain for persons and animals, to be located as bear as may be to the intersection of Washington street and Columbia Road, in the Dorchester District of Boston, and to be inscribed 'The Coppenhagen Fountain – In Memory of Beloved Parents'. Coppenhagen Fund to be held as an undiminished fund of which the income only is to be expended, first, in keeping said fountain in order and preservation and necessary renewal, and the remainder of said income to be applied towards beautifying said City's public parks, and purchasing books and works of art for its public libraries, as determined by the Mayor of said City."

**Purpose:** "...to the City of Boston, a fund to be held in trust, the income of which to be applied for the adornment and benefit (of Boston) by the erection of statues, monuments, fountains for men and beasts and for the ornament of its streets, ways, squares and parks in such a manner as will promote the pleasure, comfort, education, patriotism and good taste of its citizens."

Name: Elisha Goodnow Fund

Year Established: 1851

**Purpose:** Relief, assistance, and support of the poor, sick, and infirm of the city.

Name: Ellen C. Johnson Bequest

Year Established: 1902

**Purpose:** "...To pay all the balance then remaining to the City of Boston in said Commonwealth for the following public purpose: to construct and erect upon some place to be designated by the City a fountain ... according to plans which I may furnish before my decease, and I request that there be cut or carved on said fountain to writ: 'A gift to the City of Boston in memory of Jesse C. Johnson by Ellen C. Johnson."

Name: Emelie Pugliano Trust Fund

**Purpose:** To maintain and improve the recreational area around and including the municipal pool and bathhouse along Commercial Street in the North End section of Boston.

**Purpose:** "A city of town may receive, hold and apply any funds, money or securities deposited with the treasurer thereof for the preservation, care, improvement or embellishment of any public or private burial place situated therein, or burial lots situated in such burial places. Such funds, money or securities shall be entered upon the books of the treasurer, and held in ordinances or bylaws relative hereto. A city or town may pass ordinances or bylaws consistent with law, necessary for the purposes of this section. Name: George Francis Parkman Fund

Year Established: 1909 (from 1877 Bequest)

**Purpose:** "...I devise said residue to the City of Boston to constitute a fund, the income of which is to be applied to the maintenance and improvement of the Common and Parks now existing and is not to be used for the purchase of additional land for the park purposes. Any portion of said income which may not be required of the above purpose in any year is to be added to and invested as a part of said fund..."

Name: George Hovey Fund

Year Established: 1877

**Purpose:** "... for such benevolent, charitable and humane purposes and uses and towards the support of any generally public charitable institutions in said City of Boston ..."

Name: George L. Randidge Fund

**Purpose:** "...Bequest of George L Randidge, ...to pay the income thereof from time to time, as shall be designated by the Mayor of the city, for the sole purpose of affording to the children of the poor of the city of all religious denomination the pleasure of one or more excursions during the months of July and August in each year."

**Purpose:** "... for such benevolent, charitable and humane purposes and uses and towards the support of any generally public charitable institutions in said City of Boston...."

Name: George Robert White Fund

Year Established: 1922

**Purpose:** To be used for creating works of public utility and beauty, for the use and enjoyment of the inhabitants of the City of Boston. Sole-source construction fund income cannot be combined with other funding sources.

Name: George Thorndike Fund

Year Established: 1901

Purpose: Coal to deserving widowed women of East Boston.

Name: Holton Protestant Pauper Fund

Year Established: 1863

**Purpose:** Thanksgiving and other holiday meals for Protestant paupers of Brighton, if income exceeds need for holiday meals and if principal exceeds 3,000, surplus interest or income may be used for the "comfort and happiness of such paupers".

Name: Holton Protestant Poor Fund

Year Established: 1863

**Purpose:** Thanksgiving meals or other holiday meals especially unmarried Protestant females who are poor and needy such as distributors shall deem conductive to comfort and happiness of that lone class of citizens.

Name: J. Harleston Parker Medal Fund

**Purpose:** "... to pay the net income of thereof from time to time but at no greater intervals than every three years to the Mayor of the City of Boston for the purchase of a suitable medal to be known as the Harleston Parker Medal, to be presented by the Mayor of the City, with the approval of the Boston Society of Architects or its successor, to such architect or firm of architects as shall in the judgement of the Mayor, with the approval of the Boston Society of Architects...., erect for any private citizen, association, corporation or public authority the most beautiful piece of architecture, building, monument or structure within the limits of the metropolitan parks district as defined in Section 3, Chapter 407, of the Acts of 1893."

Name: John Larkin Fund

Year Established: 1807

**Purpose:** "...I give twenty shares in bank aforesaid (the Union Bank) to the Town of Charlestown, the interests and profits of said twenty shares to be disposed of from time to time for relief of the poor of said town ..."

Name: Jonathon Mason Fund

Year Established: 1798

**Purpose:** Interest to be given to the standing Chaplain of the Almshouse and Workhouse or by whatever name called.

Name: Joseph Engel Fund for Children

Year Established: 1989 (from 1964 Bequest)

**Purpose:** "Pursuant to M.G.G. c. 44, s. 53A, the sum of \$50,000.00 be and hereby is generally accepted from the trustees of a trust established by the Will of Sylvia Engel, the same to be held by the Collector-Treasurer, in trust, income to be expended annually for the purposes set forth in Article XXXIV of her Will, proved April 16, 1964."

Name: Joseph F. Berry Memorial Fund

**Year Established:** 1967

**Purpose:** "...to be used by the Police Commissioner (of Boston) for the purchase of a horse for the Boston Mounted Police in memory of said Joseph F. Berry

Name: Lenora and Bernard McGovern Trust Fund

Year Established: 2001

**Purpose:** To purchase books of permanent value for the Public Library.

Name: Lucy Bullman Fund

Year Established: 1833

**Purpose:** "...my real estate is to go to the City of Boston for the benefit of the poor..."

Name: Lucy Bullman Fund

Year Established: 1832 (from 1828 bequest)

**Purpose:** Benefit of the poor.

Name: Mary E. Curley & George R. White Fund

Year Established: 1930

**Purpose:** "...Section 5: I further direct that there be paid to the following organizations the sum of five hundred dollars (\$500.00) each... George Robert White Foundation"

Name: Mary E. Lampson Fund

**Year Established:** 1974 (from 1930 Bequest)

**Purpose:** "...To the City of Boston ...to hold and invest and reinvest the same and to use the income therefrom for the purchase of coal for the poor and needy families of said city..."

Name: Mary P.C. Cummings Fund

Year Established: 1925

**Purpose:** "Fourth, to the City of Boston, Massachusetts, I give and devise all the land together with the building thereon, in the City of Woburn and Town of Burlington, Massachusetts, which was conveyed to me by Charles Fairchilds by deed dated February 26, 1890, and recorded with Middlesex South District Deeds, Book 1967, page 131, excepting so much thereof as shall have been conveyed by me in my lifetime or is herein otherwise specifically devised the same being purposes and uses: To hold and keep the same forever open as a public pleasure ground, and to maintain and care for the same in a suitable manner in accordance with that purpose..."
