Public Hearing Continued

PHC 1. On a joint petition by the City of Boston Transportation Department and the City of Boston Public Works Department for the making of **Specific Repairs** within the following public ways in West Roxbury, consisting of curb realignment, roadway and sidewalk reconstruction, as well as new and relocated pedestrian ramps, specialty pavement, traffic signal infrastructure, street lighting infrastructure, stormdrain infrastructure, landscaping, driveway curb cuts, and raised crosswalks:

- South Street generally between Fletcher Street and Walter Street;
- Walter Street generally between South Street and Hewlett Street;
- Fletcher Street northwest of South Street;
- Robert Street southeast of South Street;
- Farquhar Street northwest of South Street;
- South Walter Street southeast of South Street;
- Hewlett Street northwest of Walter Street.

PHC 2.
