At interior: Replace existing 1990s pendant lights with Monterey Hanging Lanterns



**25.0857 MHT - 15 WIGGLESWORTH STREET**

At garden level:

- dig window well around the center bay window
- build a retainer wall using red brick or cinder blocks
- enlarge central casement window height but maintain identical width
- install a new casement window.
