**5:21 PM**: Commissioner Trowbridge called the public hearing to order. She also briefly explained how to participate in the online hearing. There were no members of the press present.



Proposed Work: At front facade reopen three bricked-in garden level windows and install windows and window wells; and at rear elevation replace seven windows, replace section of stockade fence with brick wall, and install gate and lighting.

**PROJECT REPRESENTATIVES:** Derek Bloom, Seang Ny, and Rob and Amy Kadner were the project representatives.

**DOCUMENTS PRESENTED:** Documents presented included photos of existing conditions and plans for the proposed work.

**DISCUSSION TOPICS:** Discussion topics included the appropriateness of using metal window wells, and the appropriate style of window for the front garden-level windows.

**PUBLIC COMMENT:** There was no public comment.

# COMMISSIONER RUSSELL MOTIONED TO APPROVE THE APPLICATION WITH PROVISOS. COMMISSIONER KUTCHIN SECONDED THE MOTION. THE VOTE WAS 3-0-0 (Y: JK, NR, ST)(N: NONE)(ABS: NONE).

- The window sash at the front facade lower level should be a hopper window or fixed-in-place window with final details remanded to staff.
- III. ADMINISTRATIVE REVIEW/APPROVAL: In order to expedite the review process, the Commission has delegated the approval of certain work items, such as those involving ordinary maintenance and repair, restoration or replacement, or which otherwise have a minimal impact on a building's appearance, to Commission staff pending ratification at its monthly public hearing. Having been identified as meeting these eligibility criteria and all applicable guidelines, the following applications will be approved at this hearing:
  - Applicants whose projects are listed under this heading **NEED NOT APPEAR** at the hearing. Following the hearing, you will be issued a Determination Sheet to present at the Inspectional Services Department (1010 Massachusetts Avenue) as proof of project approval when applying for permits. ISD personnel will send an electronic copy of your building-permit application to the commission staff for review. (To avoid potential confusion, the text of your building-permit application should be consistent with the project description given below.) Commission staff will accordingly authorize the

execution of the work, attaching any applicable provisos, reflecting the relevant guidelines and precedents.

▶ PLEASE NOTE THAT FOLLOWING ISSUANCE OF THE DETERMINATION SHEET NO FURTHER CORRESPONDENCE WILL BE ISSUED FOR THE APPLICATIONS LISTED BELOW. The electronic building-permit application as annotated by commission staff will constitute your Certificate of Appropriateness; this will be valid for two years from the date of the approval letter. The applicant is required to notify the commission of any project changes; failure to do so may affect the status of the approval.
