I. BOSTON LANDMARKS COMMISSION BUSINESS HEARING 6:04 PM

6:04 PM: Commissioner Walker called the public hearing to order. He explained that, pursuant to the Commonwealth of Massachusetts Executive Order Suspending Certain Provisions of the Open Meeting Law, that the public hearing was being conducted virtually via the online meeting platform Zoom in order to review Design Review applications. He also briefly explained how to participate in the online hearing. Member of the press, Alison Pultinas, Fenway News made herself known. Elected officials present included Senator Nick Collins, Boston City Councilor Gabriela Coletta and her staff member Elaine Donovan, Kevin O'Sullivan, a representative from Boston City Councilor Erin Murphy's office, and a representative from Boston City Councilor Ed Flynn.

Following this brief introduction Commissioner next reviewed petitions, study reports, and designation.

DISCUSSION TOPICS: Discussion topics included an overview of the existing conditions, a summary of the modifications and restorations made to the property, elements of the property that are original to the 1791 building, the previous and current owners, the historical significance of the property, and staff recommendations regarding the survey rating of local importance.

COMMISSIONER COMMENTS AND QUESTIONS: Commissioners discussed which elements of the property were original and restored.

PUBLIC COMMENT: Joseph Zuffante, a petitioner representative, spoke in support of the petition and landmark designation.

Five written comments were submitted in opposition to the landmark designation. Letters from the property owners' legal representatives stated that the property does not meet the criteria for designation. An online petition with 112 signatures opposing the landmark designation was also submitted.

Douglas Stefanov, the property owner's representative, offered comments regarding the criteria for landmark designation and the property's architectural elements.
