BOSTON AIR POLLUTION CONTROL COMMISSION

In accordance with the Procedures and Criteria for the Issuance of Parking Freeze Permits adopted under M.G.L. Chapter 111, Section 31C, and pursuant to the Building Emissions Reduction and Disclosure Ordinance, Boston City Code, Ordinances, Section 7-2.2, the City of Boston Air Pollution Control Commission will hold a **virtual public hearing at 2:30 p.m. on October 15, 2025**, to review the following projects to regulate and control air pollution so as to promote the public health and welfare of Boston residents.

Any matter posted as part of a public hearing may be deliberated on at a subsequent meeting.

Members of the public may share public comments during the hearing. The Air Pollution Control Commission will also accept written testimony for agenda items via email at apcc@boston.gov prior to the hearing. Written testimony should be submitted by October 8, 2025 at noon.

PUBLIC HEARING:

Application for a Modified Downtown Boston Parking Freeze Permit from The Druker Company, Ltd. on behalf of Arlington-Boylston Realty Trust for 150 commercial spaces in a garage at 350 Boylston St. This application requests modification of an existing permit for 150 exempt parking spaces, to change the usage of the spaces to commercial parking. Issuance of permit would withdraw 150 spaces from the Downtown Boston parking freeze bank.

Application for a Modified Downtown Boston Parking Freeze Permit from Towne Park LLC on behalf of Related Beal for 40 commercial spaces, 59 exempt spaces, and 121 residential excluded spaces in a garage at 101 Beverly Street. This application requests modification of an existing permit for 69 exempt spaces and 151 residential excluded spaces. Issuance of permit would withdraw 40 spaces from the Downtown Boston parking freeze bank.
