The Boston City Council's Committee on Ways and Means will hold a hearing on **Thursday**, **November 6**, **2025 at 10:00 am.** This hearing will be held **virtually**.

The subject of the hearing is:

Docket #1926, Message and order for your approval an Order authorizing the City of Boston to appropriate the amount of Eleven Million One Hundred Thousand Dollars (\$11,100,000.00) for the purpose of paying costs for the window and door replacement projects at the following schools: the Gardner Pilot Academy School and the Lyndon Elementary School. This includes the payment of all costs incidental or related thereto, and for which the City of Boston may be eligible for a grant from the Massachusetts School Building Authority ("MSBA"), said amount to be expended under the direction of the Public Facilities Department on behalf of the Boston Public Schools.

This matter was sponsored by Mayor Michelle Wu, and was referred to the Committee on October 29, 2025.
