### **Discussion: CRB and IAOP Letters To Commissioner Cox**

The Commission discussed the [September 11, 2025 Civilian Review Board Letter](#) including but not limited to BPD employees' participation in the OPAT investigation process and delayed response to CRB recommendations.

The Commission discussed the [IAOP letter dated October 17, 2025](#) addressing automatic appeals. In it IAOP requests that per ordinance, the following categories of cases be automatically referred by the BPD Internal Affairs Division for review within fourteen (14) days of a finding of not sustained, exonerated or unfounded:

- Excessive use of force
- Theft
- Death in custody
- Perjury
- Unlawful arrest or stop
- Abuse of authority
- Violation of the Bias Free Policing policy

### **Discussion: Updates to OPAT Commission Regulations**

The Commission reviewed OPAT Commission Regulation 2.01 – This regulation pertains to the timing of responses from the BPD Commissioner after an investigation. The proposed timeframe is 45 days.

(adding language around 45 day timeframe)**

The Commission reviewed OPAT Commission Regulation 2.02 – This regulation pertains to findings of the CRB being final and remaining undisturbed by the BPD Commissioner. Samuel Harold proposed an update to include “and” after “final”.

The Commission discussed how OPAT’s ordinance allows for Commissioner Cox to only have discretion regarding the CRB’s recommended discipline on a case and not its findings.

The Commission reviewed OPAT Regulation 2.03 – This regulation pertains to subpoena powers. The Commission proposed a verbiage update “to issue a subpoena” in order to reflect the active nature of this power.

The Commission addressed Regulations 1.01 and 1.02 for further discussion.

- 1.01 had proposed verbiage updates to make it consistent with BPD regulations and POST regulation. Striking out “greater than” and “;but less than the beyond a

reasonable...”

- 1.02 had proposed updates to the single entry policy. Although OPAT cannot interfere with criminal investigations, there should still be an ability to review cases in tandem with both POST or IAD.
