### **ADDITIONAL PROVIDER-SPECIFIC ELIGIBILITY GUIDELINES:**

#### ❖ **XFINITY**

- You must not have had Xfinity Home Internet for the past 90 days
- You must not have any outstanding debts to Comcast that are less than 1 year old

#### ❖ **VERIZON**

- You may also be eligible if you receive WIC benefits

#### ❖ **T-MOBILE**

- You may also be eligible if you receive EBT, CEP, or be a foster, migrant, or runaway youth

#### ❖ **ASTOUND**

- You may also be eligible if you receive FSEOG or TEACH grants, or receive Iraq and Afghanistan Service Grants

#### ❖ **LIFELINE**

- You may also be eligible if you receive Bureau of Indian Affairs General Assistance or Veterans and Survivors Pensions Benefits
