



## **RINGER PARK CONSTRUCTION UPDATE DECEMBER 2025 - JANUARY 2026**

Thank you for your interest in the improvements to Ringer Park. We know this is an important community and event space, and our goal is to reopen the park in the summer of 2026. Below are some important construction updates.

We recognize that some of the recent site work has been noisy and disruptive for some neighbors. During excavation, significant ledgestone was discovered that needed to be removed to install new underground utilities; this drilling process causes the hammering sounds you may have heard. We apologize for any disturbance caused to your daily lives.

The contractor plans to cease all work and shut down the site at the end of this week until temperatures rise enough to allow work to safely resume. The contractor is expected to return in late February or March, weather permitting. There should be no construction activity until then.

We also want to share an update regarding several trees along the path behind the tennis courts. Due to unforeseen subsurface conditions requiring additional excavation, four trees will need to be removed that had not been previously marked. To offset this impact, six (6) new 3-inch caliper trees will be planted.

Finally, construction revealed that the existing subsurface electrical infrastructure serving the sport courts are in poorer condition than anticipated. The existing sport court lights and conduit have therefore been removed with the intent to replace them with new lighting infrastructure. This potential change order is under review, and we will continue to keep the community informed about this topic as the details become more clear.

### **CONSTRUCTION DECEMBER-JANUARY:**

- Demolition of electrical systems
- Removal of existing non-salvagable light poles
- Installation of catch basins
- Installation of drain lines
- Cleaning and lining of existing drain lines to be removed
- Woodland path regraded

## WHAT TO EXPECT JANUARY - MARCH:

- No construction until further notice.


