Chapter 111, Section 31C, and pursuant to the Building Emissions Reduction and Disclosure Ordinance, Boston City Code, Ordinances, Section 7-2.2, the City of Boston Air Pollution Control Commission will hold a **virtual public hearing at 2:30 p.m. on March 11, 2026**, to review the following projects to regulate and control air pollution so as to promote the public health and welfare of Boston residents.
