Deputy Director's Report

Deputy Director Laine provided a status update regarding the CRB's 9.11.25 letter to the Commissioner noting that the OPAT Commission would be meeting and that further discussion regarding the letter was forthcoming.

Subcommittee members expressed that the CRB remains available to engage with the BPD Commissioner regarding the contents of the letter, if requested.

Policy Discussion: Information Sharing and Federal Agencies

- Subcommittee members discussed information sharing between BPD and federal agencies, including BRIC-related matters and the policies governing such practices.
- Subcommittee members discussed Snapchat surveillance and investigative use
- Subcommittee members identified the need for a review of any written policies governing above practices, and public availability of any existing policies

Members emphasized the urgency of the issue given the current climate surrounding federal enforcement actions, including ICE activity.

Members further discussed the broader relationship between BPD and federal law enforcement agencies:

- The federal 287(g) program, recommending against participation
- The Massachusetts Safe Communities Act
- The presence of ICE, HSI, and FBI task forces operating within BPD facilities

There was ongoing discussion regarding Boston's designation as a sanctuary city and legal and policy implications of such status.

Discussion on Board Coordination

Members discussed how CRB, IAOP and OPAT Commission are addressing similar issues and suggested a proposed workflow model.

- Narrowing information-sharing provisions with the FBI
- Including recommendations regarding relevant grants
