COMMITTEE HEARING NOTICE

March 24, 2026

The Boston City Council's Committee on Ways and Means will hold a hearing on **Thursday, March 26, 2026 at 10:30 am**. This hearing will be held **virtually**.

The subjects of the hearing are:

Docket #0570, Message and order authorizing the City of Boston to appropriate the amount of Twenty Million Two Hundred Thousand Dollars (\$20,200,000.00) for the purpose of paying costs for the window and door replacement projects at the following schools: Adams Elementary School. This includes the payment of all costs incidental or related thereto, and for which the City of Boston may be eligible for a grant from the Massachusetts School Building Authority ("MSBA"), said amount to be expended under the direction of the Public Facilities Department on behalf of the Boston Public Schools.

Docket #0571, Message and order authorizing the City of Boston to appropriate the amount of One Million One Hundred Thousand Dollars (\$1,100,000.00) for the purpose of paying costs for the window and door replacement projects at the following schools: Margarita Muniz Academy, Mildred Avenue K-8 School, Orchard Gardens School. This includes the payment of all costs incidental or related thereto, and for which the City of Boston may be eligible for a grant from the Massachusetts School Building Authority ("MSBA"), said amount to be expended under the direction of the Public Facilities Department on behalf of the Boston Public Schools.

This matter was sponsored by Mayor Michelle Wu, and was referred to the Committee on March 18, 2026.

NOTICE: The Boston City Council may have a quorum participating due to standing committees of the City Council consisting of both voting and non-voting members. However, members participating in this duly posted meeting are participating and deliberating only in conjunction with the business of the standing committee.

Attendance In accordance with Chapter 2 of the Acts of 2025 modifying certain requirements of the Open Meeting Law and relieving public bodies of certain requirements, including the requirement that public bodies conduct its meetings in a public place that is open and physically accessible to the public, the City Council will be conducting this hearing remotely. This enables the City Council to carry out its responsibilities while ensuring public access to its deliberations through adequate, alternative means.
