COMMITTEE HEARING NOTICE

April 15, 2026

The Boston City Council's Committee on Environmental Justice, Resiliency, and Parks will hold a hearing on **Tuesday, April 21, 2026 at 11:00 am**. This hearing will be held **virtually**.

The subjects of the hearing are:

Docket #0260, Message and order for the confirmation of the appointment of Samira Ahmadi as a Member of the Building Emissions Reduction and Disclosure Ordinance (BERDO) Review Board, for a term expiring May 23, 2026.

This matter was sponsored by Mayor Michelle Wu, and was referred to the Committee on February 4, 2026.

Docket #0760, Message and order for your approval an appropriation order in the amount of Eight Hundred and Sixty Thousand Dollars (\$860,000) for the Cemetery Division of the Parks and Recreation Department and the Trust Office of the Treasury Department to be funded from the Cemetery Trust Fund established under Chapter 13 of the Acts of 1961.

Docket #0761, Message and order authorizing the City of Boston to accept and expend the amount of Three Hundred Seventy-Five Thousand Dollars (\$375,000.00) in the form of a grant, Red Sox Arts and Parks Program Grant, awarded by the Boston Red Sox to be administered by the Mayor's Office.

These matters were sponsored by Mayor Michelle Wu, and were referred to the Committee on April 8, 2026.
