To Whom it May Concern,

Enclosed please find the Application of THEATRE DISTRICT LLC (the Applicant) to the City of Boston Air Pollution Control Commission (APCC) for a modification to APCC South Boston Parking Freeze Permit No. APCC453676, in connection with a request for additional spaces within the Boston Proper Freeze Zone. The Site is currently permitted for 275 commercial spaces with additional exempt spaces for fleet vehicles. The Applicant requests to convert all existing except spaces to commercial, an additional 70 spaces (345 total), to meet the demands of current garage operations. The Permit Application retains the existing parking configuration and site access. The Site has no ongoing or expected review by other City agencies.

As further detailed in the enclosed materials, the Applicant seeks the APCC's approval of a modified South Boston Parking Freeze Permit. In support of this application, we provide the following Exhibits:

Statement of Need

133-135 STUART STREET – STATEMENT OF NEED

Parking Freeze Application to Modify Downtown Parking Freeze Permit

Exemption #APCC453676

Theatre District LLC (the “Applicant”), an affiliate of Boylston Properties., is the master lessee for 48,000 square feet of ground floor retail and below grade garage at 133-135 Stuart Street, commonly known as 10 Park Plaza or the State Transportation Building, bordering Charles Street S, Stuart Street, and Tremont Street in the Bay Village neighborhood of Boston (the “Property”). The Property Owner (Massachusetts Department of Transportation - MassDOT) has a long-term ground lease with the Applicant. The Applicant has been issued Downtown Parking Freeze Permit Exemption #APCC453676, which expires on July 1, 2026, for a parking facility at the Property with 275 commercial vehicle parking spaces (as described below, the “Garage”).

The Garage contains 275 commercial vehicle parking spaces, has a single access point on Charles Street South. The Property meets the intentions of the BTD EV Readiness Guidelines and Bike Parking through 7 spaces with Type 2 EVSE installed chargers and, as well as 36 long-term/employee bicycle parking spaces with access to two locker rooms, 4 showers and 59 lockers. In addition, 12 visitor bicycle parking spaces in six racks are provided around the Site. The Garage specifics are further shown on the enclosed Site Plan and Parking Level Plans.

The Garage is integrated within, and located directly below, the State Transportation Building, eight story office and retail building. The office floors two through eight are fully occupied by State Agency Office including MassDOT-including Highway, Rail, Aeronautics, Office of Diversity and Civil Rights, General Counsel-, Massachusetts Bay Transportation Authority (MBTA), Department of Conservation and Recreation (DCR), Boston Region Metropolitan Planning Organization and executive offices for the Secretary of Transportation . The Garage is generally self-park with a small valet component to allow for surge of capacity during week workdays.

The number of vehicle parking spaces in the garage was originally approved by the Commission via letter dated February 24, 1978, issued by the Acting Executive Director. That approval included 275 commercial parking spaces and 100 fleet vehicle spaces. Since that time, the operational needs of the Commonwealth’s office space have evolved, and the Executive Office of Transportation and MassHighway (the predecessor to MassDOT) have continuously occupied space at the property.

In 1985, a letter from EOT’s General Counsel indicated that the garage could accommodate up to 340 vehicles, including 124 spaces reserved for the motor pool and 33 reserved spaces. Subsequently, a 1994 letter from the APCC Executive Director approved the facility for up to 375 spaces, including 18 spaces associated with a rental car function.

More recently, the garage underwent a major rehabilitation in 2022 that included structural repairs, ventilation upgrades, parking system improvements, EVSE installation, and restriping.

Through this Parking Freeze application, the Applicant requests to modify the existing Downtown Parking Freeze Permit to increase the number of commercial parking spaces from 275 to 345 to reflect current garage operations. This modification would formalize fleet vehicle spaces that were previously not included in the permit space count but have generally been considered exempt under the Downtown Boston Parking Freeze Regulations. Given changes in the use of the facility, the request seeks to classify all spaces as commercial to provide flexibility as the Commonwealth's state agency office needs continue to evolve. The intent is to continue supporting general commercial parking needs, including evening and weekend demand associated with the adjacent Theatre District.

For these reasons, approval of this application is respectfully requested. Thank you for your consideration.

- (ii) the portion of the second floor of the Building labeled and identified on Exhibit A as the "Building Food Service Area", unless and to the extent the same is removed from the Premises as provided in the Lease;
- (iii) to the extent (and as long as) the same is a part of the Premises pursuant to the Lease, the portion of the second floor labeled and identified on Exhibit A as the "Second Floor Option Premises"
- (iv) the portion of the Building labeled and identified on Exhibit A as the "Food Court".

TERM: The period commencing on September 12, 1985 and ending on January 31, 2021, subject to the options to extend described below.

OPTIONS TO EXTEND OR RENEW

Tenant has two (2) options to extend the term for two consecutive periods of ten (10) years each, and, subject to the provisions of the Lease, certain holders of a leasehold mortgage on the Tenant's interest under the Lease have the right to extend the term for an additional period of five (5) years.

OTHER PROVISIONS

The Lease also contains the following provisions:

Notwithstanding the bankruptcy of Landlord and any rejection of the Lease, any Permitted Leasehold Mortgage (i.e., a mortgage on Tenant's interest in the Lease which qualifies as such under the Lease) shall be deemed to have encumbered, and its rights shall extend to, any continuing rights to possession of the Premises by Tenant which shall retain the same priority as the Permitted Leasehold Mortgage possessed at the time of recording thereof.

In the event of termination of the Lease by reason of certain defaults of Tenant or in the event of the rejection of the Lease in a bankruptcy or insolvency or similar proceeding involving Tenant, Landlord will enter into a new Lease with the holder of a Permitted Leasehold Mortgage on the same terms as the Lease as existed immediately prior to such termination, subject to certain provisions set forth in the Lease. Any such new Lease shall be superior to and shall not be subordinated to any mortgage or other lien or other encumbrance now or hereafter existing on all or any portion of the Building and/or the Land.

For the authority of Landlord to execute and deliver the Lease, see Chapter 240 of the Acts of 1984.

This instrument is executed pursuant to the provisions contained in the Lease and is not intended to vary the terms and provisions thereof.

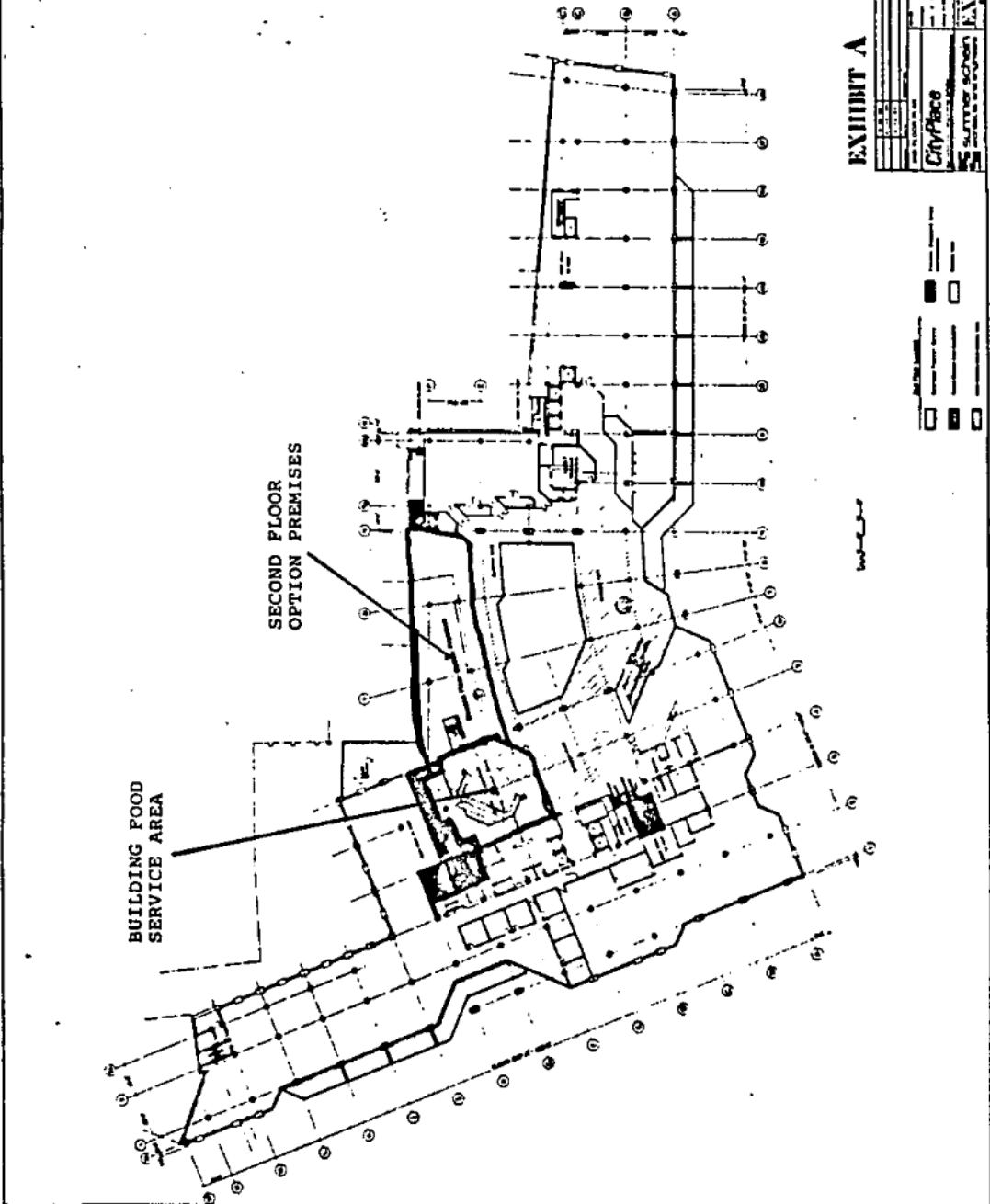

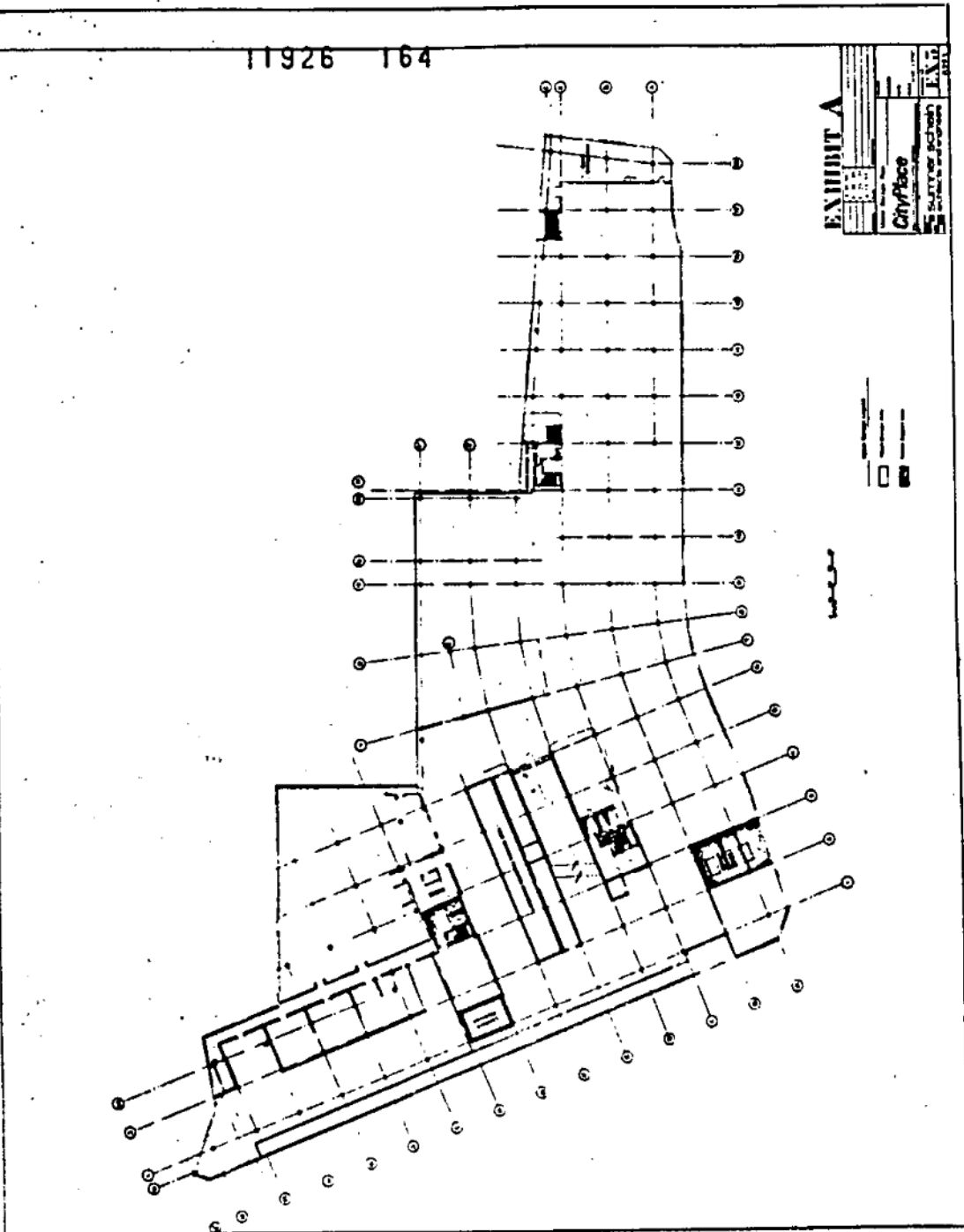

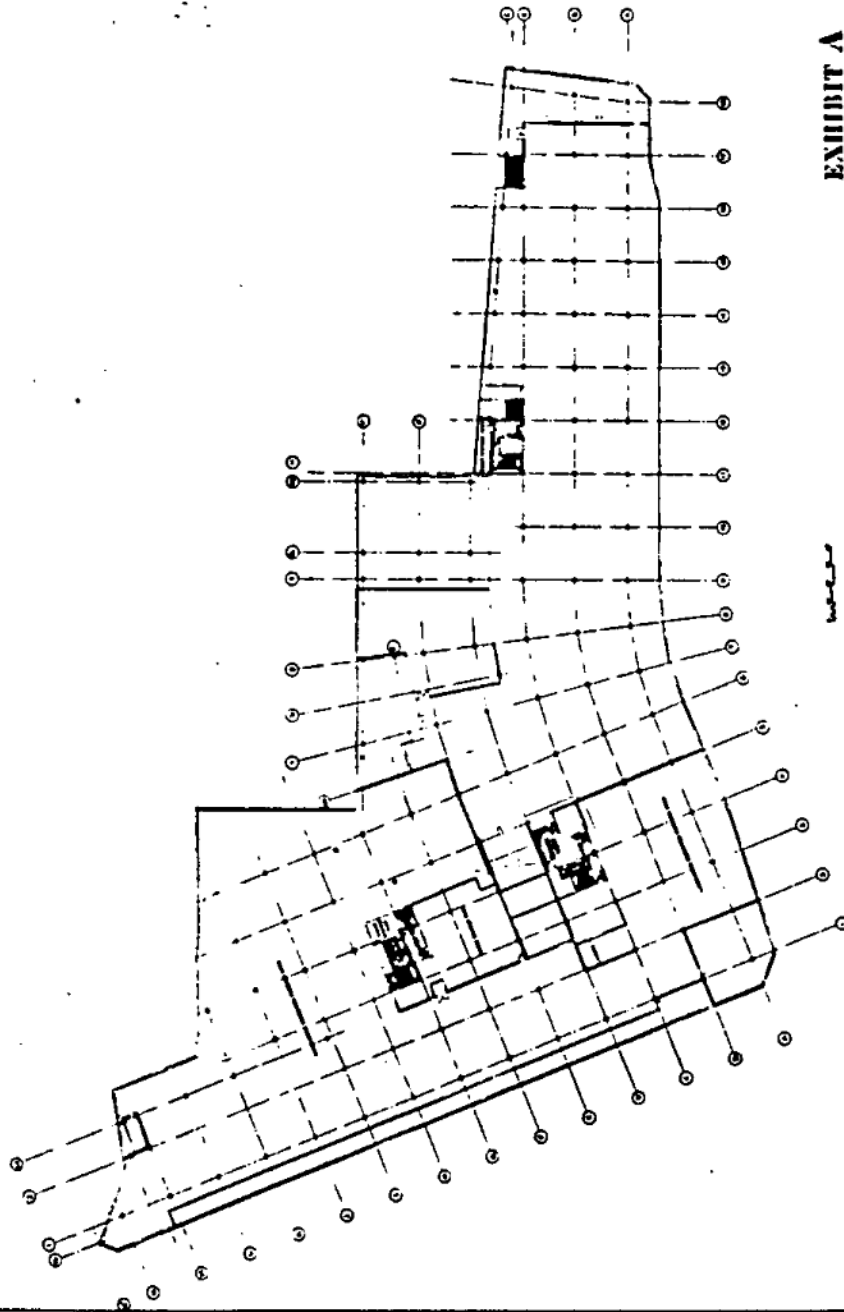

SCHEDULE C

Collateral Rights: The following items shall together constitute the Collateral Rights:

- (i) The non-exclusive right to utilize the Parking Garage in common with Landlord, those authorized by Landlord consistent with the provisions of this Indenture and the public as such right is specifically described in this Indenture and subject to the terms hereof.
- (ii) The exclusive right to use the areas labelled and identified on Exhibit A as "Retail Storage Area" and "Tenant's Exclusive Support Area" and the right to use, in common with Landlord and those authorized by Landlord, the areas labelled and identified on Exhibit A as "Tenant's Non-exclusive Support Area."
- (iii) The right, in common with Landlord and others entitled thereto, including without limitation, Landlord's employees, persons having business with Landlord, other tenants of Landlord, all Building occupants, and the public generally to use: (A) all public or commonly used streets, sidewalks, drives and ways located on the Land providing access and egress to and from the Building and the Parking Garage, provided, however, that there is hereby reserved unto Landlord the right, after not less than thirty (30) days prior written notice to Tenant, to relocate any such access or egress at any time and from time to time in such manner as may be reasonably satisfactory to Tenant; (B) all public doors of the Building, public stairs and stairwells, public elevators and escalators and freight elevators providing access to and egress from the Building; (C) such non-public Building entryways not otherwise included in the Collateral Rights hereunder which Landlord may permit Tenant to use from time to time (which use of such non-public building entryways by Tenant may be revoked from

time to time or at any time by written notice from Landlord); (D) the loading docks, freight areas, freight elevators, service courts, and the compactor and rubbish room shown on Exhibit A during the normal business hours in which such areas are utilized by Landlord, Monday through Friday, and such other days and times as Landlord may approve in writing prior to the commencement of such use, such approval not to be unreasonably withheld, provided that Tenant shall pay to Landlord all of Landlord's additional costs, including additional security and/or maintenance costs (or, at Landlord's option, Tenant shall provide such additional security and/or maintenance at Tenant's expense), resulting from Tenant's use of the same during such other days and times, all to the reasonable satisfaction of Landlord; (E) the "Common Areas" hereinafter defined; (F) all pipes, ducts, conduits, wires and meters and appurtenant equipment serving the Premises, whether or not in common with other portions of the Building, including, without limitation, the duct risers shown on Exhibit A, all central installations of utility services intended to serve the Premises or the Building and the right to use the areas near the ceiling of the upper level of the Parking Garage for the installation and maintenance of utility lines serving the Premises; (G) the areas referred to in Section 26.27 used as sidewalk cafes in accordance with and subject to said Section; and (H) subject to Landlord's prior approval, which shall not be unreasonably withheld or delayed, in writing in each instance, the Land and such portions of the Building, including Landlord's risers, conduits, feeders, pipes, wiring and the like, necessary or convenient to provide utilities and other services to the Premises from time to time, including, without limitation, water, electricity, sewerage, sprinklers, heating, ventilating, air-conditioning and telephone, provided that all installations in the unimproved portions of the Land shall be underground only, and all other such utility connections shall be within interior walls or in areas designed therefor or otherwise located so as not to be visible or otherwise receive Landlord's prior written consent.

(iv) Such rights as Landlord may have to use, in common with Landlord and those authorized by Landlord, the alleys abutting the Land or in the vicinity thereof now known as Allen's Alley, Boylston Place and Carver Street.

Common Areas: The common areas and facilities of the Building as identified on Exhibit A, including without limitation, the Mall, hydraulic elevators and stairs and stairwells leading from and to each floor of the Parking Garage and the ground floor of the Building and, solely to the extent that the Second Floor Premises remain a part of the Premises, the second floor lobby and corridors adjacent to or serving the Second Floor Premises and all stairs and stairwells, escalators, and hydraulic elevators leading from and to the second floor and the ground floor of the Building. The restrooms in the First Floor Premises and the Food Court are part of the Premises, but shall be available for use by the public as provided in this Indenture and shall be considered as Common Areas hereunder for the purpose of the reserved rights of Landlord described in this Section 1.

Parking Garage: The two-level Parking Garage situated in the basements of the Building and so labelled and identified on Exhibit A.

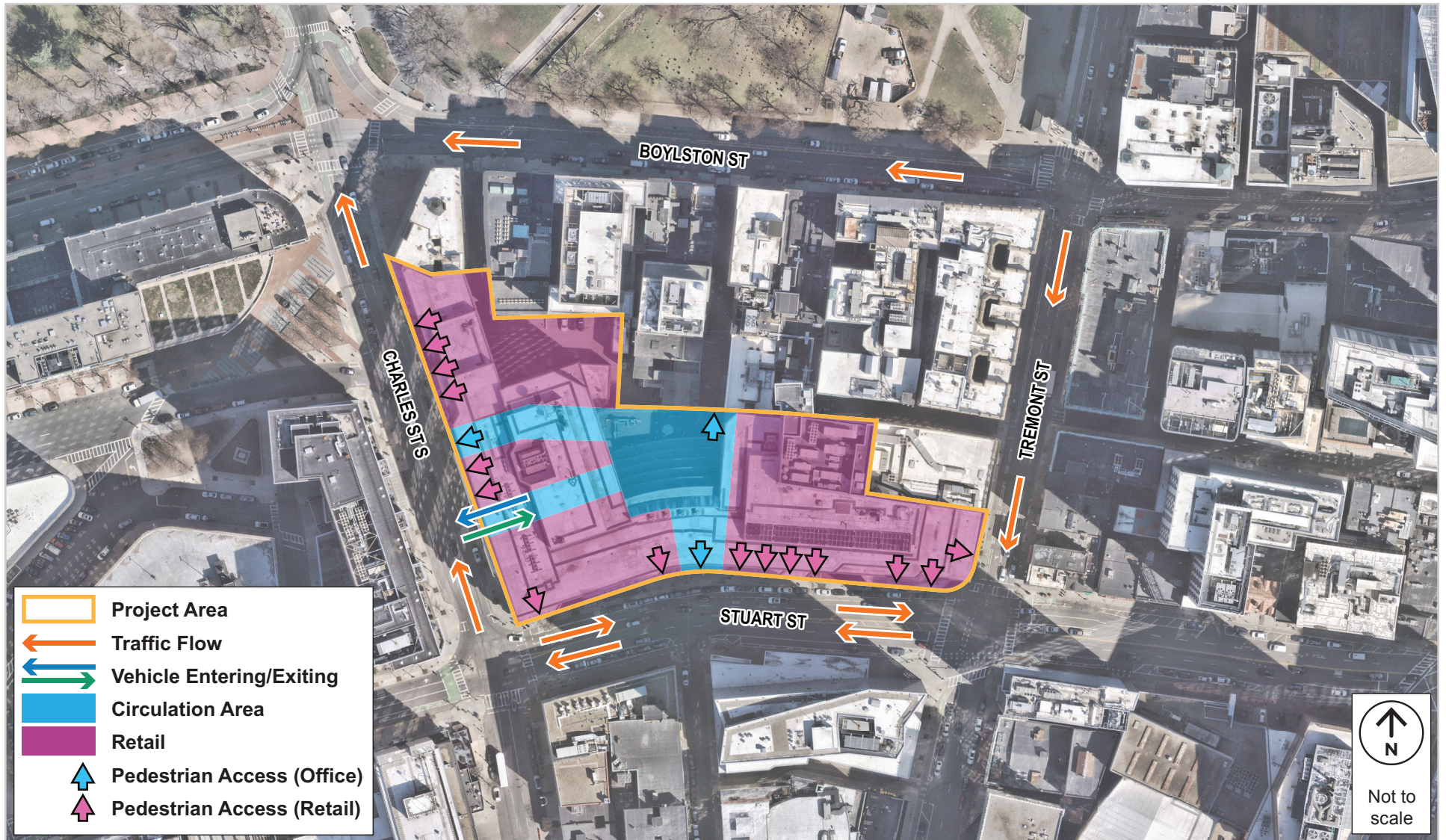




Figure 4. *Parking Floor Plan - Upper Level*

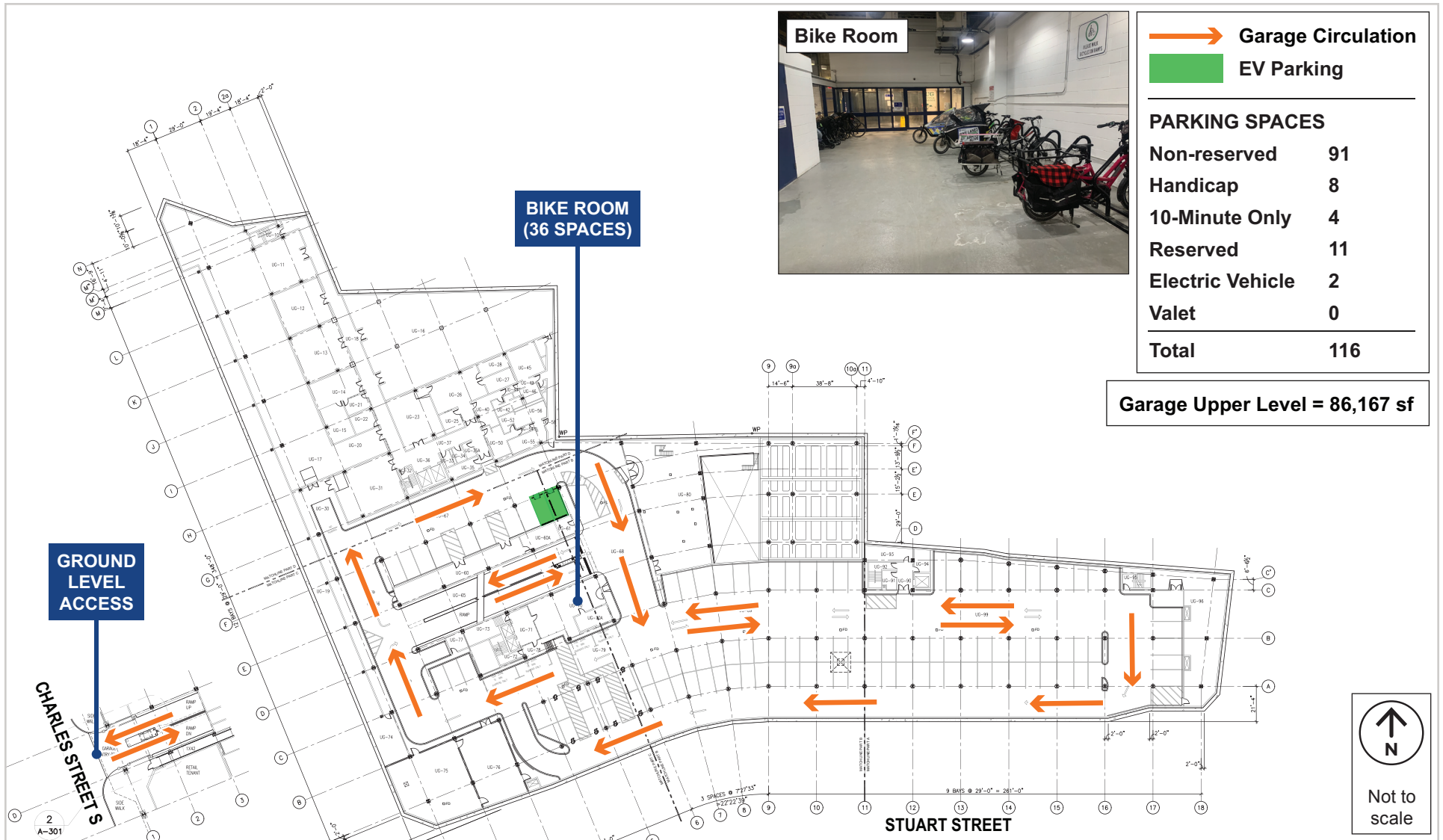
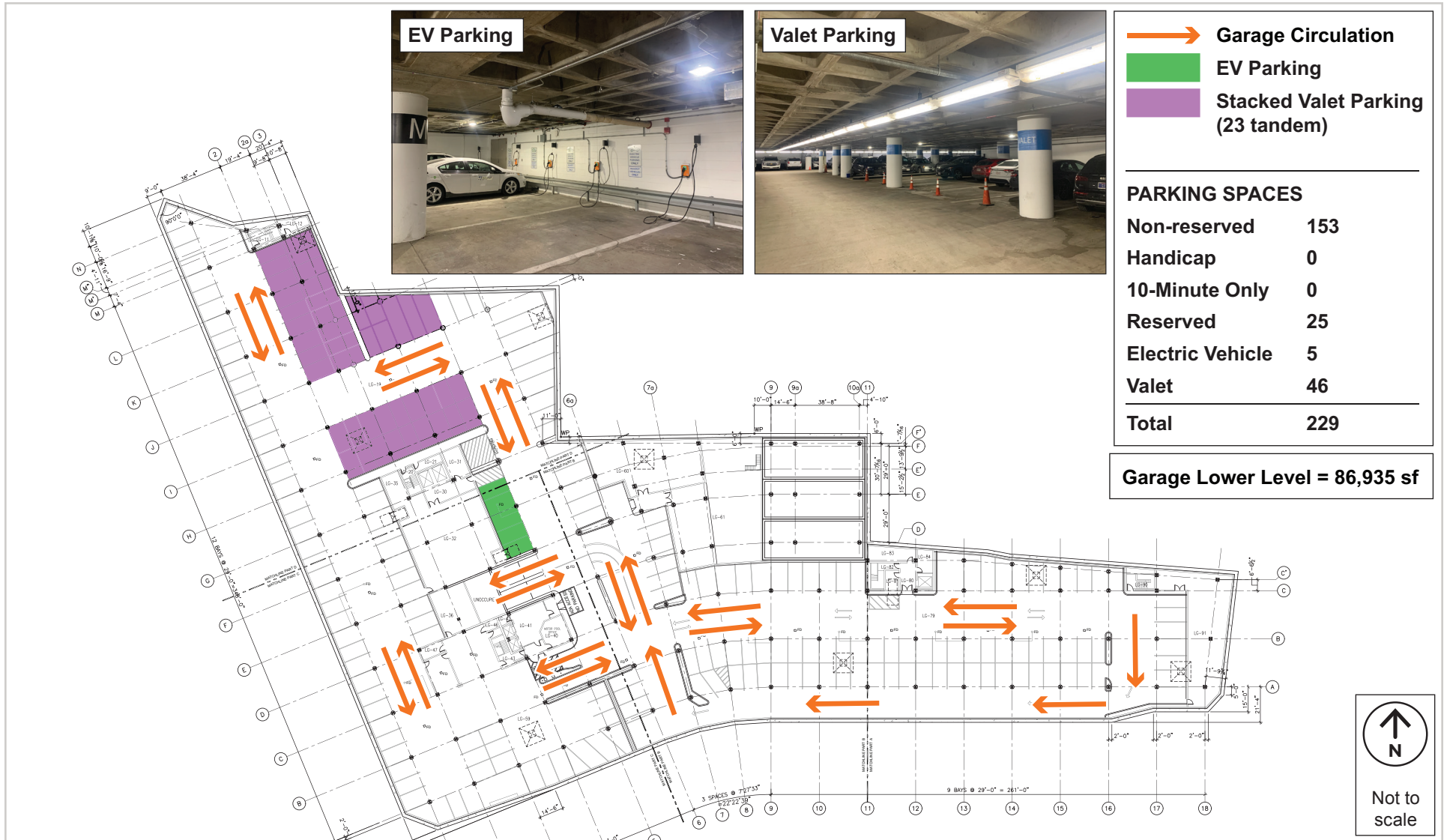




Figure 5. *Parking Floor Plan - Lower Level*
