In accordance with the Procedures and Criteria for the Issuance of Parking Freeze Permits adopted under M.G.L. Chapter 111, Section 31C, and pursuant to the Building Emissions Reduction and Disclosure Ordinance, Boston City Code, Ordinances, Section 7-2.2, the City of Boston Air Pollution Control Commission will hold a **virtual public hearing at 2:30 p.m. on June 17, 2026**, to review the following projects to regulate and control air pollution so as to promote the public health and welfare of Boston residents.

Any matter posted as part of a public hearing may be deliberated on at a subsequent meeting.

Members of the public may share public comments during the hearing. The Air Pollution Control Commission will also accept written testimony for agenda items via email at apcc@boston.gov prior to the hearing. Written testimony should be submitted by June 17, 2026 at noon.

Application for a Modified Downtown Boston Parking Freeze Permit from Howard Stein Hudson and Boylston Properties on behalf of Theatre District LLC for 345 commercial spaces in a garage at 133–135 Stuart Street. This application requests modification of an existing permit for 275 commercial spaces. Issuance of the permit would withdraw 70 spaces from the Downtown Boston parking freeze bank.

Continued; Application for a Modified South Boston Parking Freeze Permit from Kennedy Law Office on behalf of Stanhope Garage, Inc. for 15 commercial spaces in a surface lot at 19–21 A Street. This application requests modification of an existing permit for 11 commercial spaces.
