>> WE'RE TO DISCUSS AN ORDER ON THE PRESERVATION ACT TO HOLD INTERVIEWS FOR THE COMMITTEE PURSUANT TO CHAPTER FOUR OF THE ORDINANCES OF 2017 AN ORDINANCE CREATING THE PRESERVATION COMMITTEE.

THE SPECIAL COMMITTEE IS
REQUIRED TO NOMINATE FOUR
PERSONS TO BE CONSIDERED BY THE
FULL CITY COUNCIL.

AS CHAIR OF THE COMMITTEE I SPONSOR THE DOCKET 1433 IN ORDER FOR THE COMMITTEE TO INTERVIEW THE FINALIST FROM A LIST OF OVER 100 APPLICANTS, 104 TO BE EXACT AS RECOMMENDED BY THE WORKING GROUP CREATED AND SPONSORED BY CITY COUNCIL PRESIDENT WU HELD MONDAY NOVEMBER 20th AND THE SESSIONS APPLICANTS DESCRIBED THEIR INTEREST, STRENGTH AND PAST WORK AND PERSONAL EXPERIENCE.

FURTHER, APPLICANTS GAVE EXAMPLES OF PROJECTS AND DISCUSSED PRIORITIES OF FUNDING AND PRIORITIZATION OF THE USE OF THE FUNDS AND THE FEASIBILITY OF THE PROJECTS.

AT THE END OF THE LAST INTERVIEW, THE COMMITTEE ENTERED INTO A SECTION 28A8 TO DETERMINE THE LIST OF THE FOUR CANDIDATES THAT WILL BE PRESENTED TO THE BOSTON COUNCIL.

DURING THE EXECUTIVE SESSION THE COUNCIL MUST DISCUSS THE QUALIFICATIONS OF THE INDIVIDUALS AND CONSIDER THE FACTORS LOOKING AT DEMOGRAPHICS, GEOGRAPHIC LOCATION AND BUSINESS EXPERTISE.

AFTER A DISCUSSION THE CHAIR MADE A MOTION FOR THE FOLLOWING INDIVIDUALS BE SELECTED TO THE PRESERVATION COMMITTEE SUBJECT TO CONFIRMATION BY THE FULL CITY COUNCIL.

THAT'S YING WANG, 493 ROSLINDALE, MASS FOR A TERM OF THREE YEARS AND HAS BEEN IN THE PUBLIC, PRIVATE AND NONPROFIT AND WHILE SHE APPLIED AN APPLICANT GIVEN HER ROLE AS A COUNSEL THE COUNCIL WANTED TO HIGHLIGHT THE WORK SHE'D DONE AT SPARK BOSTON AND ADVISING ON CITY POLICIES AFFECTING THE MILLENNIAL POPULATION AND THE NEXT APPLICANT FOR A TERM OF THREE YEARS AND MADELINE HAS A STORY OF GOING HOMELESS TO HOMEOWNER AND INVOLVED IN INITIATIVES FOR HOUSING AND THEN THE NEXT OF 213 WEBSTER STREET FOR A TERM OF TWO YEARS. HAS EXPERIENCE BEING DEVELOPED IN THE COMMUNITY AND HIS WORK AND WORKED WITH COMMUNITY LEADERS AND LOCAL E OFFICIALS.

AND THE LAST BUT NOT LEAST MATT KEIFER OF JAMAICA PLAINS.
HIS IN DEPTH LEGAL AND REAL ESTATE EXPERIENCE PROVIDES A UNIQUE PERSPECTIVE TO THE CPC ESPECIALLY DURING ITS INAUGURAL YEAR AND HIS TRAINING AND EXPERIENCE AND GUIDANCE WILL BE IMMEASURABLE ASSISTING IN THE ONLY THE CHAIR BUT THE ENTIRE MEMBERSHIP.

SO WITH THAT, WE ARE JOINED BY MY COLLEAGUES TO MY LEFT, ANDREA CAMPBELL AND WE HAVE QUESTIONS FOR THE FINALISTS AND FOR THEM TO ASK US QUESTIONS BEFORE WE MOVE FOR CONFIRMATION AT TOMORROW'S BOSTON COUNCIL'S HEARING.

I LIKED IT SO MUCH I STAYED THROUGH COLLEGE AND LAW SCHOOL AND I ALSO SERVEDS IN MILITARY AS A JOB OFFICER.

I REMAIN CIVICALLY ENGAGED.
FOR ME THE INTEREST IN SERVING
ON THE CPC IS JUST GIVING BACK
TO THE COMMUNITY THAT'S GIVEN ME
SO MUCH AND JUST CONTINUING TO
SHOW THAT COMMITMENT TO SEEING
THE CITY FLOURISH.

I'VE LIVED IN EAST BOSTON ABOUT SEVEN YEARS BUT THE BOSTON AREA ABOUT 20 YEARS.

BECAUSE THE IDEA SHOULD COME OUT OF THE COMMUNITY.

AND THEY COULD HAVE MEETINGS, CALL PEOPLE, HAVE THE MEETINGS PUBLIC AND HAVE CONNECTIONS. THE GOVERNMENT IS PROPOSING AN IDEA HOPEFULLY PEOPLE HAVE CONNECTIONS IN THE COMMUNITY AND TALK TO THEM ABOUT WHAT THEIR NEEDS AND CONCERNS ARE AND BASED ON THAT, COME UP WITH SOMETHING THAT ADDRESSES THE COMMUNITY NEED.

I THINK THAT WOULD BE ONE PIECE OF ADVICE I'D HAVE AND OUTSIDE OF THAT OF COURSE PEOPLE CAN THINK OUTSIDE THE BOX AND THINK OF CREATIVE INNOVATIVE THINGS TO DO WHICH IS ALSO WELCOME BUT SHOULD BE VETTED BY THE COMMUNITY FIRST.

AND THE OTHER THING I WOULD SAY IS ANYBODY WHO IS SUPPORTING ANYTHING SHOULD CONNECT WITH OTHER POTENTIAL APPLICANTS AND ORGANIZATIONS IN THEIR NEIGHBORHOOD WHO MAY BE THINKING SOMETHING SIMILAR TO CONNECT AS A COALITION INSTEAD OF A COMPETITION.

>> MADELINE AGAIN, I WAS GOING TO SECOND WHAT HE SAID. I THINK IT SHOULD BE A COMMUNITY INVOLVEMENT PROJECT OR TRANSPARENT PROCESS WE GIVE EVERY COMMUNITY AN OPPORTUNITY TO BE INVOLVED AND WE SHOULD ENCOURAGE LEADING ORGANIZATIONS WITHIN OUR COMMUNITIES WHETHER THEY'RE COMMUNITIES OR INCORPORATIONS OR ANY ORGANIZATION THAT IS DEEPLY ROOTED IN THE COMMUNITY MAKING SURE THAT THEY'RE WORKING TOGETHER ALONG WITH THE RESIDENTS TO MAKE SURE ANY PROPOSALS AND ANY IDEAS COME FORWARD ARE COMING FROM THE COMMUNITY.

I THINK PART OF WHAT WE SIGNED ONTO IS TO BE OPEN MINDED AND NOT HAVE PRECONCEIVED NOTIONS ABOUT WHAT NEIGHBORHOODS OR WHAT SPECIFIC PROJECTS ARE BEST GIVING EVERYONE A SHOT AND I THINK EVERYONE SAID SOME VERSION OF THAT.

I AGREE WITH THAT.

APPLICANTS WOULD BE TO BE ASPIRATIONAL AND ACHIEVABLE AND TO COMBINE HIGH ASPIRATIONS BUT FIGURE OUT HOW TO GET IT DONE. WE'RE SPENDING PUBLIC MONEY AND YOU WANT TO MAKE SURE IT HAS THE EFFECT PEOPLE WANT IT TO HAVE. THINK IT THROUGH AND SHOW US YOU'VE GOT A WAY TO DO IT. >> THANK YOU SO MUCH TO ALL FOUR OF YOU AND AGAIN TO THE COMMITTEE CHAIR AND THE MEMBERS OF THE COMMITTEE. I TRUST THAT EVERYONE HAS BEEN THROUGH A VIGOROUS TRAINING AND WE'RE ALWAYS PREPARED TO HELP WITH THAT AS WELL.
