JUST TO GO BACK A LITTLE WAYS WE

STARTED THIS PROCESS WITH A

HUNDRED OFFICERS WEARING THE CAMERAS IN SEPTEMBER OF 2018.

THE OFFICERS WORE THEM FOR SIX

THE OFFICERS WORE THEM FOR SIX MONTHS ORIGINALLY.

AFTER THE SICK MONTHS WE

ATTENDED A MEETING I THINK

COUNSELOR CAMPBELL HOSTED.

WE HEARD A LOST FEEDBACK ON THE TECHNICALITIES.

ONE WAS TO EXTEND IT ANOTHER SIX MONTHS.

WE ONLY HAD A SNAP SHOT OF SEPTEMBER TO MARCH.

THOSE AREN'T USUALLY OUR BUSIEST MONTHS.

WE EXTENDED IT THE FULL YEAR.

IN LEADING UP TO THIS WE HAD NOT ONLY COMMUNITY MEETINGS BUT ALSO

A SOCIAL JUSTICE TASK FORCE.

COUNSELOR CAMPBELL, YOU KNOW A LOT OF OF THE COMMUNITY MEMBERS WERE THERE TO HELP US CRAFT, YOU KNOW, THE POLICIES AND SOME OF

THE PROCEDURES.

WOULD YOU WEAR THEM.

WHAT DISTRICTS.

THEY WANTED THE GANG UNIT TO WEAR THEM.

THE PROCEDURE WAS WELL THOUGHT OUT BY THE SOCIAL JUSTICE TASK FORCE.

THE RESULTS, JACK CAN GET MORE NO DETAILS.

FOR THE MOST PART IT'S BEEN POSITIVE.

I HAVEN'T HEARD ANY COMPLAINTS FROM THE OFFICERS.

I THINK THEY WERE ENCOURAGED BY WEARING THEM.

I THINK IT DOES A LOT OF THEM. ONE, IT HELPS TO QUELL

DISTURBANCE WHEN PEOPLE SEE THEMSELVES ON CAMERA THEY TAKE IT DOWN A BIT.

I THINK WE SEE THE VALUE OF THE BRINGING THE CASES TO COURT, SPECIALLY DONE CASES WHERE IT'S ALL ON VIDEO.

I KNOW THE DISTRICT ATTORNEY'S OFFICE LIKES THEM AND THE DEFENSE ATTORNEYS LIKE THEM. FOR THE COURT THEY'RE GOOD. THEY'RE ALSO EXCELLENT IN INVESTIGATIONS.

HAVING THE CAMERA OUT THERE HELPS IN TAKE SOMETHING OF THE GANG ISSUES OUT OF THE MIX. IT ALLOWS US TO HAVE VIDEO FOOTAGE AND PUT TOGETHER THE GANG ORGANIZATION.

FROM AN ORGANIZATIONAL STAPD POINT IT'S ALL POSITIVE.

THE ONLY NEGATIVE IS SOMETIMES THE OFFICERS LOSE THE CAMERAS IN FOOT PURSUIT.

SOMETIMES WHEN THEY'RE INTO FIGHTS THEY GET RIPPED OFF THEIR BODY.

OTHER THAN THAT THINGS HAVE GONE REALLY WELL.

I THINK YEAR TO DATE WE HAVE APPROXIMATELY THOUSAND 200 VIDEOS IN THAT YEAR -- 38,200 VIDEOS.

AT LEAST TWO CASES WHERE COMPLAINTS WERE BROUGHT AGAINST OFFICERS WERE CLEARED BY VIEWING THE VIDEOS.

IT'S BEEN GOOD ALSO TO BACK OUR OFFICERS FOR FRIVOLOUS COMPLAINTS.

FOR THE MOST PART THINGS ARE GOOD.

THE PRELIMINARY SHOWED WE HAD 12 ARRESTS I'M SORRY 12 LESS CIVILIAN COMPLAINTS AGAINST US FOR THE YEAR.

ONE A MONTH.

>> WE DON'T REALLY HAVE A PROBLEM ON USE OF FORCE IN THE DEPARTMENT.

IN TO 11 WE HAD 10 COMPLAINTS. IN 2017 WE HAD 21 IT'S STEADILY DECLINED OVER THE YEARS. ANY COMPLAINTS ABOUT EXCESSIVE FORCE.

ALSO CITIZEN COMPLAINTS.

IN TO 13 WE HAD 360 LAST YEAR WE HAD 211.

YOU CAN SEE OUR NUMBERS IN THE COMPLAINTS HAVE SIGNIFICANTLY GONE DOWN THIS.

WILL MOST LIKELY IMPROVE THAT AS THE STUDY HAS SHOWN.

YOU KNOW I COME IN HERE SAYING RIGHT FROM THE GET GO.

I DON'T THINK THE MAYOR OR MYSELF HAS OPPOSED THIS.

THE QUESTION ALWAYS IS HOW MUCH WILL IT COST THIS.

IS A THOROUGH AND COMPREHENSIVE STUDY.

THAT'S WHAT THE MAYOR AND I WANTED FROM THE GET GO.

TO WEIGHT THE COSTS FROM THE BENEFITS.

I THINK THE OFFICERS ARE ALL ONBOARD AND LIKE IT.

SO, YOU KNOW THE BIG QUESTION IS THE COSTS.

JOHN CAN TALK ABOUT THE OUESTIONS.

WE ESTIMATE \$7 MILLION TO EQUIP ALL OF THE OFFICERS THE FIRST YEAR.

OVER THE FIRST FIVE YEARS UP TO \$25 MILLION.

THAT'S THE ONLY POINT THAT WE'RE REALLY CONTESTED.

AS I SIT BEFORE YOU TODAY I THINK THE MAYOR REALIZED THE POSITIVE BENEFITS FROM, THIS I DO.

I THINK THE DEPARTMENT, ALTHOUGH A LITTLE RELUCTANT TO JUMP IN FIRST SEE IT'S PROTECTS MEMBERS WELL.

IT HELPS US TREMENDOUSLY AS WE DEAL SOMETIMES WITH THE PUBLIC OUT THERE THAT IS UNFORTUNATELY NOT TOO NICE TO US.

A COUPLE OF PROTOCOL ISSUES. A COUPLE OF PEOPLE HAVE SKWRO +*EUPBD JOINED US. COUNSELORS, THANK YOU. ALSO I WANT TO REMIND EVERYONE THIS IS A PUBLIC HEARING BEING RECORDED AND BROADCASTED. ON COMECAST 8, RCN82 AND VERIZON 1964.

IF YOU WANT TO TESTIFY YOU CAN SIGN UP TO THE LEFT HERE. YOU WILL HAVE A COUPLE OF MINUTES TO TESTIFY.

ALSO SILENCE YOUR CELLPHONES AND OTHER DEVICES AS WE GET INTO THE HEARING.

I WILL HAND IT BACK OVER TO SUPERINTENDENT DAILY.

- >> I'M ANTHONY, THE DIRECTOR OF THE SCHOOL CRIMINOLOGY AND CRIMINAL JUSTICE AT NORTHEASTERN UNIVERSITY.

WE'RE LEADING THE STUDY OF THE IMPACTS OF THE BODY WHETHER OR NOT CAMERAS ON A RANGE OF MEASURES FOR THE CITY OF BOSTON. AS THE COMMISSIONER SUGGESTED THE STUDY WAS LAUNCHD IN FIVE DISTRICTS.

TWO, THREE POLICING DISTRICTS.
TWO, THREE, FOUR, FOURTEEN,
EIGHTEEN AND THE YOUTH VIOLENCE
STRIKE FORCE.

WE WERE FORTUNATE BOTH THE MAYOR AND THE COMMISSIONER WERE SUPPORTIVE OF A RIGOROUS STUDY OF THE IMPACTS OF THE CAMERAS. WE WERE ABLE TO PURSUE A EXPERIMENT THAT IS GENERALLY CONSIDERED THE GOLD STANDARD AND PROGRAM EVALUATION.

WHERE WE RANDOMLY ALLOCATE OFFICERS TO TWO GROUPS.

ONE GROUP WAS A CAMERA GROUP OR TREATMENT GROUP.

ANOTHER WAS A COMPARISON GROUP. THE NICE THING ABOUT RANDOMIZING IT ASSUMES THERE IS NO SYSTEMATIC DIFFERENCES BETWEEN THE GROUPS AND IT'S AN APPLES TO APPLES COMPARISON.

WHEN WE LOOK AT THE AFFECTS OF

THE CAMERA THE ONLY THING DIFFERENT WITH THE OFFICERS RECEIVING THE CAMERA AND DON'T ARE THE CAMERAS THEMSELVES. AS THE COMMISSIONER MENTIONED THE POLICE DEPARTMENT HAD ONE HUNDRED CAMERAS TO PLACE ON OFFICERS.

WE SELECTED OFFICERS WORKING THE DAY SHIFT, THE FIRST HALF SHIFTS FOR THE POLICE DEPARTMENT.
THEY WERE 281 OFFICERS WHO WERE ELIGIBLE AND ACTUALLY DOING A TROLL WORK OR WORKING IN THE GANG UNIT TO BE INCLUDED IN THE STUDY.

WE RANDOMLY ALLOCATED THEM TO THE TWO GROUPS.

RESULT -GS IN 140 OFFICERS IN THE CAMERA GROUP.

AND 141 OFFICERS IN THE COMPARISON GROUP.

WE LOOKED AT THE DIFFERENT CHARACTERISTICS TO MEASURE ON THE OFFICERS.

SEX, RACE, AGE, YEARS ON THE JOB, SHIFT ASSIGNMENT, PRIOR COMPLAINTS THEY HAD UNTIL THAT POINT IN TIME, AND PRIOR USE OF FORCE REPORTS MADE.

NO SYSTEMATIC DIFFERENCES BETWEEN THE TWO GROUPS SO WE ACHIEVED THE APPLES TO APPLES COMPARISON.

IT WAS IMPORTANT FOR THE INTEGRITY OF THE DESIGN.
ALL 140 OFFICERS IN THE CAMERA GROUP WERE TRAINED TO USE THE CAMERA AND THE POLICY OF THE BOSTON POLICE DEPARTMENT.
HOWEVER FROM THE INITIATION OF THE PROGRAM.

THERE WERE 100 CAMERAS.

THEY WERE PLACED ON ONE HUNDRED OF THOSE 140 OFFICERS.

THE OTHER 40 OFFICERS WERE ALTER TPHAEUTS DRAWN UPON CYCLED OUT OF THEIR ASSIGNMENTS.

THE PERIOD OF THE ASSIGNMENT WAS ONE YEAR.

DURING THAT TIME PERIOD WE HAD 21 OFFICERS IN THE TREATMENT GROUP CHANGE ASSIGNMENTS OR BE PROMOTED OR GO OUT ON MEDICAL

LEAVE TO BE REPLACED.

THEY WERE REPLACED OVER THE
COURSE OF THE STUDY.

SO THEY WERE A TOTAL OF 121
OFFICERS OVER THE ONE YEAR
PERIOD WHO WORE THE CAMERAS.

WE DECIDED TO DO OUR COMPARISON

WE DECIDED TO DO OUR COMPARISON OF THE FULL 140 WHO WERE TRAINED IN THE POLICY RELATIVE TO THE 141 WHO DIDN'T.

TO BE A LITTLE NERDY, IT'S A DESIGN CHOICE NOT A INTENT TO TREAT.

I CAN TALK LATER WHY THAT'S A GOOD THING TO DO.

ESSENTIALLY IF YOU TRAIN OFFICERS TO BEHAVE A CERTAIN WAY YOU EXPECT THEM TO CHANGE THEIR BEHAVIOR ANYWAYS.

THEY WERE TRAINED ON WHAT WAS EXAMINED IN THE STUDY.

IT WAS ALSO IMPORTANT BECAUSE ONE HUNDRED OFFICERS WEARING THE CAMERAS, A RELATIVELY SMALL SAMPLE TO OBSERVE.

AS I WILL MENTION IN A MINUTE THESE ARE RARE EVENTS WE'RE LOOKING AT IN THE PRELIMINARY IMPACT ASSESSMENT.

HAVING MORE OFFICERS TO INCLUDE IN THE STUDY WAS A GOOD DESIGN DECISION.

SO FOR THE PRELIMINARY RESULTS WE REPORTED ON OFFICER USE OF FORCE REPORTS AND OFFICER COMPLAINTS.

IT'S WORTH NOTING HERE THAT FOR US ON THE RESEARCH TEAM THERE WAS A CHALLENGE OF TRYING TO DETECT THE EFFECTIVENESS OF THE CAMERAS.

THE BASE RATE OF BOTH EVENTS WAS VERY SMALL.

FOR THE OFFICERS IN THE
TREATMENT AND CONTROL GROUPS
BEFORE THE CAMERAS WERE
IMPLEMENTED FOR COMPLAINTS THEY
HAD A RATE OF .22.
THAT IS AN AVERAGE OF ONE
COMPLAINT EVERY FIVE YEARS.
FOR USE OF FORCE IT WAS .12.
THAT TRANSLATES TO ONE USE OF

FORCE REPORT EVERY TEN YEARS. THESE ARE VERY LOW BASE RATES IN

A RELATIVELY SMALL SAMPLE OVER ONLY A YEAR PERIOD TO OBSERVE CHANGE.

SO IT'S ONE OF THE CHALLENGES OF THE DESIGN.

AS WE GO FORWARD WE CONTINUE TO WRESTLE WITH THIS.

AS WE DID THIS AS THE

COMMISSIONER MENTIONED WE FOUND SMALL IMPACTS.

THAT'S IN PART BECAUSE OF THE SAMPLE SIZE AND THE RARE RATES WE'RE DEALING WITH.

FOR THOSE OFFICERS WEARING THE CAMERA RELATIVE TO THOSE WHO DIDN'T THEY HAD 12 FEWER COMPLAINTS OR ON AVERAGE ONE FEWER PER MONTH OF WEARING THE CAMERAS AS A GROUP.

FOR USE OF FORCE THE USE OF DIFFERENCE WAS SEVEN USE OF FORCE REPORTS.

WE WERE ABLE TO CONFIRM THAT THIS RELATIVELY MODEST REDUCTION IN COMPLAINTS WAS SIGNIFICANT. WHICH MEANS WE DIDN'T OBSERVE IT JUST BY CHANCE ALONE.

THINGS CAN GO UP, THINGS GO GO DOWN.

THIS ARE RANDOM FLUCTUATIONS. THE USE OF FORCE WAS ON THE SMALLER SIDE.

WE COULDN'T CONFIRM THAT WITH CONFIDENCE AT THIS POINT IN TIME IT WASN'T JUST A CHANCE REDUCTION.

HOWEVER STEPPING BACK, TAKEN AS A WHOLE THESE SUGGEST THEY WERE VERY SMALL BUT NOTABLE IMPROVEMENTS ON THOSE TWO DIMENSIONS.

THINK RELATIVE TO, I SHOULD MENTION I HAVE DONE A BOD OTHER WORN CAMERA EXPERIMENT IN LAS VEGAS.

THE BASE RATES WERE MUCH HIGHER AND MUCH MORE ROOM FOR IMPROVEMENT.

I THINK THE CASE IN BOSTON, IT WAS A SMALL EFFECT WITH NOT A LOST ROOM FOR IMPROVEMENT. EVEN WITH THE LOW BASE RATES. WE WILL CONTINUE TO LOOK AT THE NUMBERS AND YOU KNOW LOOK AT IT

IN DIFFERENT WAYS TO SEE IF THE EFFECTS ARE CHANGE AS TIME HAS GONE ON.

A FEW OTHER MEASURES WE'RE LOOKING AT I'M LOOKING AT KHAEPBG IN POLICE OFFICER WORK ACTIVITIES.

SOME SUGGEST IF YOU OUT FIT OFFICERS WITH CAMERAS THEY MAY SECOND GUESS BEHAVIORS AND BE LESS LIKELY TONE GAUGE AND BE PROACTIVE.

WE WILL LOOK AT A RESTS FIOS, INCIDENT REPORTS, PROACTIVE STOPS THAT THEY DO.

WE WILL ALSO LOOK AT WHETHER THE CAMERAS HAVE IMPACT ON THE LAWFULNESS OF INTER ACTIONS. IF THERE IS ANY CHANGE IN THE RATIO DISTRIBUTION ON WHO IS BEING STOPPED AND ARRESTED. WHO IS WEARING CAMERAS RELATIVE TO THOSE WHO ARE NOT. THE FISCAL RESEARCH AND WHETHER THERE IS A CHANGE THERE ACROSS

THERE IS A CHANGE THERE ACROSS
THE TWO GROUPS.

MY ROLL IN THE PROJECT IS TO TALK A LITTLE BIT ABOUT THE COMMUNITY REACTION TO THE CAMERAS BEING OUT THERE.
TO GET THAT WHAT WE HAVE DONE IS TO HAVE A NUMBER OF COMMUNITY MEETINGS WITH DIFFERENT GROUPS WITH THEIR MEMBERS.
THERE HAVE BEEN OVER A HUNDRED COMMUNITY MEMBERS INTERVIEWED AS

COMMUNITY MEMBERS INTERVIEWED AS WELL AS PEOPLE REPRESENTING DIFFERENT PLACES IN GOVERNMENT. TAKE A STEP BACK AND SAY THE COMMISSIONER MENTIONED THE SOCIAL JUSTICE TASK FORCE. WITH REVEREND MARK SCOTT I CO-CHAIR.

THAT GROUP HAS HAD A PRETTY DIRECT AND ON GOING ROLL IN HOW THIS HAS BEEN IMPLEMENTED.

THERE HAVE BEEN REPORTS BACK TO THE GROUP.

THAT GROUP HAS HAD FEEDBACK. ONE OF THE PLACES THE GROUP SUGGESTIONED.

THE KPWHEUGSER SAID THE ORIGINAL PLAN WAS FOR 50 CAMERAS.

THEY SAID IT WOULD BE BETTER TO HAVE A HUNDRED.

IT WAS INSIGHTFUL HELPING WITH THE NUMBERS THAT ANTHONY TALKED ABOUT.

HAVING ENOUGH NUMBERS TO MAKE A FINDING.

WE HAVE MET WITH A OVER A HUNDRED COMMUNITY MEMBERS IN DIFFERENT GROUPS.

THE PRELIMINARY FINDINGS HAVE BEEN THE CAN COMMUNITY MEMBERS BELIEVE THE BOSTON POLICE DEPARTMENT IS GOOD OVER ALL, ABOVE AVERAGE.

IT'S A DEPARTMENT THEY THINK OF AS ONE OF THE BETTER ONES IN THE COUNTRY.

THEY, THEY ALSO REALLY LIKE THE OFFICERS THAT THEY WORK WITH. YOU KNOW, THEY HAVE GOOD RELATIONSHIPS WITH INDIVIDUAL OFFICERS WORKING WITH THEIR ORGANIZATIONS AND HAVE A RELATIONSHIP WITH.

THOSE BEAR A LOST FRUIT AND THEY HAVE A LOST TRUST IN THOSE INDIVIDUAL OFFICERS.

THEY ALSO SAY THAT, YOU KNOW
THERE ARE MORE THAN TWO THOUSAND
OFFICERS IN THE POLICE
DEPARTMENT.

THEY DON'T KNOW THEM ALL THIS. ARE CONCERNS ABOUT, THE ONES I KNOW ARE GOOD.

ARE THEY ALL REALLY GOOD? I DON'T KNOW.

THAT THAT WAS ARTICULATED.

MOST OF THE PEOPLE WE HAVE

SPOKEN WITH AND INTERVIEWED ARE

HAPPY THE CITY IS ENGAGED IN THE

PILOT PROGRAM.

THEY THINK OF IT AS A STEP IN THE RIGHT DIRECTION.

THEY'RE LOOKING FORWARD TO THE ANSWERS THAT WILL COME FROM NORTHEASTERN AND THE BOSTON POLICE DEPARTMENT.

IN TERMS OF HOW EFFECTIVE THEY ARE.

THEY ALSO, ONE OF THE THINGS THEY WOULD SAY IS THINK ABOUT THE NUMBERS.

IF A HUNDRED OFFICERS ARE
WEARING CAMERAS LIKE ANTHONY
LAID OUT FOR YOU AND TWO
THOUSAND OFFICERS ARE
INTERACTING WITH THE PUBLIC WE
HAVEN'T RUN INTO MANY PEOPLE
WITH A OFFICER WITH A CAMERA.
SO, WE'RE STILL LOOKING AND
CONTINUE TO HAVE COMMUNITY
GROUPS.

I ENCOURAGE ANYONE WHO HAVE LISTS OF GROUPS TO REACH OUT TO, TO LET ME KNOW AND I WILL BE HAPPY TO GO AND TALK WITH THEM. ONE OF THE THINGS I GUESS I WOULD SAY AS AN OVER ALL MEASURE IS THAT MOST OF THE COMMUNITY GROUPS WE SPOKE TO THINK CAMERAS THE FUTURE IN POLICING.
THAT IT WILL BE SOMETHING THAT POLICE DEPARTMENTS WILL HAVE IN THE FUTURE.

SO THAT'S COME UP A NUMBER OF TIMES.

ASKED WHAT THE NUMBER S WHAT WILL IT DO FOR THE CITY AND POLICE DEPARTMENT.

THAT'S SOMETHING PEOPLE ARE CONCERNED ABOUT FIGURING OUT HOW TO DEAL WITH.

THAT THE OTHER GROUP WE MET WITH THAT I THINK IS PRETTY INTERESTING IS MEETING WITH

DIFFERENT COURT OFFICIALS. WE HAVE MET WITH THE DEFENSE BAR.

WE WILL BE MEETING WITH PROSECUTORS AND JUDGES.
THE DEFENSE BAR THINKS THAT IT REALLY MAKES A DIFFERENCE IN COURT IF THERE IS A CAMERA THERE.

AS YOU ALL KNOW A LOT OF BACK AND FORTH IN THE COURT CASE IS A POLICE REPORT THAT SAYS X AND A COMMUNITY MEMBERS THAT SAYS "Y." THE COURT IS FIGURING OUT WHERE THE TRUTH IS IN THAT.

IF YOU HAVE A CAMERA SOMETIMES THAT EX PLACATES THE TRUTH AND YOU SEE HOW PEOPLE ACT.
AND AN ADDED VALUE FOR THE CAMERA FOR THE PROSECUTOR AND DEFENSE BAR POINT EVER VIEW IS THE AUDIO.

AS WE KNOW THERE ARE LOTS OF CAMERAS AROUND THE CITY.
A LOT OF INCIDENTS ARE ON CAMERA, BUT YOU DON'T HEAR THE INTERACTION.

WITH THE BODY CAMERA YOU GET TO HEAR HOW THE POLICE OFFICER TREATED THE INDIVIDUAL.

HOW THE INDIVIDUAL TREATED THE POLICE OFFICER.

YOU GET A BETTER FEEL OF THE INTER ACTION AND HOW IT WENT DOWN.

THAT'S HELPFUL BRINGING THE CASES TO COURT.

I ALSO SAY ONE OF THE REALLY INTERESTING THINGS THAT HAS HAPPENED IN THE COMMUNITY GROUPS IS THAT THE COMMUNITY MEMBERS IN THE CITY WANT TO BE HELPFUL. THEY WANT TO TRY TO BE HELPFUL. THEY SAID THINGS LIKE, YOU KNOW, WE COULD FORM A GROUP TO REVIEW THE CAMERAS AND TALK TO YOU ABOUT WHAT IS NORMAL BEHAVIOR FOR THIS GROUP OR THAT GROUP. TO HELP YOU UNDERSTAND THE -P INTER ACTION BETWEEN THE OFFICER AND INDIVIDUAL COMMUNITY MEMBERS MIGHT BE DIFFERENT.

THEY REACH OUT TO DO THAT ON TH +*
OWN TO SAY WE WOULD BE HAPPY TO

DO.

THAT THINK CREATIVELY HOW WE INTERACT WITH THE POLICE AND HOW HISTORY MAY INFORM. THAT I THINK THERE ARE INTERESTING POSSIBILITIES AS THIS CONTINUES DOWNHILL TO SEE HOW THAT HAS BEEN DONE. I GUESS WE ARE ALSO LOOKING AT THE VIDEOS THEMSELVES FOR QUESTIONS OF QUALITY. OUESTIONS OF CONSISTENCY AND. THAT WE WILL HAVE SOME OF THE FINAL REPORTS, THE IDEA OF THE OVER ALL QUALITY OF THE VIDEOS AND HOW THAT'S WORKING. WE HAVE STUDENTS AS WE SPEAK. I WILL STOP THIS AND TAKE ANY

WHERE THERE HAS BEEN POSITIVE
BENEFITS AND NEGATIVE BENEFITS.
I KNOW WASHINGTON DC DID A PILOT

THOUSAND DIDN'T.

THEY DIDN'T SEE MUCH CHANGE IN BEHAVIOR.

ANTHONY TALKED ABOUT LAS VEGAS. OFFICERS WORE THE CAMERAS. THE ISSUE THAT HAPPENED WAS COMPLAINTS, I THINK AND RUSE OF FORCE CAME DOWN.
WHAT WENT UP IS THE AMOUNT OF ARRESTS AND AMOUNT OF TICKETS WRITTEN.

IT TAKES AWAY A LOT OF
DISCRETION WHERE OFFICERS COULD
GIVE KIDS BREAKS ON SOMETHING.
WHAT THEY FOUND IN LAS VEGAS IS
THE AMOUNT OF ARE EASTS WENT UP.
OFFICERS ARE ON VIDEO.
I THINK SOMETIMES THEY ARE
COMPELLED WHERE THEY COULD OF
GIVEN SOMEONE A BREAK THEY CAN'T
NOW.

THE ONLY CONCERN IS, WE'RE DOING A GOOD JOB KEEPING ARRESTS DOWN.

THINK DOWN 30% THE LAST THREE OR FOUR YEARS.

ON CAMERA SOMETIMES THAT TAKES AWAY THE DISCRETION.

WE WANT TO GIVE GIVE SOMEONE, IN THE PAST A BREAK FROM DOING SOMETHING, NOW IT'S ON CAMERA AND THERE IS LIABILITY.

IF WE LET THE PERSON GO AND HE HURTS SOMEONE.

I THINK HAVING CAMERAS -- THE LAS VEGAS STUDY AND THAT CONCEPT BOTHERED ME.

I THINK WE DO A GOOD JOB NOT LOCKING KIDS UP.

SOMETIMES THIS MAY TIE US IN A LITTLE BIT.

JOHN, WHAT WANT TO TALK ABOUT THE COSTS.

>> SURE.

I CAN ANSWER QUESTIONS ABOUT THEM.

WE'RE LOOKING FOR A FULL IMPLEMENTATION OF \$5 MILLION TO \$7 MILLION THE FIRST YEAR. SOME COSTS COULD GO DOWN AND WE COULD NEGOTIATE.

THESE ARE HIGH LEVEL ESTIMATES AND QUOTES WE HAVE RECEIVED FROM DEVELOPEDDERS OUT THERE.

SOME OF THE SHALL SHALL SHALL VENDORS OUT THIS.

THOSE ARE IMPLEMENTATION AND FIRST YEAR COSTS.

DEPENDING ON THE DEAL WE GET FROM A VENDOR LOOKING AT FIVE MILLION DOLLARS TO SEVEN MILLION DOLLARS YEARLY BASIS MOVING FORWARD FOR A FULL IMPLEMENTATION.

IF WE APPROACHED IT WE COULD PHASE IT IN THE FIRST YEAR.
MAYBE BEGIN HALF WAY THROUGH THE YEAR AND DO A SMALLER NUMBER OF OFFICERS AND RAMP UP FROM THAT TO LOWER THE COST IMPACTS.

>> THANK YOU, VERY MUCH.

SO THIS HEARING WAS OFFERED BY PRESIDENT CAMPBELL.

I WILL LET HER OPEN THE FLOOR, COUNSELOR CAMPBELL.

WE WILL GO FROM THERE.

>> THANK YOU, COUNSELOR McCARTHY.

THANK YOU, ALL OF YOU FOR BEING HERE.

COMMISSIONER, WE HAVE GROWN IN OUR RELATIONSHIP JUST THROUGH THIS PROCESS.

I WANT TO APPLAUD YOU FOR THE WORK YOU HAVE DONE.

SPECIFICALLY TO THE SOCIAL JUSTICE TASK FORCE.

PULLING TOGETHER A GROUP OF FOLKS THAT DON'T ALWAYS AGREE WITH YOU.

I THINK THIS IS A GREAT EXAMPLE WHERE EVERYONE IN THE ROOM DIDN'T START ON THE SAME PAGE. AROUND THIS PARTICULAR TOPIC, BUT THROUGH DIFFERENT KPHAO +*ET KPHOUPT MEETINGS, AROUND THE CITY IN PARTNERSHIP WE HAVE GOTTEN TO A PLACE TO EXTEND THAT PILOT PROGRAM TO ANOTHER SIX MONTHS.

SO HERE WE ARE.

I WILL TELL THAT YOU THROUGH THE PROCESS I HAVE ONLY GROWN TO NOW SAY WE SHOULD DO BODY CAMERAS. NOT ONLY BASED ON CONVERSATION FROM THE SOCIAL JUSTICE TASK FORCE, AD ROW INDICATES, SOME HERE TODAY AND OTHERS WE SEE IN THE COMMUNITY.

THROUGH SOME OF THE PRELIMINARY FINDINGS.

BECAUSE OF THE BENEFITS YOU SUGGESTED.

YOU KNOW WHETHER IT'S USEFUL IN COURT, THIS IDEA THAT TECHNOLOGY IS COMING, UNFORTUNATE INCIDENTS WE SEE HERE AND THERE WITH THE COMPLIMENTING THE NODE TO COME UP WITH A TOOL WE KNOW WORK AND BODY CAMERAS BEING ONE OF THEM. I HAVE GONE TO A PLACE NOW I SAY OUTSIDE -- THIS IS A QUESTION TO START WITH.

OUTSIDE OF BODY CAMERAS WHAT OTHER TECHNOLOGY SHOULD WE LOOK AT.

WHEN I SAY THAT COUNSELOR McCARTHY AND I MET WITH A VENDOR AT LEAST TRYING TO ENLIGHTEN US ON THE TECHNOLOGY AND WHAT IT LOOKS LIKE. BODY CAMERAS FRANKLY IS DOWN

HERE COMPARED TO ALL OF THE OTHER TOOLS THAT EXIST IN THIS COUNTRY WHEN IT COMES TO COMPLIMENTING YOUR COMMUNITY POLICING EFFORTS.

MY FIRST QUESTION IS HAVE WE GIVEN THOUGHT TO TAKING THIS CONVERSATION OUTSIDE OF THE CONTEXT OF BODY CAMERAS AND LOOKING AT.

THEY HAVE TASERS WITH BODY CAMERAS ATTACHED TO THEM.
LOOKING AT TECHNOLOGY IN GENERAL AND WHAT TOOLS MAYBE AVAILABLE FOR US TO DO BETTER POLICING.
>> THANK YOU.

>> YES SO, THIS ALIGNED WITH THE BODY CAMERAS.

FOR MOST OF THE VENDORS WHO SUPPLY BODY CAMERAS THEY REQUIRE ALSO MOBILE DEVICES iPHONES OR ANDROID PHONES.

THAT'S ANOTHER PIECE.

THINK IN POLICING SOME
DEPARTMENTS, LARGE DEPARTMENTS
HAVE FORMALLY MOVED TO SUPPLYING
SMART DEVICES TO OFFICERS.
THAT'S SOMETHING WE'RE LOOKING
CLOSELY AT.

ALL OF THE TECHNOLOGY TOOLS THAT COULD LEVERAGE MOBILITY FROM RECORDS MANAGEMENT SYSTEMS TO TRANSLATION SOFTWARE.

YOU KNOW THINGS LIKE THAT THAT OFFICERS COULD HAVE INFORMATION AT THEIR FINGER TIPS.

YOU KNOW IN THEIR CARS AS THEY'RE WALKING BEATS AND THINGS LIKE.

THAT I THINK WE'RE REALLY LOOKING CLOSELY AT MOBILITY AND HOW TO LEVERAGE THAT AND DO IT IN A SENSIBLE WAY.

IF THIS DOES ALIGN WITH THE BODY CAMERAS AS WELL.

>> I BRING THIS UP WE TALK ABOUT BODY CAMERAS AS A TOOL ONLY EFFECTIVE, NOT SAYING YOU ON THE PANEL BUT FOLKS IN THE COMMUNITY WE ENGAGE WITH ON THIS PARTICULAR ISSUE, THAT IT'S ONLY A BENEFIT FOR SAY CIVILIANS. WE HAVE COME TO LEARN THROUGH COMMUNITY MEETINGS WITH OFFICERS

AND OTHER HEARINGS WE HAVE HAD THESE ARE TOOLS THAT CAN BENEFIT THE OFFICERS AS WELL. WHETHER IT'S PAINTING THE PICTURE AROUND A PARTICULAR INCIDENT, MORE DETAIL, LEARNING FROM WHAT HAPPENED GOING BACK. USING IT FOR TRAINING PURPOSES, ETCETERA, THE QUESTION AROUND, OR MY SUGGESTION IS THAT WE EXPANDED IT OUTSIDE OF THE CONTEXT OF BODY CAMERAS AND LOOK AT ALL TECHNOLOGY THAT MAYBE INFORMATIVE FOR THOSE PURPOSES AND HOW MIGHT WE ACTUALLY SAVE MONEY BY INVESTING IN CERTAIN TECHNOLOGY IN A COMBO FASHION. I PUSH THE DEPARTMENT TO THINK ABOUT IT IN THOSE TERMS. GO AHEAD, COMMISSIONER. >> AN ISSUE THAT, YOU KNOW IS A LITTLE CONTROVERSY. WE'RE READY TO ROLL IT OUT.

WE WILL GO TO THE COMMUNITY. THE ISSUE OF DRONES.

YOU KNOW, I THINK YOU TALK ABOUT COSTE FECK STIFFER.

TO HAVE THOSE OUT AT INCIDENT RECONSTRUCTION SITES OR CRIME SCENES THE ABILITY TO FLY ONE AND GET THOSE MAYS AOURPLTSZ AND GET THE CAMERAS SHOTS.

THE ACT TO PUT THEM UP FOR THE BOSTON MARATHON FOR A GOOD SNAP SHOT OF SECURITY CONCERNS.

THE WHOLE COUNTRY IS GOING TO THEM NOW.

POLICE DEPARTMENTS ACROSS THE COUNTRY.

THAT'S A WAY TO MOVE TO BE SMARTER AND MORE EFFICIENT. RIGHT NOW IF WE HAVE A CRIME SCENE WE'RE THERE FOR THREE HOURS.

HEAVEN FORBID WE HAVE A BODY AT THE SCENE, THOSE CAN TAKE QUITE A LONG TIME, TAKE UP RESOURS AND KEEP STREETS CLOSED.

THAT'S SOMETHING WE'RE MOVING TO SHORTLY.

SOMETIMES WE GET A FIGHT BACK AS WE'RE UP TO SOMETHING SINISTER BY ROLLING THOSE OUT.

IT'S TO BE A MORERY EFFECTIVE

DEPARTMENT.

WHEN YOU MOVE ON TECHNOLOGY PEOPLE LOOK AT IT LIKE WE'RE UP TO NO GOOD.

WE TRY TO MOVE ON SOCIAL MEDIA BECAUSE WE TRY TO PREVENT TRAGEDY THAT'S HAPPEN IN PLACES LIKE PARKLAND.

YOU KNOW EVEN IN WINCHESTER, EVERYWHERE WE CAN PICK UP. WE'RE MOVED TO BE MORE EFFICIENT.

INITIALLY WE GET CALLED ONTO THE CARPET YOU CAN'T DO THIS.

THIS IS A INVASION.

AS MUCH AS WE TRY TO MOVE IN THE DIRECTION YOU KNOW EVERYONE THINKS OUR MOTIVES ARE NOT THE BEST.

IT'S ABOUT PUBLIC SAFETY.

>> I WILL SAY THIS.

YOU SPEAK TO MY POINT.

THERE IS AN ARRAY OF TOOLS OUT THERE.

BECAUSE WE HAVE HAD THIS CONVERSATION RELATED TO BODY CAMERAS FOR SOME TIME NOW I THINK WE SOMETIMES GET SUCKED INTO JUST THIS ONE TOOL CALLED BODY CAMERAS.

I THINK WE SHOULD ABSOLUTELY DO. THERE ARE OTHER TOOLS OUT THERE PROVEN TO BE EFFICIENT AND ALLOW TO YOU DO YOUR JOB MORE EFFICIENT.

I WANT US NOT TO JUST GET STUCK ON THE BODY CAMERA PIECE. TWO MORE POINTS BEFORE I THEN I

TWO MORE POINTS BEFORE I TURN IT OVER.

I CAN ASK MORE QUESTIONS IN THE SECOND ROUND.

THE COST ANALYSIS PIECE I DON'T THINK ACCOUNTS FOR THE POSSIBILITY OF SETTLEMENTS DOWN AGAINST THE DEPARTMENT THAT COULD, WHERE WE COULD SAVE ON THE COST SETTLEMENT SIDE OF THINGS OR WHAT FUNDING MIGHT BE AVAILABLE AT THE STATE OR FEDERAL LEVEL FOR THIS PURPOSE REGARDLESS HOW YOU FEEL ABOUT WHAT IS COMING OUT OF WASHINGTON. THERE MAYBE A FUNDING

OPPORTUNITY FOR POLICE
DEPARTMENTS THAT ARE TAKING ON
THE NEW TECHNOLOGY TOOLS.
I ENCOURAGE US TO LOOK INTO
THAT.

IT'S DIFFICULT SOMETIMES TO MONITORRIZE THE FEELING SOMEONE HAS WHEN SOMEONE IS WEARING A BODY CAMERA.

I KNOW THAT THERE ARE QUALITATIVE.

OUTSIDE OF THE QUANTITATIVE DATA THAT ANTHONY AND JACK HAVE DOVE INTO THERE'S QUANTITATIVE DATA AS WELL.

HAVING THE COMMUNITY MEETINGS OF A OFFICER WITH A BODY CAMERA OR A INTER ACTION HOW THEY THINK THEY WOULD RESPOND TO A OFFICER WITH A BODY CAMERA THEY HAVEN'T INTERACTED WITH YET.

THERE IS SOMETHING ABOUT INCREASING TRUST.

INCREASE AGO COUNT ABILITY AND

TRANSPARENCY.

FOR BOTH PARTIES.

YOU CAN'T ALWAYS MON TIES.

MONATIZE.SOMETIMES WE HAVE TO MAKE THESE NEW INVESTMENTS.

I HAVE HEARD OVERWHELMING SUPPORT FOR THIS PARTICULAR TOOL.

I THINK THE NEXT STEP IS WHAT IS THE PROCESS THE DEPARTMENT HAS TO UNDER TAKE TO DO THIS ON A FULL SCALE BASIS OR IF WE DID IT IN A PHASED, PHASED WAY. I SUGGESTED THAT.

IF IT COSTS A LOT OF MONEY WHY NOT START WITH THOSE DEPARTMENTS MOST QUESTIONABLE, RIGHT.
MAYBE USE CERTAIN METRICS TO

I JUST HAVE MORE OF A STATEMENT REALLY.

WHEN COUNSELOR CAMPBELL WAS

TALKING ABOUT THE TOOLBOX.

WE HAVE TALKED ABOUT IT AT LENGTH.

EVERY POLICE OFFICER HAS A RIGHT TO GO HOME AT THE END OF THE DAY.

ANYTHING HELPING THAT OFFICER GO HOME SAFELY AT THE END OF THE DAY I'M ALL ABOUT. WHEN IT'S DRONES.

WE HAVE TALKED ABOUT TASERS.
THEY RECORD THEY CAN -- IT'S
ANOTHER NON LETHAL ACTION TO
PROTECT THE OFFICER AND THE
PERSON THEY MAY TAKE DOWN.
BODY KAMS ERA, IPHONES WITH A
PLOTTER TO KNOW THE CALIBER
WEAPON OF A SITUATION THEY'RE
WALKING IN.

PROTECTING THE OFFICER AND THE PEOPLE IN THE INCIDENT SCENE AND DASHBOARD CAMS.

AS THE CHAIR WHATEVER IT TAKES TO MAKE SURE THE PEOPLE ARE SAFE AND AS IMPORTANTLY OUR POLICE OFFICERS SAFE.

I THINK THIS IS VERY IMPORTANT. WHATEVER YOU NEED IN THE TOOLBOX.

WHETHER IT'S 5 MILLION OR 7 MILLION OR 10 MILLION WE NEED TO MAKE SURE OUR POLICE FORCE IS

ADEQUATELY PREPARED TO BE SAFE FOR THE PEOPLE AS WELL AS THEMSELVES THAT'S MORE OF A STATEMENT THEN ANYTHING ELSE. COUNSELOR -- COUNSELOR, COUNSELOR ED FLYNN.

I HAVE WORKED WITH THE BOSTON POLICE FOR ALMOST TEN YEARS AS A PROBATION OFFICER.

I THINK WE HAVE THE BEST POLICE OFFICERS IN THE COUNTRY AND BEST POLICE DEPARTMENT IN THE COUNTRY.

MY QUESTION IS IF A CAMERA IS RIPPED OFF A POLICE OFFICER DURING AN ARREST HOW IS THAT CAMERA REPLACED? HOW MUCH DOES IT COST TO REPLACE

WOULD BPS HAVE TECHNICAL STAFF OR WOULD IT BE CONTACTED OUT? >> THIS HAS HAPPENED. WE HAVE LOST A FEW CAMERAS IN

SKUFLZ DURING THE PILOT.
BASICALLY WE JUST REPLACE THE
CAMERA AND SEND IT BACK TO THE
MANUFACTURE.

THERE MAYBE A COST INVOLVED, IT'S NOT TOO BAD.

IT'S A COST OF BUSINESS.

>> IF THE VIDEO IS INTRODUCED INTO THE RECORD IN COURT, DEPENDING THE CONTROLS OF THE COURT IT WOULD BE AVAILABLE AS A PUBLIC RECORD.

IF A CITIZEN MADE A REQUEST FOR A VIDEO FROM THE POLICE DEPARTMENT.

WE REVIEW THE REQUEST, REVIEW THE VIDEO.

PROTECT PRIVACY INTERESTS AND IT'S A PUBLIC RECORD TO RELEASE. >> FOR THE CAMERA ITSELF.

IS THERE ANYWAY THE CAMERA COULD NOT CAPTURE THE ENTIRE SITUATION

THAT IS TAKING PLACE AT THE TIME?

60%, YOU MAY NOT CATCH THE ACCURATE STORY WHAT HAD IS

ACTUALLY HAPPENING?

>> YES, ABSOLUTELY.

THE CAMERA GIVES A.

>> Elizabeth: ED FIELD OF VIEW.

A YEAR AGO I WAS SITTING OUT IN THE AUDIENCE AS SOMEONE WHO BELIEVED IN THE IMPORTANCE OF BODY CAMERAS.

I CAN SAY THIS REPORT CONFIRMED MY BELIEF.

A COUPLE OF QUESTIONS.

I WON'T GO ON TOO LONG.

ONE OF THE THINGS I KNOW AS SOMEONE WHO REP RECENTS AND LIVES IN A COMMUNITY OF COLOR IS THAT MANY FOLKS DON'T GO TO THE POLICE FOR COMPLAINTS FOR A

VARIETY OF REASONS.

LACK OF TRUST.

THE BELIEF THERE WILL BE RETRIBUTION.

THE BELIEF NOTHING WILL HAPPEN IF THEY COMPLAIN ABOUT USE OF FORCE OR SOME OTHER KIND OF INTERACTION.

I WONDER DO YOU BELIEVE THESE NUMBERS COULD OF BEEN HIGHER GIVEN.

THAT.

>> DO I BELIEVE?

AGAIN YOUR GUESS IS AS GOOD AS

I CAN TELL YOU WE'RE OUT THERE WORKING HARD.

I THINK WE'RE DOING A GREAT JOB OUT THERE.

YES, SOMEONE MAY NOT WANT TO

REPORT IT BECAUSE OF LACK OF TRUST.

WE MAKE IT CLEAR, YOU CAN GO ON THE COMPUTER AND ISSUE A COMPLAINT.

THERE ARE MANY WAYS.

YOU USE TO HAVE TO WALK INTO A STATION TO MAKE A COMPLAINT.

IF PEOPLE FEEL WRONGED THEY CAN MAKE A COMPLAINT OVER THE PHONE OR THE COMPUTER.

THERE ARE MANY WAYES SO THEY SHOULDN'T FEEL INTIMIDATING. I THINK IT'S CLEAR THE NUMBERS SHOW WE'RE WORKING A LOT HARDER AND WE'RE EARNING A LOT REV SPECT.

THE USE OF FORCE IN OUR CIVILIAN COMPLAINTS OVER THE LAST FIVE YEARS HAS ALMOST GONE DOWN HALF OF WHAT IT USE TO BE.

ACTION.

I WONDERED WHEN THE 2017 WOULD BE AVAILABLE.

>> I COULD PROBABLY GET IT TO YOU THE NEXT WEEK OR SO.

>> CAN YOU SPEAK TO THE SAMPLE SIZE AND WHY IT WAS SO SMALL?
>> IF YOU LOOK AT ANY SAMPLE AROUND THE COUNTRY I THINK MOST HAVE BEEN DOING 50 OR 100.
WE HAVE LOOKED AT OTHER STUDIES.
THAT GIVES YOU A GOOD SNAP SHOT.
WE HAVE COVERED FIVE DISTRICTS.
TWO OR THREE THE BUSIEST WHERE WE MAY HAVE NEGATIVE INTER

THE GANG UNITS THOSE ARE UNITS ALWAYS INTERACTING WITH THE GANG KIDS.

MOST PILOT PROGRAMS ACROSS THE COUNTRY USE THAT AMOUNT OF SIZE. >> HOW OFTEN WERE KWAPL ERAS TURNED OFF?

>> WE HAVE PROCEDURES WHEN THEY'RE ON OR OFF.

FOR THE MOST PART ANY INTER ACTION WHETHER IT'S A CAR STOP OR A FIELD INTERROGATION THEY'RE REQUIRED TO PUT THEM ON. WHEN THEY'RE TURNED OFF IS ON

THE OFFICER'S FREE TIME OR A DOMESTIC VIOLENCE.

WE DON'T WANT THAT ON VIDEO.

THAT'S SOMEONE'S PRIVATE LIFE. SEXUAL ASSAULT WE DON'T WANT TO HAVE A VIDEO IF VICTIMS DON'T WANT TO SPEAK TO US. WE ASK PEOPLE WHEN WE GO INTO

THEIR HOMES, THE HOME IS THE PRIVATE PLACE TO BE.

WE ADVICE THEM OF THE CAMERA IF THEY DON'T WANT IT ON WE SHUT IT OFF FOR THEM.

WE WILL PUT IT ON IN CIRCUMSTANCES WHERE WE WANT THE INTER ACTION TO BE FILMED.

IF WE'RE IN A CONFRONTATION ON THE STREET WITH A GROUP WE PUT THE CAMERA ON.

SOMETIMES THAT BRINGS THE TENSION RIGHT DOWN.

WE ALSO WANT PEOPLE TO KNOW THE BEHAVIOR WE'RE SUGGEST TO TOO. ON THE STREET A LOT OF TIMES WE DON'T GET THE RESPECT SOMETIMES. PUTTING THE CAMERA ON CAN MAKE A DIFFERENCE WHEN WE CAPTURE. THAT.

>> I NOTICED I THINK IT WAS PAGE SIX OF THE REPORT.

THEY TALKED ABOUT THE DEMOGRAPHICS OF THE OFFICERS WITH AND WITHOUT CAMERAS.

I WONDERFUL YOU CAN TALK ABOUT THE NUMBERS COMPARING TO THE OVER ALL POLICE FORCE.

>> ANTHONY, GO AHEAD.

>> THE TASK AT HAND WASN'T TO NECESSARILY CREATE A SAMPLE OF OFFICERS THAT WAS PRESENTED AND REPRESENTING THE POLICE FORCE AT LARGE.

IT WAS TO HAVE A FARE COMPARISON OF OFFICERS WEARING THE CAMERAS AND NOT WEARING THE CAMERAS AGAINST ANY SYSTEMATIC DIFFERENCES.

THIS WOULD BE REPRESENTING OFFICERS IN THE POLICE DEPARTMENT PARTICIPATING IN THE STUDY.

DISTRICTS TWO, THREE, FOUR, FOURTEEN, EIGHTEEN, YOUTH VIOLENCE STRIKE FORCE. IT'S REPRESENTATIVE OF OFFICERS WORKING THOSE TWO SHIFTS THAT WE

MENTIOND IN THOSE ASSIGNMENTS.

NOT THE DEPARTMENT AS A WHOLE.
>> JUST A COUPLE OF MORE IF THAT
IS OKAY I THINK OF THE INTER
ACTIONS WITH CIVILIANS CAN YOU
TELL ME HOW MANY WERE PEOPLE OF
COLOR, AGES AND GENDER, WHAT
TYPES OF INTER ACTIONS WERE
THEY?

>> WE HAVEN'T LOOKED AT THE INTER ACTION DATA YET.

WE'RE WORKING ON THAT NOW AS FAR AS THE FIOS AND ARREST DATA WE'RE RECEIVING.

WE HAVE THE INFORMATION FOR THE COMPLAINTS.

WE HAVEN'T LOOKED AT IT JUST

WE SHOULD HAVE THAT AVAILABLE FOR THE REPORT COME THE END OF JUNE.

>> OKAY.

IN TERMS OF THE ATRICION.

21 OFFICERS LEFT AND HAD YOU TO USE ALTERNATES.

I NOTICED TEN WERE ASSIGNMENT CHANGE, 15 MEDICAL REASONS. IT SEEMED A HIGH NUMBER THAT 15

OUT OF THE 21 LEFT FOR THOSE REASONS.

I WAS WONDERING IF YOU HAD MORE DETAILS OR SPECIFICATIONS AS TO THE REASONS.

SOME LEFT AS EARLY AS NINE DAYS INTO IT.

>> I THINK A LOT OF THE OFFICERS THEY'RE IN BUSIER DISTRICTS.

THEY GET IN A LOT OF ROLLS, WHAT WE CALL ROLLS, DISTURBANCES.

THEY'RE ON THE GROUND AND WE SEE THEM OUT.

THOSE OFFICERS WITH THE CAMERAS THEY'RE IN BUSY DISTRICTS.

15 WENT OUT WITH INJURIES.

AS FAR AS THE NINE DAYS

OBVIOUSLY IF SOMEONE IS MOVED AND PROMOTED WE HAVE NO CONTROL OVER THAT, OR IF THEY MOVE INTO

A DIFFERENT ASSIGNMENT.

I CAN GET YOU MORE PARTICULAR REASONS WHY BUT OVER THE COURSE OF A YEAR FOR 15 OFFICERS IN THE BUSIEST DISTRICTS TO BE OUT.

THEY WORK HARD AND UNFORTUNATELY THEY GET INTO SITUATIONS WHERE

YOU KNOW WHETHER THEY HURT A SHOULDER, BREAK A FINGER STRUGGLING WITH SOMEONE WITH A GUN.

THOSE ARE THE TYPES OF THINGS WE DEAL WITH.

IT'S A DANGEROUS JOB.

IT INVOLVES A LOST PHYSICAL.

ON THE STREET NOBODY GIVES UP EASILY.

THEY ENGAGE IN STRUGGLES.

>> I HAVE ONE FOLLOW-UP BEFORE

THE SECOND ROUND, MR. CHAIR.

ON THIS PARTICULAR CASE AROUND THE ALTERNATES.

CAN YOU TELL ME WHETHER THERE

WAS A GAP FROM A OFFICER LEAVING

AND ANOTHER COMING ONBOARD OR

WAS IT SEAMLESS.

GAP IN TIME.

>> I CAN GET YOU THAT INFORMATION.

>> TALKING ABOUT THE PROCESS.

WE IDENTIFIED THE ALTERNATIVES

AHEAD OF TIME TO DRAW FROM.

SO BASICALLY THE NEXT SHIFT, AS SOON AS WE COULD MAKE THAT

SWITCH WE DID.

THE ALTERNATES WERE PREVIOUSLY TRAINED.

IT WAS JUST A MATTER OF SWAPPING ONE OFFICER FOR ANOTHER.

>> THANK YOU.

>> THANK YOU, COMMISSIONER EVANS.

HE HAS TO GET SCOOTING.

WE HAVE A 17-INCH SNOW STORM COMING IN.

THEY HAVE A MEETING.

OBVIOUSLY HE WASN'T AWARE THAT STORM WAS COMING.

I APPRECIATE YOUR ALLOTTED TIME. YES.

WE WILL DRILL THESE GUYS WHILE YOU'RE GONE.

>> THANK YOU.

>> COUNSELOR MICHAEL FLAHERTY.

>> THANK YOU, MR. CHAIR.

THE COMMISSIONER AND HIS STAFF, I COMMEND THEM AND THE BOSTON POLICE DEPARTMENT FOR THE GREAT JOB THEY ARE DOING SO WE DON'T FIND OURSELVES, SEE OURSELVES AND FIND OURSELVES ON NATIONAL

NEWS LIKE OTHER JURISDICTION. IT'S HIS LEADERSHIP AND TEAM'S LEADERSHIP WE'RE IN A PRETTY GOOD POSITION AS A CITY. KUDOS TO THE COMMISSIONER, THE MAYOR AND THE TEAM PUT TOGETHER. SUPERINTENDENT YOU MENTIONED FIVE MILLION TO SEVEN MILLION. THREW THAT OUT FIVE TO SEVEN GRAND OR 50,000 TO 70,000. THAT'S A 2 MILLION-DOLLAR SWING. IS THAT FULL IMPLANTATION FOR EVERY OFFICER, SUPERIOR OFFICER AND DETECTIVE. IS IT ON THE SNAP SHOT OF THE

PILOT PROGRAM.

CAN YOU PUT A SUBSTANCE BETWEEN THE FIVE MILLION TO SEVEN MILLION.

>> THE ESTIMATE IS BASED ON A IMPLEMENTATION OF 1500 CAMERAS FOR THE PATROL FORCE IT WOULD ALSO INCLUDE SOME IMPLEMENTATION COSTS.

UPGRADING SOME OF THE NETWORK INFRASTRUCTURE.

PHYSICAL INFRASTRUCTURE.

DOCKING STATIONS, CONSTRUCTION AROUND THAT FOR THE DISTRICTS.

THE COMMISSIONER MENTIONED

STAFFING IS ALSO A PREREQUISITE

AROUND REVIEWING VIDEO FOR

PUBLIC RECORD REQUESTS.

PUTTING VIDEO TOGETHER FOR COURT AND THINGS LIKE.

THAT ADMINISTRATIVE AND

TECHNICAL STAFFING.

>> SO THE FIVE TO SEVEN MILLION

IS THE OUT FITTING 1500

OFFICERS, MAINTENANCE, REPAIR,

STAFFING, PRESERVATION OF

EVIDENCE, THAT TYPE OF STUFF.

>> YES.

>> HOW LONG WOULD WE BE REQUIRED

TO PRESERVE VIDEO?

>> THAT WOULD BE A POLICY OUESTION.

BASICALLY WHAT HAPPENS IN MOST BODY CAMERA IMPLEMENTATIONS IS THE OFFICER WILL TAG A VIDEO BASED ON THE NATURE OF THE INCIDENT.

DEPENDING ON THE TAG, THAT WOULD PLACE THAT PARTICULAR FOOTAGE

INTO A RETENTION BUCKET.

SO IF IT WAS RELATE TODAY
HOMICIDE FOR INSTANCE THAT WOULD

BE HELD FOREVER.

IF IT WAS A, YOU KNOW, A LOOTERING ARREST IT MAYBE HELD FOR THE DURATION OF THE COURT THEN ANOTHER 90 DAYS.

SO THOSE THINGS WE HAVE TO FIGURE OUT IN THE SYSTEM.

>> OBVIOUSLY RECOGNIZING,

COLLECTIVE BARGAINING AGREEMENTS AND ISSUES.

IS THIS SOMETHING THAT WOULD BE PHASED IN.

THE 1500 OR SOMETHING HITTING THE STREETS ALL AT ONCE?
>> ONE APPROACH WE HAVE LOOKED

WE NEED LEAD TIME FOR A NUMBER OF THINGS.

INCLUDING PROCUREMENT,

NEGOTIATIONS, ADMINISTRATIVE RAMP UP AND THINGS LIKE THAT.

SO, IT WOULD SEEM TO BE ONE, ONE APPROACH IS TO DO THIS IN A

PHASED MANNER.

HAVE LEAD TIME AND LOOK AT MAYBE YOU KNOW SIX MONTHS DOWN THE ROAD.

START TO IMPLEMENT A LIMITED NUMBER OF THE DISTRICTS AND THEN RAMP UP AS WE GO.

>> I KNOW WE'RE STILL IN THE DATA COLLECTION PHASE WITH RESPECT TO THE PILOT PROGRAM. WANTED TO KNOW IF WE HAVE RECOGNIZED A COST SAVINGS, MAYBE STATING OFF -- STAVING OFF LITIGATION.

HAVE WE RECOGNIZED OR USED THE FOOTAGE IN A CRIMINAL OR CIVIL CASE TO DATE.

THE COMMISSIONER WOULD BE THE BEST PERSON, THE CHILLING AFFECT.

AN ASSISTANT DA I SAW SOMEONE WILL WALK UP TO THE POLICE OFFICER AND SAY THE GUY IN A RED SHIRT AND BLUE SHIRT THEN WALK AWAY.

THEY DON'T WANT TO BE INVOLVED BUT THEY GIVE YOU A LEAD, A TIP TO START THE PROCESS.

MY CONCERN IS THE CHILLING AFFECT.

THE COMMISSIONER REFERENCED THAT.

GIVING SOMEONE A BREAK AND HAVING THE DISCRETION.

BUT ALSO SOMEONE GIVING YOU THE STRAIGHT SCOOP AFTER A SITUATION BUT DON'T WANT TO BE NEAR A COURT PROCEEDING OR MENTIOND IN A POLICE DEPARTMENT.

THEY HAVE VITAL AND SKREUT CAL INFORMATION AT THE ONSET OF A CRIME.

I DON'T KNOW WHETHER YOU HAVE THAT DATA COLLECTION INDICATING THE PERSON COMING UP FOR THE STRAIGHT SCOOP IMMEDIATELY THERE AFTER SCOOP

IMMEDIATELY THEREAFTER, THAT'S BEEN DMIRKD, YOU KNOW?

THEY QUESTIONS FROM THE DATA YOU HAVE RITE NOW, ANY COST SAVINGS RECOGNIZED, HAS ANY OF THE FOOTAGE BEEN USED IN CRIMINAL CIVIL TRIALS, RECOGNIZING OR SEEING ANY TYPE OF CHILLING EFFECTS SIMILAR TO WHAT THE COMMISSIONER SPOKE ABOUT, THE

>> STARTING AT THE FINAL QUESTION, WE'VE NOT HAD ANY ANECDOTAL INFORMATION THAT PEOPLE WERE SCARED OFTEN FROM THE BODY CAMERAS, IT'S NOT SOMETHING WE WOULD KNOW.

DISCRETIONARY FORM?

REGULARLY IN COURT.

BUT I HAVEN'T HEARD ANY ANECDOTAL EVIDENCE ABOUT THAT. VIDEO FOOTAGE HAS BEEN USED

THE OFFICERS WEARING THE BODY CAMERAS HAVE BEEN SUPPLYING THE VIDEO TO THE COURT.

I DON'T KNOW HOW MANY CASES BUT CONSIDERABLE AMOUNT OF CASES HAVE BEEN SUPPORTED BY BODY CAMERA FOOTAGE.

AS FAR AS COST SAVINGS, AGAIN HARD TO MEASURE.

WITH THE SMALL NUMBERS IN THE PILOT.

BUT WE DO HAVE TWO IAD CASES THAT WE KNOW OFFICER WAS WEARING A BODY CAMERA.

I THINK TWO OF THOSE CASES WERE NOT SUSTAINED BECAUSE THE OFFICER WAS WEARING A BODY CAMERA AND HAD THAT INFORMATION THERE.

SO AGAIN, YOU DON'T KNOW WHAT IT COULD HAVE LED TO.

BUT WE DO HAVE THAT SMALL DATA SET.

>> VERY IF AND FINALLY JUST
THROUGH THE CHAIR AND THIS WILL
BE VERY IMPORTANT THROUGH OUR
BUDGET PROCESS IN TERMS OF THAT
5%, A MILLION, THAT IS A \$2
MILLION SWING, AS YOU'RE GETTING
DATA, THAT KIND OF GET -- THE
COST MAYBE KIND OF GETS
SHARPENED A LITTLE BIT.
BUT IS THAT COMING OUT OF THE
EXISTING BPD BUDGET OR IS THIS
GOING TO NEED ADDITIONAL FUNDS
FROM THE ADMINISTRATION AND THE
COUNCIL THROUGH THE BUDGET
PROCESS?

IF THAT'S THE CASE NEW AND

ADDITIONAL FUNDS THOSE ARE REAL NUMBERS THAT I NEED TO SEE. AND WE'RE NOT GOING TO BE ABLE TO DEAL WITH A \$2 MILLION SWING. WE'LL HAVE TO ZONE IN TO WHAT THAT NULL IS, THE 1500 PLUS THE MAINTENANCE REPAIR AND ALL THE STUFF THAT GOES WITH IT. >> SO WE'RE CURRENTLY IN DISCUSSION WITH THE BUDGET OFFICE ON THE COSTS RELATED TOIÑÑ BODY CAMERAS AND IMPLEMENTATION. I DON'T KNOW WHAT WILL COME OUT OF THOSE DISCUSSIONS BUT I CAN TELL YOU WE'RE LOOK AT -- IF WE DID A PHASED IMPLEMENTATION WE WOULD LOOK AT A PLACE HOLDER OF \$1.9 MILLION.

- >> THANK YOU SUSPECT DALY FOR ALL THE WORK YOU DO ON THAT. THANK YOU, MR. CHAIRMAN. >> THANK YOU COUNCILOR FLAHERTY. COUNCILOR.
- >> I WANT TO ECHO MY THANKS FOR INITIATING THIS CONVERSATION.
 I HAD, SOME, BETTER
 DIRECTTOWARDS THE COMMISSIONER
 WHO IS NOT HERE SO I MIGHT JUST
 GO AHEAD AND MAKE THIS STATEMENT

AND YOU CAN LET ME KNOW IF YOU HAVE THE INFORMATION FOR THEM. I'M PARTICULARLY CURIOUS ABOUT THE INCIDENTS OF THE CAMERA NOT BEING ACTIVATED AT ALL IN YOUR WHERE REPORT WITH FOLKS DID YOU HAVE THAT HAPPEN?

>> I'M ONLY AWARE OF ONE CASE WHERE AN INQUIRY WAS MADE AROUND THAT AND WE REVIEWED THE VIDEO AND FOUND THAT THAT DID HAPPEN AND THE OFFICER ACTED STRICTLY ACCORDING TO POLICY IN THAT CASE.

>> SO THERE ARE CERTAIN POLICIES THAT THE COMMISSIONER MENTIONED WHEN IT COMES TO DOMESTIC VIOLENCE AND ENTERING SOME PEOPLE'S HOMES THAT THE PUBLIC HAS THE OPTION TO SAY NO I DON'T WANT THE CAMERA IN MY HOME AND IN THOSE INSTANCES ONLY THE OFFICERS TURNING THE CAMERA OFF? >> IN A DWELLING THE OFFICER IS OBLIGATED TO ANNOUNCE THEY ARE WEARING AND RECORDING. AND IF THE PERSON IN THE DWELLING, ANY PERSON IN THE DWELLING STATES THAT THEY DON'T WANT THE RECORDING ON, THE OFFICER IS OBLIGATED TO DISCONTINUE THE RECORDING. THE ONLY EXCEPTION IS IF AN EXIGENT SITUATION RISE IS THE OFFICER CAN ELECT TO REACTIVATE THE CAMERA.

>> HOW HAVE YOU BEEN NOTIFIED THAT THE CAMERA HAS BEEN TURNED OFF, POLICE REPORT NO CAMERA FOOTAGE, HOW WOULD YOU KNOW TO COME?

>> THE ONLY WAY WE WOULD KNOW IS IF WE DID SPOT CHECKS.
AND WE DID THROUGH THE PILOT DO RANDOM SPOT CHECKS FOR

COMPLIANCE WITH POLICY AND OUR AUDITING DEPARTMENT HAS SOME OF THAT INFORMATION.

BUT THEY HAVE NOT PUBLISHED THEIR REPORT YET.

WE EXPECT THAT AT ABOUT THE SAME TIME AS WE HAVE THE FINAL REPORT.

>> SO WHEN THIS ROM -- BY THE

WAY IEFERL I'LL GO ON RECORD, STATING MORE POSITIVES BEING NEGATIVES, THE BIGGEST NEGATIVES IS POTENTIAL COST, I'M FULLY IN SUPPORT OF EXPANDING THIS WITHIN THE DEPARTMENT, ARE YOU GOING TO HAVE STRUCTURALLY WITHIN THE DEPARTMENT A WAY TO KNOLL UP ON CAMERAS BEING TURNED OFF OR IS IT ALWAYS GOING TO BE RANDOM WHO TURNED OFF THEIR CAMERA?

>> IT'S KIND OF A DIFFICULT SITUATION.

JUST FOR THE PILOT WE HAD ALMOST 40,000 VIDEOS.

SO -- AND TO WATCH A VIDEO REQUIRES SOMEONE TO WATCH IN REAL TIME.

THERE IS NO REAL SORT OF WAY TO COMPRESS THAT.

SO WE RELY ON SORT OF A RANDOM SELECTION OF COMPLIANCE OVERSIGHT.

AND THAT'S PROBABLY THE MODEL THAT WE'LL BE LOOKING AT BASED ON AVAILABLE STAFFING.

>> WITH REGARD TO THE VIDEOS AND THEN PRIVACY, SO THE COMMISSIONER HAD MENTIONED, I

THINK YOU ADDED TO THE FACT THAT YOU WOULD HAVE TO HIRE

ADDITIONAL STAFF TO MAKE SURE YOU COULD REQUEST WITH THE FOIA REQUESTS, I WAS CURIOUS TO KNOW WHO COULD STOP THE VIDEO COMING OUT?

THE IMMEDIATE INCIDENT NOT HERE BUT IN CHICAGO, MAYOR EMANUEL, STOPPING A VIDEO MOST LIKELY FOR HIS OWN POLITICAL GAIN, A PERSON BEING SHOT SEVERAL TIMES BY A POLICE OFFICER AND THEN RELEASING IT, HOW WOULD WE STOP A SPECIAL INTEREST OR POLITICAL INTEREST TO STOP CAMERA FOOTAGE GOING OUT?

>> THE VIDEO PRODUCED 50 BODY CAMERAS WOULD BE CONSIDERED PUBLIC RECORDS UNDER THE PUBLIC RECORDS LAW.

THERE ARE PROVISIONS IN THE LAW TO.REDACT, TO PROTECT SOMEONE'S PRIVACY.

AND WE WOULD FOLLOW THE LAW.

>> IS THERE ANY OPPORTUNITY TO HAVE PERHAPS A CITIZEN COMMITTEE TO REVIEW THE 92nd AN COMING IN AND ALSO HELPING TO RESPOND TO THE FOIA REQUEST, BEFORE THEY GO OUT TO THE PUBLIC BEING REPRESENTATIVE OF THE PUBLIC? >> THAT'S SOMETHING CERTAINLY TO CONSIDER.

>> THE COMMISSIONER HAD MENTIONED AND I THINK HE WOULD BE MORE APPROPRIATE TO ANSWER SO I'LL JUST MAKE THIS STATEMENT, THE COMMISSIONER HAD MENTIONED THE USE OF DRONES, I DON'T THINK YOU WERE EXPECTING HIM TO DO THAT, HE HAD MENTIONED THE USE OF DRONES BEING HELPFUL, BEING SOMETHING THAT THEY HELP WITH ACCIDENTS, THEY HELP WITH BEING ABLE TO GET THERE FASTER, AFTER THE BOMBING, SO ON SO FORTH, I WOULD HOPE HE'S OPEN TO CONTINUED CONVERSATION ABOUT HOW IF COMMUNITY IS ABLE TO CHECK HOW THEY ARE BEING POLICEAND BEING SURVEYED.

SO I WONDER IF WE COULD FOLLOW OTHER CITY'S MODELS SUCH AS STAB SANTA BARBARA?

THEY HAVE EQUIPMENT COMING
BEFORE THE CITY COUNCIL AT WHICH
POINT WE LOOK AT I AND THEN AS A
COMMUNITY AGREE THAT THIS IS HOW
WE ARE WILLING TO BE SIR VEILE SUR VEILED.
SUR VEILED.

JUST TO GO BACK TO SOME OF THE STATISTICAL DATA, I'M NOT CATCHING WHAT YOU'RE SAYING WHEN YOU ARE SAYING YOUR COMPARATIVE SAMPLET.

I'M GOING TO BE JUST DIRECT.
ARE YOU SAYING YOU TOOK A WOMAN,
BLACK WOMAN WHITE WOMAN POLICE
OFFICER WITH A CAM ARE AND
WITHOUT, YOUR COMPARATIVE
SARCHL, IS THAT WHAT YOU'RE
SAYING?

I'M CONFUSED.

>> WE TOOK THE GROUP OF OFFICERS WHO WERE IN THOSE 5 DISTRICTS AND ON THE STRIKE FORCE WHO WERE WORK THOSE TWO SHIFTS, THE FIRST DAY SHIFT AND FIRST HALF SHIFT

AND ALL OF THE OFFICERS WHO WERE IN ASSIGNMENTS WHERE THEY'RE ACTUALLY PROVIDING POLICE SERVICES NOT ADMINISTRATIVE ASSIGNMENTS, WE GOT THE ROSTER AND WE RANDOMLY ALLOCATED THEM TO TWO GROUPS.

THE NICE THING ABOUT RANDOMIZATION WHEN YOU CREATE THOSE TWO GROUPS IN A RANDOM MARRY THEY END UP BEING THE SAME OR EQUIVALENT.

SO YOU'RE ABLE TO SAY, BASED ON THIS APPLES TO APPLES COMPARISON, WHAT'S THE DIFFERENCE BETWEEN USE OF FORCE, THE ONLY DIFFERENCE IS CAMERAS. >> YOU HAVE THE SAME PEOPLE OF COLOR, THAT'S WHAT I WAS SAYING, YOU HAD THE SAME PERCENTAGE OF ETHNICITY IN ONE GROUP AND THE OTHER AS WELL, THE ONLY DIFFERENCE BEING THE CAMERA? >> EXACTLY.

>> JUST TO ECHO WHAT MY
COLLEAGUE, COUNCILOR JANEY HAD
MENTIONED, WHILE WE START WITH
LOW NUMBERS A LOT OF THAT HAS TO
DO WITH THE FACT THAT PEOPLE
AREN'T COMING FORWARD MAYBE DUE
TO LACK OF LANGUAGE SKILL SET
MAYBE LACK MUCH IMMIGRATION
STATUS, PEOPLE AREN'T COMING
FORWARD TO BEGIN WITH WHICH
ARTIFICIALLY DEPRESS THE AMOUNT
OF COMPLAINTS.

I UNDERSTAND YOU HAVE TO USE WHAT STATISTICAL DATA YOU CAN.
BUT WAS THERE ANY WAY TO GET ANY OTHER FORM OF UNDERSTANDING HOW MANY INCIDENTS NOT NECESSARILY COMPLAINTS BUT INCIDENTS, USE OF FORCE, BEYOND WHETHER SOMEONE FILED A COMPLAINT OR NOT?

>> THE ONLY WAY YOU WOULD BE ABLE TO GLEAN THAT WOULD BE THROUGH SOME OF THE INTERVIEWS THAT JACK'S BEEN DOING IN THE COMMUNITY TO GET A SENSE OF THE PREVALENCE OF THAT.

FOR THE STATISTICAL ANALYSIS

FOR THE STATISTICAL ANALYSIS WE'RE LYING ON THE-RELYING ON THE DATA THAT'S AVAILABLE AS THE BOSTON POLICE FORCE KEEPS IT.

>> BASED ON YOUR UNDERSTANDING IS THAT TYPICAL WAYS OF STUDYING THE USE OF CAMERAS?
NO OTHER EXAMPLE OF GETTING INTO THE COMMUNITY, GETTING A SAMPLE, DOING PHONE INTERVIEWS NONE OF THAT?

>> THERE HAVE BEEN EXAMPLES OF FOLKS LOOKING AT HOW COMMUNITY MEMBERS IN AREAS THAT RECEIVE CAMERAS VERSUS ONES THAT DID NOT, REACT TO THE INTRODUCTION OF CAMERAS ON POLICE OFFICERS. AND BY AND LARGE THOSE STUDIES TEND OSUGGEST POSITIVE EFFECTS, THE COMMUNITIES WELCOME THEM, THEY FEEL THAT THEY ADD TO THE TRANSPARENCY OF POLICING, AND OTHER POSITIVE BENEFITS SUCH AS THAT.

>> JUST TWO MORE QUESTIONS. I KNOW, I KNOW.

TWO MORE QUESTIONS.

SO WE ALSO, I I KNOW SEVERAL FOLKS SAID CAMERA FOOTAGE, I ESTIMATE HE WAS NOT PART OF THIS.

- >> ACTUALLY HE WAS PART OF THE BODY CAMERA PILOT.
- >> HE WAS?
- >> HE WAS NOT WEARING A BODY CAMERA, THE PILOT HAD ENDED BY THAT POINT.
- >> SO HE WAS PART OF THE PILOT. THE PILOT PROGRAM HAD ENDED.
- >> YES.
- >> 50 TIME HE HAD DONE THIS AND SOMEONE ELSE CAUGHT HIM ON THEIR CELL PHONE?
- >> YES.
- >> OKLAHOMA, AND ANOTHER
 INDICATION OF WHY I SUPPORT
 HAVING BODY CAMERAS, IT IS
 UNFORTUNATE HE WAS OUT OF THE
 PROGRAM WHEN THIS HAPPENED.
 AND THEN JUST IN LIGHT OF THE
 PRO TRAICT OF TRACTED
 NEGOTIATIONS WITH THE UNION TO
 HAVE A STRONG POLICY FOR PILOT
 PROGRAM, I GUESS, TO ENSURE
 ADOPTION OF A STRONG POLICY,
 PRIVACY PROTECTIONS, TO MAY SURE
 WE ARE STILL PROTECTING PRIVACY?
 >> SO THE POLICY DEVELOPMENT

MEES -- PIECE, WE DO HAVE FOR THE PILOT WE PUT TOGETHER A POLICY THAT WE THE WORK GROUP FOR SOCIAL JUSTICE TASK FORCE TO DEVELOP AND WE HAD A NUMBER OF MEETINGS WITH COMMUNITY GROUPS. AND SO WE WOULD EXTEND THAT, WE WOULD TAKE ANY LESSONS LEARNED FROM THE PILOT AND EXTEND THE POLICY INTO A FULL IMPLEMENTATION.

 WE REVIEWED SEVERAL DIFFERENT

 POLICIES AND ADOPTED LANGUAGE

 FROM SOME OF THE ACLU'S LANGUAGE

 AROUND POLICY, TO INCORPORATE

 THAT INTO THE POLICY AND SOME OF

 THE OTHER ACTIVISTS AS WELL,

 SOME OF THEIR LANGUAGE.
- THE DEPARTMENT DID ADOPT SOME OF THAT AND I THINK THAT'S CRITICAL TO NOTE TOO.
- >> JUST ONE OTHER FOLT UP TO THAT -- FOLLOW UP TO THAT QUICKLY, COUNCILOR FLAHERTY'S POINT.
- ONE OF THE PLACES A CAMERA IS SUPPOSED TO BE TURNED OFF, IF A CONFIDENTIAL INFORMANT IS COMING UP, TO GIVE YOU INFORMATION, THE CAMERA WOULD NOT BE ACTIVE.
- >> COUNCIL JOSH ZAKIM.
- >> I THINK IT'S GREAT HOW WE'VE DONE IT IN THE CITY OF BOSTON, PRESIDENT CAMPBELL FOR TWO YEARS, A YEAR OF THESE MEETINGS, AND LEADING THIS AND GETTING US TO THIS POINT.
- TO IT'S MUCH APPRECIATED, IT'S A HUGE SERVICE I THINK BOTH TO POLICE DEPARTMENT AND THE PEOPLE OF THE CITY OF BOSTON.
- I'M ENCOURAGED TO HEAR THAT ESPECIALLY RELATIVE TO OTHER DEPARTMENTS WE START OFF ON A LOW BASELINE OF USE OF FORCE COMPLAINTS, THAT FITS IN REQUEST

A LOT OF THE DATA ANECDOTAL AT RESEARCH BASE THAT WE SEE ABOUT THE BOSTON POLICE DEPARTMENT. I THINK THE MEN AND WOMEN DO A GREAT JOB.

IT COMES DOWN TO TRAIN, I APPRECIATE THAT.

THERE'S A NEED TO EXPAND THIS PROGRAM.

KNOWING THAT THE WAY THAT I AND MANY OF MY CONSTITUENTS AND MANY OTHERS INTERACT WITH THE POLICE DEPARTMENT MAY BE DIFFERENT, FROM PEOPLE OF DIFFERENT BACKGROUNDS AND I THINK IT'S IMPORTANT THAT PEOPLE FEEL SAFE ON BOTH SIDES.

IT SOUNDS LIKE POLICE OFFICERS ARE WELL SERVED BY THESE CAMERAS AS WELL AS MEMBERS OF THE COMMUNITY AND MAKE SURE THAT PEOPLE ARE FEELING BETTER AND MORE COMFORTABLE AS WEIGHING THE PRIVACY CONCERNS.

THIS HAS SORT OF BEEN CANADA EARLIER, PERHAPS IT NEEDS TO HAPPEN 31 EVERE THROUGH COMMUNITY MEETINGS AS -- THRUR COMMUNITY MEETINGS, ARE MEMBERS OF THE COMMUNITY GENERALLY MORE COMFORTABLE, FEEL BETTER WITH THESE CAMERAS ON?

I DON'T KNOW IF THIS GOES TO YOU SUPERINTENDENT OR YOU GENTLEMEN ABOUT THE RESEARCH ASPECT OF IT. I THINK THAT'S THE ULTIMATE GOAL HERE.

OBVIOUSLY WE WANT TO MAKE SURE THAT PEOPLE ARE BEHAVING WELL ON BOTH SIDES OF THIS.

BUT WHAT IS YOUR SENSE OF WHO FEELS SAFER, WHORCH WANTS TO --> IN THE COMMUNITY MEETINGS I'VE BEEN AT, PEOPLE DO FEEL SAFER, THEY FEEL BETTER ABOUT THEIR INTERACTIONS WITH THE POLICE, IN GENERAL, IT'S NOT 100% BUT THE MAJORITY OF FOLKS FEEL THAT THIS IS BETTER FOR POLICING AND BETTER FOR THEIR INTERACTION HE AND INCREASED TRUST IN THE POLICE.

>> SO I GUESS GIVEN MY OUTSTANDING COLLEAGUES HERE,

MOST OF THE QUESTIONS I HAD WERE ASKED.

I HAVE ONE MORE AND THEN -- MAYBE TWO MORE.

WE OFTEN HAVE TALKED ABOUT IN THE CONTEXT OF THESE DASHBOARD CAMERAS ON POLICE CARS.

BOSTON WE DON'T HAVE THEM.

WHETHER THEY ARE CERTAINLY NOT MUTUALLY EXCLUSIVE, WHAT IS OUR FEELING ON THAT IS THERE A MOVEMENT ON THAT?

A LITTLE OFF TOPIC, I APOLOGIZE TO THE SPONSOR AND CHAIRMAN, IS THERE PART OF THE DISCUSSION IS THERE A WAY TO COUPLE THESE TOGETHER?

>> THERE ISN'T, ACTUALLY THE FEELING IS THAT THEY NEED TO BE COUPLED TOGETHER.

THAT YOU CANNOT HAVE TWO DIFFERENT SORT OF PLAT FORMS THAT DOING THE SAME THING, ONE GATHERING INFORMATION FROM A BODY CAMERA, THE OTHER ONE FROM A CAR, BASICALLY PRODUCING THE SAME THING.

YOU NEED THE SAME BACKHAND, EVERYTHING WORKING TOGETHER. SO I THINK IT'S A QUESTION OF SETTING THE PRIORITIES. I THINK BODY CAMERAS IS THE

THING WE'RE LOOKING AT MOST CLOSELY NOW.

BUT ANY OTHER VIDEO COLLECTION DEVICE SHOULD BE PART OF THE SAME SYSTEM.

>> GREAT.

I DO THINK THIS HEARING AND ONES LIKE IT ARE HELPFUL.

I THINK IT IS REGRETTABLE THAT IN MANY INSTANCES WE FEEL LIKE PEOPLE ARE BEING PITTED AGAINST EACH OTHER IN THIS DISCUSSION.
I THINK WE SHARE THE SAME GOALS.
I THINK WE HAVE A GREAT POLICE DEPARTMENT AND I THINK COMMUNITY RELATIONS ARE BETTER THAN MANY OTHER COMPARABLE CITIES.
HAVING SAID THAT I DO EXPERIENCE THE CITY OF BOSTON AS AN INDIVIDUAL, AS I AM, A WHITE ABLE BODIED MALE IN A SUIT, I

MIGHT BE INTERACTING WITH POLICE

AND OTHERS MUCH DIFFERENT THAN OTHERS IN THE CITY OF BOSTON, I WANT TO BE COGNIZANT OF THAT 'AND MAKE SURE WE ARE WORKING TOGETHER THOUGHTFULLY TO MAKE THIS CITY SAFER AND MORE OUIBBLE EQUITABLE FOR EVERYONE. I LOOK FORWARD TO THESE DISCUSSION HE AND HAVING A FULL

IMPLEMENTATION HERE. THANK YOU.

>> THANK YOU COUNCILLOR ZAKIM, COUNCILOR ESSAIBI-GEORGE.

>> THANK YOU FOR CALLING THIS HEARING.

I ALSO WANT TO THANK MY COLLEAGUES FOR ASKING AND COMMENTING PRETTY IN DEPTH SO MY QUESTIONS WILL BE BRIEF. HAS THERE BEEN ANY REFLECTION ON THE TWO MODELS?

BECAUSE AS I RECALL THERE WERE TWO MODELS OF CAMERA SAMPLES. >> YES.

WE HAD TWO DIFFERENT VENDORS COME IN, AND WE SPLIT IT RIGHT DOWN THE MIDDLE. BOTH HAD STRENGTHS AND

WEAKNESSES.

FROM THE TECHNICAL OFFERINGS, OPERATIONALLY, YOU KNOW, BOTH WORKED THE WAY THEY WERE ADVERTISED.

BUT WE'RE GOING TO DO A DEEPER DIVE INTO PERFORMANCE, TECHNICAL PERFORMANCE, RELIABILITY AND THINGS LIKE THAT.

BEFORE WE MAKE ANY DECISION ON THE PROCUREMENT.

>> AND THEN, CONSIDERING THAT, WERE THERE ANY SURVEY RESULTS OR INFORMATION FROM POLICE OFFICERS WHO WORE THE BODY CAMERAS AS TO THE PREFERABLE MODEL? INTO COMFORT, EASE OF USE,

ABILITY TO TURN ON OR TURN OFF, AND THEN ALSO, WERE THEY SECURE TO THEIR UNIFORM?

WERE THEY A DISTRACTION OR GOT GOT IN THE WAY OF PERFORMING DUTIES?

>> YES, WE COLLECTED INFORMATION BOTH FROM THE OFFICERS WEARING THE CAMERAS AND THE TECHNICIANS

WHO WERE SERVICING THE CAMERAS AND WE HAD SOME CLEAR PATTERNS BETWEEN THE TWO VENDORS REGARDING SOME EVER THOSE ISSUES.

- -- SOME OF THOSE ISSUES.
- >> I THINK THAT'S IT.
- MY QUESTIONS HAVE BEEN ASKED AND ANSWERED.
- >> MY GOOD FRIEND FROM DISTRICT 6, E.
- >> THANK YOU, MR. CHAIR.
 GLAD TO BE WITH YOU.
 THANK YOU CENTIEMEN FOR Y

THANK YOU GENTLEMEN FOR YOUR GREAT WORK.

I THINK WE HAVE THE BEST POLICE FORCE NOT ONLY IN THE COUNTRY, IN THE WORLD AND I THINK THIS IS A CITY WHERE COMMUNITY POLICING WAS BORN AND WE'VE DONE EXCEPTIONALLY WELL AND I COULD GO ON AND ON SO I APPRECIATE YOUR LEADERSHIP AND I ALSO THINK THAT THIS PROCESS REALLY LED BY COUNCILOR CAMPBELL AND HER CAPACITY AS THE FORMER PUBLIC SAFETY CHAIR BEFORE COUNCILLOR McCarthy Someone who has been A GREATLY ADVOCATE FOR THIS ONCE AGAIN HAS EXEMPLIFIED, ASS A SLOW ROLLOUT IT WAS DONE DELIBERATELY AND WELL. A COUPLE OF POINTS. THE COMMISSIONER BROUGHT UP, I

THE COMMISSIONER BROUGHT UP, I
THINK HE WAS CITING LAS VEGAS AS
OFFICERS FELT THEY COULDN'T GIVE
BREAKS TO KIDS IF SOMEONE IS
PULLED OVER FOR EXAMPLE FOR
SPEEDING OR SOMETHING.
THAT WAS SOMETHING, AN
UNINTENDED CONSEQUENCE.
WOULDN'T THERE BE CERTAIN
DISCRETION THAT, COULDN'T AN
OFFICER, I DON'T KNOW, I JUST -THAT WORRIES ME TOO BECAUSE THAT
IS A PRETTY COMPELLING ARGUMENT
THAT HE MADE.

BUT I ALSO FEEL THAT THAT MIGHT ACTUALLY HELP THINGS.

IN OTHER WORDS IF I'M PULLED OVER FOR SPEEDING AND COUNCILOR ESSAIBI-GEORGE IS AN OFFICER WEARING A CAMERA THAT PULLS ME OVER, SHE EXPLAINS I'M GOING TO

GIVE YOU A WARNING THIS TIME BUT YOU NEED TO -- I DON'T KNOW, MAYBE THAT'S ONE EXAMPLE AND I'M NOT GETTING SORT OF THE POINT. BUT I DO THINK IF ANYONE WANTS TO TELL ME IF I'M WRONG ON THAT POINT, THE QUESTION I'M ASKING IN THIS LONG WINDED WAY IS WHY WOULD BODY CAMS PREVENT AN OFFICER FROM GIVING A BREAK TO SOMEONE WHO WAS PULLED OVER? >> IT'S SOMETHING THAT IS HARD TO MEASURE BUT WHAT THE OFFICERS STATE THEY USE DISCRETION ON A DAY-TO-DAY BASIS. BUT SOMETIMES THE DISCRETION

WOULD, THEY WOULD MAKE A VALUE
JUDGMENT AND GIVE SOMEONE A
BREAK NOT BEING SECOND GUESSED
ABOUT THAT, FOLLOWING THEIR
HEART, WEARING A BODY CAMERA
THEY MIGHT TAKE A MORE TECHNICAL
VIEW OF DISCRETION --

>> I GUESS I SORT OF SEE IT BUT I DO THINK, I DON'T KNOW, I THINK THE TWO OUGHT NOT BE MUTUALLY EXCLUSIVE.

OFFICERS GIVING BREAKS AND ALSO WEARING OBODY CAM.

SECONDLY, SOMEBODY HAD BROUGHT UNCONCERN, MAYBE COUNCILOR FLAHERTY, BROUGHT UP THE CONCERN OF PEOPLE BEING UNWILLING TO TALK TO AN OFFICER BECAUSE OF THAT.

WOULDN'T AN OFFICER HAVE THE DISCRETION TO TURN THE CAMERA OFF IN A SITUATION LIKE THAT JUST AS THEY WOULD GOING INTO SOMEONE'S HOME?

>> DEPENDING ON THE CIRCUMSTANCES, WE DON'T WANT TO GIVE TOO MUCH LATITUDE TO THE OFFICERS TO JUST TURN THE CAMERA OFF.

BUT WE WANT TO SORT OF GIVE SPECIFIC CIRCUMSTANCES, IN A COMMON SENSE THAT WOULD BE ALLOWED TO USE THEIR COMMON SENSE TO TURN THE CAMERA OFF. IN THE CASE OF AN INFORMANT, YOU COULD TURN IT OFF, BUT THE OTHER REMEDY WOULD BE THEY WOULD STILL BE USING THE PHYSICAL CAMERA.

IF THE INTERACTION WAS RECORDED WE COULD REDACT THAT AS -- FOR PRIVACY ALONG FOR ENFORCEMENT PURPOSES.

>> THE CONCERN WOULD BE EVEN IF IT IS SHUT OFF OR REDACTED THE ACTS OF WEARING THE CAMERA COULD BE A DETERRENT TO SOMEONE, MAYBE?

>> IT COULD BE.

BUT I THINK AS OFFICERS WEAR CAMERAS ON A REGULAR BASIS, THAT BECOMES NORMALIZED BEHAVIOR AND PEOPLE WOULD GET USED TO IT.
>> IS THERE -- FORGIVE MY IGNORANCE, I HAVE SEEN THEM BUT IS THERE A LITTLE RED LIGHT THAT WOULD INDICATE TO SOMEONE IT IS OFF?

>> YES.

>> OKAY SO THAT IS HELPFUL.

IS ARE THEY RUN BY -- ARE THEY RUN BY BATTERY?

WHAT IS THE BATTERY LIFE TYPICALLY?

>> IT SHOULD BE MORE THAN EIGHT HOURS.

>> AND THEN YOU CHARGE IT.

>> YES.

>> OKAY AND HOW LONG DOES IT TAKE TO FULLY CHARGE?

>> IT WILL CHARGE AGAIN
DEPENDING ON THE MODELS, THE
TECHNOLOGY GETS BETTER EVERY
YEAR.

>> OF COURSE.

>> BUT IT URK GOES INTO ITS BASE STATION TO DO TWO THINGS, TO CHARGE OVERNIGHT AND TO UPLOAD ANY VIDEO THAT IT HAS.

AND SO IT WILL BE THERE FOR THE FULL TWO SHIFTS THAT THE OFFICER IS NOT WORKING.

IT WILL -- BUT THEY CHARGE IN A MUCH SHORTER TIME.

>> LIKE A PHONE WOULD.

>> IN TWO, THREE HOURS.

>> IN A WAY TO CUT COST, INSTEAD OF HAVING ONE FOR EVERY OFFICER, WE COULD HAVE ONE FOR EVERY TWO OFFICERS?

>> WE COULD DO THAT.

PROBABLY IT WOULD BE LOGICALLY CHALLENGING TO MAKE SURE THE

RIGHT CAMERA WENT TO THE RIGHT PERSON EVERY DAY AND ON THE OTHER HAND THE COSTS ARE MORE ON THE BACK EARNED FOR STORAGE, PLATFORM SUPPORT.

>> MY NAME IS CHARU VARMA, I'M A FULL TIME PUBLIC DEFENDER, HERE TESTIFYING ON BEHALF OF THE MASSACHUSETTS BAR ASSOCIATION, CRIMINAL JUSTICE REFORM WORKING GROUP, THE KIND OF A CLUNKY TITLE BUT IT IS A GROUP THAT'S COMPRISED OF THE CRIMINAL JUSTICE SECTION OF THE MASSACHUSETTS BAR WHICH I'M ON AND THE CIVIL RIGHTS SECTION. SO WE COMPILED ACTUALLY BROUGHT A REPORT I WOULD LIKE TO DISTRIBUTE TO THE COUNCILMEMBERS AND I APOLOGIZE FOR JUST RUSHING IN.

I WAS IN COURT ALL MORNING. SO THIS WAS A FORCE THAT WAS ENDORSED BY THE MASSACHUSETTS BAR ASSOCIATION.

IF I COULD DRAW YOUR ATTENTION SPECIFICALLY TO SECTION 4.5 IT IS A RESOLUTION AS I SAID THAT WAS ADOPTED UNANIMOUSLY BY THE HOUSE OF DELEGATES, A RESOLUTION IN SUPPORT OF BODY CAMERAS. AND HOUSE OF DELEGATES IS
COMPRISED OF MEMBERS FROM ACROSS
THE STATE AND CONTAINS A VERY
LEGAL AND GEE GRAPHIC VIEWPOINT,
THE FACT THAT THE HOUSE OF
DELEGATES STOOD UNITED, WITH NO
DISSENT SPEAKS VOLUMES TO THE
ADOPTION OF BODY CAMERAS.
STARTING WITH RESOLUTION 5 WHICH
IS ON PAGE 24, WHICH SUPPORTS
THE POLICE USE OF BODY WORN
CAMERAS, THE WORK GROUP FEEMTION
STRONGLY IT IS NOT A QUESTION OF
IF BODY WORN CAMERAS WOULD BE A

REQUIREMENT, BUT WHEN BODY CAMERAS BECOME A REQUIREMENT. WE REALIZE THE DELAY IS IN LARGE PART FINANCIAL.

WE URGE THE COUNCIL AND ANY LEGISLATORS TO PROVIDE THE FUNDING NECESSARY TO IMPLEMENT THIS PROGRAM.

AND WE FEEL STRONGLY THAT NOW IS THE TIME TO ADOPT SOMETHING LIKE BODY WORN CAMERAS.

I DID HAVE A CHANCE TO REVIEW
THE REPORT THAT -- THAT IS BEING
TESTIFIED ABOUT TODAY AND ONE OF
THE CONCERNS THAT THE COMMITTEE
HAS IS THAT SOME OF ITS
STATISTICAL VECTORS ARE VERY
NARROW IN TERMS OF JUST LOOKING
AT CITIZEN AND POLICE COMPLAINTS
AND THINGS LIKE THAT.

WE FEEL IF YOU BROADEN OUT SOME OF THE DATA POINTS THERE MIGHT BE MORE INFORMATION THAT'S PROVIDED RATHER THAN SOME OF THE SMALL STATISTICAL DIFFERENCES THAT WERE PRESENTED IN THE REPORT.

AND WE ALSO THINK THAT THE USE OF BODY CAMERAS CAN PROVIDE SORT OF HIDDEN BENEFITS AS WELL WITH ENHANCED DATA COLLECTION, ENHANCING COMMUNITY STAKEHOLDERS, BEING A PART OF THE PROCESS, AND IMPLEMENTING THE USE OF BODY CAMERAS POLICIES AND PROCEDURES SUCH LIKE THAT. AND INCLUSION OF COMMUNITY STAKEHOLDERS IS A VERY IMPORTANT PART OF THIS PROCESS. AND ANOTHER THING THAT -- AND I WILL JUST FINISH WITH THIS. I'VE HAD THE OPPORTUNITY THROUGH COMMITTEE TO BE SOME DECISIONS OF SOME OF THE BODY CAMERA FOOTAGE THAT WAS PRESENTED AND AVAILABLE, WE THINK FOOTAGE LIKE THIS CAN BE DISPOSITIVE FOR BOTH SIDES, THE ARGUMENTS ON BEHALF OF THE COMMONWEALTH CAN ALSO BE STRENGTHENED BY LOOKING AT FOOTAGE SUCH AS THAT. SO WE WOULD ADOPT AND URGE THE COUNCIL TO PROPOSE LEGISLATION

THAT WOULD REQUIRE THE USE OF

BODY CAMERAS FOR POLICE DEPARTMENTS THROUGHOUT THE CITY. AND I URGE YOU TO READ THE REPORT THAT WE PROVIDED, ALL OF IT IN ITS ENTIRETY BECAUSE IT'S RIVETTING.

PARTICULARLY 4 AND 5 PERTAIN TO THE HEARING TODAY.

WE WOULD LIKE TO ASK THAT YOU NOT WAIT FOR THE STUDY AND THAT THERE'S FULL CAN IMPLEMENTATION NOW AND ASK THAT THE MAYOR PUT MONEY IN HIS BUDGET FOR THE BUDGET TO REFLECT THAT IMPLEMENTATION.

I'D ALSO LIKE TO JUST STATE WE'VE HEARD TODAY A LOT ABOUT DISCRETION AND GIVING PEOPLE A BREAK.

THIS IS A GOOD PLUG I BELIEVE TO SAY WE REALLY NEED MEMBERS OF LAW ENFORCEMENT AND POSSIBLY EVEN OF THIS PANEL THAT BETTER REFLECT THE COMMUNITIES, THAT THE RICH AND DIVERSE COMMUNITIES OF BOSTON.

WE ASK THAT THERE ARE POLICIES IN PLACE WITH RESPECT TO WHEN THE CAMERAS ARE TURNED ON AND OFF AROUND THERE'S TRANSPARENCY AND CITIZEN OVERSIGHT AND THOSE ARE OUR COMMENTS.

SO I KNOW THIS IS NEW FOR US.

DOES ANYBODY ELSE WANT TO TESTIFY BEFORE WE GO AROUND ONE MORE TIME?

I THOUGHT YOU WERE JUST SIGNING AUTOGRAPHS ON THE WAY IN.
SIGN YOUR NAME AND AFFILIATION

FOR THE RECORD. >> THAT HAS HAPPENED, RASAN HALL, AMERICAN CIVIL LIBERTIES UNION OF MASSACHUSETTS. THANK YOU MEMBERS OF THE COUNCIL, MA'AM PRESIDENT, MR. CHAIR AND OTHER MEMBERS HERE. THE ACLU IS THANKFUL FOR YOU ALL HOLDING THIS HEARING, SINCE 2014 WHEN WE RELEASED OUR REPORT BLACK BROWN AND TARGETED, WE STRONGLY URGED THE BOSTON POLICE DEPARTMENT TO ADOPT A BODY WORN CAMERA POLICY OR PROGRAM. AND SUPPORTED BY STRONG PRIVACY PROTECTIONS AND A ROBUST POLICY TO ENSURE THAT THE INFORMATION THAT IS CAPTURED WITHIN THE BODY-WORN CAMERA FOOTAGE AS WELL AS THE PRIVACY PROTECTIONS AND CONCERNS OF THE RESIDENTS OF BOSTON ARE WELL PROTECTED. IT WAS PARTICULARLY DISTURBING WHEN THAT REPORT WAS INITIALLY RELEASED, TO SHOW THERE ARE RACIAL DISPARITIES IN WHO WAS STOPPED, INTERROGATED, OBSERVED AND FRISKED BY THE BOSTON POLICE DEPARTMENT DESPITE ONLY MAKE UP 24% OF THE CITY POPULATION, BLACK PEOPLE MADE UP 63% OF THOSE POLICE CIVILIAN INTERACTION HE, WE FELT IT WAS APPROPRIATE AT THAT TIME THAT THE DEPARTMENT ADOPT BODY WORN

IT HAS ONLY SINCE BEEN AIL THE MORE EMPHASIZED THROUGH WHAT WE'VE SEEN AROUND POLICING AND THE INTERACTION WITH POLICE AND COMMUNITY THAT THE WAY BODY WORN CAMERAS SERVE AS AN ACCOUNTABILITY MEASURE, CERTAINLY BY NO STRETCH OF THE IMAGINATION ARE THEY A PAN PANACEA. BUT AS RECENTLY AS A FEW WEEKS AGO WE HAVE SEEN THE VALUE OF POLICE INTERACTION, NOT TOO

CAMERAS.

LONGAL OFFICER CROSSON HAD AN INTERACTION WITH A PEDESTRIAN IN BOSTON, A YOUNG AFRICAN AMERICAN MAN WHERE WE SAW A LEVEL OF ACTION THAT VERNLGD ON CONDUCT THAT WAS QUESTIONABLE AS TO ITS CONSTITUTIONALITY, BUT RAISED SOME CONCERNS OVER THE LEVEL OF RESPECT OR DISRESPECT TO THAT YOUNG MAN.

WHILE THERE IS TENSION AMONG COMMUNITY AND POLICE OFFICERS WE CAN GET TO THE HEART OF WHY PEOPLE ARE LESS WILLING TO ENGAGE WITH POLICE WHEN WE SEE VIDEOS LIKE THAT.

WE ARE ENCOURAGED BY THE INITIAL REPORT, BUT WE LOOK FORBID TO THE -- LOOK FORWARD TO THE FULL REPORT.

AS WAS MENTIONED THERE IS A NEED OF A BROADER ARRAY OF METRICS TO EVALUATE WHAT SUCCESS ACTUALLY LOOKS LIKE.

ANOTHER THING THAT COULD BE CONSIDERED IS HOW THOSE -- HOW THAT FOOTAGE IS IMPACTED, THE OUTCOMES OF CRIMINAL CASES.
IT IS OUR UNDERSTANDING THAT THERE HAVE BEEN SEVERAL CASES THAT HAVE BEEN IMPACTED BY BODY WORN CAMERA, FOOTAGE BOTH IN A NEGATIVE AND POSITIVE WAY.
SO I ENCOURAGE THE CITY COUNCIL TO CONTINUE TO RIGOROUSLY EXAMINE MEMBERS OF THE DEPARTMENT.

TO THE EXTENT THERE IS A CONSIDERATION ABOUT OTHER TECHNOLOGICAL ADVANCEMENT AND SURVEILLANCE TOOLS THAT WE WOULD HAVE A SIMILARLY ROBUST CONVERSATION ABOUT BODY WORN CAMERAS, TO THE EXTENT THERE ARE CONVERSATIONS AROUND COST OF BODY WORN CAMERAS, I WOULD ACKNOWLEDGE AND NOTE, REGARDING THE AMOUNT OF OVERTIME COSTS THAT ARE BEING SPENT OR AS COUNCILOR CAMPBELL RAISED THE AMOUNT OF PAYOUT THAT HAS BEEN HAPPENING WITH POLICE OFFICER MISCONDUCT ACTIONS. TO ENCOURAGE THE BOSTON FLAMPLET OIMPLEMENT A FULL BODY WORN CAMERA POLICY AND PRACTICE, ROBUST AND COMPREHENSIVE POLICY. THANK YOU.

THE FIRST IS THAT EVEN THOUGH THIS MARKS THE FOURTH YEAR OF US TALKING ABOUT BODY CAMERAS WE ARE STILL TALKING ABOUT WHETHER OR NOT WE SHOULD DO BODY CAMERAS.

WE SHOULD ALREADY BE AT THE DISCUSSION ABOUT FOLLOW.
A LOT OF QUESTIONS CAME UP TODAY, WHICH I NOT ONLY APPRECIATE THE COUNCILORS WHICH ARE HERE, BUT THE QUESTIONS YOU ASKED WHICH ARE IMPORTANT AND INSIGHTFUL.

I WANTED TO MAKE SURE SOME THESE QUESTIONS WERE ASKED SO I APPRECIATE THEY WERE ASKED TODAY.

BUT A LOT OF THE QUESTIONS WERE AROUND POLICY.

SO IT WOULD BE GREAT FOR NEXT HEARING THAT WE HAVE TO ACTUALLY START TALKING ABOUT WHAT THAT POLICY LOOKS LIKE SINCE IT SEEMS THAT BPD IS ACTUALLY ON THE TRACK OF IMPLEMENTING THE PROGRAM, GOOD NEWS TO HEAR NOT SOMETHING WE HEARD ABOUT BEFORE TODAY.

SO THAT'S THE ONE THING THAT I REALLY WISH TO MAKE HERE TO YOU,

IS TO ENCOURAGE YOU TO EMBRACE THE COMMUNITY OVERSIGHT COMMITTEE MODEL THAT THE ACLU AND OTHERS ARE RECOMMENDING. BECAUSE I THINK THE DETAILS OF THESE POLICIES ULTIMATELY MATTER A LOT AND WE'VE HEART A LOT ABOUT HOW OFFICERS TURN ON AND OFF THEIR CAMERAS, SPOT CHECKS OR OTHER MECHANISMS, THOSE DAYLIGHTS ARE IMPORTANT, BUT A COMMUNITY ADVISORY MESH WOULD BE WELL TO LOOK INTO, THE TIP OF THE ICEBERG AS I THINK WE ALL KNOW ARE GOING TO BE IMPLEMENTED IN A WAY THAT AFFECTS CIVIL I WILL ALSO NOTE THAT FIGURING OUT WHETHER THE CURING EFFECT IS HAPPENS HAPPENING, AS FAR AS I KNOW, I BELIEVE IT IS IF NOSE PICKING DELAY, WHENEVER YOU ARE DOING A STUDY WITH THE CAMERA POINTED AT THE SUBJECT, HOW LONG IT IS THAT THEY START PICKING THEIR NOSE.

AS WE STUDY BODY CAMERAS YOU CAN LOOK AT MAYBE NOT THAT EXACT METRIC, BUT FIGURE OUT ARE PEOPLE ACTUALLY AWARE BEING RETICENT BECAUSE OF THE CAMERA THAT'S POINTING OUT TO THEM OR ARE THEY INTERACTING ACTUALLY.

AS WE MOVE FORWARD WILL PATROL SUPERVISORS ALSO BE WEARING CAMERAS AS WE MOVE FORWARD OR JUST CONTINUE TO BE PATROLMEN AND PATROL WOMEN?

>> INITIALLY IS FOR OFFICERS FIRST AND THEN QUESTIONS ABOUT SUPERIOR OFFICERS, DEPENDING ON THEIR ROLES IN THE DEPARTMENT.

>> OKAY.

>> THANK YOU, COUNCILLOR McCARTHY AND THANK YOU FOR THOSE WHO TESTIFIED.

THOSE WHO TESTIFIED.

IT IS ALWAYS INSIGHTFUL TO GET
TESTIMONY FROM THE COMMUNITY.

I ACKNOWLEDGE I GOT TO THE
COUNCIL ONLY ACOUPLE OF YEARS
AGO, THISK STARTED WAY BEFORE I
GOT TO THE COUNCIL.

I APPRECIATE THE PUBLIC AND THE OFFICERS AND THE DEPARTMENT AS WELL, I HAVE TO ACKNOWLEDGE SHAKIA WHO WORKS CURRENTLY IN MY OFFICE, SECOND HALF OF BP CAT AND DID A LOT OF WORK WITH RESPECT TO THIS ISSUE.

I JUST HAVE TWO QUICK FOLLOW UP QUESTIONS, WITH RESPECT TO NEGOTIATING, I'M ASSUMING THAT IF WE DO THIS AND AT SOME POINT DO IT WITH FULL IMPLEMENTATION, THE OTHER BARGAINING UNITS WILL ALSO BE PARTICIPATING IN THE BARGAINING RELATED TO THIS PARTICULAR ISSUE?

I THOUGHT THE POINT ON HAVING SOME OUTREACH OR PLATFORM FOR FOLKS TO PROACTIVELY REACH OUT TO YOU IF THEY HAVE THOUGHTS AND IDEAS, WE CAN CONTINUE THAT BUT I THINK IT'S A GREAT IDEA. I WASN'T SURE, I THINK THE

>> I THINK THAT WAS A GREAT IDEA AND WE CAN WORK WITH YOUR OFFICE TO FIGURE OUT IF BEST MODEL HOW TO GET THOSE COMMENTS.
WE'D LOVE TO HAVE THANK YOU, MAYOR.

- >> AND WE CAN SHARE THAT THROUGH COUNCILLOR McCARTHY AND MY COLLEAGUES.
- I KNOW WE'RE WAITING FOR THE FINAL REPORT TO COME OUT IN JUNE.

BASED ON WHAT YOU HAVE TESTIFIED TODAY, AND ANSWERING WELL, DO YOU EPA THE FINAL REPORT CHANGING ANYTHING IN TERMS OF THE LIST OF BENEFITS OR THOSE SUGGESTED BENEFITS WE'VE ALREADY IDENTIFIED RELATED TO BODY CAMERAS?

>> IT'S HARD TO TELL WHAT THE FINAL REPORT WILL DO.
BUT IT WILL, ONE THING THAT IT WILL DO IS SPEAK TO SOME OF THE OTHER INDICATORS THAT PEOPLE HAVE MENTIONED, YOU KNOW LIKE HAS THERE BEEN DEEP PLEASING, HAS POLICING CHANGED, HAS IT CHANGED IN TERMS OF CERTAIN GROUPS.

WE'LL HAVE MORE INFORMATION ON THAT.

- >> AND MORE METRICS USED IN THE FINAL ANALYSIS?
- >> YES.
- >> THANK YOU VERY MUCH. COUNCILLOR McCARTHY.
- >> COUNCILOR.
- >> ABSOLUTELY RIGHT TO BPD, I KNOW THIS IS ONLY L L A TOOL IN THE TRIAL BUT WHAT WOULD HAPPEN IF YOU BOTH SIDES WOULD DISAGREE WITH THE VIDEO THAT IT DIDN'T CAPTURE THE ENTIRE SCENE, IS THERE SOME TYPE OF AN APPEAL

PROCESS THAT IF ONE SIDE OR THE OTHER COULD WEIGH IN ON?
>> I'M NOT SURE WHAT
CIRCUMSTANCES THERE WOULD BE AN APPEAL WITHIN.

>> OKAY.AND I KNOW DURING THE TURN ON, TURN OFF OF THE CAMERA ASK THE POLICE OFFICER USE DISCRETION?

THERE ARE CASES WHERE HIM OR HER COULD USE A DISCRETION OUTSIDE OF THE REASONS YOU WOULD ENACT, USING THEIR DISCRETION BASED ON THEIR YEARS OF SERVICE THEIR PROFESSIONALISM, AND WHAT WOULD THAT TYPE OF DISCRETION -->> THE CATCHALL FOR DISCRETION BY THE OFFICER WOULD BE EXIGENCY.

WHERE SOMETHING CAME UP THAT WAS SO FAR OUT OF THE ORDINARY THAT WOULD REQUIRE THAT EITHER THE CAMERA BE TURNED ON OR TURNED OFF.

BUT IN THOSE CASES YOU KNOW, ANNAL E-AN AFTER THE FACT JUSTIFICATION WOULD BE REQUIRED FOR THAT NONCOMPLIANCE. >> OKAY.

AS IT RELATES TO THE COMMUNITY

OFFICER WOULD LIKELY BE ISSUED A

BUILT THERE ARE POLES WITHIN THE

BUT THERE ARE ROLES WITHIN THE POLICE DEPARTMENT WHERE USING A BODY CAMERA OR WEARING A BODY CAMERA WOULD NOT BE PRODUCTIVE.

WE HAVE OFFICERS WHO ARE BOOK OFFICERS, WE HAVE OFFICERS WHO DO ADMINISTRATIVE TASKS.
IF SOMEONE'S AT A COMMUNITY MEETING IF THEY'RE NOT OUT ON PATROL, DOING ENFORCEMENT WORK, THERE MAY BE CIRCUMSTANCES WHERE THEY WOULD NOT BE REQUIRED THE WEAR A BODY CAMERA.

>> IN MY EXPERIENCE I'VE SEEN A LOT OF CSO'S ENGAGE THE PUBLIC, THEY HAVE HAD GREAT CONVERSATIONS LEARNING ABOUT WHAT'S HAPPENING IN A PARTICULAR NEIGHBORHOOD, WHAT CONCERNS THERE ARE.

BUT PEOPLE WOULD LIKE TO TALK TO THE CSO KNOWING THAT THEIR INFORMATION IS CONFIDENTIAL. >> SURE, ABSOLUTELY.

>> I KNOW THE QUEST BEEN ASKED ASKED -- QUESTION'S BEEN ASKED SEVERAL TIMES AND I'VE ASKED IT, FIVE TO \$7 MILLION TO GET ALL THE PATROLMEN WITH THE BODY CAMERA.

BUT WHEN IT BREAKS DOWN THE TECHNICAL PARTS OF THE CAMERA HOW MUCH WOULD YOU ENVISION THAT WOULD COST EACH YEAR IN TERMS OF REPLACING, FIXING DAMAGED CAMERAS?

DO OTHER DEPARTMENTS AROUND THE COUNTRY HAVE A FIGURE SIMILAR WHAT THEY WOULD SPEND ON THAT MAY BE HELPFUL TO YOU?

>> WE WOULD LOOK AT A MODEL THAT

>> WE WOULD LOOK AT A MODEL THAT WOULD BE INCLUSIVE THAT WE WOULD PURCHASE, THE SERVICE, SO YOU WOULD GET A CAMERA, YOU'D HAVE PROBABLY ANYWHERE BETWEEN MAYBE AN 18-MONTH REFRESH CYCLE ON THAT CAMERA.

IF THE CAMERA STOPPED WORKING FOR ANY REASON YOU JUST SWAPPED THAT OUT.

SO BECAME OF WE WOULDN'T BE
PAYING FOR EVERY DEVICE TO BE
ACTIVATED, WE WOULD BUY A
PACKAGE AND WE WOULD EXPECT THE
VENDOR TO PROVIDE THOSE END TO
END SERVICES FROM THE DOCK
STATION TO THE CAMERA, TO THE
SOFTWARE TO VIEW THE VIDEO, TOD

CLOUD SERVICE THAT WOULD STORE THE VIDEO AND THAN RETENTION. THAT'S THE MODEL THAT A LOT OF POLICE DEPARTMENTS ARE LOOKING AT

A LOT OF VENDORS ARE MOVING TO THAT ALT IN ONE PACKAGE.

I THINK THERE'S SOME SAVINGS AND ECONOMY OF SCALE THERE SO THAT'S ONE OF THE THINGS THAT WE WOULD BE LOOKING CLOSELY AT.

COUNCILOR JANEY.

>> THANK YOU, SUPERINTENDENT, THANK YOU FOR THE WORK YOU AND YOUR DEPARTMENT DO EVERY SINGLE DAY.
