INCOMES HAVE NOT KEPT UP WITH THE HOUSING COSTS AND NOT UNLIKE OTHER CITIES ACROSS THE NATION, THE CITY OF BOSTON IS GENTRIFYING.

MY GREAT-GRANDPARENTS BOUGHT THEIR HOME FOR \$2,000 IN THE 1920s

JUST A COUPLE OF YEARS AGO, ONE CONDOMINIUM IN THIS VERY BROWN STONE SOLD FOR \$1.6 MILLION.
THIS IS AN OPPORTUNITY FOR RESIDENTS OF COLOR WHO WERE LIVING AT THE SOUTH END AT THE TIME TO BUILD A GENERATION OF WEALTH, BUT UNLIKE MY FAMILY, THEY WERE DISPLACED AS THE SOUTH END WAS GENTRIFIED.

IN ROXBURY, THE SAME THING IS HAPPENING.

FAMILIES ARE BEING HIT ESPECIALLY HARD.

ACCORDING TO THE IMAGINE BOSTON 2030 REPORT, HOUSING CRISIS IN ROXBURY INCREASED NEARLY 70% BETWEEN 2010 AND 2015.

WHILE THE CITY AS A WHOLE INCREASED 36% DURING THAT SAME PERIOD, THAT'S 70% COMPARED TO 36%, ALMOST DOUBLE.

ROXBURY FAMILIES ARE RENT-BURDENED, MANY PAYING HALF OF THEIR INCOME ON HOUSING. ACCORDING TO THE BPDA, ROXBURY IS 81% RENTER OCCUPIED, MAKING RESIDENTS EVEN MORE VULNERABLE TO DISPLACEMENT AND EVICTION. THE POPULATION IN ROXBURY IS GROWING.

NEW RESIDENTS ARE MOVING IN, AND AS A PROUD ROXBURY RESIDENT, I WELCOME EVERYONE WHETHER THEY HAVE MOVED TO ROXBURY FROM ACROSS TOWN OR ACROSS THE WORLD. AS THE POPULATION GROWS IN ROXBURY, WE HAVE TO MAKE SURE THAT LONG-TIME RESIDENTS WHO GREW UP IN THIS COMMUNITY CAN CONTINUE TO CALL ROXBURY HOME. I'M THINKING ABOUT ALL THE

PEOPLE I HAVE SPOKEN TO WHO HAVE TOLD ME THEY HAVE TO MOVE BECAUSE THEY CANNOT AFFORD TO STAY.

I'M THINKING ABOUT CONSTITUENTS WHO CALL MY OFFICE BECAUSE THEY'RE BEING EVICTED.

I'M THINKING ABOUT MY NEIGHBORS WHO WANT TO BUY A HOME, BUT THE ONLY OPTION THEY HAVE IS TO LOCK TO BROCKTON OR RANDOLPH.

I'M THINKING ABOUT THE FAMILIES WHO HAVE GROWN CHILDREN STILL LIVING AT HOME BECAUSE THEY CANNOT AFFORD TO MOVE.

AND I'M THINKING ABOUT MY OWN GRANDDAUGHTER AND WHETHER OR NOT SHE'LL BE ABLE TO STAY IN THE NEIGHBORHOOD THAT I LOVE.

THESE ARE THE FACES OF ROXBURY AND THE COMMUNITY THAT WE ARE BUILT TOGETHER IS IN JEOPARDY.

THE CITY HAS MADE SOME INROADS, SO I WANT TO THANK THE MAYOR AND HIS TEAM FOR THEIR WORK,

ESPECIALLY THE CHIEF.

WITH THIS HEARING ORDER, I WANT US TO EXPLORE NEW AND INNOVATIVE WAYS TO CREATE AND MAINTAIN AFFORDABLE HOUSING.

AS MORE AND MORE LAND IN ROXBURY IS BEING DEVELOPED, WE NEED TO ASK OURSELVES WHO IS BENEFITTING.

DO WE HAVE ENOUGH HOUSING FOR VERY LOW-INCOME FAMILIES?
AND WHAT ABOUT THOSE WHO EARN TOO MUCH TO QUALIFY FOR A SUBSIDY BUT CANNOT AFFORD MARKET-RATE HOUSING?
DO WE HAVE THE RIGHT MIX OF HOUSING, INCLUDING MARKET RATE?
LET'S EXPLORE WAYS IN THIS HEARING TO USE SOME OF THE PROPERTY TAX ALREADY BEING GENERATED FROM, NEW LUXURY TOWERS AS A WAY TO OFFSET THE COST OF HOUSING.

LET'S EXPLORE HOW WE CAN BETTER UTILIZE LINKAGE TO FUND AFFORDABLE HOUSING IN ROXBURY. LET'S ALSO EXPLORE REDEFINING WHAT IT MEANS WHEN WE SAY AFFORDABLE AND AFFORDABLE TO WHOM

IT IS MY HOPE THAT THIS HEARING WILL PROVIDE US WITH THE OPPORTUNITY TO ENGAGE RESIDENTS AND STAKEHOLDERS IN A MEANINGFUL WAY TO ADDRESS GENTRIFICATION AND DISPLACEMENT IN ROXBURY.

I'M GRATEFUL FOR THE ADVOCACY AND PARTNERSHIP OF HOUSING RIGHTS ACTIVISTS AND NEIGHBORHOOD GROUPS, INCLUDING RECLAIM ROXBURY, ACE, MASS ALLIANCE OF HUD TENANTS JUST TO NAME A FEW.

AND I WANT TO ACKNOWLEDGE THEIR PRESENCE AND THEIR PARTNERSHIP AND LOOK FORWARD TO WORKING WITH MY COLLEAGUES AS WE TRY TO ADDRESS THE HOUSING CRISIS AND GENTIFICATION NOT ONLY IN ROXBURY BUT THROUGHOUT THE DIFFERENT NEIGHBORHOODS IN OUR CITY.

CLOSURE OF LONG ISLAND BRIDGE,

POPULATION OF INDIVIDUALS WITH
SUBSTANCE USE DISORDER AND OTHER

INCLUDING AT THE INTERSECTION OF
MASSACHUSETTS AVENUE AND THE

I'M SO PROUD TO COSPONSOR THIS

OUR NEIGHBORHOODS ARE HIT
PARTICULARLY HARD BY WHAT IS
HAPPENING WITH THIS CRISIS.
I ALSO WANT TO THANK ALL OF MY
COLLEAGUES, PARTICULAR COUNCILOR
ESSABI-GEORGE AS WELL AS THE
MAYOR FOR THEIR WORK ON
COMBATTING HOMELESSNESS AND THE
OPIOID CRISIS IN OUR CITY.
WE'VE MADE SIGNIFICANT PROGRESS
THROUGH INVESTMENTS AND SERVICES
AND SUPPORT SYSTEMS TO HELP THE
MOST VULNERABLE IN OUR
COMMUNITY, BUT I BELIEVE, AS I'M

SURE WE ALL AGREE, THAT MORE
NEEDS TO BE DONE.
JUST A WALK THROUGH DUDLEY
SQUARE CAN BE VERY SHOCKING.
THERE'S RAMPANT DRUG USE,
ALCOHOL USE, INCREASINGLY VISUAL
SEXUAL EXPLOITATION AND
VIOLENCE.

SOME ARE HOMELESS.

SOME ARE NOT.

SOME HAVE SUBSTANCE ABUSE

DISORDER.

SOME DO NOT.

MANY HAVE SERIOUS MENTAL HEALTH CONDITIONS, WHETHER DIAGNOSED OR NOT.

THESE SITUATIONS ARE
TRAUMATIZING TO RESIDENTS, TO
CHILDREN, TO THOSE WHO ARE
EXPERIENCING THESE ISSUES
THEMSELVES.

IT HURTS OUR SMALL BUSINESSES, AND IT IS JUST DEEPLY TROUBLING. THIS IS NOT ONE ISSUE.

THIS IS A VERY COMPLEX SET OF ISSUES, AND IT'S IMPORTANT TO DISTINGUISH BETWEEN THE TWO AND -- BETWEEN MANY OF THEM AND

NOT CONFLATE THEM.

WHETHER WE'RE TALKING ABOUT HOMELESSNESS OR SUBSTANCE USE OR MENTAL HEALTH OR LOITERING.

WITH THIS HEARING ORDER, I HOPE TO FOCUS ON SOME OF THESE ISSUES AND THE QUALITY OF LIFE THAT SO MANY RESIDENTS SEEK AND REALLY ENGAGE RESIDENTS IN COMING UP WITH SOME SOLUTIONS.

I'M SURE MANY OF YOU MAY HAVE SEEN THE SHOCKING VIDEO THAT WENT VIRAL OF PUBLIC SEX ACTS HAPPENING DOWN DUDLEY.

SINCE THEN, WE HAVE SEEN AN INCREASE OF LAW ENFORCEMENT. RESIDENTS HAVE BEEN ASKING AND BUSINESS OWNERS HAVE BEEN ASKING.

RIGHT NOW, THERE'S PRETTY MUCH AROUND THE CLOCK POLICE PRESENCE, WHICH HAS HELPED SOME, BUT THE PEOPLE WHO ARE SUFFERING WITH THESE ISSUES HAVE NOT SUDDENLY BECOME WELL. THEY HAVE MOVED ON SOMEWHERE ELSE, AND WE NEED TO DO MORE TO MAKE SURE THAT THEY'RE GETTING THE HELP THAT THEY NEED AND THAT WE'RE DEALING WITH THE ROOT CAUSE.

AND I'M GRATEFUL FOR THE INCREASED POLICE PRESENCE, BUT I THINK IT'S ALSO IMPORTANT FOR US TO RECOGNIZE THAT WE NEED TO BE LOOKING AT LONG-TERM STRATEGIES, THAT WE CANNOT JUST PUT A BAND-AID ON A BULLET WOUND. WE NEED A LONG-TERM STRATEGY THAT WILL HELP PEOPLE GET BACK ON THEIR FEET AND STAY WELL. WHILE POLICE ARE PART OF THE SOLUTION, WE'RE NOT GOING TO ARREST OUR WAY OUT OF THIS ISSUE.

WE NEED TO MAKE SURE THAT WE HAVE COMPASSION, THAT WE RECOGNIZE, AS I CERTAINLY DO, THAT THESE ARE FAMILY MEMBERS. THESE ARE OUR NEIGHBORS. THESE ARE OUR BROTHERS, OUR SISTERS, OUR AUNTS, OUR UNCLES WHO ARE SUFFERING WITH MANY OF THESE ISSUES.

I RECENTLY CONVENED A GROUP OF BUSINESS LEADERS IN DUDLEY WHO HAD SOME CONCERNS AND A MEETING WITH OTHER STAKEHOLDERS AROUND THIS ISSUE.

AND I BELIEVE THAT WE NEED A COORDINATED PLAN AND A RESPONSE THAT LOOKS AT NOT JUST LAW ENFORCEMENT BUT PUBLIC HEALTH OFFICIALS, HOMELESSNESS PREVENTION, ADVOCATES OF MENTAL HEALTH, CERTAINLY CITY AGENCIES, AND THAT ENGAGES BUSINESS OWNERS, CLERGY, NONPROFIT LEADERS, RESIDENTS AS WELL. THIS IS DEFINITELY A PUBLIC HEALTH CRCRISIS, AND IT WILL REQUIRE A COORDINATED RESPONSE FROM MULTIPLE CITY AGENCIES AS WELL AS THE STAKEHOLDERS I JUST MENTIONED.

OUR RESPONSE MUST BE FAIR, JUST,

COMPASSIONATE, AND INCLUSIVE OF ALL STAKEHOLDERS.

WE NEED TO ACT TO TAKE CARE OF

THOSE WHO ARE SUFFERING WITH ILLNESSES AS WELL AS THE LARGER COMMUNITY THAT HAS TO BEAR THE BRUNT OF THE BURDEN, SO THANK YOU.

IS IT MENTAL HEALTH?

IS IT ADDICTION?

OR IS IT JUST BEING ON THE STREET?

THAT'S SOMETHING THAT I SEE SOME OF THESE KIDS DOING.

THEY WANT TO SAY THEY'VE LIVED ON THE STREET AND WHATEVER THAT IS.

WE'RE ALMOST THE ONLY PLACE IN THE COMMONWEALTH OUTSIDE OF COUPLE OTHER PLACES THAT ARE ACTUALLY HELPING WITH THIS CRISIS.

EVERYBODY'S TALKING ABOUT IT.
NOBODY'S DOING ANYTHING.
A COUPLE YEARS AGO, ON THIS
FLOOR, I HAD A PROPOSAL FOR A
TAX ON ALCOHOL, A 2% TAX THAT
WOULD HAVE GONE DIRECTLY TO HELP
THE CITY COMBAT THIS.

WE NEED MONEY FOR THIS.

IT WAS VOTED DOWN 11-2.

WE'RE TALKING ABOUT SAFE INJECTION SITES.

AND IT FEELS LIKE WE'RE NOT BEING PAID ATTENTION TO.

PUBLIC WORKS, POLICE, PUBLIC HEALTH, THEY SHOULDN'T BE ABLE TO JUST -- IT'S SAD WHEN THE PEOPLE IN THE POSITION THEY'RE IN, BUT IT SHOULDN'T IMPACT THE

NEIGHBORHOODS THAT ARE

SURROUNDING THERE THE WAY IT IS IMPACTING NOW.

THERE'S GETTING PEOPLE HEALTHY.

MY CLIENTS OR PROBATIONERS OVER
THERE.

I THINK THAT'S CRITICAL THAT THE BRIDGE IS REOPENED.

I'D LIKE TO ACKNOWLEDGE THE HARD WORK OF CITY OFFICIALS, MAYOR WALSH AND HIS TEAM, IN WORKING HARD TO GET THAT BRIDGE REOPENED.

I KNOW THE CITY COUNCIL
SUPPORTED THAT INITIATIVE, AND
I'M PROUD TO SPONSOR THIS,
COSPONSOR IT.

I KNOW HOW IMPORTANT IT IS WHEN SOMEONE IS DEALING WITH SUBSTANCE ABUSE ISSUES, MENTAL HEALTH ISSUES, AND MAKING SURE ALSO THAT QUALITY OF LIFE ISSUES ARE ALSO FACTORED IN AS WE DISCUSS THIS.

I'M PROUD TO BE HERE.
I'M PROUD OF THE GREAT WORK
COUNCILOR JANEY IS DOING ON THIS
ISSUE AS WELL AS COUNCILOR
BAKER.

I HAD THE OPPORTUNITY TO TALK TO JOHN McGAN YESTERDAY ABOUT SOME OF THESE ISSUES.

AS I WAS TALKING TO JOHN McGAN, COUNCILOR BAKER WAS CALLING UP, ASKING ABOUT HOW WE CAN GET SOMEONE INTO A DRUG TREATMENT PROGRAM, SO I WANT TO THANK COUNCILOR BAKER FOR HIS WORK NOT JUST AS A CITY COUNCILOR BUT FOR SO MANY YEARS AS WELL.

I'M PROUD TO BE A COSPONSOR.
THANK YOU, MADAME PRESIDENT.
>> COUNCILOR PRESSLEY, YOU HAVE
THE FLOOR.

>> I'M GOING TO TAKE A MINUTE.
>> COUNCILOR ESSABI-GEORGE, YOU
HAVE THE FLOOR.

>> THANK YOU, MADAME PRESIDENT. I WANT TO THANK THE SPONSORS OF THIS HEARING AND ASK THAT MY NAME BE ADDED.

AS A NEIGHBOR IN AN AREA THAT WAS HEAVILY OVERRUN BY INDIVIDUALS SUFFERING FROM ADDICTION AND HOMELESSNESS AND LIKE ALL OF US WHO KNOW, WE ALL KNOW, THIS IS NOT A NEW ISSUE. I COMPLIMENT THE COUNCILORS ON THIS HEARING ORDER AND THEIR CONTINUED EFFORT TO FIND SOLUTIONS FOR THOSE IN CRISIS AND FOR THOSE THAT ARE ALSO

IMPACTED SO GREATLY BY THIS EPIDEMIC.

WE HAVE HELD COUNTLESS HEARINGS ADDRESSING AN ARRAY OF SYMPTOMS OF THE OPIOID CRISIS, WHETHER IT WAS PART OF THE CONVERSATION OF THE LONG ISLAND BRIDGE AND THE ONE YET TO COME IN OCTOBER, THE PROPOSAL OF SAFE INJECTION SITES, OR THE COUNTLESS BUDGET HEARINGS ADVOCATING FOR FUNDING TO IMPROVE HOW WE ADDRESS QUALITY OF LIFE ISSUES. THESE HEARINGS ARE IMPORTANT WAYS TO HELP ELEVATE THE WORK. THIS HEARING WILL DO THE SAME. WE HAVE HAD ALSO ADDITIONAL CONVERSATIONS AT MANY OF OUR CIVIC AND COMMUNITY MEETINGS, INCLUDING THE SOUTH END TASK FORCE, WHERE WE SPEND OUR TIME LISTENING TO OUR RESIDENTS REGARDING THEIR CONCERNS ON THIS PUBLIC HEALTH CRISIS AND LOOKING FOR CONTINUED SOLUTIONS TO THESE CHALLENGES.

YET STILL TODAY THE PROBLEM WORSENS.

IT IS TIME TO MOVE AWAY FROM

SOME OF THESE REACTIVE
CONVERSATIONS AND MOVE TOWARD
PRODUCTIVE SOLUTIONS.
I FIND MYSELF -- AND I KNOW ALL
OF US FIND OURSELVES -- VERY
FRUSTRATED BY THE LACK OF
PROGRESS WE FEEL TO BE MAKING IN
FIGHTING THIS EPIDEMIC AND WANT
TO ENSURE THAT ALL PARTS OF OUR
GOVERNMENT ARE WORKING TOGETHER
TO PURSUE THE RIGHT APPROACH.
TO ECHO SOME OF COUNCILOR
BAKER'S COMMENTS ABOUT GETTING
ALL THE PARTIES TO THE TABLE, IT
NEEDS TO BE AN ALL-HANDS-ON-DECK

DOING MORE AND DOING IT IN A MUCH MORE COORDINATED WAY.
YESTERDAY, I ACTUALLY EMAILED ALL OF YOU AS WELL AS OUR STATE COLLEAGUES AND THOSE WHO WILL SOON BE OUR STATE COLLEAGUES TO JOIN TOGETHER SO WE CAN COME TOGETHER TO FIND SOME VERY PRACTICAL SOLUTIONS THAT WE AS

APPROACH.

AN ELECTIVE BODY THAT WE CAN PUT ON THESE OTHER PARTNERS TO FIND THE RIGHT MEASURE OF COLLABORATION AND THE RIGHT MEASURE OF PRESSURE. IN DOING THIS WORK AND DOING THIS WORK TOGETHER IS SO CRITICALLY IMPORTANT TO HELP THOSE WHO ARE SUFFERING FROM THIS PUBLIC HEALTH CRISIS, WHO ARE FEELING THE IMPACTS, THE CRISIS OF ADDICTION AND THE CHAOS OF HOMELESSNESS BRINGS. I TRULY BELIEVE THAT BOSTON HAS THE POTENTIAL TO BE THE MODEL FOR FIGHTING THIS CRISIS AND TO LEAD THE WAY FOR THE REST OF THE UNITED STATES AND THE WORLD BECAUSE WE KNOW THIS IS A WORLDWIDE CRISIS.

I LOOK FORWARD TO EXPEDITING THIS HEARING TO GETTING TO THIS, AND I LOOK FORWARD TO CONTINUING THIS WORK NO DOUBT IN PARTNERSHIP.

I WOULD ADD VERY SPECIFICALLY I KNOW THEY WILL BE INCLUDED, BUT I WANT TO MAKE SURE THAT OUR DEPARTMENT OF PUBLIC HELT THROUGH THE STATE IS INCLUDED AND THE DEPARTMENT OF MENTAL HEALTH IS INCLUDED, THE ATTORNEY GENERAL'S OFFICE AS WELL AS THE DISTRICT ATTORNEY'S OFFICE IS INCLUDED IN THIS WORK AS WELL AS THE GOVERNOR'S OFFICE.

WE NEED ALL-HANDS-ON-DECK.

I LOOK FORWARD TO THIS AND LOOK FORWARD TO SCHEDULING IT SOON. THANK YOU.

>> MADAME CLERK, IF YOU CAN ASKED COUNCILOR ESSABI-GEORGE'S NAME AS WELL AS THE CHAIR. COUNCILOR PRESSLEY, YOU HAVE THE FLOOR.

PEOPLE LIKE MY FATHER BATTLED OPIOID ADDICTION BECAUSE OF TRAUMA THAT WENT UNTREATED, SO ALL OF THESE THINGS -- IF WE DON'T HAVE EQUITABLE ACCESS TO A SCHOOL NURSE OR A GUIDANCE COUNSELOR IN OUR SCHOOLS, ALL THESE THINGS ARE THE CONSEQUENCE, SO I WOULD JUST URGE ALL OF US TO FUNCTION WITH A FIERCE URGENCY OF NOW ON THESE OTHER ISSUES BECAUSE THIS IS THE CONSEQUENCE OF THESE OTHER ISSUES THAT WE'RE TALKING ABOUT. AND I WOULD ALSO JUST ADD THAT THERE'S NO ONE SIZE FITS ALL APPROACH TO ANY OF THIS. WE TALK ABOUT THOSE WHO ARE LIVING IN SHELTER. I USE THAT -- WE'VE MADE GREAT

STRIDES, BUT WE NEED TO SEE THAT AT OTHER SHELTERS, HOUING FIRST, OF COURSE, BUT THEY'VE GOT TO BE TREATED WITH DIGNITY. IT HAS TO MEET THE NEEDS OF ALL THE VARIOUS POPULATIONS. THE LGBT YOUTH THAT I ENGAGE WITH THAT ARE TRADING SEX FOR SHELTER ON THOSE STREETS ARE THERE BECAUSE AS YOUTH THEY DON'T FEEL SAFE IN OUR SHELTER SYSTEM.

THERE IS NO ONE-SIZE-FITS-ALL APPROACH TO THIS.

OFFERING, AND MANY OF THEM HAVE
BEEN TURNED ON TO DRUGSPLICIT IN THESE THINGS.
WE HAVE ONE SAFE HOUSE IN THE
CITY OF BOSTON.

I THANK THE MAYOR AND THE ATTORNEY GENERAL AND THE ADVOCATES.

OUR HUMAN TRAFFICKING UNIT IS NOT FUNDED, SO ALL OF THESE THINGS ARE INTERRELATED AND CONNECTED.

WHAT I'M OFFERING HERE IS, ONE, I WANT TO MAKE SURE FOR EVERY SINGLE ONE OF THESE ISSUES -- AND I WILL BE HELPFUL WHATEVER WAY I CAN BE -- THAT THOSE WHO ARE MOST IMPACTED ARE AT THE TABLE.
