Proposed Work: Alter fenestration at rear dormer by installing three anged 1/1

aluminum-clad windows.

19.416 SB 69 St. Botolph Street

Applicant: Laura van Rooyen

Proposed Work: Replace front door and repair door frame due to rot and damaged

wood.

19.533 SB 175 St. Botolph Street

Applicant: William Finnerty Architect LLC

Proposed Work: Rooftop addition to existing 3 story building. At front façade install

scupper and downspout.

19.538 SB 6-12 Blackwood Street

Applicant: Katherine Cipriana; GTI Properties

Proposed Work: At rear of the structure repoint brick in kind and install 2 decks in

existing light wells.

- II. ADMINITRATIVE REVIEW/APPROVAL: In order to expedite the review process, the commission has delegated the approval of certain work items, such as those involving ordinary maintenance and repair, restoration or replacement, or which otherwise have a minimal impact on a building's appearance, to commission staff pending ratification at its monthly public hearing. Having been identified as meeting these eligibility criteria and all applicable guidelines, the following applications will be approved at this hearing:
 - Applicants whose projects are listed under this heading **NEED NOT APPEAR** at the hearing. Following the hearing, you will be issued a Determination Sheet to present at the Inspectional Services Department (1010 Massachusetts Avenue) as proof of project approval when applying for permits. ISD personnel will send an electronic copy of your building-permit application to the commission staff for review. (To avoid potential confusion, the text of your building-permit application should be consistent with the project description given below.) Commission staff will accordingly authorize the execution of the work, attaching any applicable provisos, reflecting the relevant guidelines and precedents.
 - ▶ PLEASE NOTE THAT FOLLOWING ISSUANCE OF THE DETERMINATION SHEET NO FURTHER CORRESPONDENCE WILL BE ISSUED FOR THE APPLICATIONS LISTED BELOW. The electronic building-permit application as annotated by commission staff will constitute your Certificate of Appropriateness; this will be valid for one year from the date of the hearing. The applicant is required to notify the commission of any project changes; failure to do so may affect the status of the approval.
