JUST ONE PETITION WAS FILED WITH COUNCILLOR CAMPBELL WITH RELATED HOMELAND PETITIONS. I'LL SPEAK TO ALL THREE OF THEM. THEY WERE REFERRED IN FEBRUARY. THE NOTICES HAD BEEN SPONSORED BY COUNCILLOR BAKER BACK IN 2016. THE COMMISSIONER AND HEAD OF THE **REISTRAR SAID THE PROPOSAL WILL BE UP TO \$1.6 MILLION IN SAVINGS** FOR THE CITY.

COUNCIL IS IN SUPPORT OF THE PROPOSAL INCREASING THE TERM FROM 2 YEARS TO 4 YEARS AND ALLOWING THE COUNCIL TO BE MORE **EFFECTIVE AND FOCUS ON MORE TIME** OF THE WORK BECAUSE THEY WON'T HAVE TO CONTINUE CAMPAIGNING. THE CURRENT STATE OF CAMPAIGN FINANCE AND HOW LONG A TERM COULD STRAIGHTEN AN INCUMBENT'S ABILITY TO GET RESOURCES. DURING THE HEARING, THE COMMITTEE DISCUSSED IN BROAD TERMS HOW THE PROPOSAL COULD ALIGN THE PROCEDURES ACROSS THE BODY AS WELL AS TECHNICAL CHANGES THAT MAY NEED TO BE ADDRESSED IN THE EVENT THIS THE COUNCIL WOULD GO FROM TWO YEARS TO FOUR YEARS. AS A RESULT OF THE FEEDBACK COLLECTED IN THE HEARING, I **RECOMMEND THAT DOCKET NUMBER** 0313 REMAIN IN THE COMMITTEE AND WILL TURN IT OVER TO LEAD SPONSOR FOR ANY ADDITIONAL COMMENTS IF SHE SO CHOOSES. WHICH HAS TO DO WITH A SPECIAL ELECTION THROUGH MANY CONVERSATIONS FROM THE HEARING, OF COURSE, AND WITH THE CHAIR OF THE COMMITTEE HAVE DECIDED TO LEAVE THAT IN COMMITTEE AND TO **RE-VISIT THAT IF IN FACT BEFORE** YOUR TERM CHANGE GOES THROUGH. WANTED TO THANK YOU FOR YOUR WORK ON THAT. I APPRECIATE THE QUICK TURN AROUND. ANYONE ELSE LOOKING TO SPEAK ON THESE DOCKETS AND TO TO SO AT THE SAME TIME AND THEN TAKE ACTION ON THEM SEPARATELY? COUNCILLOR, YOU HAVE THE FLOOR. >> I'LL BE BRIEF. I'LL START WITH THE ONE THAT WE DID NOT CALL FORWARD TODAY. I DID WANT TO EXPRESS THAT THE -- WHAT I THOUGHT WHAT WAS LACKING CURRENTLY IN OUR SYSTEM. THE FACT THAT IT WOULD GO TO A DEFAULT IN THIS POSITION, IT'S

ALMOST LIKE WE'RE TRYING TO GET A VOTE WITHOUT CHOICE VOTING. AS WE COME BACK TO DEAL WITH THIS ISSUE IS WHETHER WE SHOULD GO TO RAIN CHOICE VOTING OR THE AT LARGE OR ALL OF OUR ELECTIONS WHERE PEOPLE CAN RANK THE FOLKS. SO ONE A PERSON LEAVES, THAT PERSON IS 1, 2, 3, 4 AND 5 ARE SLOWED DOWN TO THE OTHER FOLKS THAT ALREADY RAN AND WE CAN HAVE A COMBINATION OF WHO IS THE FIFTH PLACE POSITION. SO I ACTUALLY THINK WE NEED TO **REFORM THAT.** WE NEED TO GO TEACHER AND LOOK AT HOW RANKED CHOICE VOTING CAN SOLVE THIS WITH ONE ELECTION AND NOT CAUSE ADDITIONAL FUNDS. I WANTED TO SAY THAT. WHEN YOU BRING THAT BACK UP AGAIN. WITH REGARDS TO THE TERMS. I FULLY SUPPORT THAT. I WANTED TO ADDRESS THE CONCERNS THAT PEOPLE HAVE BEEN VOICING IN THE MEADIAN IN GENERAL WITH THE CONCENTRATION OF POWER. THE FACT THAT IT WOULD DISCOURAGE FOLKS FOR RUNNING. IF ANYTHING, IF IT WAS ENACTED IN 2021 IN THAT ELECTION, I CAN IMAGINE FOLKS LOOKING AT A FOUR-YEAR TERM WILL COME OUT OF THE WOOD WORK TO TRY TO RUN FOR A CITY COUNCIL, WHICH IS A GOOD THING. I ALSO THINK THAT IF THE CONCERN IS ABOUT CONCENTRATION OF POWER OVER TIME, IT'S NOT NECESSARILY -- I DON'T THINK WE SHOULD MAKE US LESS POWERFUL OR MAINTAINING OUR CURRENT TWO-YEAR TERMS. IF IT'S A MATTER OF TURNOVER, PEOPLE RUNNING, THEN I THINK WE CAN LOOK AT OUR FOUR-YEAR TERM POSITION. WHICH IS THE MAYOR. IF IT'S A REAL CONCERN, I DON'T KNOW WHY PEOPLE ARE MAKING THAT PUSH FOR TWO YEARS. MY POINT IS, IF YOU CONCERNED ABOUT THE TURNOVER OF PEOPLE RUNNING, THERE'S A WAY TO MAKE

SURE THAT THAT HAPPENS, REDUCING THE FOUR YEARS TO TWO YEARS. I DON'T THINK THAT THIS IS **REALLY GOING TO STOP -- A** FOUR-YEAR TERM WILL PREVENT FOLKS BEING HERE FROM 30 YEARS AND NOT PREVENT FOLKS FROM CHALLENGING PEOPLE FROM COMING FORWARD AND SAYING IT'S NOT ONLY MY TURN BUT IT'S TIME FOR A CHANGE. WE'VE SEEN THAT IN ELECTIONS AS WELL. I THINK THE CONCERNS EXPRESSED ARE POLITICIZED AND THEY SHOULD **BE CONSISTENT.** YOU'RE CONCERNED ABOUT CONCENTRATION OF POWER IN FOUR YEARS, CALL FOR THAT CHANGE AS WELL. FINALLY, I THINK -- WELL, I'M ALL SET. >> THANK YOU, COUNCILLOR EDWARDS. COUNCILLOR BAKER, YOU HAVE THE FLOOR. >> THANK YOU. I MORE WANT TO TALK ON 0313. I ORIGINALLY FILED THIS THINKING ABOUT IT THE LAST COUPLE WEEKS AND WE TALKED ABOUT THE MONEY THAT WE SAVE WITH THE FOUR-YEAR TERM WE CAN LOSE IN ONE ELECTION HERE AT THE AT LARGE. WHEN I THOUGHT ABOUT IT, I THOUGHT OF MY COLLEAGUE. I THINK A VOTE FOR THIS IS A VOTE AGAINST MY COLLEAGUE, COUNCILLOR GARRISON. I WASN'T PREPARED TO TAKE THAT VOTE. I WAS PLANNING TO VOTE NO. I THINK IT'S A GOOD MOVE. I SPOKE ABOUT IT IN COMMITTEE. JUST TO BRIEFLY TOUCH ON THE MAYOR'S TERM BACK TO TWO YEARS. THE MAYOR'S JOB IS SO COMPLEX AND SO MUCH WITH IT AND INVOLVED, I THINK THAT MAJOR, COULD BE SOMEBODY IN THIS BODY IN A COUPLE YEARS, NEVER KNOW, BUT THE MAYOR NEEDS FOUR YEARS. I COMMEND YOU ON YOUR TWO YEARS, I WOULD NOT BE IN FAVOR OF THAT.

THANK YOU. >> THANK YOU, COUNCILLOR BAKER. THANK YOU FOR YOUR PREVIOUS WORK ON THIS. COUNCILLOR WU, YOU HAVE THE FLOOR. >> I JUST WANTED TO MAKE SURE AND REITERATE HOW MUCH I SUPPORT YOUR PORTION AND THE COUNCIL'S PUSH TO HAVE THIS CONVERSATION AND KEEP BRINGING PEOPLE IN TO TALK ABOUT WHAT THE BIG STRUCTURAL DISCUSSIONS ARE THAT EMPOWER CIVIC ENGAGEMENT AND BRING PEOPLE IN. WE'VE TALKED ON THE OTHER TWO. I WANTED TO WEIGH-IN ON THE DOCKET ABOUT TWO-YEAR TERM VERSUS FOUR-YEAR TERM. THAT I HAVE THREE CATEGORIES OF CONCERNS. ONE IS AROUND CAMPAIGN FINANCE AND ABSENT CHANGES AROUND HOW OUR CYCLES WORK. IF FOR EXAMPLE WHEN YOU RAISE MONEY FOR CONGRESS. PEOPLE CAN DONATE ONCE UP UNTIL THE PRIMARY AND THEN DONATE ONCE AGAIN FOR THE FINAL ELECTION RATHER THAN YEAH BY YEAR. THAT WOULD CREATE A NEW BARRIER FOR PEOPLE AS THE AMOUNT OF TIME THAT PEOPLE ARE ABLE TO USE THAT YEARLY CYCLE. I ALSO -- I WAS CONSULTING THE MUNICIPAL HISTORIAN HERE BEFORE THE MEETING ABOUT WHETHER THERE WAS A TIME IN A MAYORAL ELECTION YEAR WHERE AN INCUMBENT COUNCILLOR LOST HIS OR HER SEAT. MANY OF THE SUCCESSFUL CHALLENGES COME IN THOSE NONMAYORAL YEARS. IT KIND OF FEELS COUNTER INTUITIVE BECAUSE MORE PEOPLE ARE PAYING ATTENTION TO THE RACES. MY SENSE IS THERE'S THE EFFECT OF PEOPLE PAYING ATTENTION TO THAT AND MAYBE HAVE LESS TIME OR FOCUS ON THE COUNCIL RACES. SO THE MAKEUP OF THE COUNCIL TODAY IS BECAUSE OF THE **OPPORTUNITY TO CHALLENGE AND** 

BRING NEW PEOPLE IN. MANY EXAMPLES THAT WE CAN POINT TO WHERE SOMEONE STOOD UP TO CHALLENGE A SITTING COUNCILLOR. THEY WERE SUCCESSFUL IN THE NONMAYORAL YEARS BECAUSE OF THE EXTRA FOCUS. SO WE WOULD BE CUTTING IN HALF THE NUMBER OF CHANCES THAT PEOPLE COULD CHALLENGE. FINALLY, ALL OF THAT ASIDE, MAYBE A PERSONAL PREFERENCE, BUT IT IMPOSES ACCOUNTABILITY. THERE'S ISSUES THAT GO LONGER THAN TWO YEARS AND FOUR YEARS PARTICULARLY AROUND DEVELOPMENT PROJECTS, ET CETERA. BUT WE SHOULD BE ACTING AS FAST AS POSSIBLE AND IDEALLY THAT WE CAN TURN AROUND LEGISLATION AND INITIATIVES EVERY YEAR AND CERTAINLY EVERY TWO YEARS. JUST WANTED TO GET THAT ON RECORD. I SUPPORT YOUR PUSH. >> THANK YOU, COUNCILLOR WU. >> COUNCILLOR ZAKIM? >> THANK YOU AND THE CHAIR FOR THEIR GOOD COMMENTS ON THIS. I RISE TO TALK BRIEFLY ABOUT DOCKET NUMBER 0311. TALKING ABOUT EXTENDING FROM TWO TO FOUR-YEAR TERMS. I INTEND TO VOTE NO ON THIS DOCKET. OUR GOOD COLLEAGUE AT COUNCILLOR WU JUST SHARED. WE NEED TO BROADEN THIS DISCUSSION. I THANK YOU FOR BRINGING THIS FORWARD. IT'S NOT AN EASY PROPOSAL TO FILE OR TALK ABOUT. BUT IF WE'RE TALKING ABOUT EXPANDING TURNOUT, EXPANDING OPPORTUNITY, WE SHOULD ALSO BE TALKING ABOUT AS COUNCILLOR EDWARDS SAID, RIGHT CHOICE VOTING. TALKING ABOUT MOVING IT TO EVEN YEARS IF HIGHER TURNOUT IS THE GOAL. THAT'S SOMETHING THAT WE SEE DRAMATICALLY.

WE'RE TALKING ABOUT SAVING MONEY, IT'S IMPORTANT. I KNOW COUNCILLOR CIOMMO HAD COMMENTS ON OUR FISCAL **RESPONSIBILITY HERE.** WE ALL TAKE THAT RESPONSIBILITY SERIOUSLY. NOT AT THE EXPENSE OF HAVING AN **OPPORTUNITY TO CHALLENGE US.** SO WHEN THEY THINK THEY HAVE BETTER IDEAS OR THINK THERE'S A TIME FOR CHANGE HERE IN THIS BODY. SO I DO APPRECIATE THE DISCUSSION. I RESPECT WHERE YOU STAND, MADAM PRESIDENT ON THIS AND WHERE OUR COLLEAGUES DO. I WILL VOTE NO. THERE'S AN OPPORTUNITY FOR A LONGER DISCUSSION AROUND THINGS LIKE RANK CHOICE VOICING, TERM LIMITS. THANKS FOR THE OPPORTUNITY. >> THANKS. COUNCILLOR O'MALLEY, YOU HAVE THE FLOOR. >> THANK YOU, MADAM PRESIDENT. I RISE IN SUPPORT IN ALL THREE DOCKETS. I UNDERSTAND WE'RE NOT MOVING WITH DOCKET 0313, WHICH IS AN ACT CONCERNING A VACANCY IN THE CITY COUNCIL AT LARGE. ANY TIME WE CAN OFFER THE POPULOUS MORE CHOICE AND ELECTION TO MAKE SURE THAT WE HAVE AN OPPORTUNITY FOR FOLKS THAT WANT TO BE CIVICALLY ENGAGED AND RUNNING FOR OFFICE, I WANT TO DO THAT. IF A DISTRICT COUNCILLOR LEAVES MID-TERM, WE HAVE THE SYSTEM NOW. I DON'T IT'S THE APARTMENT MALL WAY TO GO. I APPRECIATE YOUR LEADERSHIP ON THIS. DISAPPOINTED THAT I CAN'T VOTE ON IT. MAKES A LOT OF SENSE. IN TERMS OF THE OTHER TWO **ISSUES, THEY'RE COMMON SENSE** REFORM AND HELP THE BODY AND GET MORE PEOPLE INVOLVED. AFTER TALKING WITH MY COLLEAGUE AND FRIEND FROM ROSENDALE, I DID A BACK OF THE ENVELOPE. IT'S MY UNDERSTANDING, I JUST WENT BACK TO 93, THERE'S BEEN SIX SCENARIOS OF INCUMBENTS LOSING THEIR SEATS. I'M SURE THE CLERK WOULD KNOW THIS. THREE OCCURRED IN OFF YEAR ELECTIONS. THREE OCCURRED IN MAYORAL ELECTIONS. THE TWO AT-LARGE COUNCILLORS, THAT OCCURRED IN OFF-YEAR ELECTIONS. THE THREE OF THE FOUR DISTRICT COUNCILLORS LOST IN MAYORAL ELECTIONS. THE POINT IS A FOUR-YEAR TERM IS NOT -- DOES NOT SET THE BAR AND MAKE IT MORE DIFFICULT. IN FACT, I WOULD ARGUE IT DOES THE OPPOSITE AND GETS MORE INVOLVED AND HIGHER TURNOUT AND MORE PEOPLE INVOLVED, WHICH IS SOMETHING THAT WE SHOULD CELEBRATE. SIMILARLY, I THINK DOCKET 0312. WHICH I BELIEVE IS RULED THAT A PERSON CANNOT RUN FOR MORE OFFICE AT ONCE, I WOULD ASSUME -- ALL OF US THAT 99.9% OF THE PEOPLE TEND TO WIN. THAT'S A COMMON SENSE RULE THAT YOU'RE MOVING THE FACT AND SOMEONE COULD RUN FOR MORE THAN ONE SEAT AT THE SAME TIME. THEY WOULD HOPE TO WIN BOTH SEATS AND SET UP A SPECIAL ELECTION. THESE ARE THREE INITIATIVES THAT MAKE SENSE. THEY STRENGTHEN THE BODY AND PROUD TO SUPPORT ALL OF THEM. THANK YOU. >> THANK YOU. ANYBODY ELSE LOOK TO SPEAK? I'M CALLING THIS HEARING TO GET FURTHER CLARIFICATION OR EXACTLY WHAT THE PROCESS IS TO REQUEST WORK TO BE DONE OUTSIDE OF TRADITIONAL HOURS. CERTAINLY WE SUPPORT IT. DURING EMERGENCIES. THAT IS CRITICAL. BUT IT'S BEEN BROUGHT TO MY ATTENTION PEOPLE ARE WORKING ON WEEKENDS. I HAD AN INCIDENT IN SOUTH BOSTON. SOMEONE WAS WORKING ON VETERANS DAY. I WAS COMING HOME FROM A COMMUNITY FORUM ALSO IN SOUTH BOSTON. SOMEONE WAS AT A CIVIC ASSOCIATION. WORKING AT 8:30 P.M. I'VE HEARD FROM THE SOUTH END FORUM ABOUT SIMILAR INCIDENTS ACROSS THE SOUTH END AND IN CHINA TOWN. I DO WANT TO ACKNOWLEDGE THE GREAT WORK OF THE CITY COUNCIL ON THIS ISSUE AND THE MAYOR'S OFFICE AS WELL ALONG WITH ISD COMMISSIONER BUDDY CHRISTOPHER. I JUST WANT TO GET SOME CLARIFICATION ON EXACTLY WHAT YOU CAN DO AND WHAT YOU CAN'T DO DURING NONTRADITIONAL WORKING HOURS. IF YOU'RE CAUGHT WORKING ON THE

WEEKENDS OR AFTER HOURS, IT'S A \$300 FINE.

THAT'S SOMETHING THAT MAY NOT BE A DETERRENT FOR DEVELOPERS OR CONTRACTORS THAT CONTINUE TO WORK OUTSIDE OF THESE HOURS. SO I WANT TO DO MORE RESEARCH, CALL A HEARING AND LEARN FROM THE EXPERTS AND LEARN EXACTLY WHAT IS HAPPENING ACROSS OUR CITY.

ON A FINAL NOTE, MAYBE IT'S UNDERRATED. AS WE LOOK AT THE AIR B&B ISSUE, YOU KNOW, WHAT IS THE ROLE OF ISD IN TERMS OF SUPERVISORING THIS PROJECT DURING THE BUDGET PROCESS. WE MAY HAVE TO CONSIDER INCREASING THEIR BUDGET OR ADVOCATING FOR INCREASING THEIR BUDGET IF THEY'RE TAKING ON A HUGE RESPONSIBILITY. WE WANT TO MAKE SURE THEY HAVE THE TOOLS NECESSARY TO MAKE SURE THE QUALITY OF LIFE FOR ALL OF OUR RESIDENTS IS IMPORTANT. THAT'S WHY I'M CALLING THIS HEARING.

THE MBTA RELEASED A SET OF **RECOMMENDATIONS FOR HOW TO** IMPROVE BUS SERVICE. THESE ARE THINGS ABOUT CHANGING ROUTES, MOVING BUS STOPS BASED ON DATA AND ANALYSIS IN OUR DISTRICT ON HOW TO SPEED THINGS UP FOR BUS RIDERS. IF YOU LOOK AT RIDERSHIP ACROSS THE DIFFERENT MODES, THERE'S 121,000 TRIPS ON COMMUTER RAIL, ON YOUR AVERAGE WEEK DAY. EVEN IF YOU DOUBLED THE NUMBER OF PEOPLE RIDING ON ALL THE DIFFERENT COMMUTER RAIL LINES. IT WOULD STILL BE WAY LESS THAN THE AMOUNT OF PEOPLE RISING BUSES. THAT'S 355,000 TRIPS PER WEEK DAY. IT'S A HUGE EQUITY ISSUE. WE KNOW THE NUMBERS REFLECT THAT. LOW INCOME RESIDENTS, RESIDENTS OF COLOR SPEND WAY LONGER ON BUSES THAT ARE STUCK IN TRAFFIC. YOUR AVERAGE AFRICAN AMERICAN RIDER SPENDS MORE TIME THAN A WHITE COMMUTER ON A BUS. SO WHATEVER WE CAN DO TO HELP THEM SPEED THIS ALONG BETTER. FINALLY, I WAS JUST HOPING THAT WE COULD MAYBE BUNDLE THIS HEARING ORDER WITH THE ONE THAT ESSAIBI-GEORGE AND I HAVE BEEN WORKING ON AND HOW WE CAN WORK TO KEEP IMPROVING BUS SERVICE. NOT ONLY IN FOOTBALL BUT IN TRAFFIC AROUND RUSH HOUR. THAT'S BECAUSE WE HAVE TOO MANY CARS ON THE ROAD. **QUITE SIMPLE.** THE MORE THAT WE DO TO MAKE SURE THAT OUR BUSES ARE WORKING BETTER FOR WORKING FAMILIES. THE BETTER OFF WE WILL BE. PLEASE ADD MY NAME. >> THANK YOU, COUNCILLOR JANEY. COUNCILLOR ESSAIBI-GEORGE? >> THANK YOU, MADAM PRESIDENT. THANK YOU TO THE MAKER. I WOULD ASK THAT WE INCLUDE THE BOSTON PUBLIC SCHOOLS. SO MANY STUDENTS ARE RIDING THE BUSES EVERY DAY AND THE CONNECTIONS FROM OUR NEIGHBORHOODS TO OUR HIGH SCHOOLS ESPECIALLY. IT'S IMPORTANT THAT THAT ALL WORKS AS WELL. SO I WOULD ADD THAT. AND AN INVITATION FOR THE GUEST LIST. THANK YOU. >> COUNCILLOR, YOU WANT TO ADD YOUR NAME? MADAM CLERK IF YOU COULD ADD COUNCILLOR JANEY, ESSAIBI-GEORGE, BAKER, CIOMMO, EDWARDS, FLAHERTY, FLYNN, GARRISON, McCARTHY, O'MALLEY, ZAKIM AS WELL AS THE CHAIR. DOCKET NUMBER 0347 WILL BE

ASSIGNED TO THE COMMITTEE ON PLANNING, DEVELOPMENT AND TRANSPORTATION. >> DOCKET NUMBER 0348. COUNCILLOR WU OFFERED THE FOLLOWING ORDER FOR A HEARING REGARDING EQUITY IN THE CITY OF BOSTON'S PROCUREMENT AND PURCHASING. >> COUNCILLOR WU. >> COULD I MOVE TO SUBSTITUTE THE VERSION ON JUST NOW TO INCLUDE COUNCILLOR JANEY AS A **ORIGINAL**? >> ABSOLUTELY. >> ANY OBJECTIONS TO CHANGING THE ORIGINAL CO-SPONSOR TO ADD COUNCILLOR JANEY? THAT WOULD CHANGE THE LANGUAGE SLIGHTLY. >> NO. >> THANK YOU. >> THANK YOU. THIS IS FOLLOWING UP ON A PUSH THAT COUNCILLOR BAKER HAD PREPARE ADD HEARING FOR SEVERAL YEARS AGO NOW AND COUNCILLOR PRESSLEY AND I HAD WORKED ON LEGISLATION FOR THE COUNSEL TO PASS IN 2017. LOOKING AT CITY SPEND AND EQUITY IN CONTRACT DOLLARS MADE AVAILABLE BY THE CITY OF BOSTON. BOTH ON THE PROCUREMENT SIDE IN TERMS OF SERVICES AND CONTRACTS AND ON THE PURCHASING SIDE FOR GOODS THAT WE USE IN MUNICIPAL BUILDINGS. THE FIRST REPORT CAME BACK IN NOVEMBER OF 2018 FOLLOWING THE ORDINANCE THE COUNCIL PASSED. WE DIDN'T GET A CHANCE TO HAVE A HEARING ON IT. BUT A COUPLE OF SPEAKERS THAT CAME OUT OF THAT RECORD. IN FY 2018, THE CITY OF BOSTON SPENT \$664 MILLION ON GOODS AND SERVICES. OUT OF THAT DOLLAR VALUE, THE, A -- THE AMOUNT THAT WENT TO BUSINESSES OWNED BY WOMEN CERTIFIED BUSINESS OWNERS, .75%. SO WE HAVE A LOT OF WORK TO DO,

EVEN IF YOU LOOK AT THE DOLLAR

VALUE THAT WENT TO BOSTON RESIDENTS. IT'S WAY LOWER THAN WHERE REALLY COULD BE IF WE TRIED TO SQUEEZE EVERY BIT OUT OF PUBLIC DOLLARS. I'M EXCITED TO PARTNER WITH COUNCILLOR JANEY AND CONTINUING TO WORK WITH THE CITY. THE STAFF'S EFFORTS TO KEEP EXPANDING THAT INVESTMENT. PARTICULARLY BUILDING WEALTH IN OUR COMMUNITY AND OUR CITY. THANK YOU. >> THANK YOU, COUNCILLOR ONE. COUNCILLOR JANEY? >> THANK YOU, MADAM PRESIDENT. I APPLAUD THE MAKER OF THIS **IMPORTANT HEARING ORDER TO** FOLLOW UP THAT VERY IMPORTANT ORDINANCE THAT WAS PASSED DECEMBER OF 2017. BEFORE I JOINED THIS BODY. I CAN'T REMEMBER IF IT WAS 17 OR 16 THAT I CAME TO A HEARING AND WAS JUST BLOWN AWAY AROUND THE AMOUNT OF MONEY THAT THE CITY SPENDS. I GUESS THAT IS NOT SURPRISING. BUT HOW LITTLE OF THAT MONEY ENDS UP WITH LOCAL RESIDENTS WITH WOMEN AND PEOPLE OF COLOR. SO NOW THAT THE ORDINANCE HAS BEEN PASSED. VERY IMPORTANT THAT WE FOLLOW THIS ISSUE CLOSELY. I'M GRATEFUL FOR THE OPPORTUNITY TO PARTNERSHIP. I CARE DEEPLY ABOUT EQUITY AND MAKING SURE WE ARE DOING ALL WE CAN TO MAKE SURE OUR LOSE CALL **RESIDENTS AND PEOPLE OF COLOR** HAVE A SHOT AT GETTING THESE CONTRACTS. THE CITY OF BOSTON IS GOING TO SAME WITH THIS MONEY AS ITS OWN CONTRACTS, THIS IS A WONDERFUL EXAMPLE WHERE WE CAN LEAD AS A CITY, SHOW WHAT IT MEANS TO PUT THE MONEY WITH THE MOUTH IS AND INVEST IN EQUITY FOR OUR OWN FUTURE AND OUR OWN BENEFIT. THANKS TO THE MAKERS. >> THANK YOU, COUNCILLOR EDWARDS. IF YOU COULD ADD COUNCILLOR EDWARDS, BICYCLER, CIOMMO, SAAB GEORGE, FLAHERTY, FLYNN, GARRISON, McCARTHY, ZAKIM AS WELL AS THE CHAIR. DOCKET NUMBER 0348 WILL BE PLACED IN THE COMMITTEE OF GOVERNMENT OPERATIONS. >> DOCKET NUMBER 0349. COUNCILLOR WU OFFERS THE FOLLOWING ORDINANCE REGARDING CORPORATE TAX BREAK TRANSPARENCY IN THE CITY OF BOSTON. >> COUNCILLOR WU. >> THANK YOU. THIS, AGAIN, IS FOLLOW UP FROM WORK THAT WAS STARTED LAST YEAR. AT OUR HEARING IN I BELIEVE NOVEMBER OF 2018 ON THE IDEA OF CORPORATE TAX TRANSPARENCY. THIS GENERATED THAT WE RECEIVED INTO SPECIFIC LEGISLATIVE LANGUAGE. CITIES ACROSS THE COUNTRY ARE HAVING A CONVERSATION ABOUT WHAT IT MEANS TO OFFER INCENTIVES AND TAX BREAKS AND PARTICULARLY WITH AMAZON AND HP2 BUZZING AROUND IN THE NEWS. WE SHOULD LOOK AT BOSTON AND EVALUATE WHETHER THE TAX BREAKS WE HAVE GIVEN OUT OVER THE PAST ENDED UP FULFILLING THE GOALS THAT WERE SET OUT. SO RIGHT NOW THERE'S VERY LITTLE TRANSPARENCY AT THE STATE LEVEL AND THEN SIMILARLY AT THE CITY LEVEL ABOUT ONCE THOSE AGREEMENTS HAVE THE CORPORATIONS

OR DEVELOPERS OR PARTIES THAT MADE THOSE GUARANTEES, DID THEY FOLLOW-THROUGH, WERE THE PAYMENTS MADE ON TIME AND AT THE LEVEL REQUIRED. WE'RE WORKING WITH SOME ORGANIZATIONS NATIONALLY AND THIS WOULD BE AN AREA THAT WOULD HELP CODIFY SOME OF WHAT THE CITY IS ALREADY DOING AND MOSTLY TO PROVIDE THAT TRANSPARENCY, WHICH WE NEED FOR ANY FOUNDATION OF GOOD POLICY MAKING. WE NEED TO KNOW -- TO REALLY HOLD OURSELVES ACCOUNTABLE FOR VOTING ON SOME THINGS THAT MIGHT **BE COUNTER INTUITIVE. IT'S VOTING FOR ENVIRONMENTAL** POLICY AND HAVE RETIREMENT OF FOSSIL FUELS. WE'RE ASKING A LOT OF COMPANIES THAT HAVE GOTTEN BENEFITS FROM THE CITY OF BOSTON BE HELD ACCOUNTABLE. WE'VE SEEN WHAT HAPPENS WHEN CONSTITUTIONAL MEMORY IS FADED AND PEOPLE FORGET ABOUT THE PROMISES MADE. CERTAIN DEVELOPMENTS ARE **REQUIRED TO HAVE CHILD CARE** SERVICES ON SITE AND NOT ENFORCED THIS. ALONG WITHHOLDING THEM ACCOUNTABLE, WE WANT TO TALK ABOUT HOW WE CAN MAKE UP FOR TIME LOST AS WELL. PROMISES ARE MADE. THE BENEFITS ARE GIVEN. HOW DO WE MAKE SURE THAT **INTEREST IS APPLIED, THERE'S** CASH BENEFITS SUPPOSED TO BE

PAID. DON'T THINK \$5,000 IS THE SAME IN 2025. HOW DO WE APPLY INTEREST AND PENALTIES. SILENCE SHOULDN'T BE GOLDEN FOR THESE COMPANIES. IF WE DO NOT COME FORWARD, IT SHOULD BE ON THEM TO PAY DOUBLE, TRIPLE THE AMOUNT OF MONEY. I DON'T SEE WHY FORGETTING SOMETHING SHOULD BENEFIT THESE COMPANIES. THEY'VE GOT TEN A LOT OF TAX BREAKS FROM US. IT'S CONSISTENT AS WE MOVE AND LOOK AT OUR TAX BASE BONDING FOR HOUSING, LOOKING AT THIS, ALL OF THE DIFFERENT WAYS IN WHICH WE'RE TRYING TO MOVE OUR MONEY TO HELP INVEST AND BENEFIT DEVELOPERS. THE CITY OF BOSTON AND CITY COUNCIL, FEBRUARY 13, 2019. COUNCILLOR CAMPBELL, COUNCILLOR McCARTHY. COUNCILLOR McCARTHY SEEMED SUSPENSION OF THE RULES. ALL IN FAVOR SAY AYE. ALL OPPOSED SAY NEY. THE AYES HAVE IT. THE FIRST LATE FILE MATTER HAS BEEN PASSED. >> THE CITY OF BOSTON AND STILL COUNCIL, FEBRUARY 13, 2019. MATTER. (VOTING) THE AYES HAVE IT. >> PASSAGE OF THE THIRTY LATE FILE MATTER. (VOTING) THE THIRD LATE FILE MATTER HAS BEEN PASSED. >> COUNCILLOR CAMPBELL FOR COUNCILLOR FLYNN. >> COUNCILLOR FLYNN SEEKS SUSPENSION OF THE RULES AND PASSAGE OF THE FOURTH LATE FILE MATTER. CITIZENS TO PARTICIPATE IN ELECTIONS IS A FUNDAMENTAL CIVIL RIGHT AND ESSENTIAL PRINCIPLE OF OUR DEMOCRACY, WHERE THEY CAN MAKE THEIR VOTES HEARD, WHEREAS EXTENDED THE AVAILABLE DAYS AND TIMES FOR PEOPLE TO CAST THEIR BALLOTS WOULD MAKE IT EASIER FOR BOSTONIANS OF ALL BACKGROUNDS TO PARTICIPATE IN THEIR MUNICIPAL ELECTION. THEREFORE, ORDERED THAT A PETITION OF THE GENERAL COURT OF THE COMMONWEALTH OF MASSACHUSETTS ACCOMPANIED BY A BILL FOR SPECIAL OR RELATED TO THE CITY OF BOSTON TO BE FILED WITH A COPY OF THIS ORDER TO BE AND HEREBY IS APPROVED UNDER **CAUSE FORM SECTION 8 OF ARTICLE** 2 AS AMENDED. THE AMENDMENTS OF THE CONSTITUTION OF THE COMMONWEALTH OF MASSACHUSETTS, TO THE END THAT LEGISLATION BE ADOPTED AS FOLLOWS EXCEPT AS TO EDITORIAL CHANGES OF FORM ONLY. >> COUNCILLOR FLAHERTY, YOU HAVE THE FLOOR. >> THANK YOU, MADAM PRESIDENT. THAT'S CONSIDERED A LATE FILE AS WE MENTIONED AT LAST COUNCIL MEETING TO MAKE SURE WHEN WE VOTED ON THIS MATTER WE WANTED TO PUT IT IN WITH ALL THE OTHER **ELECTION-RELATED MATTERS** TOGETHER TO BE SUBMITTED AND GET IT TO APPROVAL AS SOON AS POSSIBLE AT THE MAYOR'S OFFICE. WE HEARD TESTIMONY FROM JOHN **IRISH FROM THE ELECTION** DEPARTMENT AS WELL AS FOLKS FROM MASS VOTE AND PROGRESSIVE MASSACHUSETTS, TO ENCOURAGE GREATER PARTICIPATION IN THE ELECTION PROCESS, MENTIONED EARLY VOTING IN THE RECENT ELECTIONS AS WELL AS THE COST OF IMPLEMENTING THE EARLY VOTING AT A CITY LEVEL OF CITY ELECTIONS. COMMISSIONER IRISH AND REGISTRAR DEMONTY OFFERED TESTIMONY ESTIMATING THE COST WOULD BE ABOUT \$380,000 FOR EARLY VOTING.

THE ELECTION DEPARTMENT NOTED THEY WOULD LIKE AT LEAST A SIX-MONTHS ADVANCED TIMELINE TO EFFECTIVELY IMPLEMENT EARLY VOTING IN BOSTON IF IT SHOULD PASS ON BEACON HILL. BASED ON PASSING, THE DOCTOR WILL BE PROPERLY IMPLEMENT. THE PROPOSAL REFLECTS THESE AMENDMENTS THE SUMMARY OF WHICH FOLLOWS, IN THE FIRST SENTENCE OF ONE, THE PHRASE, BEGINNING IN THE YEAR 2019, IS STRICKEN AND THE WORD "REGULAR" IS ADDED. THE THIRD PARAGRAPH IS AMENDED BY ADDING LANGUAGE THAT GIVES THE BOARD OF ELECTION SIX MONTHS TO PROMULGATE REGULATIONS CONCERNING EARLY VOTING IMPLEMENTED AT THE NEXT BOSTON ELECTION. I RECOMMEND DOCKET 0130 OUGHT TO PASS AND A NEW DRAFT AT THIS TIME TURN OVER TO THE CHAIR FOR THE LEAD SPONSORS COUNCILLOR ZAKIM. COUNCILLOR JANEY AND HERSELF MADAM PRESIDENT IF YOU WISH TO ADD FURTHER COMMENT. >> THANK YOU, COUNCILLOR FLAHERTY COUNCILLOR ZAKIM. >> I WILL BE BRIEF. I WANT TO THANK THE CHAIRMAN FOR HIS QUICK WORK AND BRINGING THIS FORWARD TO A VOTE. COUNCILLOR JANEY AND YOURSELF AS ORIGINAL CO-SPONSORS AND OUR COLLEAGUES AND MAYOR WALSH AND HIS ADMINISTRATION AND SUPPORT FOR WORKING TOGETHER ON THIS. YOU HEARD ABOUT THE CHANGES TO THE DOCUMENT. THEY ARE MINOR AND REALLY WANTED TO MAKE SURE OUR ELECTION DEPARTMENT HAS TIME TO PUT THESE **REGULATIONS IN PLACE BEFORE AN** ELECTION. I BEING AN ETERNAL OPTIMIST EXPECT THAT ONCE WE PASS THIS TODAY, THE MAYOR WILL SIGN IT, IT WILL BE UP TO BEACON HILL AND WE'LL HAVE THIS IN PLACE FOR THE 2019 ELECTIONS. BUT JUST TO BE SURE, JUST TO MAKE, YOU KNOW, IN CASE OF A

WORST CASE SCENARIO, WE WANT TO MAKE SURE THAT COMMISSIONER **IRISH AND TEAM HAVE SIX MONTHS** TO PUT THE REGULATIONS IN PLACE. OTHER THAN THAT, THIS DIRECTLY ADDRESSES SO MANY OF THE ISSUES WE TALK ABOUT EXPANDING ACTS TO MAKE IT EASIER TO PARTICIPATE PARTICULARLY IN OUR ELECTION. SO I AM EXCITED TO HAVE THIS UP FOR VOTE AND LOOK FORWARD TO IT PASSING AND RESPECTFULLY ASK MY COLLEAGUES FOR SUPPORT. THANK YOU. >> THANK YOU. COUNCILLOR JANEY. >> QUICK THANK YOUS. CERTAINLY THANK YOU TO THE CHAIR FOR MOVING QUICKLY. THIS IS PART OF THE LARGER PACKAGE YOU PUT FORTH. GRATEFUL TO HAVE YOUR PARTNERSHIP, MADAM PRESIDENT, AS WELL AS THE CHAIR OF THE CIVIL **RIGHTS COMMITTEE FOR YOUR** LEADERSHIP, THANK YOU TO COUNCILLOR ZAKIM. AND CERTAINLY THE ADMINISTRATION. THAT IS THE MATTER THAT'S THE **RIGHTS TO FREE PETITION** SPONSORED BY OUR COLLEAGUE COUNCILLOR WU. THE COMMITTEE HAS HELD TWO HEARINGS, ONE IN 2017, ONE IN 2018. ALSO WE'VE HAD THE WORKING

SESSION IN LATE 2018 ON THE MATTER. SO I LOOK FORWARD TO BRINGING IT TO THE FLOOR. >> GREAT, WE'LL DO THAT AND HAVE THE LENGTHY DISCUSSION. SO THANKS FOR THE HEADS UP. >> WE'LL LOOK FORWARD TO SEEING EVERYONE. >> THANK YOU. COUNCILLOR ESSAIBI-GEORGE, YOU HAVE THE FLOOR. >> THANK YOU, MADAM PRESIDENT. I RISE TO MAKE A BRIEF STATEMENT **REGARDING THE ANNIVERSARY OF THE** PARKLAND SHOOTING WHICH IS TOMORROW. >> TOMORROW FEBRUARY 14 MARKS THE ONE-YEAR ANNIVERSARY OF THE PARKLAND SCHOOL SHOOTING. ONE YEAR SINCE TOO MANY STUDENTS LOST THEIR LIVES. AS A FORMER TEACHER AND A MOTHER, I CANNOT BEGIN TO IMAGINE THE PAIN AND FEAR THE STUDENTS, FACULTY, PARENTS AND COMMUNITY MEMBERS OF THE HIGH SCHOOL FELT IN THE AFTERMATH OF THIS TRAGEDY. WHAT HAPPENED IN PARKLAND WAS DEVASTATING AND. AS WE CLOSE THIS MEETING TODAY, I DO ASK THAT WE REMEMBER THE FAMILIES AND THE INDIVIDUALS IMPACTED, BUT ALSO REMEMBER IN OUR MOMENT OF SILENCE THE MANY PRECIOUS LIVES THAT HAVE BEEN LOST IN VIOLENT ACTS, ESPECIALLY IN OUR SCHOOLS. SINCE THAT TIME. PARKLAND IS OFTEN, WHEN WE TALK ABOUT SCHOOL SAFETY, WE TALK ABOUT SCHOOL SECURITY, PARKLAND IS OFTEN THE EVENTS THAT WE **REMEMBER BECAUSE IT'S MOST** RECENT, BECAUSE IT WAS SO LARGE. BUT SINCE LAST FEBRUARY 14, WE'VE HAD ALMOST 100 INCIDENTS IN SCHOOLS ACROSS THIS UNITED STATES. SO AS YOU REMEMBER, PARKLAND, THE COMMUNITY, THE SCHOOL, THE GREATER COMMUNITY AT LARGE, ALL, WE NEED TO THINK TO HAVE THE

SAFETY OF THE CHILDREN IN OUR

SCHOOLS. HOPE WE REMEMBER THEM TODAY, TOMORROW, EVERY DAY, BUT ALSO STUDENT SAFETY ACROSS THE CITY AND ACROSS THE COUNTRY. THANK YOU, MADAM PRESIDENT. >> THANK YOU, COUNCILLOR ESSAIBI-GEORGE. AND HAPPY VALENTINES TO ALL. THE LADY IN RED WASN'T QUITE COORDINATED BUT IT'S WORKED OUT SOMEWHAT. SO HAPPY VALENTINES TO EVERYONE. I ASK EVERYONE PLEASE RISE INCLUDING OUR GUESTS.
